Stewards granted permission on Tuesday 26 July for T Harris to be released from his engagement in Race 5 on FIFITA. T Harris was replaced by C Grylls.

## RACE COMMENTS

**Race 1** | **WAIPA EARTHWORKS 1550**

**HIBERNIA SEA** (N Parmar) - Began awkwardly losing ground. Had to be steadied when placed in restricted room to the inside of BINGWA passing the 1100 metres.

**OUR WONDERLAND** (B Rogerson) - Restrained in the early stages to obtain cover from the outside barrier. Over-raced in the early stages.

**CURRENT SURGE** (C Grylls) - Slow to begin.

**ALPHA CHARLIE** (E Nicholas) - Began awkwardly. Raced wide through the early and middle stages.

**WHETU** (R Elliot) - Began awkwardly.

**EL COOLIO** (T Thornton) - The left side barrier once opening did not latch, springing back making slight contact with the gelding. When questioned rider T Thornton advised that this did not have a detrimental effect on the horse's performance.

**BINGWA** (J Kamaruddin) - Shifted inwards near the 1100 metres when not fully clear of HIBERNIA SEA. Rider J Kamaruddin was advised to exercise greater care in similar circumstances. Finished a distant last. Underwent a post-race veterinary and endoscopic examination which did not reveal any abnormalities.

**FELIX FAURE** (K Hannan) – Established a considerable lead from the rest of the field through the early and middle stages of the race. Weakened in the final straight. When questioned regarding the tactics adopted on FELIX FAURE rider K Hannan advised that her instructions from Trainer G Lord were to lead and not restrain the gelding as the horse would resent it. Notwithstanding the instructions given, K Hannan was shown footage of her ride in the presence of riding mentor N Harris and advised that she is expected to exercise better judgement of the pace in future.

**CATWALK GIRL** (T Yanagida) - Held up for clear running entering the final straight.

**Race 2**

**MARTIN COLLINS NEW ZEALAND 1550**

**JIMMY DEAN** (J Riddell) - Slow to begin.

**FAR AND AWAY** (C Grylls) - Slow to begin. Performed below market expectations. When questioned, C Grylls could offer no explanation. Underwent a post-race veterinary examination which found the filly to be mildly lame in the left hind leg. Stewards will follow up the recovery of the filly with connections in the coming days.

**MISS LOVATO** (D Prastiyou) – Raced four wide without cover throughout. Crowded when weakening near the 400 metres. Rider D Prastiyou reported that being caught wide had proved detrimental to the filly's chances.

**FREEWHEELIN** (J Kamaruddin) – Raced keenly outside the leader through the middle stages.

**ELUSIVE FIGHTER** (M McNab) – Over-raced through the middle stages and near the 1000 metres became awkwardly placed on heels.

**CALVARIA** (L Allpress) - Performed below market expectations. When questioned, L Allpress reported that the filly hung outwards in the final straight. Underwent a post-race veterinary examination which found a minor laceration to the right coronet band.

**MISS BEE** (B Rogerson) – Held up by a weakening runner passing the 400 metres.

**GO LUCINDA** (N Parmar) – Finished a distant last. Underwent a post-race veterinary and endoscopic examination which revealed blood in the trachea.

**J Riddell** (JIMMY DEAN) - Issued with a warning after weighing in 0.6 kgs over the weight at which he weighed out at.

<p><b>SET IN STONE</b> (J Kam) - Began awkwardly losing ground. Raced wide through the middle stages. Lay in having to be corrected by its rider near the 100 metres.</p> <p><b>SAINT TROPEZ</b> (E Nicholas) – Began awkwardly losing ground.</p> <p><b>GATO MONTES</b> (B Rogerson) - Slow to begin.</p> <p><b>MR PUCCI</b> (D Danis) - Raced wide in the early stages.</p> <p><b>J Kam</b> (SET IN STONE) - Admitted a charge in that he struck his mount seven times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$250.</p>	
<b>Race 4</b>	<b>MARTIN COLLINS NEW ZEALAND 1300</b>
<p><b>RED VIENNA</b> (M McNab) - Slow to begin. Held up for clear running until near the 100 metres.</p> <p><b>SUPER WRAITH</b> (A Goindasamy) - Crowded shortly after the start.</p> <p><b>CARAMELLA</b> (L Allpress) - Raced wide through the early and middle stages. Had to be steadied near the 100 metres when weakening.</p> <p><b>GOOD OIL</b> (K Hannan) – Over-raced through the middle stages. Lay in and away from <b>ANNIE</b> making contact with the running rail passing the 800 metres proving a difficult ride. Held up for clear running throughout the final straight.</p> <p><b>ANNIE</b> (T Thornton) - Briefly lay in passing the 800 metres placing GOOD OIL in restricted room for a short distance.</p> <p><b>KELLY KEEPER</b> (C Lindsay) – Held up for clear running throughout the final straight.</p> <p><b>C Grylls</b> (PENSARDO) - Stewards inquired into the manner in which C Grylls used his whip in the home straight and could not be conclusively satisfied that he had contravened the rules.</p> <p><b>A Goindasamy</b> (SUPER WRAITH) - Stewards inquired into the manner in which A Goindasamy used his whip in the home straight and could not be conclusively satisfied that he had contravened the rules.</p>	
<b>Race 5</b>	<b>CAMBRIDGE GRAINS 970</b>
<p><b>ROC CHA</b> (R Elliot) - Reared as the start was effected, losing ground.</p> <p><b>GAME NIGHT</b> (R Beemud) - Raced wide without cover. Performed below market expectations. When questioned, rider R Beemud reported that the filly felt indifferent in her action. Underwent a post-race veterinary examination which found the filly to be mildly lame in the right foreleg.</p>	
<b>Race 6</b>	<b>MARTIN COLLINS NEW ZEALAND 970</b>
<p><b>ELUSIVE NATION</b> (C Grylls) - Slow to begin.</p> <p><b>ROCKBANK</b> (T Thornton) – Began awkwardly with the rider losing the use of her left iron for a distance.</p> <p><b>STAR TRAIL</b> (L Satherley) – Over-raced in the early stages.</p> <p><b>MS CANDEE LANE</b> (V Colgan) - Raced wide without cover throughout.</p> <p><b>AOIDE</b> (N Parmar) – Lay out under pressure early in the final straight making brief contact with IS THAT SO.</p>	

**IS THAT SO** (T Harris) – Briefly contacted in the final straight.

**Race 7**

**MARTIN COLLINS NEW ZEALAND 2000**

**LOFTYS GIFT** (E Nicholas) - Restrained in the early stages from its outside barrier draw. Became detached from the body of the field through the early and middle stages. Performed below market expectations. When questioned, rider E Nicholas reported that the filly never travelled throughout. Stewards will follow up the recovery of the filly with connections in the coming days.

**GOODO JO** (D Danis) - Began awkwardly. Over-raced in the early stages.

**BROTHER MAX** (N Parmar) - Slow to begin.

**CASPER** (K Asano) - Raced wide without cover throughout.

**LITTLE JOE** (T Thornton) – Held up for clear running prior to entering the final straight.

**KANTRA** (D Prastiyou) – Held up for clear running entering the final straight.
