**SUPPLEMENTARY****Oamaru Racing Club - Sunday 24 July 2022****Race 7 - CROMBIE AND PRICE LTD OAMARU CUP 1600m**

**GREEN LUCK** (B May) – Trainer Mr P Harris advised Stewards that on return to the stable GREEN LUCK underwent farrier attention, which upon removing the right fore plate revealed a small abscess which has been removed and treated. P Harris further advised it is his intention to continue with the gelding's preparation towards the Winter Cup.

**Race 8 - GLENMOA FARM LTD WAITAKI RIVER TROPHY 1200m**

**I'M A TIGER** (K Williams) – Trainer Mr D Frye reported to Stewards that I'M A TIGER underwent a veterinary examination on Monday 25 July which revealed no abnormalities. D Frye advised he will carry on with I'M A TIGER's current preparation and will look to nominate the gelding during the Grand National Carnival.

**RACE COMMENTS****Race 1****GRAND NATIONAL RACING FESTIVAL 6-13 AUGUST MAIDEN 2200m**

**GABBY DIAZ** (R Beeharry) - After being very fractious in the barriers jumped away very awkwardly almost dislodging the rider, then attempted to buck in the early stages when the saddle had shifted becoming tailed off and losing its chance in the race. The connections were advised the mare must barrier trial to the satisfaction of a Stipendiary Steward prior to racing again. A post-race veterinary inspection did not reveal any obvious abnormality.

**HEADS UP** (K Mudhoo) - Jumped away awkwardly.

**DEGREEOFINNOCENCE** (K Williams) - When attempting a marginal run between TREKOLURE and BEAUTY'S SECRET early in the straight made contact with BEAUTY'S SECRET, then lay inwards away from TREKOLURE which shifted ground marginally further hampering BEAUTY'S SECRET which was checked passing the 300 metres. Rider K Williams was advised to exercise greater care when attempting a marginal run.

**BEAUTY'S SECRET** (B May) - Crowded then checked passing the 300 metres and was not persevered with for the remainder of the race.

**Race 2****STALLION TENDER OPEN NOW 2200m**

**PLATINUM PETALS** (C Johnson) - Jumped away awkwardly after being fractious in the barriers.

**A LITTLE VAGUE** (K Mudhoo) - Slow away.

**RED SUNDAY** (B May) - Slow away.

**ALL LIT UP** (M McNab) - Raced wide without cover in the early stages.

**STAR VISTA** (K Asano) - When over racing improved onto heels having to be steadied near the 1200 metres. Placed in restricted room having to be steadied passing the 100 metres. When questioned regarding performance rider reported the gelding was not suited by the slow tempo of the race.

**TIFFEN** (D Montes de Oca) - Held up near the 200 metres having to shift outwards to obtain clear running.

**M Taylor** (ROAD TO REIGN) - Issued with a warning in that she used her whip with an action which raised the rider's arm above shoulder height with Stewards taking into consideration her clear record with regard to this whip rule.

**B May** (RED SUNDAY) - Admitted a charge in that he struck his mount RED SUNDAY 6 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a suspension of B May's licence to ride in races from the conclusion of racing on Friday, 29 July until the conclusion of racing on Wednesday, 17 August, 8 national riding days. The Stewards directed B May to meet with the Rider Skills Review Panel under the provisions of Rule 343 given that this was his sixth breach of this section of the whip rules in the previous six months.

**D Montes de Oca** (TIFFEN) - Admitted a charge in that he used his whip with an action which raised the rider's arm above shoulder height. After considering submissions the Adjudicator imposed a fine of/suspension of D Montes de Oca's licence to ride in races from the conclusion of racing on Friday, 29 July until the conclusion of racing on Wednesday, 3 August, 2 national riding days, and in addition imposed a fine of \$500.

**Race 3** | **NZB INSURANCE PEARL SERIES RACE MAIDEN 1400m**

**PEUT RESPIRER** (M Taylor) - Contacted leaving the barriers when PAGE THREE lay out.

**G Jogoo** (ANNEXCEPTION) - Issued with a warning after he struck his mount ANNEXCEPTION 6 times prior to the 100 metre mark, with Stewards taking into account his clear recent record with regard to this section of the whip rule.

**Race 4** | **PURE CHAMPION AT WILLOW GLEN STUD MAIDEN 1600m**

Trainer **L Prendergast** was issued with a warning after presenting ARABIA to race in blinkers rather than the notified visor blinkers.

**AMATERASU** (K Williams) - Slow away. Lost the right front plate passing the 400 metres.

**ANTEATER** (K Asano) - Held up early in the straight.

**Race 5** | **EL DOUTE AT LEITHFIELD LODGE 1600m**

**YEAH RIGHT** (M Taylor) - Slow away.

**DA VINCI GIRL** (D Montes de Oca) - Slow away. Lay in under pressure in the straight.

**TENNESSEE ROCK** (R Mudhoo) - Raced three wide without cover.

**Race 6** | **JON SNOW AT CLEARVIEW PARK 1400m**

**SHOW ME CHAMPAGNE** (K Williams) - Hampered leaving the barriers when STOP YELLING jumped outwards. Held up entering the final straight and was unable to obtain clear running until approaching the 200 metres.

**DRAKE BAY** (L Callaway) - Slow away.

**STOP YELLING** (C Carmine) - Jumped away awkwardly making contact with SHOW ME CHAMPAGNE. Over raced in the early and middle stages.

**THE MOTIVATOR** (K Kwo) - Had to be firmly restrained when commencing to over race passing the 1000 metres.

**FAME SHINES** (B May) - Held up near the 400 metres.

**SHAMELESS TART** (M Taylor) - When questioned regarding performance rider advised that she had been satisfied with the run and in her opinion the filly was now looking for a step up in distance.

**S Muniandy** (BACK HUT) - Issued with a warning after weighing in 0.6 kg in excess of his weigh out weight.

**C Carmine** (STOP YELLING) - Admitted a charge in that he struck his mount STOP YELLING 6 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a suspension of C Carmine's licence to ride in races from the conclusion of racing on Friday, 29 July until the conclusion of racing on Wednesday, 3 August, 2 national riding days, and in addition imposed a fine of \$500.

**Race 7** | **HIGHLY RECOMMENDED AT BERKLEY STUD MAIDEN 1200m**

**RAARDY RAAR** (B Murray) - Began awkwardly losing ground.

**THE BOLD LOOK** (K Kwo) - Slow away. Was inclined to shift ground under pressure through out the final straight.

**MARCHING ON TAVI** (L Calloway) – Briefly inconvenienced when becoming awkwardly near the heels of THE BOLD LOOK near the 300 metres when both runners shifted ground. Crowded and cheeked 175 metres.

**K Kwo** (THE BOLD LOOK) - Admitted a charge of careless riding in that he permitted his mount THE BOLD LOOK to shift inwards when not sufficiently clear of MARCHING ON TAVI which was crowded and checked near the 175 metres. After considering submissions the Adjudicator imposed a suspension of K Kwo's licence to ride in races from the conclusion of racing on Saturday, 6 August until the conclusion of racing on Friday, 19 August, 6 national riding days.

Following the running of the race the connections of the second placed horse MARCHING ON TAVI lodged a protest alleging interference in the final straight by the first placed horse THE BOLD LOOK. After considering submissions the Adjudicator dismissed the protest with the placings standing 1<sup>st</sup> THE BOLD LOOK, 2<sup>nd</sup> MARCHING ON TAVI, 3<sup>rd</sup> DOC MARTYN, 4<sup>th</sup> AORANGI ASSASSIN.

**B Murray** (RAARDY RAAR) - Was advised he has been charged with a breach of 648(5)(a) in that he weighed in 0.6 kg in excess of his weighed-out weight, and also with a breach of rule 606 in that he left the jockeys' area without permission, with both matters being adjourned until the Riccarton race meeting on Saturday, 6 August.

**Race 8** | **ECHOES OF HEAVEN AT CLEARVIEW PARK 1200m**

**FIRST ROCK** (M Taylor) - Began awkwardly.

**VINO BELLA** (K Asano) - Hampered at the start losing ground.

**SOOO DUSTY** (S Toolooa) - Began awkwardly losing ground. Hampered 1000 metres. Commenced to race ungenerously getting its head up on a number of occasions passing the 900 metres.

**SELFIE** (R Mudhoo) - Hampered at the start losing ground.

**GALILEO EXPRESS** (Y Atchamah) - When over racing improved onto heels having to shift out hampering SOOO DUSTY which had to be restrained near the 1000 metres. Returned to the enclosure with blood present in both nostrils. Following a post-race veterinary inspection including an endoscopic examination GALILEO EXPRESS was confirmed to have bled. GALILEO EXPRESS shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.

**RADIANT ROSIE** (B May) - Held up approaching the 400 metres having to shift out to obtain clear running early in the final straight.

**LOVE SQUIRRELS** (C Johnson) - Raced three wide without cover throughout. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.
