Following Race 2 O Bosson was stood down after becoming unwell. O Bosson is required to provide a medical clearance to Stewards prior to riding next.

Race 6 MCKEE FAMILY SUNLINE VASE (G3) (2100 metres)
THATSALLSHEWROTE (M Hashizume) – Co-trainer P Gerard advised Stewards the stable was satisfied with the post-race condition of the filly, however, has now been sent for a spell.
Race 8 HAUNUI FARM KING'S PLATE (G3) (1200 metres)
MANRICO (T Newman) – Trainer S Ralph reported to Stewards he was satisfied with the post-race condition of the gelding and it his intention to continue on with the gelding's current preparation.
Race 9 VODAFONE NZ DERBY (G1) (2400 metres)
MARCHAND (L Innes) – Trainer L Noble advised Stewards MARCHAND underwent a veterinary examination on Tuesday 8 March which revealed the gelding to have a bone chip to the left front fetlock. L Noble further advised the gelding will undergo surgery next week to have the bone chip removed.

RACE COMMENTS
Race 1 MOUNT SHOP 2100
TRUST IN YOU (A Calder) - Slow to begin. Shifted in approaching the 150 metres to obtain clear running when improving near heels.
KERMALINA (T Newman) – Restrained in the early stages to obtain cover from its wide barrier.
SAVAGE KATIE (M Cameron) - Raced wide for the majority of the race.
ANNETARZ (D Danis) – Began awkwardly.
SACRED BOURBON (T Yanagida) – Held up for clear running until approaching the 200 metres. T Yanagida was reminded of his obligation in that he must ride his mount out to the end of the race when circumstances permit. T Yanagida explained that SACRED BOURBON had been somewhat reluctant when amongst runners.

TAVI WITH ME (R Beemud) - Rider dropped his whip near the 400 metres.

J Riddell (ROCKET LAD) - Admitted a charge in that he struck his mount ROCKET LAD six times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$500.

Race 2 | **SONIA MACFARLANE MEMORIAL (1400 metres)**

FOLLOW YOUR DREAMS (S Weatherley) - Began awkwardly then restrained in the early stages from its outside barrier.

CULLINAN (A Goindasamy) - Raced wide for the majority of the race. Forced wider 1000 metres.

LADY KOVAL (O Bosson) - Crowded shortly after leaving the barriers, losing ground. When questioned regarding performance O Bosson explained that after beginning poorly, the filly had failed to recover. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

REKINDLED EXPRESS (J Riddell) – Began awkwardly.

DOUBTFUL SOUND (R Elliot) - Jumped awkwardly and was then crowded and steadied. Held up early in the final straight but then failed to respond once placed under pressure. When questioned regarding performance rider R Elliot could offer no excuse.

STARS 'N' CREAM (A Calder) - Became awkwardly placed on heels near the 1000 metres and shifted out forcing CULLINAN wider on the track. When questioned regarding the improved performance connections advised that the filly had been racing in strong company and at its most recent start had received a poor run in transit.

Race 3 | **NZB INSURANCE PEARL SERIES RACE (1200 metres)**

I'M NOT BOSSY (A Goindasamy) - Slow to begin.

BIT NOSY (R Elliot) - Began awkwardly.

TREAT DAPAINTER (M Hashizume) - Began awkwardly.

SPLASH OF RED (A Lawson-Carroll) – Began awkwardly.

ROW OF EIGHTS (E Nicholas) - Began awkwardly making contact. When questioned regarding the riding tactics apprentice E Nicholas explained that she had been instructed to lead, further advising that after beginning poorly the mare had shown good speed to lead in the early stages. E Nicholas explained that she had erred in her judgement after allowing ROW OF EIGHTS TO lead by some distance. Rider dropped her whip near the 400 metres.

SILK 'N' DALE (T Newman) – Raced wide without cover throughout.

A Goindasamy (I'M NOT BOSSY) - Admitted a charge in that he struck his mount I'M NOT BOSSY six times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$250.

Race 4 | **MOUNT SHOP 1200**

NO AGENDA NIGEL (T Newman) - Slow to begin.

MYLETT (T Thornton) - Restrained to obtain cover in the early stages from its outside barrier draw.

SALENTO (J Riddell) - Slow to begin.

NUHAKA (E Nicholas) - Began awkwardly.

HARD NOSE (S Weatherley) - Held up for clear running until passing the 400 metres and when shifting out, inconvenienced KAI. Shifted out under pressure passing the 250 metres dictating KAI wider on the track.

KAI (R Elliot) - Inconvenienced 400 metres. Dictated wider 250 metres. Inconvenienced and briefly steadied 200 metres by OH NO NO NO which shifted in. T Yanagida was advised to exercise care in a similar circumstance.

OH NO NO NO (T Yanagida) - When questioned regarding the improved performance trainer K Harrison advised that the mare had been racing in strong company in her most recent starts with changes in gear also being beneficial.

Race 5 | **FRANKLIN PRIVATE HOSPITAL GALLOP (1200 metres)**

GAME DUKE (C Burdan) - Began awkwardly losing ground. Made the bend awkwardly passing the 1000 metres.

SLEEPY JEAN (R Elliot) – Began awkwardly and restrained in the early stages.

OUR TRISTABELLE (M Hashizume) - Raced keenly near the 900 metres when being restrained.

SAINT BATHANS (J Riddell) – Over-raced through the middle stages. Shifted out to obtain clear running passing the 400 metres.

SUPER DAISY (T Yanagida) - Became awkwardly placed near the heels of CIMARRON having to be restrained passing the 900 metres.

CIMARRON (A Calder) - Restrained off heels passing the 500 metres.

Race 6 | **HAUNUI FARM 1400**

POKURU TWISTER (C Burdan) – Began awkwardly. Raced wide without cover throughout. Hampered approaching the 400 metres when crowded to the outside of CAMACHO which shifted out and away from BRILLIANT COLOUR (a Goindasamy) which shifted out slightly. A Goindasamy was advised to exercise care in a similar circumstance with Stewards taking into account the racing manners of all three runners.

BELLE OF THE BALL (D Danis) – Raced three wide without cover throughout.

TOMSK (J Riddell) - Began awkwardly.

CAERUS (R Elliot) – Held up for clear running early in the final straight and then failed to respond once placed under pressure.

MYLA (J Fawcett) - Lay in across heels passing the 300 metres.

ASTRON (M Cameron) - Returned to the enclosure with blood present in the right nostril. Following a veterinary inspection ASTRON was confirmed to have bled. ASTRON shall not be ridden in exercise for a period of two months or start in any Race or Trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.

Race 7 | **NZB INSURANCE PEARL SERIES RACE (1400 metres)**

ALEGRE (L Satherley) - Resaddled after becoming fractious in the barrier undergoing a pre-race veterinary inspection before being declared fit to start. Co-trainer G Rogerson advised that he would experiment with gear changes on the mare and would be also considering the racing future of ALEGRE.

DARK SATIN (T Yanagida) - Became fractious in the barriers and underwent a pre-race veterinary inspection before being declared fit to start. Began awkwardly.

MADAME MOET (R Elliot) - Slow to begin.

BEA A ROCA (M Hashizume) – Raced wide without cover throughout.

LE CHAMOSSAIRE (A Goindasamy) - Over-raced when being restrained near the 1000 metres.

LOOKSEASY (A Calder) – Held up for clear running passing the 300 metres.

CLEVER RUDS (C Burdan) – Shifted out under pressure over the concluding stages.

Race 8

BARFOOT & THOMPSON 1600

FLOSSYROSYCANDY (T Newman) - Dislodged the rider after becoming fractious behind the barrier and was declared a late scratching as rider T Newman was not in a fit condition to ride, being attended to by St John Ambulance personnel. As a result, this race was delayed by approximately 4 minutes. T Newman is to provide a medical clearance prior to riding next.

POP CULTURE (R Beemud) - Slow to begin.

VISTOWN (A Calder) - Slow to begin. Held up early in the final straight. Hampered 300 metres when improving onto the heels of **ROCABURY** which shifted out under pressure. **VISTOWN** then had difficulty obtaining clear running for a distance. J Riddell was advised to exercise care in a similar circumstance.

GHOST PROTOCOL (A Lawson-Carroll) - Began awkwardly then crowded. Made the bend near the 900 metres awkwardly shifting out onto heels and was hampered. As a result, **PROOST** was crowded.

PROOST (T Yanagida) – Crowded 900 metres and steadied.

ATAAHUA (C Barnes) - Raced wide without cover throughout.

ROCABURY (J Riddell) - Raced ungenerously in the early stages when being steadied.

WONDERSTRUCK (S Weatherley) – Made the final bend awkwardly, shifting outwards. Steadied 300 metres when becoming awkwardly placed near the heels of **VISTOWN** then further crowded by **NOVAK** which shifted out and away from **PROOST** which shifted out under pressure. Riders E Nicholas and T Yanagida were advised to exercise care in a similar circumstance.

NOVAK (E Nicholas) - Raced greenly under pressure in the final straight, shifting in passing the 100 metres to obtain clear running.

Following the race, the connections of the 2nd placed horse **VISTOWN** lodged a protest against the 1st placed horse **ROCABURY** alleging interference in the final straight. After considering submissions the Adjudicative Committee dismissed the protest with the placings standing 1st **ROCABURY**, 2nd **VISTOWN**, 3rd **PROOST**, 4th **NOVAK**.
