Race 4 DAPHNE BANNAN MEMORIAL (1000m)

MR HASS (L Allpress) – Co-trainer Mrs. A Harrington reported to Stewards; that on Monday 25 June MR HAAS underwent a veterinary examination which included x-rays with results showing a bone chip to the knee of the right foreleg. A Harrington further advised the gelding will now have surgery to remove the chip on Thursday 7 July and will then be sent for a 3-month spell.

RACE COMMENTS

Race 1 GRAND NATIONAL FESTIVAL TICKETS ON SALE MAIDEN (2200m)

POROTENE DUNDEE (L Allpress) - Began awkwardly losing ground. Improved forward to lead near the 1200 metres.

HEADS UP (K Mudhoo) - Got its head up in the early stages when racing keenly and being steadied away from heels. Stewards questioned rider K Mudhoo regarding the tactics he adopted near the 250 metres when electing to shift ground outwards as opposed to taking a run between SWEET VIRGINIA and GOING STEADY. Mr Mudhoo advised the mare had raced greenly and been reluctant to take the run between those runners despite his urgings therefore he elected to shift outwards to find clear racing room. Stewards noted Mr Mudhoo's comments.

VITAL PERFECTION (M Taylor) - Over-raced through the middle stages due to the lack of tempo. Lost contact with the body of the field when the pace of the race increased passing the 1200 metres. When questioned regarding the performance rider advised the mare was left flat footed when the pace increased and was not suited to the changing tempo throughout the race. A post-race veterinary examination revealed no obvious abnormalities.

PACKING TAVI (T Jonker) - Raced three-wide without cover from near the 1000 metres. Held up in the run home until shifting ground inwards near the 150 metres to find clear racing room.

GOING STEADY (K Williams) - When questioned regarding the improved performance trainer Mr. S Woodsford advised the mare had benefitted from the step up in distance of today's race.

Race 2 WINTER FASHIONS 13 AUGUST MAIDEN 1200

Due to the incidents at the barriers with ANTEATER and MACKENZIE CHIEF the start of this race was delayed approximately 8 minutes. All runners were removed from the barriers until the riderless MACKENZIE CHIEF was caught and removed from the track.

MACKENZIE CHIEF (S Toolooa) - Escaped riderless under the barriers before being caught by the Clerk of the course and was subsequently declared a late scratching at 1.44pm by order of Stewards. Underwent a veterinary examination on return to the stabling area which revealed no abnormalities. Connections were advised a barrier manners warning has been placed on the gelding. Stewards took into consideration the barrier manners of the horse to its inside when assessing this penalty.

ANTEATER (K Williams) - Reared in the barriers dislodging rider K Williams who was uninjured in this incident. Underwent a pre-race veterinary examination and was cleared to start. Connections were advised a barrier manners warning has been placed on the gelding. Slow to begin.

HIGHLAND FLING (L Callaway) - Slow to begin then hampered losing ground.

SPICY FILLY (L Allpress) - Crowded at the start losing ground. Raced greenly throughout. Rider reported the filly had hung outwards throughout the final straight and was unable to be fully ridden out over the concluding stages.

THE MOTIVATOR (K Kwo) - Commenced to over-race passing the 800 metres and when doing so improved onto heels having to shift ground outwards and was then obliged to race three-wide without cover thereafter.

NORTOLOSE (C Carmine) - Raced wide without cover throughout.

SPORT MODE (C Johnson) - Steadied to avoid the heels of BLACKS POINT near the 100 metres when both runners shifted ground.

C Carmine (NORTOLOSE) - Spoken to advisedly regarding his whip use on a runner which was out of contention.

Race 3

NZB INSURANCE PEARL SERIES RACE (1400m)

IN VEGAS (K Mudhoo) - Slow to begin.

PERFECTIONIST (L Allpress) - Slow to begin. Held up passing the 200 metres and was unable to obtain clear running until near the 50 metres.

LADY'S LEGACY (M McNab) - Slow to begin. When questioned regarding the performance which was below market expectations rider advised the filly had lay inwards under pressure throughout the run home.

GLOBAL BEAUTY (B May) - Over-raced in the early stages having to be steadied off heels on a number of occasions. Lay outwards throughout the final straight having to be corrected by its rider and shifted up the track dictating FOLKTALE wider on two occasions.

FOLKTALE (R Mudhoo) - Dictated wider on the track on two occasions in the run home.

Following the race the connections of the 2nd placed **FOLKTALE** (R Mudhoo) lodged a Protest pursuant to Rule 614(2) against 1st placing being awarded to **GLOBAL BEAUTY** (B May) alleging interference in the final straight had been detrimental to their runners' chances of winning the race. After viewing replays and hearing evidence from the Stewards and connections of both horses the Adjudicator dismissed the Protest.

B May (GLOBAL BEAUTY) - Issued with a warning for allowing his mount to shift ground outwards in the run home dictating FOLKTALE wider.

Race 4

SPEIGHT'S MAIDEN (1600m)

ALLASERA (C Carmine) - Slow to begin. Shifted out and away from ROYAL KHAN near the 100 metres briefly inconveniencing CEEDOUBLEUJAY.

KENKI (B May) - Slow to begin. When questioned regarding the improved performance trainer P Harris advised the gelding had benefitted from a brief freshen up.

NELLIE GREY (G Jogoo) - Slow to begin. Rider reported the mare had hung inwards throughout the run home.

TIRATORE (L Allpress) - Lay outwards early in the run home having to be straightened by its rider.

SERAPHIC (Y Atchamah) - Had some difficulty obtaining clear running for a distance passing the 200 metres.

CEEDOUBLEUJAY (M McNab) - Inconvenienced near the 100 metres. When questioned regarding the performance rider advised the gelding had made abnormal breathing noises over the concluding stages. A post-race veterinary examination revealed no obvious abnormalities. Stewards will follow up the recovery of CEEDOUBLEUJAY with connections in the coming days.

ROYAL KHAN (L Callaway) - Lay out under pressure over the concluding stages.

Race 5

RICCARTON PARK FUNCTION CENTRE RATING 65 (1600m)

ALASKAN GOLD (S Toolooa) - Burst through the barriers prior to the start however was quickly restrained by its rider. Underwent a pre-race Veterinary examination and was cleared to start.

LADY MODENA (R Mudhoo) - Began awkwardly losing ground. Improved quickly onto heels near the 900 metres getting its head up when being restrained.

CHOISIA PRINCE (L Allpress) - Over-raced in the early stages.

FAME SHINES (L Callaway) - Raced three-wide without cover from the 1000 metres. When questioned regarding the performance rider advised the gelding had raced wide for the majority of the event and this had taken its toll.

SARAYU (T Moseley) - Held up early in the run home.

YEAH RIGHT (C Barnes) - Held up entering the final straight having to shift ground inwards to obtain clear running.

HEY SOUL SISTER (K Kwo) - Held up through the middle stages of the run home only gaining clear racing room inside the final 125 metres.

Race 6 VALACHI DOWNS DISPERSAL SALE ON GAVELHOUSE PLUS RATING 65 (1200m)

LIGHT UP (C Carmine) - Late scratching on Veterinary advice at 9.00am.

MAKE BELIEVE (K Mudhoo) - Began awkwardly losing ground. Commenced to over-race getting its head up when being steadied off heels near the 800 metres.

LADY CORA (L Callaway) - Began awkwardly losing ground.

LOVEBUG (C Barnes) - Began awkwardly. Raced three-wide without cover throughout.

OUR ROSETTE (K Williams) - Bounded at the start. Held up entering the final straight and was unable to obtain clear running throughout the run home with the mare going to the line untested by its rider.

SELFIE (R Mudhoo) - Placed in restricted room to the inside of TWIN SHOT passing the 900 metres having to be steadied. D Montes de Oca was advised to exercise care when shifting ground.

MEGALOMANIAC (L Allpress) - Held up early in the final straight and was unable to obtain clear running throughout with the gelding going to the line untested by its rider.

TWIN SHOT (D Montes de Oca) - Shifted inwards under pressure over the concluding stages.

COMMITMENT (M McNab) - Crowded having to be steadled near the 150 metres when BLAIR FLIGHT shifted outwards under pressure simultaneous to some slight inwards movement from TWIN SHOT. D Montes de Oca was advised to exercise care. Then held up for a run until near the 75 metres.

OUR CLARRY (Y Atchamah) - Held up early in the run home, then had to be steadied when becoming awkwardly placed on the heels of CAUSE CELEBRE near the 250 metres. Placed in restricted room having to be steadied passing the 100 metres

CAITLYN JAY (T Moseley) - Attended to by the on-course Veterinarian on pulling up with the Horse Ambulance being deployed. The mare was found to have displaced the left front racing plate causing an abrasion to the coronet band. Stewards will follow up on the recovery of CAITLYN JAY with connections in the coming days.

K Kwo (BLAIR FLIGHT) - Issued with a warning under the Careless Riding rule when allowing his mount to shift ground outwards near the 150 metres crowding COMMITMENT.

L Allpress (MEGALOMANIAC) - Was reprimanded by Stewards regarding the manner in which she reacted when her mount MEGALOMANIAC was proving reluctant to proceed from the crossing to the Synthetic track.
