RACE COMMENTS

Race 1 | **HERBERTS TRANSPORT/VETCO EDENDALE MAIDEN 2000m**

WUDDZZ (G Jogoo) - Slow away.

TAPPY'S LAD (S Toolooa) - Slow away.

LEAVE IT TO ME (S Muniandy) - Began awkwardly losing ground. Held up approaching the 400 metres. Improved onto the heels of TAPPY'S LAD and in doing so shifted outwards to obtain clear running when not clear of MI JADORE which was crowded and checked near the 200 metres.

ROYAL KHAN (K Kwo) - Shifted outwards shortly after the start making contact with THE CLUSTER. Lost the left front plate during the running.

THE CLUSTER (K Mudhoo) - Contacted shortly after the start. Raced keenly in the early and middle stages.

LEVON (D Bothamley) - Restrained behind runners to obtain cover shortly after the start.

VILLANELLE (K Chowdhoo) - Raced three wide without cover passing the 800 metres.

MI JADORE (R Mudhoo) - Crowded and checked passing the 200 metres.

RENAULT (C Johnson) - Lost the right front plate during the running.

TAPPY'S LAD (S Toolooa) - Lay out rounding the final turn.

Following the running of this race rider B Murray reported that his mount LIEINWAIT had lost its footing near the 600 metres. Film coverage of the incident was inconclusive. After meeting with all riders a delegation of Stipendiary Stewards and Rider representatives conducted an inspection of the area of concern along with the course manager. Following this inspection a further meeting was convened with all riders after which it was agreed to continue with the meeting.

S Muniandy (LEAVE IT TO ME) - Defended a charge of careless riding alleging that he permitted his mount LEAVE IT TO ME to shift out when not sufficiently clear of MI JADORE which was crowded and checked near the 200 metres. After considering submissions the Adjudicator upheld the charge and imposed a suspension of S Muniandy's licence to ride in races from the conclusion of racing on Monday, 21 March until the conclusion of racing on Saturday, 2 April, 6 national riding days.

GERRY JOYCE (C Johnson) - Underwent a veterinary inspection on arrival at the course and was cleared fit to race.

MY CASHIER (G Jogoo) - Slow to begin.

PINHEAD (K Mudhoo) - Raced ungenerously in the early stages.

HEIDI HI (T Comignaghi) - Raced three wide without cover from passing the 1000 metres.

CARISBROOK (S Muniandy) - Raced keenly in the early stages. When questioned regarding performance rider advised that the gelding had felt a little reluctant amongst other runners. A post race veterinary inspection did not reveal any obvious abnormality.

YING RESOLUTE (K Chowdhoo) - Held up approaching the 400 metres having to shift out to obtain clear running early in the straight.

B Murray (OLAF) - Admitted a charge of failing to make the contracted weight for OLAF and was replaced. After considering submissions the Adjudicator imposed a fine of \$300.

PETE THE DRIVER (R Mudhoo) - Over raced in the early and middle stages.

REDGUM (C Johnson) - When questioned regarding performance rider was unable to offer any excuse.

Race 4 | **AUTO WINDSCREEN REPLACEMENTS MAIDEN 1200m**

WING IT (G Jogoo) - Slow away.

CHISSIE (C Johnson) - Crowded leaving the barriers losing ground.

LIGHTNING RIDGE (K Kwo) - When questioned regarding performance rider was unable to offer any excuse. A post race veterinary inspection found the mare to have an elevated heart rate and a poor rate of recovery.

THE FABULOUS PEARL (K Chowdhoo) - Checked to avoid the heels of HENRY HUBBER near the 300 metres.

T Comignaghi (HENRY HUBBER) - Admitted a charge of careless riding in that she permitted her mount HENRY HUBBER to shift outwards when not sufficiently clear of THE FABULOUS PEARL which was checked near the 300 metres. After considering submissions the Adjudicator imposed a suspension of T Comignaghi's licence to ride in races from the conclusion of racing on Thursday, 17 March until the conclusion of racing on Friday, 25 March, 4 national riding days.

Race 5 | **CALDWELL CONTRACTING/BEATTIES COLLISION REPAIR 1200m**

NOAH (K Chowdhoo) - Jumped away awkwardly losing ground. When questioned regarding performance rider could offer no excuse. A post race veterinary inspection did not reveal any obvious abnormality. Trainer K Dickson was advised that a veterinary certificate of fitness would be required prior to racing next, a warning would be placed against the gelding regarding its poor performance, and it would be expected to be more competitive in any future racing.

FULLTOTHEBRIM (S Toolooa) - Slow away.

SACRED KITTY (K Kwo) - Blundered leaving the barriers.

LINCOLN HILLS (C Johnson) - Over raced in the middle stages.

ZAC BLACK (R Mudhoo) - Raced three wide without cover.

RUBY ROYALE (T Comignaghi) - Held up early in the straight until near the 150 metres.

Race 6 | **GORE ELITE PLUMBING/ADVANCE AGRICULTURE MAIDEN 1335m**

LINCOLN LANE (C Johnson) - Slow to begin.

CATS IN THE CRADLE (K Chowdhoo) - Began awkwardly losing ground. Lost the right front plate during the running.

TOTAL (D Bothamley) - Commenced to race ungenerously for a distance passing the 1200 metres. Lay out rounding the final turn.

LILYBET (T Comignaghi) - Raced three wide without cover throughout. Blundered passing the 600 metres then commenced to give ground dropping out to finish a distant last. When questioned, rider was of the opinion there might have been something amiss with the mare. A post race veterinary inspection did not reveal any obvious abnormality. Trainer G Robinson was advised that a warning would be placed against the mare for its performance and it would be expected to be more competitive in any future racing.

<p>GOODANYA (K Chowdhoo) - Began awkwardly losing ground. Was inclined to lay in under pressure in the straight.</p> <p>DUNHILL (R Mudhoo) - Briefly steadied when THE GIFT (T Comignaghi) shifted inwards when not fully clear near the 1200 metres. T Comignaghi was advised to exercise greater care.</p>

<p>CLASSIC DIVA (K Chowdhoo) - Slow away.</p> <p>DREAM BRAVE (S Muniandy) - Slow away.</p> <p>IRISH ENVY (T Moseley) - Jumped away awkwardly losing ground.</p> <p>SUPER TAP (B Murray) - Blundered leaving the barriers.</p> <p>MAXIE TAP (K Kwo) - Hung outwards rounding the bend from the 800 metres running wide entering the final straight.</p> <p>LA OPCION (T Comignaghi) - Contacted passing the 200 metres when PANDDE shifted away from LOUIS LUCK. When questioned regarding performance rider was unable to offer any excuse.</p> <p>CLASSIC DIVA (K Chowdhoo) - Had difficulty obtaining clear running inside the final 100 metres having to shift ground before being steadied just short of the finish.</p> <p>C Johnson (BENNY LINCOLN) - Admitted a charge of using the whip in four consecutive strides on his mount BENNY LINCOLN over the concluding stages. After considering submissions the Adjudicator imposed a suspension of C Johnson's licence to ride in races from the conclusion of racing on Monday, 21 March until the conclusion of racing on Saturday, 2 April, 6 national riding days.</p>
