Race 7 HUMPHRIES CONSTRUCTION 1400

WICKET MAIDEN (L Allpress) – Trainer Mr J Bary advised Stewards, WICKET MAIDEN was seen by the chiropractor on Monday 14 March and was satisfied with the post-race recovery of the mare. J Bary further advised it is his intention to continue on with WICKET MAIDEN'S current preparation.

RACE COMMENTS

Race 1 | **RAT TAT (HE'S 22) 2YO PLATE 1200**

SHEEZ DOMINANT (M Singh) - Jumped away awkwardly. Held up passing the 600 metres before shifting out to obtain clear running near the 450 metres.

TRAV (S Macnab) - Raced wide without cover throughout and was inclined to lay out. When questioned regarding performance, rider advised that the gelding had raced very greenly. A post-race veterinary examination did not reveal any obvious abnormality.

SWAZI (L Allpress) – Made the bend awkwardly crossing the junction onto the course proper and lay out.

K Asano (DISS IS DRAMATIC) - Admitted a charge in that he struck his mount DISS IS DRAMATIC 6 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.

Race 2 | **NZB NATIONAL ONLINE YEARLING SALE 20/04 PREMIER 1400**

SAILOR (J Mudhoo) - Restrained to obtain cover after jumping from a wide barrier.

HELLUVAH RETURN (C Dell) - Raced three wide without cover and lay out rounding the final turn. When questioned regarding performance, rider reported the filly had hung throughout the running.

SHARPIE (M McNab) - Over-raced early. Lay out rounding the final bend.

TRUSTWORTHY (A Goindasamy) - Over-raced and hung through the middle stages, making the final turn awkwardly.

SACRED PEARL (T Yanagida) - When questioned regarding performance, rider advised that the mare had never travelled well and had felt disinterested.

Race 3 | **LYNAIRE MONNERY TRAVEL BROKER PREMIER 1600**

KICK START (R Hannam) - Very slow to begin. Held up for a distance near the 200 metres.

I AM A ROCK (J Laking) - Held up early in the final straight.

SERGIO (A Goindasamy) – When questioned regarding performance rider advised that the gelding had raced keenly in the lead and hung throughout. A post-race veterinary examination did not reveal any obvious abnormality.

KELLY COE (M Hudson) - When questioned regarding performance rider advised that in her opinion the mare is better suited to more rain-affected footing.

<p>FAMILY TIME (K Hercock) – Slow away. Held up rounding the final turn.</p> <p>BEAUDZ WELL (M Cameron) - Jumped away awkwardly. Held up early in the home straight when in restricted room. When questioned regarding performance, rider was of the opinion that the gelding may be feeling the effects of recent racing and travelling.</p> <p>WANNABE 'N' PARIS (A Goindasamy) - Rider dropped his whip passing the 350 metres.</p> <p>LETSBRINGITON (K Williams) - Lay in under pressure in the home straight.</p> <p>DARLINGTON COUNTY (S Macnab) - Raced in restricted room for a distance passing the 150 metres.</p> <p>DALMATIA (L Allpress) - When questioned regarding performance rider was of the opinion the gelding may be feeling the effects of recent racing. Co-trainer J Benner advised DALMATIA would now be sent for a spell.</p>	
Race 5	WENTWOOD GRANGE CUDDLE STAKES (G3) 1600
<p>DAISY DAISY (A Mudhoo) - Restrained to the rear to obtain cover from a wide draw.</p> <p>SAMIAM SEUSSIE (M McNab) - Contacted and forced outwards on to LES CRAYERES shortly after the start by ISLA JAY, which lay out.</p> <p>LES CRAYERES (K Hercock) - Unbalanced when receiving firm contact shortly after the start.</p> <p>ISLA JAY (A Goindasamy) - Lay out making contact with SAMIAM SEUSSIE shortly after the start.</p> <p>MAGIC INCANTO (M Hudson) - Raced wide without cover.</p> <p>MAI TAI (K Asano) - Over-raced through the middle stages.</p>	
Race 6	WELLINGTON SEAMARKET LEVIN CLASSIC (G1) 1600
<p>ZEITAKU (J Laking) - Underwent a veterinary inspection at the start due to having minor abrasions to the left hip and hock, being passed fit to run. Held up early in the straight before being angled outwards across heels to obtain clear running passing the 350 metres.</p> <p>I WISH I WIN (K Asano) - Slow away before being further hampered by SHAMUS. Over-raced in the middle stages having to be firmly restrained when improving onto heels near the 800 metres. Had to shift ground to obtain clear running passing the 200 metres.</p> <p>SHAMUS (R Elliot) - Jumped away awkwardly. Finished towards the rear. When questioned regarding performance rider was of the opinion the gelding may be feeling the effects of recent racing. Trainer A Sharrock advised SHAMUS would be spelled. A post-race veterinary examination did not reveal any abnormality.</p> <p>MOHAWK BRAVE (C Grylls) - Slow away.</p> <p>ONE DREAM ONE SOUL (A Mudhoo) - Began awkwardly. Steadied to avoid the heels of ON THE BUBBLES approaching the 200 metres.</p> <p>CACOFONIX (T Yanagida) - Contacted passing the 350 metres.</p>	

BELLA LUCE (S Macnab) - Raced wide without cover throughout. Crowded and checked passing the 300 metres.

ON THE BUBBLES (J Parkes) - Held up entering the final straight and did not obtain clear running until angling outwards across heels approaching the 200 metres.

J Parkes (ON THE BUBBLES) - Issued with a warning after permitting ON THE BUBBLES to shift outwards when not fully clear of ONE DREAM ONE SOUL which was steadied approaching the 200 metres.

J Laking (ZEITAKU) - Admitted a charge of careless riding in that he permitted ZEITAKU to shift outwards when not sufficiently clear crowding BELLA LUCE which was checked passing the 300 metres. After considering submissions the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing on 26 March until the conclusion of racing on 10 April, 9 national riding days, and in addition imposed a fine of \$300.

M McNab (IMPERATRIZ) - Spoken to regarding his celebratory gesture just prior to the finish.

Race 7

RACE A HORSE WITH TE AKAU STABLE LIGHTNING HCP 1200

LINCOLN'S KRUZ (A Mudhoo) - Underwent a veterinary check after becoming fractious in its barrier and was cleared to start. Raced ungenerously when being steadied in the early to middle stages, shifting outwards to avoid heels near the 1000 metres, hampering OKAY PAL. Again shifted outwards when being restrained contacting OKAY PAL approaching the 600 metres. Shifted outwards to obtain clear running 450 metres.

SCOTCH (S Macnab) - Slow away. Over-raced through the middle stages. Held up early in the straight. Struck a heel and blundered badly near the 50 metres when in third placing dislodging its rider. S Macnab was immediately attended to by St Johns Ambulance personnel before being transferred to hospital for further evaluation. A post-race veterinary examination of SCOTCH was clear.

BURGUNDY ROSE (K Asano) – Crowded leaving the barriers. Shifted outwards under pressure over the final 150 metres.

OKAY PAL (M McNab) - Hampered 1000 metres. Contacted approaching the 600 metres.

CAVALLO VELOCE (S McKay) - Forced over extra ground near the 450 metres.

STUMPY (L Allpress) – Shifted outwards to obtain clear running 450 metres. Hampered by fallen rider passing the 50 metres.

MATT CAIN (F Lazet) - Checked near the 450 metres.

EPTIMUM (K Williams) – Hampered by fallen rider passing the 50 metres.

A Mudhoo (LINCOLN'S KRUZ) - Issued with a warning after permitting his mount to shift outwards near the 450 metres forcing CAVALLO VELOCE over extra ground.

L Allpress (STUMPY) - Admitted a charge of careless riding in that she permitted STUMPY to shift outwards near the 450 metres when not sufficiently clear of MATT CAIN which was checked. After considering submissions the Adjudicative Committee imposed a suspension of her licence to ride in races from the conclusion of racing today, Saturday 19 March until the conclusion of racing on Wednesday 30 March, 5 national riding days.

K Hercock (CAN I GET AN AMEN) - Admitted a charge of careless riding in that she permitted CAN I GET AN AMEN to shift inwards when not sufficiently clear crowding SCOTCH which struck a heel near the 50 metres dislodging its rider.

After considering submissions the Adjudicative Committee imposed a suspension of her licence to ride in races from the conclusion of racing on Sunday 27 March until the conclusion of racing on Sunday 24 April, 4 weeks.

K Asano (BURGUNDY ROSE) - Admitted a charge of careless riding in that he permitted BURGUNDY ROSE to shift outwards when not sufficiently clear crowding SCOTCH which struck a heel near the 50 metres dislodging its rider. After considering submissions the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing on Saturday 26 March until the conclusion of racing on Saturday 23 April, 4 weeks.

Race 8 | **AL BASTI EQUIWORLD DUBAI NEW ZEALAND OAKS (G1) 2400**

ANOTHER BELLA (K Hercock) - Began awkwardly and settled at the rear.

RUE CLER (D Turner) - Jumped away awkwardly.

APACHE ANNE (K Williams) - Over-raced and had to be steadied near the 1500 metres.

BELLATRIX BLACK (T Yanagida) – Had difficulty obtaining clear running in the final straight having to be steadied and shift ground near the 200 metres then laying in having to be steadied away from the heels of MUSTANG VALLEY near the 100 metres.

THE PERFECT PINK (K Asano) – Received post-race veterinary treatment after being galloped on to the right hind during the running.

J Laking (BELLE EN ROUGE) - Stewards inquired into the manner in which J Laking used his whip in the home straight and could not be conclusively satisfied that he had contravened the rules.

Race 9 | **NEW WORLD CHURTON PARK PREMIER 2200**

PINSK (L Allpress) - Proved difficult to load. Connections were advised that a warning has been placed against the barrier manners of PINSK.

TRAMORE (C O’Beirne) - Began awkwardly and settled towards the rear.

NOD (R Hannam) - Raced wide without cover through the early stages.

I’M CHUCK (E Nicholas) - Raced wide throughout.

THE BLIKSEM (A Mudhoo) – Steadied when improving onto heels near the 1500 metres.

FLOAT (K Williams) - Underwent a post-race veterinary examination did not reveal any obvious abnormality.

D Bradley (THE SEAGULL) - Admitted a charge in that he struck his mount THE SEAGULL 8 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.
