J Laking advised Stewards on the morning of the races that he was unwell and was replaced on his rides as per the schedule above.

RACE COMMENTS

Race 1 HELENSBROOK PROPERTIES 2200m

REDGUM (C Johnson) - Slow to begin. When asked to comment on the disappointing performance of race favourite the rider could offer no tangible excuse.

EKSTREMEMISS (R Mudhoo) - Slow to begin.

PETE THE DRIVER (K Kwo) - Slow to begin. Held up approaching the 400 metres and was unable to obtain clear running until near the 250 metres. Had to change ground passing the 100 metres and when shifting out inconvenienced NO QUARTER ASKED. **K Kwo** was advised to exercise greater care when shifting ground.

PINHEAD (K Mudhoo) - Crowded then became awkwardly placed on heels having to be steadied shortly after the start when NEVER QUITZ shifted in when not fully clear. When asked to comment on the apparent improved performance trainer K Tyler advised that the gelding had been going reasonable races recently however he was still surprised by the result today.

NO QUARTER ASKED (T Moseley) - Inconvenienced passing the 100 metres.

NEVER QUITZ (D Montes de Oca) - Rider advised that the mare is better suited to tracks with more moisture content.

D Montes de Oca (NEVER QUITZ) - Issued with a warning for allowing his mount NEVER QUITZ to shift inwards when not fully clear of PINHEAD which was crowded and had to be steadied shortly after the start.

Race 2 NIGHT'N DAY MILTON, BALCLUTHA, LAWRENCE MAIDEN 1200m

UNDECIDED (J Lowry) - Late scratching on Veterinary advice at 11.35am.

The start was delayed due to **SWISS 'N' GIGGLES** proving difficult to load.

WILLIS (D Bothamley) - Blundered at the start losing ground.

CANDIDATE (K Mudhoo) - Slow to begin. Crowded and checked passing the 250 metres having to be steadied and change ground.

IRON MIKE (G Jogoo) - Began awkwardly contacting VIVA ESTELLA. Raced in restricted room shortly after the start then commenced to race ungenerously through the early and middle stages.

VIVA ESTELLA (L Callaway) - Contacted then hampered shortly after the start.

SWISS 'N' GIGGLES (B Murray) - Rider advised the filly had travelled well in the trail but when placed under pressure in the straight had been disappointing.

T Moseley (NANA JAY) - Admitted a charge that he directed his mount inwards crowding and checking CANDIDATE near the 250 metres. After considering submissions on penalty the Adjudicative Committee imposed a suspension of Mr Moseley's licence to ride in races from the conclusion of racing Saturday 26 March 2022 until the conclusion of racing on Sunday 3rd April 2022, 4 national riding days.

Race 3 LYNDSAY MOYLE MEMORIAL CUP 1200m

PARAMOUNT PRINCE (Y Atchamah) - Began awkwardly losing ground. Raced keenly through the middle stages.

THE BUFFER (D Bothamley) - Began awkwardly. Raced three-wide without cover throughout.

DESERT MAGIC (S Muniandy) - Raced keenly in the early and middle stages.

GIVEHERAGO (C Campbell) - Had to be steadied when racing keenly for a short distance passing the 800 metres.

LINCOLN HILLS (C Johnson) - When asked to comment on the performance of the gelding rider advised that the impost of 59kgs had been detrimental to the performance today.

Race 4 TEMUKA TRANSPORT / PETER LYON SHEARING 1400m

SECRET SOUND (T Moseley) - Slow to begin.

PONIARD (R Mudhoo) – Slow to begin. Raced greenly when making the bend near the 900 metres awkwardly, having to be steadied for a distance.

O'JUDE (J Lowry) - Began awkwardly contacting STELLA CREEK. Raced three-wide without cover throughout.

STELLA CREEK (S Muniandy) - Contacted at the start. Lay in early in the run home having to be straightened.

WILLPOWER (K Williams) – Contacted then crowded at the start losing ground when runners either side shifted ground.

PLUTONIUM (L Callaway) - Over-raced through the early to middle stages causing the rider some difficulty. Badly hampered and clipped a heel when improving onto the heels of ON THE BACKFOOT after that runner broke down and gave ground quickly near the 450 metres.

ON THE BACKFOOT (G Jogoo) - Broke down passing the 450 metres and was immediately retired from the race with the horse Ambulance and Veterinarian in immediate attendance. Following an examination, the mare was found to have suffered a serious off-hind pastern injury and after x-rays and further examination was humanely euthanised.

JOHNNIE REDMOND (K Kwo) - Reported by the rider to have hung throughout.

S Muniandy (STELLA CREEK) - Admitted a charge of using the whip in two consecutive strides on STELLA CREEK near the 125 metres. After considering penalty submissions the Adjudicative Committee imposed a fine of \$150.

Race 5 R.M.G PUBLICAN'S CUP 1600m

FIRODEN (C Campbell) - Slow to begin.

RAY'S IN COMMAND (C Johnson) - Raced keenly in the early and middle stages.

SO MUCH MOUR (R Mudhoo) - Rider dropped his whip passing the 200 metres.

Race 6 NZB INSURANCE PEARL SERIES RACE 1600m

CLASSIC DIVA (L Callaway) - Blundered at the start losing ground.

ROYAL WINGS (J Lowry) - Hampered shortly after the start losing ground.

TAIMATE DIVA (K Williams) - Raced keenly in the early and middle stages.

ROSY CLARK (C Campbell) - Raced ungenerously for a distance passing the 1200 metres when being restrained to take cover.

KITTY POWER (K Kwo) - Raced three-wide without cover throughout.

LILY OF THE VALLEY (R Mudhoo) - Held up through the middle stages of the run home.

SYMPATHIQUE (B Murray) - Held up approaching the 150 metres and was unable to obtain clear running with the mare going to the line not fully tested.

Race 7 EDINBURGH REALTY MAIDEN 1600m

THE ARCTIC BLAST (K Williams) - Began awkwardly making contact with STAR VISTA losing ground. Commenced to over-race passing the 1200 metres getting its head up on a number of occasions.

STAR VISTA (T Moseley) - Contacted at the start losing ground.

TUMBARUMBA (C Campbell) - Began awkwardly and was then restrained behind runners to obtain cover. Held up early in the run home.

JUSTA LAD (B Murray) - Raced ungenerously in the early and middle stages. Held up entering the final straight and was unable to obtain clear running until passing the 200 metres.

ACQUITTAL (D Montes de Oca) - Raced three-wide without cover throughout.

MARMADUKE (K Mudhoo) - Raced in restricted room having to be steadied passing the 200 metres when the runner in front gave ground.
