Rider C Grylls advised Stewards that he was unwell and was unable to attend today's race meeting. C Grylls is to provide a medical clearance to Stewards prior to riding next.

NZTR contacted Stewards to advise that several of the weights in Race 1 and Race 2 had been incorrectly published with 3 year olds being given a half kilo allowance which was not part of the standard regulations. This was rectified on race morning.

#### RACE COMMENTS

##### Race 1 | STELLA ARTOIS MAIDEN HIGHWEIGHT 1600

**GIRLBOSS** (K Joyce) – Began very awkwardly losing ground. Over-raced when being steadied in the early stages then being allowed to improve forward to lead passing the 900 metres.

**UPLAND COURT** (E Farr) - Slow to begin.

**ON THE RIVET** (M Cropp) - Improved onto heels passing the 200 metres having to shift outwards to improve.

**K Joyce** (GIRLBOSS) - Stewards questioned her riding tactics, in particular the reasons why she had elected to improve forward to lead racing down the back straight. K Joyce advised that after beginning poorly she had asked her mount to improve, however after improving onto the heels of runners in front of her, she was unable to settle the mare. She then elected to improve forward rather than attempt to restrain GIRLBOSS. K Joyce's explanation was noted.

**C Thornton** (SWEET TABOO) - Issued with a warning after he struck his mount SWEET TABOO six times prior to the 100 metre mark with Stewards taking into account his clear recent record with regard to any breach of the whip rule.

##### Race 2 | MOUNT SHOP MAIDEN HIGHWEIGHT 2100

**THE BAMBINO** (C Chipperfield) – Began awkwardly then restrained.

**NOIFFSORBUTTS** (K Joyce) - Steadied when placed in restricted room passing the 2000 metres. Held up until approaching the 200 metres then raced in restricted room until passing the 100 metres.

**KHAN HUNTER** (M Cropp) – Raced ungenerously in the early stages making the bend awkwardly near the 1800 metres. Raced keenly in the early and middle stages due to the slow pace of the race before shifting out to avoid heel passing the 1300 metres.

**NANTUCKET** (L Douglas) – Steadied when placed in restricted room passing the 2000 metres.

**S O'Malley** (MR JINGLES) - Issued with a warning after easing the pace entering the back straight causing interference to trailing runners.

**M Cropp** (KHAN HUNTER) – Issued with a warning after permitting his mount to shift in when not sufficiently clear of NANTUCKET and NOIFFSORBUTTS which had to be steadied when placed in restricted room passing the 2000 metres.

##### Race 3 | PUKEKOHE MITRE 10 2100

**YES WE KHAN** (M McNab) – Raced keenly in the early stages.

**R Beemud** (TAVI WITH ME) - Admitted a charge in the he struck his mount TAVI WITH ME seven times prior to the 100 metre mark. After considering submissions the Adjudicative Committee suspended R Beemud's licence to ride in

**Race 4** | **BARFOOT & THOMPSON 2YO 1200**

**WAITAK** (S Spratt) - Steadied soon after leaving the barrier when awkwardly placed near heels then raced keenly in the early to middle stages.

**BOSS MAN** (A Goindasamy) – Raced in restricted room over the concluding stages.

**B Wallace & G Cooksley** (COPPERS) - Issued with a warning after presenting COPPERS to race without notified gear (side winkers).

**Race 5** | **HAUNUI FARM MAIDEN 1200**

**NO MYTH** (L Douglas) – Began awkwardly.

**SYMPHONY OF LOVE** (T Yanagida) - Restrained from its wide barrier. Became awkwardly placed near heels passing the 300 metres shifting out to obtain clear running passing the 150 metres.

**SHAMBLES** (B Grylls) - Raced ungenerously when making the bend near the 900 metres then hung out making the final bend awkwardly.

**SEEUINABIT** (S Spratt) - Had some difficulty obtaining clear running early in the final straight.

**B Grylls** (SHAMBLES) - Admitted a charge in that she struck her mount SHAMBLES six times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$500.

**Race 6** | **FRANKLIN PRIVATE HOSPITAL GALLOP MAIDEN 1200**

**PYRAMUS** (K Asano) – Began awkwardly.

**SUPER DAISY** (T Yanagida) - Began awkwardly.

**AMOROUS STU** (L Douglas) – Restrained from a wide barrier.

**Race 7** | **WESTBURY STUD MAIDEN 3YO 1400**

**EKSTATIQUE** (T Yanagida) - Raced greenly under pressure in the final straight.

**Race 8** | **DUNSTAN HORSEFEEDS MAIDEN 3YO 1400**

**HEY GIRLFRIEND** (E Nicholas) - Raced keenly in the early stages.

**CALL ME FLINT** (M Hashizume) - When questioned regarding the improved performance connections advised that the gelding had benefitted from the addition of blinkers.

**T Yanagida** (LUCA DELI) - Admitted a charge in that he struck his mount LUCA DELI six times prior to the 100 metre mark. After considering submissions the Adjudicative Committee suspended T Yanagida's licence to ride in races from the conclusion of racing on Saturday 2 April up to and including racing on Wednesday 6 April, 2 national riding days and in addition imposed a fine of \$500.
