M McNab and J Riddell advised they were unwell and would not be attending today's race meeting due to being unwell. Both riders are to provide a medical clearance prior to riding next.

SUPPLEMENTARY

Race 1 BAYLEYS WHAKATANE 3YO (1400 metres)

NOVASHOW (M McNab) – Co-trainer A Scott advised Stewards the stable was satisfied with the post-race condition of NOVASHOW, however, has now been sent for a spell until Spring.

RACE COMMENTS

Race 1 MATAMATA FUNCTION CENTRE MAIDEN 1600

GOODO JO (A Mudhoo) - Began awkwardly losing ground. Checked near the 275 metres.

CASPER (L Innes) - Slow to begin. Rider reported that the gelding had been making abnormal breathing noises. Underwent a post-race veterinary inspection including an endoscopic examination which found dirt in the trachea consistent with inhaling clods.

OZARK (S Weatherley) - Slow to begin.

CONTEMPLATION (R Elliot) – Placed in restricted room passing the 1450 metres and blundered when restrained. Had some difficulty obtaining clear running early in the final straight.

ARDIJAH (J Kamaruddin) – Raced three wide without cover throughout.

PINTAVO (L Satherley) - Blundered passing the 400 metres then raced greenly when in restricted room for a distance. When questioned rider L Satherley advised that she felt after blundering near the 400 metres something was amiss and did not persevere with the filly for the remainder of the race. Underwent a post-race veterinary inspection which

found the filly to be 2/5 lame in the left hind leg. Connections were advised that a veterinary clearance would be required prior to racing next.

JIMMY THUMPER (B Grylls) - Held up until passing the 200 metres.

MAENAD (A Goindasamy) - Held up until passing the 150 metres.

BELLE OF THE BALL (O Bosson) – Held up until passing the 150 metres.

J Fawcett (SWEY MY WAY) - Issued with a warning after permitting her mount to shift in near the 1450 metres when not sufficiently clear of CONTEMPLATION which had to be steadied when placed in restricted room.

C Grylls (DIOSA LUNA) - Admitted a charge of careless riding in that he angled his mount outwards when not sufficiently clear dictating CASPER into the line of GOODO JO which was checked near the 275 metres. After considering submissions the Adjudicative Committee suspended C Grylls' licence to ride in races from the conclusion of racing on Saturday 2 April up to and including racing on Saturday 9 April, 5 national riding days.

Race 2 NZB INSURANCE PEARL SERIES MAIDEN RACE 1050

DIGNITOSA (S Weatherley) - Slow to begin.

ZOOM (J Kamaruddin) - Began awkwardly losing ground.

AL MALIK (O Bosson) – Began awkwardly then restrained from its wide barrier. When questioned regarding the performance the rider could offer no excuse.

DIAGON ALLEY (R Elliot) – Placed in restricted room near the 950 metres having to be restrained losing ground.

WINEXPRESS (A Goindasamy) - Made the bend near the 800 metres awkwardly and shifted wider. When questioned regarding the performance the rider advised that in his opinion the colt was feeling the firm track conditions.

ARROWETTE (L Innes) - Held up until passing the 200 metres.

L Satherley (GRACES GIFT) – Issued with a warning after permitting her mount to shift in when not sufficiently clear of ARROWETTE which shifted inwards forcing ENRAPTURED into the line of DIAGON ALLEY which had to be steadied when placed in restricted room near the 950 metres.

Race 3 AUTO SUPER SHOPPE MATAMATA MAIDEN 1200

AWESOME JIMBO (S Spratt) - Underwent a veterinary inspection at the barrier after being kicked and was cleared fit to start.

NEIGHBOURHOOD (L Innes) - Slow to begin.

HARD NOSE (S Weatherley) - Began awkwardly then lay out. Made the bend near the 800 metres awkwardly. Lay out when placed under pressure rounding the bend and throughout the final straight being unable to be ridden out fully over the concluding stages.

ATLANTIC CITY (A Goindasamy) – Crowded shortly after the start. When questioned regarding performance the rider advised that the gelding had been outpaced throughout, and in his opinion would be better suited over more ground.

PISCO SOUR (O Bosson) - Made the bend near the 800 metres awkwardly when racing keenly and shifted outwards.

EXPRESS DESIRE (R Elliot) - Made the bend near the 800 metres awkwardly when racing keenly and shifted outwards. When questioned regarding performance the rider could offer no excuse. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

ORANGE PEARL (A Calder) - Lay out rounding the final bend forcing ALBY PARK wider.

EXPRESSO (J Fawcett) – Lay out rounding the final bend having to be straightened by its rider.

Race 4 MATAMATA DIRECTIONAL DRILLING MAIDEN 1200

SWERVE (M Hashizume) - Began awkwardly and settled back. Steadied after improving into restricted room passing the 950 metres.

ANTEATER (J Kamaruddin) – Raced in restricted room shortly after the start.

MOLINARA (T Newman) - Improved onto heels passing the 100 metres having to be steadied.

Race 5 O'REILLYS MOTEL MAIDEN 1200

THATSMORELIKEIT (C Grylls) - Crowded shortly after the start.

CHATTERTON (A Calder) - Began awkwardly then hampered shortly after. Commenced to over-race in the early stages despite the efforts of its rider before improving forward to race outside the lead near the 700 metres. Briefly raced in restricted room entering the final straight.

SIZZLING GOLD (L Satherley) – Slow to begin.

CANDYCANE (J Fawcett) – Held up until passing the 200 metres.

MR BIGGLESWORTH (L Innes) - Rider reported that the gelding had felt indifferent in its action. Underwent a postrace veterinary inspection which did not reveal any obvious abnormality.

F Leahy (MR BIGGLESWORTH) - Issued with a warning for presenting MR BIGGLESWORTH to race without the notified nose band.

Race 6 NZB INSURANCE PEARL SERIES MAIDEN RACE 1400

I'M NOT BOSSY (O Bosson) – Began awkwardly losing ground. Improved onto heels passing the 300 metres and was then held up until near the 250 metres.

NINE REALMS (A Goindasamy) - Crowded shortly after the start. Improved onto heels passing the 300 metres and was then held up until passing the 200 metres.

TIME AND AGAIN (S McKay) - Over-raced in the early and middle stages.

INCHAARJ (L Innes) – Raced wide without cover throughout.

FLOSSYROSYCANDY (S Spratt) – Raced three wide without cover throughout.

Race 7 CHALLENGE MATAMATA 1400

REVERBERATIONS (N Parmar) – Began awkwardly, shifting out losing ground.

JACK THE LASS (L Satherley) - Began awkwardly.

FINEST WINE (S Spratt) – Began awkwardly.

ANGE DE REVE (J Kamaruddin) – Raced three wide without cover throughout.

J Kamaruddin (ANGE DE REVE) - Reminded of his obligations in that he must ride his mounts out fully to the end of the race when circumstances permit him to do so.

Race 8 PAPER PLUS MATAMATA MAIDEN 1400

BLACK CHEETAH (J Fawcett) - Began awkwardly losing ground.

JAKKALNUTS (J Kamaruddin) - Began awkwardly and blundered. Held up until near the 250 metres.

TRUE NORTH (C Barnes) - Knuckled at the start.

PRAETORIAN (M Hashizume) – Began awkwardly losing ground. Raced wide without cover throughout.

FRUITY WOODS (S Spratt) – Restrained from its wide barrier at the start.

CLASSIC BEETHOVEN (S Weatherley) - Lay in passing the 75 metres making slight contact with KAI.

KAI (O Bosson) - Briefly contacted passing the 75 metres.

Race 9 GOOD LUCK HONG KONG BOUND JAMIE RICHARDS 1400

MIDNIGHT SPECIAL (A Goindasamy) - Restrained from its wide barrier then raced ungenerously throughout.

TAIKA (A Mudhoo) - Blundered at the crossing in the back straight, briefly unbalancing the rider.

VIRTUOSO LAD (M Hashizume) – Raced wide without cover throughout.

EDGE OF WONDER (T Newman) - Raced in restricted room approaching the 800 metres. Improved onto heels approaching the 250 metres having to be steadied.

RAGAMUFFIN (N Parmar) – Lay out when placed under pressure in the final straight.

LE CHAMOSSAIRE (J Kamaruddin) - Returned to the enclosure with blood present in both nostrils. Following a veterinary inspection LE CHAMOSSAIRE was confirmed to have bled and suffered from cardiac arrhythmia. LE CHAMOSSAIRE shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.

D Weatherley (CAPISTRANO ROCS) - Issued with a warning for presenting CAPISTRANO ROCS in pre-race ear covers that were not notified.

M Hashizume (VIRTUOSO LAD) – Issued with a warning after weighing in 0.4 kgs under the handicap weight.

Race 10 FLETCHER SHEDS MAIDEN 2000

KIWI MAN (C Burdan) - Began awkwardly after being fractious in its barrier, then hampered.

MASTER ORTEGA (S Spratt) - Slow to begin. Steadied when placed in restricted room passing the 1600 metres.

MEANT TO BE (J Fawcett) - Commenced to race keenly approaching the 1600 metres and then was crowded by UPLAND COURT which was dictated inwards by SACRED BOURBON with MEANT TO BE then continuing to over-race for a distance. L Innes was advised to exercise care in a similar circumstance.

POLLY POWER (T Newman) - Raced keenly when being steadied in the early and middle stages.

SACRED BOURBON (L Innes) - Raced three wide without cover throughout.

SIDE HUSTLE (W Pinn) - Raced four wide without cover from near the 1000 metres.
