Co-trainer B Anderton advised the Stewards on 13 April that blood tests conducted following the disappointing performance have shown **NEVETS** to have had an elevated muscle enzyme count which has been treated accordingly and the mare will now continue with her current campaign.

Following the running of this race Stewards convened a meeting with the riders from Race 1 regarding the very stron winds encountered. After hearing from all riders, it was unanimously agreed to continue with the meeting and monit the conditions on a race-by-race basis.
Race 2 D T KINGS TRANSPORT / TODD & CO REALTY MAIDEN (1400m)
<b>SPIN A CHAMPION</b> (S Khetoo) - Slow to begin. Shifted ground outwards passing the 250 metres when under pressure placing outside runners in restricted room. S Khetoo was advised to exercise greater care when shifting ground.
ROYAL KHAN (B Murray) - Taken back from a wide draw shortly after the start.
NAVAHO JO (D Montes de Oca) - Raced three-wide in the early and middle stages. Rider dropped his whip near the 2 metres.
GINTYS GIRL G Jogoo) - Raced three-wide without cover throughout.
THE DUDE (J Lowry) - Placed in restricted room near the 250 metres.
BACK HUT (S Muniandy) - Placed in restricted room near the 250 metres and forced wider on the track.
Following the running of this race Stewards convened a further meeting with all riders as the very strong winds encountered earlier had not abated. After hearing from the riders it was initially agreed to delay racing for an hour however as the winds then strengthened it was unanimously agreed to abandon the remainder of the meeting.
