## RACE COMMENTS

Race $1 \quad$ MOUNT SHOP MAIDEN HIGHWEIGHT 2100
UPLAND COURT (M Roustoby) - Began awkwardly losing ground. Contacted passing the 200 metres. Lost the off side
front plate during the running.
SMUG (D Parker) - Began awkwardly.
NANTUCKET (L Douglas) - Raced keenly rounding the first bend.

OAK (C Chipperfield) - Raced three wide without cover for the majority of the race. Lay out making contact with UPLAND COURT passing the 200 metres.

K Joyce (UHTRED) - Admitted a charge in that she struck her mount 8 times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of $\$ 500$.

K Joyce (UHTRED) - Issued with a warning after she used her whip in 2 consecutive strides near the 200 metres with Stewards taking into account her clear recent record.

D Parker (SMUG) - Issued with a warning after he struck his mount 6 times prior to the 100 metre mark with Stewards taking into account his clear recent record.

G Walsh (MR JINGLES) - Issued with a warning after he struck his mount 6 times prior to the 100 metre mark with Stewards taking into account his clear recent record.

B Donoghue (NOIFFSORBUTTS) - Issued with a warning after he struck his mount 6 times prior to the 100 metre mark with Stewards taking into account his clear recent record.

M Cropp (ON THE RIVET) - Issued with a warning after he struck his mount 6 times prior to the 100 metre mark with Stewards taking into account his clear recent record.

L Douglas (NANTUCKET) - Issued with a warning after omitting the stirrups when weighing out.

## Race $2 \quad$ TUAKAU COSSIE CLUB 2100

KHAN HUNTER (M Cropp) - Steadied to avoid the heels of CLEESE which shifted in near the 1800 metres. Raced three wide without cover for the majority of the race.

PLUSHENKO (B Donoghue) - Steadied passing the 1800 metres. Lay in under pressure over the concluding stages. Lost the near side front plate during the running.

NITRATE (C Chipperfield) - Steadied when improving onto heels near the 1800 metres.
LOGAN'S LOGIC (L Douglas) - Steadied when placed in restricted room passing the 1800 metres.
GINGER TOO (D Parker) - Steadied passing the 1600 metres.

PEPPERELLO (E Farr) - When questioned regarding the performance rider E Farr could offer no tangible excuse. Underwent a post-race veterinary inspection which revealed the mare to have suffered cardiac arrhythmia. Trainer S Ralph was advised that PEPPERELLO will not be permitted to start in any race or trial until a veterinary certificate declaring the horse free of any cardiac arrhythmia following a gallop of at least 1000 metres.

M Roustoby (CLEESE) - Issued with a warning after permitting CLEESE to shift inwards when not sufficiently clear of KHAN HUNTER which was steadied near the 1800 metres.

## Race $3 \quad$ HAUNUI FARM MAIDEN 1100

FAIRSHARE (D Danis) - Slow to begin. Commenced to over-race passing the 1000 metres then lay out rounding the bend hampering FAYTINA. Steadied passing the 300 metres when AMOROUS STU shifted out.

TREAT DAPAINTER (T Thornton) - Began awkwardly then restrained in the early stages to obtain cover. Had difficulty obtaining clear running in the early part of the straight.

MAGAWA (O Bosson) - Began awkwardly losing ground.

SYMPHONY OF LOVE (M Hashizume) - Raced three wide without cover throughout.

ARABIA (J Kamaruddin) - Raced wide early before being ridden forward to lead.

FAYTINA (A Calder) - Raced greenly making the first bend awkwardly then hampered passing the 700 metres when MAGAWA shifted in. Contributing was FAIRSHARE which was laying out.

AMOROUS STU (N Parmar) - Held up for clear running until passing the 300 metres.

N Parmar (AMOROUS STU) - Issued with a warning after permitting his mount to shift out passing the 300 metres hampering FAIRSHARE who had to steady to avoid heels.

## Race $4 \quad$ BAYLEYS PUKEKOHE 1600

MAKTOUM (A Calder) - Began awkwardly then crowded shortly after having to be steadied. Lay out under pressure making contact with CELEBRE passing the 100 metres.

LAVITA VISHVI (S Spratt) - Slow to begin. Raced in restricted room passing the 200 metres to the inside of CELEBRE and outside of MAKTOUM which had both shifted under pressure. Riders D Danis and A Calder were advised to exercise greater care.

CLEVERCONVERSATION (N Parmar) - Slow to begin.
ATA RANGI (J Kamaruddin) - Raced wide without cover throughout.
CELEBRE (D Danis) - Bumped passing the 100 metres.
ON DEMAND (C Grylls) - Steadied over the concluding stages when MAKTOUM shifted in.

## Race 5 <br> BAYLEYS PUKEKOHE MAIDEN 1600

URBAN MYTH (O Bosson) - Contacted shortly after the start losing ground.
THELASTINVINCIBLE (N Pamar) - Began awkwardly then crowded shortly after. Steadied passing the 1400 metres when the pace eased.

ROCK UP (M McNab) - Began awkwardly and shifted out making contact with URBAN MYTH.

TIME AND AGAIN (C Grylls) - Slow to begin. Steadied passing the 1400 metres when the pace eased then continued to over-race through the middle stages.

EKSTATIQUE (A Goindasamy) - Steadied passing the 1400 metres.

ROYAL ROC (C Barnes) - Steadied passing the 1400 metres when PEPPERMINT LIL shifted in.

NOVAK (T Newman) - Raced wide without cover throughout.

M Hashizume (PEPPERMINT LIL) - Issued with a warning after permitting his mount to shift in when insufficiently clear of ROYAL ROC and EKSTATIQUE which both had to be steadied passing the 1400 metres.

## Race 6 DUNSTAN HORSEFEEDS 1400

THE REAL TEST (N Parmar) - Began awkwardly then hampered shortly after.

HOT SALSA (C Grylls) - Began awkwardly shifting inwards. Crowded and had to steady over the concluding stages.

THAT'S ALL FINE (J Fawcett) - Slow to begin. Raced wide without cover in the early to middle stages. Steadied passing the 250 metres when placed in restricted room

NO MYTH (L Douglas) - Raced three wide without cover throughout.
MEMORIES (R Elliot) - Held up for clear running until near the 200 metres.
OSTASIO (T Thornton) - Steadied over the concluding stages when placed in restricted room.
M Hashizume (RUBYSHOWOFF) - Issued with a warning for allowing his mount to shift inwards over the concluding stages dictating THE REAL TEST inwards onto HOT SALSA who was contacted and had to steady.

## Race $7 \quad$ FRANKLIN AUCTIONS MAIDEN 1400

BLOOD DIAMOND (C Burdan) - Slow to begin.
SILK ' $N$ ' DALE (A Calder) - Began awkwardly then steadied shortly after when placed in restricted room.

HULA BEAT (C Grylls) - Crowded shortly after the start having to be steadied.

TRIPLE MONEY (J Fawcett) - Contacted and unbalanced shortly after jumping away. Made contact with the running rail for some distance when laying in over the final 200 metres.

TE ATATU MEMPHIS (N Parmar) - Raced wide without cover throughout.

BEAU ARCHERS ROSE (L Douglas) - Steadied passing the 800 metres when improving onto heels.

NO AGENDA NIGEL (T Newman) - Commenced to race keenly in the middle stages when the pace eased.

TELERIN (S Spratt) - Held up in the run home until shifting out passing the 200 metres.

LOUISIANA MAN (M McNab) - When questioned regarding the performance rider advised that the gelding was unsuited by the muddling pace of the race.

## Race $8 \quad$ HR FISKEN \& SONS LTD MAIDEN 1400

TEGAN (A Calder) - Began awkwardly losing ground.

PACHECO (R Elliot) - Slow to begin.

CIMARRON (S Spratt) - Over-raced in the early stages then got its head up when being steadied approaching the 1000 metres.

ROCKSPELL (C Grylls) - Raced wide without cover for the majority of the race.

ANNEXCEPTION (M Cameron) - Raced wide without cover throughout.

BENEFICENT (J Kamaruddin) - Held up for clear running early in the straight.

GRETA GHARBO (J Fawcett) - Raced greenly in the home straight. Connections were advised that a warning would be placed against the filly's barrier manners.

DASHWOOD (M Hashizume) - Had difficulty obtaining clear running until passing the 200 metres.
