J Parkes did not attend today's race meeting and was replaced as above.

RACE COMMENTS

Race 1 | LANDMARK HOMES PREMIER 1600

ALBUFEIRA (F Lazet) - Slow away.

CATWALK GIRL (S Weatherley) - Restrained from its wide draw and settled at the rear. Held up early in the home straight. Lay out over the concluding stages.

PARIS RUBY (T Yanagida) - Raced wide without cover throughout.

BOLD IRIS (J Kamaruddin) - Slow away. Held up in the early stages of the home straight.

BARNEY RUBBLE (C Grylls) - Finished towards the rear. When questioned rider advised BARNEY RUBBLE was disappointing, however he was of the opinion the 61kg told in the final stages. A post-race veterinary examination did not reveal any obvious abnormality.

F Lazet (ALBUFEIRA) - Stewards inquired into the manner in which F Lazet used her whip in the home straight and could not be conclusively satisfied that she had contravened the rules.

Race 2 | THE OAKS STUD PREMIER 1200

MORMAIRE (C Grylls) - Slow away.

MR UNIVERSE (W Pinn) - Slow away. Held up early in the home straight. W Pinn advised Stewards he could not ride the gelding out due to the saddle slipping near the 100 metres.

MAGNESS (C Dell) - Raced wide without cover throughout. Hampered 100 metres.

MONTANA MIST (J Fawcett) - Shifted out abruptly when struck with the whip, passing the 100 metres hampering SUPREME KHAN (O Bosson) and MAGNESS (C Dell). The incident was considered beyond the control of J Fawcett. C Dell viewed footage but was satisfied that his chances of finishing in a higher placing were not affected. Rider J Fawcett advised Stewards that the mare had shied at the winning post.

CHIKIRA LASS (S Weatherley) - Finished last. When questioned S Weatherley was of the opinion the mare was better suited to more rain-affected footing. A post-race veterinary examination revealed potential slight lameness in the off-hind leg.

SUPREME KHAN (O Bosson) - Hampered 100 metres.

Race 3 | RICOH PREMIER 2200

SHOCKALLIA – Late scratching at 12.06pm on veterinary advice.

BROOKBOURNE (L Douglas) - Bounded as the start was effected.

HONG KONG (W Pinn) - Began awkwardly, bumping THE SEAGULL. Raced wide in the early stages so was allowed to roll forward in the back straight.

THE SEAGULL (D Bradley) - Bumped start. Raced wide in the middle stages before improving to sit outside the leader near the 800 metres.

TORQUE TIME (O Bosson) - Raced wide without cover from the 800 metres.

PRINCESS ANI (C Grylls) - Blundered as the start was effected.

MANINTHESKY (J Fawcett) - Hung inwards and had to be continuously straightened in the home straight.

YOSSARIAN (A Mudhoo) - Finished last. When questioned A Mudhoo was of the opinion the gelding was better suited to more rain-affected going.

LADY CALYPSO (L Allpress) - Slow away. Finished towards the rear. L Allpress advised the mare had been disappointing. A post-race veterinary examination did not reveal any obvious abnormality.

D Bradley (THE SEAGULL) - Stewards inquired into the manner in which D Bradley used his whip in the home straight and could not be conclusively satisfied that he had contravened the rules.

PINARELLO (L Innes) - Late scratching at 2.32pm on veterinary advice after incurring an injury to the mouth resulting in a significant amount of blood being present.

SET IN STONE (L Douglas) - Slow away, then over-raced and had to be steadied passing the 1400 metres.

ROCKET LAD (S Weatherley) - Slow away.

TITLED (L Allpress) - Began awkwardly, then restrained to the rear shortly after the start.

SOLDIER BOY (C Grylls) - Placed in restricted room entering the first bend.

SPORTING CHANCE (M McNab) - Placed in restricted room entering the first bend.

LINGJUN XIONGFENG (T Yanagida) - Placed in restricted room entering the first bend.

ATAAHUA (W Pinn) - Raced wide for the majority. Placed runners to its inside in restricted room entering the first bend. W Pinn was shown footage of the incident and reminded of his obligation to give runners to his inside more room.

Race 5	BRAMCO GRANITE & MARBLE FLYING STAKES 1400

The start was delayed approximately 4½ minutes after MISS CARTIER escaped behind the barrier and then proved slow to load.

MISS CARTIER (S Weatherley) - Hampered at the start when runners either side shifted ground.

BELCLARE (L Allpress) - Over-raced in the early stages.

FAITHFUL FEAT (M Hashizume) - Raced wide throughout without cover.

PRISE DE FER (M McNab) - Badly hampered near the 100 metres.

FAITHFUL FEAT (M Hashizuma) – Badly hampered near the 100 metres.

CAVALLO VELOCE (S McKay) – Clipped heel and blundered badly 150 metres. A post-race veterinary examination did not reveal any obvious abnormality.

GERMANICUS (T Yanagida) - Lay inwards in the home straight, shifting ground inwards near the 150 metres. Lost off side hind plate during the running.

T Yanagida (GERMANICUS) - Admitted a charge of careless riding in that he permitted GERMANICUS to shift inwards near the 150 metres dictating BRANDO (O Bosson) inwards, which in turn dictated PROVIDENCEPROVIDES (W Pinn) inwards into the line of CAVALLO VELOCE (S McKay), which clipped a heel of PROVIDENCEPROVIDES and blundered badly. After considering submissions the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing on Wednesday, 6 April until the conclusion of racing on 16 April, 7 national riding days and in addition imposed a fine of \$500.

Race 6

COURTESY FORD MANAWATU SIRES PRODUCE STAKES 1400 (G1)

ANDALUS (M McNab) - Began awkwardly, hampering inside runners.

BEST SELLER (J Kamaruddin) – Began awkwardly hampering runners to its outside. Commenced to race fiercely near the 800 metres having to be steadied, placing WOLVERINE in restricted room.

NEW ORLEANS JAZZ (T Yanagida) – Hampered at the start by inside runner.

THE RACKETEER (J Ridell) – Hampered at the start by inside runner.

WAITAK (L Allpress) – Hampered at the start by inside runner.

LICKETY SPLIT (C Grylls) – Hampered at the start by outside runner. Raced wide without cover throughout. Briefly hampered final bend needing to switch inwards across heels to gain clear racing room. A post-race veterinary examination did not reveal any obvious abnormality.

ANDALUS (M McNab) – Began awkwardly hampering LICKETY SPLIT.

DYNASTIC (O Bosson) – Hampered at the start. Made the final bend awkwardly, briefly hampering LICKETY SPLIT. When questioned O Bosson was of the opinion there may be something amiss with DYNASTIC. A post-race veterinary examination revealed a small laceration to near hind hock.

Following the running of the race the trainer of the second placed horse WOLVERINE, Mr R Bergerson lodged a protest with the Adjudicative Committee alleging interference inside the final 100 metres by the first placed horse MAVEN BELLE. After considering submissions the Adjudicative Committee dismissed the protest with the placing standing, 1st MAVEN BELLE and 2nd WOLVERINE.

S Weatherley (MAVEN BELLE) - Admitted a charge of careless riding in that he allowed his mount to shift outwards when not sufficiently clear of WOLVERINE, which was hampered near the 75 metres. After considering submissions the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing today, 2 April until the conclusion of racing on Thursday, 14 April, 8 national riding days.

Race 7

CITY OF PALMERSTON NORTH AWAPUNI GOLD CUP 2000 (G2)

TIPTRONIC (O Bosson) - Blundered at the start.

VERNANME (S Weatherley) Raced wide for the majority.

MASETTO (M McNab) - Raced ungenerously throughout placing its rider at a disadvantage. Finished last. When questioned M McNab was of the opinion MASETTO would be better suited to an easing of the track.

HUNTA PENCE (L Innes) - Began awkwardly. Over-raced and had to be steadied entering the first bend.

THE MITIGATOR (S McKay) - Lay in and away from EVEN CHANCE, which was laying in near the 200 metres, taking the line of LANGKAWI which then had to be angled outwards to improve.

EVEN CHANCE (J Fawcett) - Lay in under pressure near the 200 metres.

HYPNOS (W Pinn) - Finished well back after racing wide throughout. Lay in under pressure in the home straight. When questioned rider W Pinn advised the gelding had hung throughout and he was unable to fully test him as a result. A post-race veterinary examination did not reveal any obvious abnormality.

Race 8

RESONANT PREMIER 1600

THE MIGHTY SPAR (O Bosson) – Began awkwardly setting at the rear of the field.

TOWN CRYER (L Innes) – Raced wide without cover throughout.

TAVATTACK (L Allpress) - Held up early in the home straight.

LILLY LAGUNA (J Kamaruddin) - Shied and went off stride near the 900 metres with rider J Kamaruddin becoming unbalanced and losing his irons.

F Lazet (FLYING SURF) - Reminded of her obligation to keep her mount straight over the concluding stages.
