RACE COMMENTS**Race 1 NATIONAL SECURITY MAIDEN 1600**

PONTARDAWE (C Burdan) - Crowded shortly after the start having to be steadied then continued to over-race in the early and middle stages.

TURNMEON (B Grylls) – Crowded and hampered approaching the 1200 metres, losing ground.

ALIGHIERI (D Danis) - Crowded and hampered approaching the 1200 metres, losing ground.

MYLETT (T Thornton) – Raced three wide without cover.

NOVAK (T Newman) – Crowded 1100 metres when in restricted room to the inside of POZZI VIBE. N Parmar was advised he must exercise greater care in a similar circumstance.

POZZI VIBE (N Parmar) - Improved wide from near the 700 metres to lead near the 600 metres. Ducked out abruptly approaching the 300 metres with the rider becoming unbalanced shifting very wide on the track. Connections were advised that POZZI VIBE would be required to barrier trial to the satisfaction of Stewards prior to racing next.

PRINCIPESSA (R Elliot) – Held up approaching the 375 metres before shifting in to obtain clear running crowding VISTOWN who raced in restricted room for a short distance.

VISTOWN (A Calder) – Crowded 375 metres. When questioned regarding the performance rider A Calder advised that VISTOWN had become awkwardly placed in the field after the pace had slowed in the middle stages which had been detrimental to the filly's chances.

SIR WILLIAM WEKA (A Lawson-Carroll) – When questioned regarding the performance apprentice rider A Lawson-Carroll could offer no tangible excuse.

R Elliot (PRINIPESSA) – Issued with a warning after permitting PRINCIPESSA to shift in near the 375 metres when insufficiently clear of VISTOWN which was crowded.

N Parmar (POZZI VIBE) - Admitted a charge of careless riding in that he permitted POZZI VIBE to shift in passing the 1200 metres crowding ALIGHIERI and TURNMEON which were both checked losing ground. After considering submissions the Adjudicative Committee suspended N Parmar's licence to ride in races from the conclusion of racing on Saturday 2 April up to and including racing on Friday 8 April, 4 national riding days.

T Newman – Reprimanded regarding her conduct following the race in the weighing area.

Race 2 AUCKLAND ALARMS 1300

NOSNEVETS (T Newman) – Began awkwardly.

TEXAS (T Comignaghi) - Held up for clear running until passing the 275 metres. When placed under pressure was inclined to lay out.

BIG STORY (A Calder) - When questioned regarding the performance rider A Calder advised that in his opinion the gelding may benefit from a freshen up. Underwent a post-race veterinary inspection which revealed the gelding to have a slower than normal recovery.

Race 3 WESTERN LOCK SERVICES HANDICAP 1200

OH NO NO NO (N Parmar) - Began awkwardly losing ground.

SIDE BY SIDE (A Calder) - Crowded shortly after the start having to be steadied. Held up for clear running until passing the 200 metres.

RIDING THE WAVE (T Thornton) - Raced in restricted room soon after leaving the barrier. Briefly contacted near the 400 metres and again near the 375 metres.

DEMONETIZATION (S Spratt) – Raced in restricted room passing the 800 metres. When questioned regarding the performance rider S Spratt advised that the gelding had been outpaced under the impost of 63 kgs and could not make ground.

ACUTUS (K Hannan) - Made contact with RIDING THE WAVE when shifting out slightly approaching the 400 metres and again near the 375 metres.

Race 4 | **WESTBROOK WINES 1400**

NAVALHA (N Parmar) - Slow to begin.

LAVITA VISHVI (C Burdan) - Began awkwardly. Contacted the running rail approaching the 700 metres.

ALI ARC (A Goindasamy) - When questioned regarding the performance rider A Goindasamy could offer no tangible excuse.

Race 5 | **BRYAN JACKSON MEMORIAL 1600**

CALL ME FLINT (A Calder) - Slow to begin. Raced ungenerously for a distance in the early to middle stages.

CARTE BLANCHE (T Newman) - Steadied 350 metres when in restricted room to the inside of MIDNIGHT MASS which shifted in slightly.

SUPER SIX (C Barnes) – Held up until near the 100 metres.

DOUBTFUL SOUND (B Grylls) - Raced in restricted room passing the 75 metres. Underwent a post-race veterinary inspection which found the gelding to have a slower than normal recovery.

Race 6 | **AUCKLAND 24 HR GLASS 1600**

PATSY LASS (S Spratt) - Began awkwardly.

TAVIDORA (T Thornton) – Raced ungenerously when being restrained in the early and middle stages.

MAKTOUM (T Comignaghi) – Raced wide without cover for the majority of the race.

WAIMOKU FALLS (C Barnes) - When questioned regarding the performance rider C Barnes advised that after travelling well the mare had failed to quicken and could offer no tangible excuse. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

Race 7 | **AVONDALE SUNDAY MARKETS HANDICAP 2100**

PAISLEY PARK (R Elliot) - Steadied near the 1800 metres when awkwardly placed near heels. Hampered when forced wider 375 metres by AQUAOIR which shifted out. Inconvenienced 100 metres by AQUAOIR which was forced out.

AQUAOIR (T Newman) – Shifted out to obtain clear running 375 metres making contact. Inconvenienced 100 metres by DIONYSUS which was forced out

DIONYSUS (S Spratt) - Impeded 250 metres until approaching the 100 metres when forced wider. Inconvenienced over the concluding stages.

T Newman (AQUAOIR) - Issued with a warning after angling AQUAOIR near the 375 metres making contact with PAISLEY PARK which was forced wider.

D Danis (SUPER SID) - Admitted a charge of careless riding in that he allowed his mount to shift out when not sufficiently clear of DIONYSUS which was impeded in the final straight. After considering submissions the Adjudicative Committee suspended D Danis' licence to ride in races from the conclusion of racing on Saturday 2 April up to and including racing on Saturday 9 April, 5 national riding days.

Following the running of the race co-trainer of DIONYSUS R James lodged a protest against the 2nd placed horse SUPER SID alleging interference in the final straight. After considering submissions the Adjudicative Committee upheld the protest with DIONYSUS being promoted to 2nd place with the placings being 1ST WITHALLMYHEART, 2ND DIONYSUS, 3RD SUPER SID, 4TH AQUAOIR.

Race 8

SKINNER FAMILY MEMORIAL 2100

ASPIRING (T Newman) – Slow to begin.

BAYARMAA (A Calder) - Slow to begin. Raced ungenerously in the early stages. When questioned regarding the performance rider A Calder advised that after beginning slowly and getting further back than intended, the mare had never recovered.

TRIGON LAD (C Burdan) - Made the 1700 metres crossing awkwardly forcing PLAYSAMEANPINBALL wider on the track.

PLAYSAMEANPINBALL (R Elliot) - Made brief contact with SELVA VERDE near the 150 metres.

SELVA VERDE (T Comignaghi) - Contacted 150 metres becoming briefly unbalanced.

T Thornton (ROCHMIE RAY) - Admitted a charge in that she struck her mount ROCHMIE RAY six times prior to the 100 metres mark with the Adjudicative Committee imposing a fine of \$250.
