<b>RACE COMMENTS</b>	
<b>Race 1</b>	<b>MOUNT SHOP 1100</b>
<p><b>COOL CHANGE</b> (T Wenn) - Began awkwardly losing ground. Raced greenly under pressure in the final straight.</p> <p><b>LINEN AND LACE</b> (A Schwerin) - Slow to begin.</p> <p><b>FULLBORE</b> (D Prastiyou) - Over-raced through the early and middle stages. Raced wide throughout when hanging out and then raced greenly under pressure in the final straight. Trainer D Jeffcoat was advised that a warning would be placed against the horse's racing manners.</p> <p><b>MISCREANT</b> (A Calder) – Lay in under pressure in the straight.</p> <p><b>J Fillmore</b> (MADIRAN) - Stewards inquired into the manner in which J Fillmore used her whip in the home straight and could not be conclusively satisfied that she had contravened the rules.</p>	
<b>Race 2</b>	<b>DUNSTAN HORSEFEEDS 1100</b>
<p><b>MR JAY EIGHT</b> (A Calder) - Restrained from its wide barrier at the start. Restrained off heels for a distance passing the 300 metres then held up to obtain clear running until near the 200 metres.</p> <p><b>CALL ME FLINT</b> (A Sims) - Crowded at the start. Lost the off hind plate during the running.</p> <p><b>WANDA LU</b> (A Lawson-Carroll) – Crowded at the start.</p> <p><b>YES I AM</b> (D Prastiyou) – Crowded at the start.</p> <p><b>GIVERNY</b> (J Fillmore) - Raced wide and hung throughout proving a difficult ride. Trainer N Tiley was advised that a warning would be placed against the filly's racing manners.</p> <p><b>ME LIBEREZ</b> (M Hashizume) - When questioned regarding the performance Rider M Hashizume advised the gelding had raced keenly in the early and middle stages but was otherwise disappointing.</p> <p><b>FLIP 'N' EASY</b> (K Myers) - Received veterinary attention following the race after suffering heat stress on pulling up.</p>	

<b>Race 3</b>	<b>HR FISKEN &amp; SONS LTD 1100</b>
<p><b>ELYSIAN FIELDS</b> (J Fillmore) - Became fractious in its barrier making heavy contact with the front of its stall. Start E White was reprimanded after failing to remove ELYSIAN FIELDS to undergo a veterinary examination. Crowded and steadied concluding stages. Underwent a post-race veterinary examination which could find no significant abnormality other than a minor abrasion to the nose.</p> <p><b>SILK 'N' DALE</b> (A Sims) – Slow to begin. Crowded over the concluding stages.</p> <p><b>THE CHROME NUN</b> (K Myers) - Commenced to over-race in the early stages making the bend awkwardly near the 900 metres.</p> <p><b>GENERAL CAVIAR</b> (M Hashizume) – Raced wide in the early stages.</p> <p><b>SMOLDERING YACHT</b> (A Lawson-Carroll) – Lay in under pressure in the final straight.</p> <p><b>SYMPHONY OF LOVE</b> (D Prastiyou) - Crowded and steadied 50 metres.</p> <p><b>A Lawson-Carroll</b> (SMOLDERING YACHT) - Admitted a breach of careless riding in that he permitted SMOLDERING YACHT to shift in inside the final 100 metres when insufficiently clear, crowding ELYSIAN FIELDS, SILK 'N' DALE and SYMPHONY OF LOVE which were all steadied. After considering submissions the Adjudicative Committee suspended A Lawson-Carroll's licence to ride in races from the conclusion of racing on Sunday 14 November up to and including racing on Saturday 20 November, 4 national riding days and in addition imposed a fine of \$200.</p>	
<b>Race 4</b>	<b>HAUNUI FARM 1100</b>
<p><b>LADY MAROAL</b> (J Fillmore) - Slow to begin.</p> <p><b>MAKTOUM</b> (D Prastiyou) - Slow to begin.</p> <p><b>NICE FANDANGO</b> (T Wenn) – Over-raced when disputing the pace three wide in the early and middle stages.</p> <p><b>BREEZON</b> (A Schwerin) – Underwent a post-race veterinary inspection which could find no obvious abnormality. Rider relaxed her ride over the final 25 metres (beaten for 3<sup>rd</sup>).</p> <p><b>A Schwerin</b> (BREEZON) - Admitted a charge of using the whip in consecutive strides on three separate occasions in the final straight on her mount BREEZON with the Adjudicative Committee imposing a fine of \$450.</p> <p><b>A Schwerin</b> (BREEZON) - Admitted a charge in that she failed to ride her mount out to the end of the race when there was a reasonable chance of BREEZON running third. After considering submissions the Adjudicative Committee suspended A Schwerin's licence to ride in races from the conclusion of racing on Sunday 14 November up to and including racing on Sunday 28 November, 2 weeks and in addition imposed a fine of \$100.</p>	
<b>Race 5</b>	<b>FRANKLIN LONG ROOFING LTD 1100</b>
<p><b>OUR TRISTABELLE</b> (T Wenn) - Slow to begin.</p> <p><b>MAGEE</b> (A Calder) - Slow to begin then commenced to hang out becoming detached from the field. Rider advised that the gelding hung throughout proving difficult to ride. Underwent a post-race veterinary examination which could find no obvious abnormality. Trainer D Waddell was advised that MAGEE must trial right-handed to the satisfaction of Stewards prior to racing right-handed again.</p>	

**ROCHMIE RAY** (M Hashizume) - Raced keenly in the early stages. Crowded and hampered approaching the 1000 metres.

**CHAMPAGNE GOLD** (D Prastiyou) - Crowded and checked approaching the 1000 metres. An inquiry was opened into the manner in which D Prastiyou rode CHAMPAGNE GOLD. Underwent a post-race veterinary examination which failed to reveal any abnormality.

**THAT'S ALL FINE** (K Myers) - Crowded and checked approaching the 1000 metres. Raced in restricted room passing the 300 metres to the outside of KEYSTONE which lay out under pressure.

**THE LETTER** (J Fillmore) - Crowded and hampered approaching the 1000 metres. When questioned regarding the performance Rider J Fillmore advised that the filly got further back than intended after receiving interference and would appreciate more ground.

**A Lawson-Carroll** (KEYSTONE) - Admitted a breach of careless riding in that he permitted KEYSTONE to shift in approaching the 1000 metres when insufficiently clear, crowding THAT'S ALL FINE, ROCHMIE RAY, THE LETTER and CHAMPAGNE GOLD which were all hampered to varying degrees. After considering submissions the Adjudicative Committee suspended A Lawson-Carroll's licence to ride in races from the conclusion of racing on Saturday 20 November up to and including racing on Thursday 2 December, 7 national riding days and in addition imposed a fine of \$200.

**Race 6** | **FRANKLIN AUCTIONS 1400**

**CHEQUERED PAST** (T Wenn) - Slow to begin. Forced wider 600 metres.

**KICHEKO SANA** (A Schwerin) – Contacted leaving the barrier.

**REPO MAGIC** (A Calder) - Slow to begin. Over-raced in the early and middle stages. Made the final turn awkwardly when improving onto heels forcing CHEQUERED PAST wider. When questioned regarding the performance Rider A Calder advised that REPO MAGIC had over-raced making the final bend awkwardly and had not responded as anticipated when placed under pressure. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

**EVERY SHOW** (M Hashizume) - Shifted out passing the 200 metres to obtain clear running.

**Race 7** | **BARFOOT & THOMPSON 1400**

**DREAM FORCE** (A Lawson-Carroll) – Slow to begin. Improved onto heels approaching the 400 metres then shifting out to obtain clear running and when placed under pressure raced greenly shifting wide on the track.

**TRUST IN YOU** (D Prastiyou) – Slow to begin.

**A Sims** (EKSTRA GHIA) - Admitted a charge in that she struck her mount EKSTRA GHIA eight times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$250.

**D Prastiyou** (TRUST IN YOU) - Issued with a warning after using his whip in two consecutive strides on TRUST IN YOU inside the final 100 metres with Stewards taking into account his clear recent record.

**Race 8** | **VODAFONE 1400**

**PATSYS LAD** (A Sims) – Began awkwardly.

**RED FOREST** (A Schwerin) – Began awkwardly. Raced ungenerously in the early stages when being steadied.

**ROYAL PERFORMER** (A Lawson-Carroll) - Slow to begin. Raced ungenerously when improving onto heels near the 900 metres. Held up entering the final straight then denied clear running passing the 350 metres when attempting to improve into a marginal run being held up then finding clear running passing the 250 metres.

**Race 9** | **JARDEN 1400**

**CASCATELLA** (T Wenn) - Slow to begin.

**STAR OF WONDER** (J Fillmore) - Slow to begin. Raced ungenerously for a distance passing the 1000 metres.

**SWISS LEGEND** (A Calder) - Improved onto the heels of DE CASTELLA passing the 150 metres which was laying out under pressure.

**MARCHING ON TAVI** (A Schwerin) - Steadied when laying in across heels over the concluding stages and then briefly crowded by DE CASTELLA.

**Race 10** | **SKYCITY 1600**

This race was delayed by approximately 3 minutes when **SON OF SASANOF** proved difficult to load.

**FORTUITY** (A Lawson-Carroll) – Slow to begin.

**KATE VELOUR** (A Calder) - Held up for clear running early in the final straight then denied clear racing room near the 200 metres when attempting a marginal run. When questioned regarding the performance Rider A Calder advised that after the mare had been held up for clear running, had failed to respond as anticipated and may be feeling the effects of the firmer nature of the track conditions.

**SPICEY LAD** (A Sims) - Had blood coming from the right nostril on return to the enclosure. A subsequent veterinary examination found this to be consistent with a minor laceration.

**BAYLOR** (D Prastiyou) - When questioned regarding the performance Rider D Prastiyou could offer no excuse.

**Race 11** | **AUCKLAND CO-OP TAXIS 1600**

**J Ruddell** (ISKANDER) - Issued with a warning after ISKANDER was presented to race without notified gear (blinkers).

**PLUSHENKO** (A Schwerin) - Slow to begin. Became tailed off in the early stages despite the urgings from its rider.

**OHCEEDEE** (M Hashizume) – Rider relaxed ride inside final 50 metres (beaten for 2<sup>nd</sup>)

**M Hashizume** (OHCEEDEE) - Admitted a breach in that he relaxed his ride inside the final 50 metres when there was a reasonable chance of OHCEEDEE running second. After considering submissions the Adjudicative Committee suspended M Hashizume's licence to ride in races from the conclusion of racing on Sunday 14 November up to and including racing on Sunday 05 December, 3 weeks and in addition imposed a fine of \$150.
