Race 6 – AQUASHIELD ROOFING MAIDEN 1400

An adjourned inquiry was reconvened into the ride of R Elliot (ALBUFEIRA) who angled his mount inwards shortly after the start when not clear of MIDNIGHT SWEY (L Allpress) which was bumped and became unbalanced. R Elliot admitted a breach of Rule 638(1)(d) (careless riding) and had his licence to ride in races suspended from the conclusion of racing Saturday, 19 February 2022 up to and including racing on Friday, 25 February 2022 (4 national riding days).

RACE COMMENTS

Race 1 | WAIRARAPA TIMES AGE MAIDEN 2100

CRY BABY (R Hannam) - Hampered at the start and slow away as a result.

VESPACIAN (M Hudson) - Raced wide throughout.

POLAR BLAST (J Riddell) - Held up entering the home straight.

ROADSTER (K HercocK) - Awkwardly placed on heels entering the home straight and buffeted for several strides when POLAR BLAST (J Riddell) shifted out. After questioning riders, J Riddell was issued with warning.

PLATINUM EAGLE (D Turner) - Not persevered with and finished some distance last. Connections were advised the horse must trial satisfactorily prior to its next start. Trainer L Latta advised PLATINUM EAGLE would no longer be a racing proposition from her stable.

NASSAK DIAMOND (C Grylls) - Finished well back. When questioned, rider could offer no excuse. A subsequent veterinary examination revealed a slow post-race recovery.

R Hannam (CRY BABY) - Admitted a charge in that he struck his mount CRY BABY 7 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a fine of \$250

J Riddell (POLAR BLAST) - Issued with a warning after permitting POLAR BLAST to shift outwards near the 400 metres when not sufficiently clear of ROADSTER, which was buffered for several strides.

Race 2	MOBIL CARTERTON MAIDEN 1200

ALBATROSS (J Kamaruddin) - Raced ungenerously for a distance passing the 800 metres. Raced greenly in the home straight.

EAU DE VIE (S Weatherley) - Raced wide throughout.

SETTLE PETAL (C Grylls) - Over-raced passing the 800 metres having to be steadied. Finished well back. When questioned rider advised the filly pulled up in a normal post-race condition and had no excuse. C Grylls was of the opinion the filly may improve with the run.

DIDDY'S GIFT (M Hudson) - Improved up onto the heels of SYLVIEMOSA approaching the 400 metres and had to be steadied.

HELLUVAH RETURN (R Hannam) - Held up briefly entering the home straight and had to be angled outwards to improve.

TIN PAN ALLEY (L Hemi) - Shifted out under pressure in the home straight.

Race 3	BOND STREET BAR MAIDEN 1400

REINE D'AMOUR (W Pinn) - Began awkwardly.

CHANCELLOR (T Yanagida) - Restrained to the rear from its wide draw. Angled across heels passing the 300 metres to gain clear racing room.

POSTER BOY (A Goindasamy) - Raced greenly over the concluding stages.

Race 4	MEXTED MOTORS 1400

SUGAH SWEET (D Turner) - Slow away.

PODKAST (C O'Beirne) - Began awkwardly hampering runners to its outside. Hung outwards throughout the home straight.

PABLO CASALS (K Herccock) - Hampered at the start.

ONE DREAM ONE SOUL (A Mudhoo) - Hampered at the start.

LANDRY (R Elliot) - Lay inwards throughout the home straight.

Race 5

THE HITS MAIDEN 1400

SACRED PEARL (C Dell) - Restrained to the rear. Improved into restricted room approaching the 400 metres and was checked off heels. Angled outwards across heels to gain clear running.

CONGO (S Weatherley) - Raced wide throughout.

THATSALLSHEWROTE (T Yanagida) - Lay in approaching the 400 metres, placing runners to its inside in restricted room. Briefly held up passing the 250 metres.

MATINEE (K Herccock) - Held up passing the 400 metres having to angle her mount outwards passing the 300 metres to gain clear running.

KEEP IT LOOSE (M Cameron) - Finished well back. When questioned rider advised the gelding raced greenly and was unsuited to the Slow 8 track. M Cameron was of the opinion KEEP IT LOOSE would derive benefit from today's run.

Race 6

WCM LEGAL WAIRARAPA CUP 2100

LURID (R Hannam) - Over-raced when leading through the early and middle stages.

LINCOLN RAIDER (J Riddell) - Had to be steadied approaching the 1400 metres.

WHATSUP (M Singh) - Raced wide throughout.

JANE O' (L Hemi) - Denied a narrow run near the 200 metres when POSH POROTENE (W Pinn) shifted out when not fully clear, resulting in JANE O' having to be angled inwards to improve. Connections of the 2nd placed JANE O' viewed footage of the home straight but elected not to proceed with an objection against the winner, POSH PROTENE, alleging interference near the 200 metres. W Pinn was advised to exercise greater care and that he is expected to straighten his mount sooner than he did on this occasion.

MISS INTERPRET (A Goindasamy) - Finished last. Rider reported the mare was unsuited to the extra distance at this stage of its preparation.

Race 7

PROPERTY BROKERS WAIRARAPA THOROUGHBRED BREEDERS STAKES 1600 (Listed Race)

NO ROCK NO POP (A Mudhoo) - Slow away.

KAROLINO (C Grylls) - Slow away.

MAMMA SANS (S Macnab) - Over-raced through the middle stages.

MAGIC INCANTO (M Hudson) - Raced wide throughout.

VICTOREM (R Elliot) - Held up passing the 400 metres and had to be angled inwards to improve.

PALM SPRINGS (J Parkes) - Finished last. When questioned rider had no excuse. A post-race veterinary examination did not reveal any obvious abnormality.

KURIPUNI SPORTS BAR & TAB 1600

LINCOLN ROCKS (J Riddell) - Slow away.

KERMALINA (A Goindasamy) - Slow away.

PAPA MOANA (D Turner) - Raced wide throughout.

GOLDEN STORY (J Parkes) - Finished last. Rider had no excuse.

ZUMA ROCK (F Lazet) - Lay in under pressure over the concluding stages.
