SUPPLEMENTARY
Cambridge Jockey Club – Wednesday 3 August 2022 Race 9 – Martin Collins New Zealand 2000 (Adjourned enquiry heard at Te Rapa Racecourse Tuesday 27 September 2022) S Weatherley – Defended a charge he did ride recklessly passing the 250-metre mark, in that he directed his mount 'JACK HAMMER' outwards making heavy contact with the hindquarters of 'GOODO JO' which was forced into the line of 'TE ATATU PASH', causing that runner to fall and dislodge the rider. After viewing all available film footage and hearing submissions the Adjudicative Committee found the charge to be proven imposing a suspension of S

Weatherley's licence to ride in races from the conclusion of racing on Saturday 1 October 2022 until the conclusion of racing on Saturday 3 December 2022, a period of nine weeks.
S Weatherley is also to be directed to meet with an NZTR Rider Skills Review Panel under the provisions of Rule 343.

RACE COMMENTS

Race 1 | NZ HORSE AMBULANCE TRUST MAIDEN 1550

DIAMOND HEIST (M Sanson) – Underwent a pre-race veterinary examination due to the mare having not raced for a considerable period of time and was cleared fit to race. Raced keenly in the early stages.

ROC DANCER (S Weatherley) - Slow to begin then improved forward to race outside the leader near the 1100 metres. Raced below market expectations. When questioned, rider S Weatherley reported that the mare would be better suited ridden cold and would appreciate a step up in distance.

ZAPPA JAK (K Hercock) - Began awkwardly. Raced wide without cover from near the 1000 metres. Lay in under pressure in the final straight having to be corrected by its rider.

HARMONIA (M McNab) - Raced keenly in the early stages.

BELLA VOLAIRE (D Danis) - Weakened passing the 400 metres. When questioned regarding the performance rider D Danis advised that the mare had been unsuited by the synthetic track.

Race 2 | NZ FARRIERS ASSOCIATION (WAIKATO) MAIDEN 1550

WEE RHONA (S Spratt) - Underwent a pre-race veterinary examination at the barrier and was late scratched at 12.32 pm.

OCEAN CRUIZER (A Lawson-Carroll) - Slow to begin. Lay out near the 400 metres.

LAST CARD BETTY (T Newman) – Crowded shortly after leaving the barriers. Finished a distant last. Trainer advised that the mare would not be persevered with as a racing proposition.

KING MANDALO (M Cameron) – Had to be steadied shortly after leaving the barriers when placed in restricted room. Raced keenly in the early stages when racing to the outside of CONGO which lay out and away from LAST CARD BETTY. Contributing to this incident was inward movement from ANNIE.

JIMMY THUMPER (A Goindasamy) – Improved onto heels passing the 1200 metres having to be steadied.

Race 3 | CAMBRIDGE EQUINE HOSPITAL 1550

CATHAY EMPRESS (M McNab) - Began awkwardly. Raced below market expectations. When questioned, rider M McNab reported that in his opinion the mare was feeling the effects of recent racing. Underwent a post-race veterinary examination which revealed mild swelling in the left front fetlock, however there were no signs of lameness. Connections were advised that a veterinary clearance is required prior to racing next. Trainer B Foote reported that the mare is likely to be retired.

YOLO (L Sutherland) - Crowded leaving the barriers.

LASER'S FURY (T Thornton) – Jumped outwards leaving the barriers crowding YOLO.

LA VELOCITA (S Weatherley) - Restrained in the early stages to obtain cover from the outside barrier.

CATWALK GIRL (K Asano) - Restrained to obtain cover when racing keenly near the 1200 metres.

FELIX FAURE (Y Kumagai) - Raced keenly through the early and middle stages.

LAGERFELD (J Ridell) – Raced wide without cover throughout.

IPSO FACTO (V Colgan) - When questioned regarding the performance rider V Colgan reported that he was disappointed with the mare's effort and could offer no explanation.

Race 4 | **WAIPA EARTHWORKS MAIDEN 1300**

RIDGEVIEW MANDY (N Parmar) - Slow to begin.

THE PROPHET SPEAKS (J Kamaruddin) - Began awkwardly. Raced wide without cover throughout.

BRECKON POWER (S Weatherley) – Slow to begin. Held up for clear running rounding the final bend and early stages of the final straight.

THE CHROME NUN (T Thornton) - Began awkwardly.

JUST A TIPPLE (V Colgan) - Began awkwardly losing ground. Raced in restricted room rounding the final bend.

SWEET TALKING (R Elliot) - Raced wide without cover throughout. Lay in near the 200 metres and continued to lay in for the remainder of the final straight.

LINKIN PARK (C Grylls) – Over-raced during the running which proved detrimental to the gelding's chances. Crowded and checked passing the 250 metres.

TRAMONTO (M McNab) - Raced wide without cover.

CALGARY PARK (T Yanagida) - Raced in restricted room rounding the final bend.

S Weatherley (BRECKON POWER) - Admitted a charge of careless riding in that he directed his mount BRECKON POWER outwards when not sufficiently clear of LINKIN PARK which was crowded and checked passing the 250 metres. After considering submissions the Adjudicative Committee suspended S Weatherley's licence to ride in races from the conclusion of racing on Saturday 6 August up to and including racing on Saturday 20 August, 7 national riding days.

Race 5 | **MAGNUM INDUSTRIES 1300**

EASY PEASY (E Nicholas) – Began awkwardly losing ground.

LOCK UP (T Thornton) - Began awkwardly. Raced three wide without cover throughout.

Race 6 | **HORSE TRANSPORT SERVICES 1300**

DUNEAGLE (J Kamaruddin) - Slow to begin (3L). Made the final bend awkwardly racing wide.

KOPUA (R Elliot) - Slow to begin. Held up for clear running for the majority of the final straight.

SUPREME KHAN (O Bosson) – Restrained in the early stages to obtain cover from the outside barrier.

GAGLIARDI (R Beemud) - Raced wide without cover throughout.

ACUTUS (E Bragg) – Raced wide without cover through the middle stages.

DAME VERA (C Grylls) - When questioned regarding the performance rider C Grylls advised that the mare never travelled during the running.

PETRACHOR (D Prastiyou) - Contacted by TIVAAN WARRIOR becoming unbalanced approaching the 250 metres.

ALCHEMIA (T Yanagida) - Shifted out and away from TIVAAN WARRIOR passing the 100 metres making contact with RED VIENNA which shifted in slightly.

RED VIENNA (M McNab) - Shifted in passing the 100 metres making contact with ALCHEMIA.

S Spratt (TIVAAN WARRIOR) - Issued with a warning after directing her mount outwards when not sufficiently clear approaching the 250 metres making contact with the hindquarters of PETRACHOR which was unbalanced.

Race 7 | **PRIMA PARK 970**

LADY KOVAL (E Nicholas) - Reared as the start was effected losing ground.

BILLY BUNTER (M Cameron) - Slow to begin.

THE BOUNDER (E Leighton) - Faltered just past the winning post and was immediately attended to by the on-course veterinarian with the Horse Ambulance being deployed. The gelding was found to have suffered a compound fracture of the left front fetlock being humanely euthanised. Rider E Leighton was uninjured.

Race 8 | **CARTER CONTRACTING MAIDEN 970**

STONYBRECK (N Parmar) - Slow to begin.

STRONG (V Colgan) - Began awkwardly.

EAU DE VIE (D Danis) - Slow to begin.

GOOD BROTHERS (A Goindasamy) - Began awkwardly, then ridden urgently to recover.

THE DIVINER (K Hannan) – Lay in leaving the barriers crowding BUBBLES AWAIT.

BUBBLES AWAIT (J Kamaruddin) – Crowded leaving the barriers.

ELUSIVE NATION (C Grylls) – Raced keenly through the middle stages.

ONE POWER (M Sanson) – Fractious in the barrier prior to the start. Returned to the enclosure with blood present in one nostril. Underwent a post-race veterinary examination which revealed a small cut to the inside of the right nostril consistent with the gelding making contact with the barrier.

Race 9 | **MARTIN COLLINS NEW ZEALAND MAIDEN 2000**

NIGHTFALL (L Sutherland) - Slow to begin.

MAC MCGEE (T Newman) - Slow to begin.

LADY KHAN (M Sanson) - Began awkwardly losing ground.

ONEZEDBEE (L Satherley) – Restrained in the early stages to obtain cover from a wide barrier. Hampered by the fallen runner passing the 250 metres.

CAPE GEM (E Nicholas) – Hampered by the fallen runner passing the 250 metres.

GOODO JO (D Danis) – Contacted and unbalanced passing the 250 metres.

TE ATATU PASH (T Yanagida) - Raced three wide without cover for the majority of the race. Fell passing the 250 metres dislodging its rider. Underwent a post-race veterinary examination which found the mare to have external superficial trauma to the face. Rider T Yanagida was immediately attended to by St John Ambulance Paramedics before being transferred to Waikato Hospital for further assessment and treatment.

NANTUCKET (R Elliot) - Badly hampered by the fallen runner passing the 250 metres dislodging its rider. Underwent a post-race veterinary examination which found the gelding to have a haematoma on the point of the left buttock being 3/5 lame. Connections were advised that a veterinary clearance is required prior to racing next. Rider R Elliot was cleared by the on-course Doctor.

Stewards opened and adjourned an enquiry after taking initial evidence from the available riders into an incident near the 250 metres in which TE ATATU PASH fell dislodging T Yanagida. As a result, NANTUCKET who was following was badly hampered, dislodging rider R Elliot.
