**LOFTYS GIFT** (E Nicholas) – Co-trainer S Ritchie reported to Stewards the stable was satisfied with the post-race condition of LOFTYS GIFT, and it is their intention to continue on with the mare's current preparation.

### **Race 5 WOODS CONTRACTING 3900**

**RAUCOUS** (S Phelan) – Co-trainer P Nelson advised Stewards RAUCOUS was examined by the chiropractor on Monday 1 August which revealed soreness to the geldings back area. P Nelson further advised RAUCOUS has been rested this week and will look to return the gelding to exercise next week.

### **Race 9 NZ FARMERS LIVESTOCK 1200**

**ANGELICA** (M Kareem) – Co-trainer R Norvall reported to Stewards the stable was satisfied with the post-race condition of the mare, and it is their intention to continue on with ANGELICA'S current preparation.

### Race 11 WOODS CONTRACTING 1400

**EVA CHIARA** (M McNab) – Stable representative R Mildon advised Stewards he was satisfied with the post-race condition of EVA CHIARA, and it is his intention to carry on with the mare's preparation.

### **RACE COMMENTS**

## Race 1 GREG THORP BLASTING LIMITED MAIDEN 1600

**VADIABEEL** (C Lindsay) – Restrained in the early stages to obtain cover from the outside barrier.

**TYNESIDER** (E Bragg) – Reared as the gates opened losing ground. Made the bend awkwardly approaching the 800 metres.

TOFFEE (M McNab) - Slow to begin. Briefly held up rounding the final bend.

CAPEL PRINCE (E Leighton) - Slow to begin.

**DREAM FORCE** (T Harris) - Began awkwardly.

**TURNAROUND** (A Lawson-Carroll) - Over-raced in the early stages when leading.

**LIKE IT SWEET** (C Grylls) - Steadied when placed in restricted room approaching the 150 metres when runners either side shifted ground.

# Race 2 ALIBABA'S FLYING CARPETS STRETCH AND TRIM MAIDEN 1600

GO FIONA (M Cameron) - Slow to begin.

**MATAI BAY** (J Fawcett) – Began awkwardly. Had to be steadied after improving into restricted room passing the 850 metres. Held up for clear running rounding the bend and early in the final straight.

ARJAY'S FLIGHT (T Thornton) - Began awkwardly. Raced ungenerously for a distance passing the 1400 metres.

**RUSTIC** (T Harris) - Raced wide without cover.

**RAKAU** (A Lawson-Carroll) – Raced ungenerously for a distance passing the 1400 metres. Raced in restricted room passing the 100 metres.

**BRONTES GOLD** (E Nicholas) – Made the bend near the 850 metres awkwardly, shifting out slightly with MATAI BAY improving to its inside before having to be steadied by its rider when BRONTES GOLD was corrected by its rider.

**ONLYWORDS TO TRADE** (C Grylls) – When questioned regarding the performance the rider could offer no excuse. Underwent a post-race veterinary examination which did not reveal any abnormality.

# Race 3 HARCOURTS SERIES AT RUAKAKA 1600

CHILLAX (J Kamaruddin) - Slow to begin.

OSTASIO (A Lawson-Carroll) - Raced wide without cover throughout.

**CHEVRON** (T Newman) - Raced ungenerously in the early and middle stages when racing outside the leader. When questioned regarding the performance the rider advised that racing keenly in the middle stages and the impost of 60 kgs had been detrimental to the gelding's chances.

**FOLLOW YOUR DREAMS** (K Hannan) - Raced wide without cover for the majority of the race.

### Race 4 ALIBABA'S FLYING CARPETS DASH 1100

**MALFY ROSA** (L Satherley) - Crowded shortly after the start having to be steadied. Raced greenly when being steadied passing the 850 metres making the bend awkwardly. Raced ungenerously passing the 600 metres.

MONTEZUMA (M Cameron) - Crowded shortly after the start having to be steadied.

LORD COSMOS (J Kamaruddin) – Contacted shortly after the start becoming unbalanced.

LUCIENNE (M Kareem) - Raced wide without cover for the majority of the race when racing greenly.

### Race 5 TRUWELD ENGINEERING MAIDEN 1200

**ALCYON** (S Spratt) - Stood in the barrier when the gates opened losing ground (10L). Connections were advised that the mare would be required to barrier trial prior to racing next.

**LIKE A RIVER** (M Sanson) – Crowded shortly after the start.

**TEXAS** (D Prastiyou) – Crowded shortly after the start. Hampered approaching the 400 metres by ALPINO which was forced outwards by ANNA TAIT.

MR FANTASTIC (A Goindasamy) - Crowded shortly after the start.

I'M ALICE (T Thornton) - Restrained in the early stages to obtain cover from a wide barrier.

**ANNA TAIT** (L Satherley) - Over-raced in the early stages. Hung outwards and ran wide rounding the final bend hampering ALPINO and continued to run out in the final straight despite the efforts of its rider. Connections were advised that the mare would be required to barrier trial to the satisfaction of Stewards prior to racing next.

ALPINO (C Grylls) – Hampered being forced wider rounding the bend and early in the final straight.

Following the race connections of the  $4^{th}$  placed horse ALPINO lodged a protest alleging interference against the  $2^{nd}$  placed horse ANNA TAIT rounding the bend and in the final straight. After considering submissions the Adjudicator upheld the protest with the amended placings being  $1^{ST}$  TEXAS,  $2^{ND}$  MISCREANT,  $3^{RD}$  ALPINO,  $4^{TH}$  ANNA TAIT.

### Race 6 ALIBABA'S FLYING CARPETS OVERLOCKING MAIDEN 1200

**SULABELLA** (M Cameron) - There was a delay in getting the mare to the start after proving fractious. As a result, there was a 5 minute delay to the start of this race. Began awkwardly.

**PRINCESS KEIRA** (A Lawson-Carroll) – Began awkwardly. Became awkwardly placed on heels passing the 1000 metres having to be steadied.

**SECRETS DE SOTHYS** (M Kareem) - Slow to begin.

**ADJUDICATOR** (J Fawcett) – Slow to begin. Raced wide without cover throughout.

**FEEL THE THUNDER** (T Newman) – Raced wide without cover throughout.

WILLIAM (S Spratt) - Raced three wide without cover throughout.

**NOVAK** (T Harris) – Held up rounding the final bend.

E Nicholas (TIPPER) - Issued with a warning after weighing in 0.5 kgs over the weight at which she weighed out at.

### Race 7 THE HOMESTEAD SPORTS BAR & BISTRO 1300

**SHE SPEEDS** (T Thornton) – Slow to begin.

AGEY BABE (J Kamaruddin) - Began awkwardly.

**TAZIMOTO** (E Bragg) – Began awkwardly. Raced ungenerously passing the 1000 metres having to be restrained.

**THE HIGH PRIESTESS** (O Bosson) – Crowded shortly after the start.

**QUALITY PREVAILS** (A Goindasamy) - Crowded shortly after the start.

**VAN DIESEL** (T Newman) - Shifted outwards leaving the barriers making contact with QUALITY PREVAILS. Briefly over-raced passing the 1000 metres.

**EL ROSEAY** (C Grylls) - Raced ungenerously in the early stages when being restrained.

**TAOISEACH** (T Harris) - Raced keenly when hanging in the early stages. Rider reported that the gelding hung throughout the running. Underwent a post-race veterinary examination which did not reveal any abnormality.

**T Harris** (TAOISEACH) - Admitted a charge after weighing in 0.6 kgs over the weight at which he weighed out at with the Adjudicator imposing a fine of \$150.

#### Race 8

### **ALIBABA'S FLYING CARPETS KERIKERI CUP 1100**

**DIAMOND GIRL** (T Newman) - Turned its head sideways when the gates opened losing ground (5L).

**ENTRIVIERE** (N Parmar) – Began awkwardly.

**SCARFI** (M Sanson) – Raced wide without cover throughout.

ZELENSKI (A Lawson-Carroll) - Raced three wide without cover throughout.

**NEW YORK JAZZ** (E Bragg) – Inconvenienced passing the 400 metres. Had some difficulty obtaining clear running for the majority of the final straight.

**DRAGON LEAP** (C Grylls) - Held up for a distance approaching the 400 metres.

**IRISH GIRL** (T Thornton) - Had to be steadied to avoid heels passing the 400 metres.

**ON THE BUBBLES** (J Kamaruddin) - When questioned regarding performance the rider advised that the gelding had peaked on its run in the final straight and would derive benefit from today's performance. Underwent a post-race veterinary examination including an endoscopic examination which did not reveal any abnormality.

**O Bosson** (IMPERATRIZ) - Issued with a warning after permitting his mount to shift outwards when not sufficiently clear of IRISH GIRL which had to be steadied to avoid heels passing the 400 metres. Inconvenienced as a result was the trailing NEW YORK JAZZ.

## **TIM BRANDON LIVESTOCK 2100**

CHARRED (J Kamaruddin) - Began awkwardly unbalancing its rider, losing ground (4L).

OUTRIVAL (M McNab) – Began awkwardly.

BEAR GRYLS (M Sanson) - Raced wide without cover from near the 1500 metres.

**TRIGON LAD** (T Thornton) - Commenced to race ungenerously approaching the 1200 metres shifting outwards to avoid heels, forcing BEAR GRYLS wider then continued to over-race through the middle stages.

TE POROPITI (R Beemud) - Held up rounding the final bend.

**PEERLESS WARRIOR** (T Newman) – Held up for the majority of the final straight.

## Race 10

### **DUNSTAN ACCUMULATOR SERIES 2100**

LORD POLONIUS (T Thornton) - Slow to begin.

**ONEOUTOFTHEBOX** (C Grylls) - Slow to begin.

**BURCHA** (B Rogerson) - Began awkwardly. Crowded shortly after the start.

**IFFIE SHOWS** (T Harris) – Crowded shortly after the start. When questioned regarding the performance the rider advised that in his opinion the gelding would benefit from some easing in the ground.

**MISS ONAKI** (M McNab) - Crowded shortly after the start. Commenced to over-race rounding the first bend then continued to race keenly through the middle stages.

**CHARMINGAFFAIR** (J Kamaruddin) - Hampered rounding the first bend. Had to shift inwards early in the final straight to obtain clear running.

**EVE'S SONG** (T Newman) – Raced ungenerously rounding the first bend losing ground hampering CHARMINGAFFAIR.

**CURRENT SURGE** (S Spratt) - Raced wide without cover throughout.

**BURGUNDY DANCER** (L Satherley) – Had some difficulty obtaining clear running early in the final straight.
