RACE COMMENTS

Race 1 HOUGHTON PLUMBING, HEATING & GAS MAIDEN (2100M)

SOIREE (T Taiaroa) – Hampered at the start losing ground. Raced ungenerously in the early stages.

JESKO (H Schofer) – Began awkwardly hampering SOIREE.

HERECOMESTHESUN (B Rogerson) – Raced wide without cover throughout, commenced to give ground from the 800 metres.

ALL IN ALL (J Kamaruddin) – Became awkwardly placed behind runners near the 650 metres having to be steadied.

ACAPULCO (C Dell) – A post race veterinary examination was carried out at the trainer's request which was clear.

Race 2 M J CONCEPT & CONSTRUCTION LTD MAIDEN (1200M)

DAWN ESTELLE (M Hudson) – Hampered at the start. Briefly held up passing the 300 metres.

LATIN QUARTER (M Singh) – Began awkwardly hampering DAWN ESTELLE.

LITTLE MISS ZED (J Mudhoo) – Restrained to the rear from its wide draw.

MISS BONNY ROSE (M Sanson) – Forced wide near the 500 metres when THE AUDACITY improved to its inside.

CAPITAL EXPENSE (E Nicholas) - Lay in near the 150 metres having to be straightened.

ACCIDENTAL TOURIST (C Grylls) – Raced greenly over the concluding stages.

Race 3 D R GRAY LTD PAINTING CONTRACTORS (1200M)

WEE DRAM – Was late scratched at 12.07 pm on veterinary advice after receiving an injury in the tie-up stalls.

FIANO (J Mudhoo) – Slow away.

CATSACHARMER (L Sutherland) – Began awkwardly.

HALF OF NOTHING (M Sanson) - Began awkwardly bumping PULL NO PUNCHES.

PULL NO PUNCHES (L Allpress) – Bumped at the start.

LIGHTNING FIELD (J Kamaruddin) – Began awkwardly bumping PULL NO PUNCHES. Performed below market expectations. When questioned rider advised the gelding had not been suited by today's track conditions. Underwent a post race veterinary examination which revealed a slow recovery. Stewards will follow up with connections in the coming days.

ICONIC LASS (A Mudhoo) – Lay out under pressure across the heels of CATSACHARMER near the 200 metres.

RACE 4 TARANAKI KITCHEN SPECIALISTS MAIDEN (1400M)

IRONWOOD (A Mudhoo) – Was removed from the barrier and late scratched on veterinary advice at 1.46pm after charging the gate prior to the start.

SOUND TRACK (M Hudson) – Proved difficult to load. Connections were advised that a warning has been placed on the mare's barrier manners.

TURKEY (D Turner) – Slow to begin then commenced to over race through the early and middle stages placing the rider at a disadvantage and continued to race fiercely passing the 800 metres inconveniencing MINNIE MOUSE and TIGHTEN ME UP. Was pulled out prior to entering the home straight and took no further part. Rider D Turner confirmed to Stewards the mare had over raced and hung throughout and been a difficult ride. Connections were advised that the mare is to trial to the satisfaction of Stewards prior to its next start. Underwent a post race veterinary examination which was clear.

ZAMBUCCA ROSE – Slow to begin.

SOVIET WONDER (J Kamaruddin) – Over raced and had to be steadied through the early stages.

MINNIE MOUSE (K Hannan) – Inconvenienced near the 800 metres having to be steadied. Galloped on during the running.

TIGHTEN ME UP (C Grylls) – Inconvenienced near the 800 metres.

SHEZA FLYER (L Allpress) – Performed below market expectations. When questioned rider could offer no excuse. Underwent a post race veterinary examination which was clear.

RACE 5 WHITE ELECTRICAL LTD/EGMONT SOLAR LTD (1400M)

SHOWSHANELLE (C Dell) - Hampered at the start. Over raced and had to be steadied near the 900 metres

ORGANISED CHAOS (M Sanson) – Began awkwardly hampering SHOW SHANELLE.

HIGH FREQUENCY (E Nicholas) – Began awkwardly settling at the rear of the field.

CORINNE (H Schofer) – Was held up for a short distance approaching the home turn and then had to be angled wide to improve.

HAPPY TAV (L Allpress) – When questioned into performance rider advised the mare was not entirely suited to the ground. Connections advised they would monitor the mare's progress and advise Stewards of any further developments in the coming days.

V Jalalkuncha (MONKEY TOWN) – Was spoken to regarding the manner in which he used his whip (high). Admitted a charge in that he struck his mount MONKEY TOWN seven times prior to the 100 metres. After considering submissions the Adjudicative Committee imposed a fine of \$500.

Race 6 SANDFORDS RURAL CARRIERS (1600M)

MASSO (A Mudhoo) - Slow away.

ATENARTIN (F Lazet) - Slow away.

DEEP BLUE (J Mudhoo) – Over raced through the middle stages.

HARDTIMES (T Taiaroa) – Lay out under pressure over the concluding stages.

V Jalalkuncha (CHEEKY AZZ) – Spoken to with regards to his use of a whip on a runner out of contention.

Race 7 NZB INSURANCE PEARL SERIES RACE (1600M)

There was a short delay to the start of the race due to a section of the rail near the 1500 metres having to be repaired.

DIVINE SPIRIT (J Parkes) – Began awkwardly settling at the rear of the field.

QUEEN OF SPADES (H Schofer) – Lay out in the home straight.

LINCOLN LOVER (M McNab) – Performed below market expectation. Rider advised that the mare was not happy in today's track conditions. Underwent a post race veterinary examination which was clear.

GINSBURG (C Grylls) – Performed below market expectation. Rider advised that the mare was not happy in today's track conditions. Underwent a post race veterinary examination which was clear.

Race 8 KARL SRATTON LIVESTOCK MAIDEN (1600M)

KUVALDA (K Hercock) – Over raced in the early stages.

McKHAN (H Schofer) – Over raced in the middle stages. Rider advised the gelding had disappointed and could offer no excuse. A post race veterinary examination was clear. Connections advised they would monitor the gelding's progress and advise Stewards of any further developments in the coming days.

MOMOSA (J Kamaruddin) – Performed below market expectation. Rider advised that the gelding was not happy in today's track conditions.
