Race 3 - iLINE PROJECT MANAGERS 1200

SHOSHONE (K Hannan) – Trainer K Kelso advised Stewards SHOSHONE has been retired from racing and sent to stud.

RACE COMMENTS**Race 1****10 SEPTEMBER HARCOURTS FOR HOSPICE MAIDEN 1600 metres**

KAIMAI QUEEN (E Nicholas) - Began awkwardly. Raced wide without cover until near the 600 metres. When questioned regarding the performance rider E Nicholas advised that although the mare had been caught wide it had also felt rather flat today and had never travelled particularly well. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

SPHERICAL (V Colgan) - Slow to begin.

PILLAR OF SOCIETY (L Satherley) - Began awkwardly losing ground.

CON ARTIST (S Spratt) - Began awkwardly. Raced keenly in the early stages.

MATAI BAY (J Fawcett) - Raced wide in the early stages.

I'M ALICE (D Danis) - Held up for a distance near the 300 metres but failed to run on once obtaining clear running.

RED NYMPH (A Lawson-Carroll) - Shifted ground outwards across heels after being placed in restricted room near the 100 metres hampering **CANDYFLIP**.

CANDYFLIP (D Prastiyou) – Hampered near the 100 metres.

CAPEL PRINCE (J Kamaruddin) – Lay out under pressure approaching the 100 metres having to be corrected by its rider.

A Lawson-Carroll (**RED NYMPH**) - Issued with a warning after permitting his mount to shift outwards near the 100 metres hampering **CANDYFLIP**.

E Nicholas (**KAIMAI QUEEN**) – Issued with a warning after weighing in 0.4kgs below the weight at which she weighed out at.

Race 2**NORTHLAND BUSINESS SYSTEMS MAIDEN 1200 metres**

PYRAMUS (K Asano) - Slow to begin.

TREAT DAPainter (C Lindsay) - Began awkwardly.

SNORKEL (E Nicholas) – Began awkwardly. Raced three wide without cover throughout.

SULABELLA (T Newman) - Made the final bend awkwardly running extremely wide and continued to lay out in the final straight not being able to be ridden out by its rider. Underwent a post-race veterinary examination which did

not reveal any obvious abnormalities. Trainer M Bradley was advised that the mare would be required to barrier trial to the satisfaction of Stewards prior to racing next.

PATRICIA (A Goindasamy) – Raced wide in the early stages before improving forward to race outside the leader passing the 800 metres.

BOSCH (C Barnes) – Restrained in the early stages to obtain cover from an outside barrier.

Race 3 | **HIREPOOL RUAKAKA CUP 2200 metres**

HIT THE ROAD JACK (E Nicholas) - Slow to begin.

LORD POLONIUS (L Satherley) – Slow to begin.

CHERRY LANE (C Lindsay) - Over-raced having to be restrained near the 1700 metres.

CHEVRON (T Newman) - Lost the left hind plate during the running.

E Nicholas (HIT THE ROAD JACK) - Issued with a warning after making a celebratory gesture prior to the winning post.

C Lindsay (CHERRY LANE) - Admitted a charge in that she failed to ride her mount out to the end of the race when there was a reasonable chance of finishing into a higher position. After considering submissions the Adjudicator suspended C Lindsay's licence to ride in races from the conclusion of racing on Saturday 20 August up to and including racing on Thursday 1 September, 8 national riding days.

Race 4 | **CAMBRIDGE STUD NORTHLAND BREEDERS' STAKES 1200 metres (Group 3)**

LORD COSMOS (J Kamaruddin) – Stewards were advised by the riding agent for O Bosson at approximately 8am that he would be unable to make the required weight for this runner. O Bosson was replaced by J Kamaruddin. Lay outwards away from LICKETY SPLIT over the concluding stages.

ON THE WALL (V Colgan) - Reared as the gates opened then shifted outwards abruptly losing ground.

TEXAS (D Prastiyou) - Began awkwardly.

DEPLOY (J Fawcett) - Began awkwardly. Dictated outwards passing the 250 metres by PACIFIC DRAGON then being checked near the 125 metres when PACIFIC DRAGON continued to shift outwards.

PACIFIC DRAGON (K Asano) – Lay out under pressure in the straight finishing wide out on the track.

LICKETY SPLIT (C Barnes) – Dictated outwards near the 200 metres.

Following the race connections of the 4th placed horse DEPLOY lodged a protest against the 2nd placed horse PACIFIC DRAGON alleging interference near the 250 metres. After considering submissions the Adjudicative Committee dismissed the protest.

O Bosson (LORD COSMOS) – Admitted a charge in that he failed to make the required weight for LORD COSMOS being fined the sum of \$350 by the Adjudicator.

K Asano (PACIFIC DRAGON) - Admitted a charge of careless riding in that he permitted his mount to shift outwards when not sufficiently clear of DEPLOY which was checked near the 125 metres. After considering submissions the Adjudicator suspended K Asano's licence to ride in races from the conclusion of racing on Saturday 27 August up to and including racing on Sunday 4 September, 5 national riding days and in addition imposed a fine of \$100.

Immediately following this race T Newman advised that she was feeling the effects of dehydration and was stood down from her remaining two rides with replacements as per the schedule above.

Race 5 | **NZB INSURANCE PEARL SERIES RACE 1600 metres**

ENCHANTED ELLE (K Hannan) – Restrained in the early stages to obtain cover from the outside barrier.

SAMINA BIBI (E Nicholas) - Raced keenly passing the 1100 metres having to be restrained when becoming awkwardly placed on heels. Placed in restricted room passing the 400 metres. When questioned regarding the performance rider E Nicholas advised that the mare had travelled well but had felt a little field shy in the straight being reluctant to take gaps between runners. A post-race veterinary inspection did not reveal any obvious abnormality.

BINGWA (E Bragg) - Became detached from the body of the field throughout. When questioned regarding the performance rider E Bragg could offer no excuse.

Race 6 | **CHAMPION NZ 2YO SWORD OF STATE 1300 metres**

KIRRACONI (V Colgan) - Slow to begin (3L).

SHE'S APPLES (C Lindsay) - Began awkwardly.

SILVERINA (T Mitchell) - Slow to begin. Made contact with the running rail for a distance when crowded to the inside of POVERTY BAY near the 900 metres, then continued to race in restricted room for a distance.

POVERTY BAY (K Asano) – Checked and forced inwards near the 900 metres when THE BOOGEYMAN shifted inwards. POVERTY BAY continued to over-race for a distance when racing in restricted room and awkwardly placed near the heels of THE BOOGEYMAN.

TAZIMOTO (E Bragg) - Raced four wide without cover throughout.

REGAL DUCHESS (K Hannan) - Raced three wide without cover throughout.

FIERCE FLIGHT (O Bosson) - Held up passing the 350 metres shifting outwards across heels to obtain clear running.

A Goindasamy (THE BOOGEYMAN) - Admitted a charge in that he permitted his mount to shift inwards when not sufficiently clear of POVERTY BAY which was checked and forced inwards crowding SILVERINA near the 900 metres. After considering submissions the Adjudicator suspended A Goindasamy's licence to ride in races from the conclusion of racing on Saturday 20 August up to and including racing on Sunday 28 August, 5 national riding days.

Race 7 | **NOEL REED MEMORIAL 1400 metres**

FOLLOW YOUR DREAMS (K Hannan) - Began awkwardly. Lay out rounding the final turn.

PRISE DE FER (T Mitchell) - Began awkwardly.

DAYTONA RED (K Asano) – Slow to begin.

MANRICO (J Fawcett) - Had to be steadied near the 1200 metres when FOLLOW YOUR DREAMS shifted inwards when not fully clear.

SCARFI (A Goindasamy) - Raced three wide without cover throughout.

BRANDO (O Bosson) – When questioned regarding the performance rider O Bosson advised that the gelding had felt to be a beaten runner near the 600 metres and was unable to offer any excuse. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

ZELENSKI (A Lawson-Carroll) – Lay in under pressure passing the 200 metres having to be straightened by its rider.

K Hannan (FOLLOW YOUR DREAMS) – Issued with a warning after permitting her mount to improve forward where there was insufficient room to do so then shifting inwards when not fully clear of MANRICO near the 1200 metres.

Race 8

FIRECO 1600 metres

SONOFABUTCHER (O Bosson) – Restrained in the early stages to obtain cover from the outside barrier.

RISING DREAM (D Prastiyou) - Began awkwardly. Over-raced near the 1200 metres having to be restrained.

FLY MY WEY (J Kamaruddin) - Over-raced through the early and middle stages. Raced three wide without cover for the majority of the race.

SHOCKATILLATAP (E Bragg) - Steadied when briefly placed in restricted room passing the 1000 metres. Held up early in the straight having to shift ground to obtain clear running near the 200 metres.

PRINCE OF TALLIN (K Asano) – Raced wide throughout.

MACS (J Fawcett) - Lay out rounding the final turn.

MOLLYS GAME (A Lawson-Carroll) – Lay in under pressure over the concluding stages.
