RACE COMMENTS

Race 1 | **SPORTZ BAR/JOLT COFFEE HOUSE MAIDEN HURDLE (3000 metres)**

AONGATETE EXPRESS (C Case) – Crowded shortly after the start losing ground.

CHEEKY AZZ (G Walsh) – Raced fiercely in the early stages shifting inwards when being restrained to take cover.

HOLD MY BEER (D Parker) – Steadied shortly after jumping the first fence when CHEEKY AZZ which was racing fiercely to its outside, shifted in when being restrained. Rider lost the use of his iron after jumping the second fence when unbalanced, regaining it after approximately 100 metres.

ARGYLL (S Phelan) - Jumped indifferently and was retired from the event entering the back straight. When questioned S Phelan considered something amiss with the gelding's action. Underwent a post-race veterinary examination which did not reveal any obvious abnormality. Connections advised they would monitor the gelding over the coming days and report any finding to Stewards.

MR FAHRENHEIT (R Leech) – Improved onto the heels of the tiring MONBEAU after jumping the final fence needing to shift inwards abruptly inconveniencing MAJOR TOM passing the 100 metres.

MAJOR TOM (H McNeill) – Inconvenienced passing the 100 metres.

ZION HILL (E Farr) - Rider advised the mare had hung outwards throughout.

Race 2	PIONEER BRAND PRODUCTS/MURDOCH CONTRACTING MAIDEN HURDLE (3000 metres)

QUAFF (M Cropp) – Slow away settling at the rear. Retired from the event near the 1400 metres. When questioned M Cropp reported the gelding failed to hit out at any stage. Lost the off front plate during the running. Underwent a post-race veterinary examination which did not reveal any abnormality.

SOIREE (T Moki) – Over-raced in the early part after the saddle had slipped forward placing the rider at a disadvantage. Retired from the event after jumping the fence near the 1600 metres.

TAHUROA HEIGHT (M Roustoby) - Jumped the fence near the 2000 metres awkwardly.

DES DE JEU (P Matthews) - Retired from the event near the 400 metres when well back and out of contention.

GO MICKEY (S Karnicnik) – Retired from the event in the back straight on the last round.

JAKAMA KRYSTAL (K Joyce) – Landed awkwardly on jumping the last fence.

Race 3	4 SQUARE/DICKIE DIRECT HURDLE (3000 metres)

There was a slight delay to the start of this race with the bridle of HEY HAPPY being attended to.

HEY HAPPY (D Parker) – Jumped the first fence awkwardly.

AIGNE (M Roustoby) - Over-raced through the early and middle stages.

KAJINO (N Downs) - Jumped the fence near the 1900 metres awkwardly with the rider becoming unbalanced. Lost the left near front plate during the running.

Race 4	FOREST 360/ULTRA SCAN STEEPLECHASE (4000 metres)

BLANCO BAY (M Cropp) - Retired from the event near the 1700 metres. Underwent a post-race veterinary examination which found the gelding to be lame in the off foreleg. When questioned rider advised he had felt something was amiss and retired the gelding from the event. Connections were advised that a veterinary clearance would be required prior to racing next.

RED RACKET (G Walsh) - Retired from the event near the 800 metres.

HE'S RIC (D Parker) – Retired from the event near the 400 metres.

TELL ME MORE (S Karnicnik) - Retired from the event after jumping the fence near the 800 metres.

RAUCOUS (S Phelan) - Jumped the second to last fence awkwardly.

DONARDO (H McNeill) – Jumped the last fence awkwardly.

S Phelan (RAUCOUS & PASSWORD) - Issued with a minor infringement for failing to make the contracted weight on RAUCOUS and PASSWORD (Race 8) and was fined \$100.

S Fannin (KIDDO) - Admitted a charge of using his whip in three consecutive strides on his mount KIDDO inside the final 100 metres with the Adjudicator imposing a fine of \$600.

Race 5 | **SANDFORDS CARRIERS/PJ & DL CONTRACTING MAIDEN HIGHWEIGHT (1400 metres)**

LA CAPITA (L Douglas) - Rider L Douglas was dislodged in the parade ring and declared fit to ride after being examined by St John Ambulance personnel. Late scratched at 2.52 pm after refusing to load. Connections were advised the mare would be required to barrier trial on two occasions to the satisfaction of Stewards prior to racing next.

LOVE ME MOST (H McNeill) – Began awkwardly settling at the rear.

MY MAN'S BACK (S Fannin) - Began awkwardly.

MY ZOI (E Farr) – Over-raced through the middle stages.

Race 6 | **TOTAL FREIGHT HIGHWEIGHT (1400 metres)**

GOBUYIT (S Karnicnik) - Reared and dislodged its rider in the parade ring and was examined by the veterinarian and cleared fit to race. Rider S Karnicnik was uninjured. Held up final bend.

OFFENDED (S O'Malley) - Raced ungenerously through the middle stages.

SHOWBOURNE (E Farr) - Lay out over the concluding stages.

SEQUOIA DAWN (L Douglas) - Raced greenly in the home straight needing to be straightened on several occasions.

G Walsh (HARRY HARRISON) - Issued with a warning after using his whip in two consecutive strides on his mount HARRY HARRISON in the home straight with Stewards taking into account his clear recent record with regard to any breach of this whip rule.

Race 7 | **MOORE MARKHAMS/AMATEUR RIDERS RACE (2200 metres)**

MAGIC WONDER (C Sharp) - Began awkwardly.

BEAUDACEA (S Malki) - Slow away.

ECHO BAY (L Kennedy) - Began awkwardly.

CHOLULA (T Mercer) - Began awkwardly.

Race 8 | **TREADWELL GORDON HIGHWEIGHT (2200 metres)**

PESO (C Case) - Began awkwardly.

PASSWORD (S Phelan) - Slow away.

SPEED CALL (S Karnicnik) - Over-raced in the early stages.

ESTABLISHMENT (Sam O'Malley) - When questioned the rider could offer no excuse other than the gelding may be feeling the effects of recent racing. Underwent a post-race veterinary examination which did not reveal any abnormalities. Connections advised that consideration will be given to freshening gelding.
