In Race 7 Stewards granted permission for D Turner to ride 1kg over the carded weight.

SUPPLEMENTARY

RACE COMMENTS

Race 1 **DAFFODIL DAY GIVE GENEROUSLY 2100M**

UMUTAH LAD (D Turner) – Reared at the start losing ground. When questioned regarding performance rider advised the gelding had hung inwards throughout the running.

JAN'S GIANT (F Lazet) – Slow to begin.

SOIREE (K Hercock) – Slow to begin. Raced keenly through the early and middle stages. When questioned regarding performance rider could offer no excuse. Underwent a post-race veterinary inspection which revealed no abnormalities.

CRIMEA (B Rogerson) – Raced ungenerously through the early and middle stages.

ESCALADE (S O'Malley) – Lay in under pressure over the concluding stages.

Race 2 **LOCKWOOD HOMES TARANAKI 1200M**

CHERRY ROSE (A Bohorun) – Began awkwardly. Over raced through the early and middle stages. When improving on to heels had to be briefly steadied, shifting out passing the 600 metres.

JHADIRA (J Mudhoo) – Slow to begin.

GUNDAHAR (T Allan) – Raced keenly through the early and middle stages. When questioned into performance rider could offer no excuse. Underwent a post-race veterinary inspection which revealed no abnormalities.

WHAT A CHARMA (S O'Malley) – Over raced through the early and middle stages. Held up rounding the bend having to shift outwards to avoid GUNDAHAR which was tiring, was then again held up entering the final bend and unable to obtain clear running until near the 200 metres.

LITTLE MISS ZED (M Hudson) – Raced three wide without cover. Lay out 650 metres.

PASHAMALA (B Rogerson) – Had to steady when becoming awkwardly placed on the heels of ALLY RAT who was dictated wider by LITTLE MISS ZED which lay outwards passing the 650 metres.

ALLY RAT (K Hercock) – Raced wide without cover throughout. Dictated wider 650 metres.

Race 3 **TAB NZ NO DEDUCTIONS, NO SUPRISES 1400M**

SHE'S MISS GEVIOUS (M Hudson) – Slow to begin.

GOBUYIT (L Allpress) – Slow to begin.

MINNIE MOUSE (F Lazet) – Raced wide throughout.

HAPPY TAV (A Mudhoo) – Held up approaching the final bend and was unable to obtain clear running until early in the final straight.

L Allpress (GOBUYIT) – Reminded of her obligations when weighing in 0.4 kgs under her weigh-out weight.

Race 4	HEATHER D, YAXLEY MARTINEZ 1600M

ARICINA (A Bohorun) – Crowded shortly after the start losing ground.

WAY ABOVE (S O'Malley) – Slow to begin. Buffeted and checked, losing ground 300 metres.

QUEEN OF SPADES (L Allpress) – Ducked out abruptly having to be corrected by its rider shortly after the start. Commenced to race ungenerously throughout the early and middle stages. When questioned regarding performance rider advised the mare had blinkers applied for the first time and had pulled throughout the running which proved to be a difficult ride.

RUN LIKE BOO (J Mudhoo) – Raced three wide without cover throughout. Buffeted then hampered, losing ground 300 metres.

RONIN POROTENE (M Hudson) – Raced wide without cover from the 800 metres.

B Rogerson (RUA ROCKS) – Admitted a charge of careless riding in that she permitted her mount to shift outwards near the 300 metres making contact with WAY ABOVE which was forced on to RUN LIKE BOO with both these runners being buffeted and unbalanced losing ground, with WAY ABOVE being checked. After hearing evidence and viewing footage the Adjudicator found the charge proved and suspended B Rogerson's licence to ride in races from the conclusion of racing on 31st August up to and including racing on 9 September 2022, 5 national riding days.

Race 5	GARDEN EDGE 1600M

NIGHTFALL (L Sutherland) – Began awkwardly losing ground. Raced ungenerously through the early and middle stages.

POROTENE DUNDEE (M Singh) – Began awkwardly losing ground. Ran below market expectations and when questioned, Trainer F Auret advised he was disappointed with the mare's performance and will be reassessing POROTENE DUNDEE'S racing career.

FABULOUS NANCY (L Douglas) – Slow to begin. Lay out under pressure throughout the final straight.

Race 6	DEBBY MCKENZIE 1600M

ALMERAKI (F Lazet) – Began awkwardly losing ground.

GNASHER (L Douglas) – Began awkwardly. Commenced to race ungenerously getting its head up on a number of occasions when being restrained to obtain cover in the early stages.

SHOWSHANELLE (L Allpress) – Raced keenly in the early and middle stages. When questioned into performance rider advised after having a good run throughout, the mare had failed to respond when placed under pressure. Underwent a post-race veterinary examination which revealed no abnormalities.

RONI (K Hercock) – Ducked in abruptly having to be corrected by its rider early in the final straight.

BELLE ADAIRE (S O'Malley) – When questioned regarding the performance of the favoured runner S O'Malley advised the mare failed to handle the heavy 10 track conditions.

V Jalalkuncha (MONKEY TOWN) – Admitted a charge in that he struck his mount MONKEY TOWN 8 times prior to the 100 metre mark. The Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing 28 August until the conclusion of racing on 7 September 2022, 5 national riding days.

V Jalalkuncha (MONKEY TOWN) - Reminded of his obligation in regard to using an action that raises his arm above shoulder height.

Race 7	WYNDSPALLE 2 GRANGEWILLIAM STUD 8TH OCTOBER 2100M

INTERLLECTUS (L Sutherland) – Slow to begin.

ITISWHATITIS (B Rogerson) – Restrained behind runners shortly after the start to obtain cover.

ZABDI (L Douglas) – When questioned regarding the performance rider advised the gelding had never travelled well throughout the running and had been disappointing. Underwent a post-race veterinary examination which did not reveal any abnormalities.
