Race 7 WAIPA EARTHWORKS MAIDEN 2000

JACK HAMMER (J Riddell) – Co-trainer S Ritchie advised Stewards the stable was satisfied with the post-race condition of the gelding, however, has now been sent for a freshen up. S Ritchie further advised the stable may apply some gear changes prior to JACK HAMMER'S next raceday start.

Whangarei Racing Club - Saturday, 20 August 2022

Race 7 NOEL REED MEMORIAL 1400 metres

BRANDO (O Bosson) – Trainer M Walker reported to Stewards that upon return to the stable BRANDO was found to have some swelling to the left fore fetlock and is undergoing exercise on a water walker.

RACE COMMENTS

Race 1 | **BANQUO 3YO 1200**

TREATY OF PARIS (O Bosson) – Began very awkwardly shifting inwards abruptly badly hampering TE AWA BAY which lost ground. Raced ungenerously in the early stages and shifted outwards to avoid heels near the 900 metres hampering WILD NIGHT. Raced erratically when being steadied over the concluding stages. When questioned regarding performance rider advised that the colt had proven a difficult ride throughout. Trainer M Walker advised that TREATY OF PARIS would now be gelded and sent for a spell. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

TE AWA BAY (J Riddell) - Badly hampered leaving the barriers losing ground. Held up near the 250 metres having to be steadied to avoid the heels of BUBBLES AWAIT.

WILD NIGHT (J Kamaruddin) - Restrained in the early stages to obtain cover after jumping from the outside barrier. Hampered near the 900 metres.

ARBY (S Weatherley) - Jumped away awkwardly.

MONTEZUMA (R Beemud) - Raced three wide without cover throughout.

BUBBLES AWAIT (K Asano) - Had difficulty obtaining clear running until shifting outwards across heels near the 150 metres.

R Elliot (MONTEZUMA) - Admitted a charge in that he was unable to make the contracted weight on MONTEZUMA. After considering submissions the Adjudicative Committee suspended R Elliot's licence to ride in races from the conclusion of racing on Saturday 27 August up to and including racing on Sunday 4 September, 5 national riding days.

Race 2 | **ARDROSSAN 1200**

BETTE DAVIS EYES (K Hannan) - Stood in the barriers when the gates opened missing the start by a considerable distance. Connections were advised the mare would be required to barrier trial prior to racing next. Lost the near hind plate during the running.

APERITIF (T Mitchell) – Bounded at the start.

SAGAN (J Fawcett) - Began awkwardly losing ground.

MUSTANG VALLEY (E Nicholas) - Restrained from a wide draw to obtain cover in the early stages.

WHOSHE'S GIRL (M Sanson) - Over-raced for a distance near the 900 metres becoming awkwardly placed near the heels of ACTING OUT.

FLAT TRACK BULLY (J Kamaruddin) - Raced three wide without cover.

Race 3 | **TIVACI 2100**

RENEGADE FIGHTER (M Kareem) - Crowded leaving the barriers when runners to either side shifted ground, clipping a heel and blundering.

SHOCKING PENNY (M Sanson) - Jumped away awkwardly. Improved onto the heels of LOT OF ZEES then striking a heel and blundering badly near the 800 metres dislodging rider M Sanson. M Sanson was immediately attended to by St John Ambulance personnel and found to have been briefly unconscious with no other apparent injuries other than minor soreness in a shoulder. M Sanson was stood down from her remaining rides and is required to provide a medical clearance prior to riding next.

Race 4 | **OCEAN PARK 2400**

RED 'N' SURF (C Barnes) - Late scratched on veterinary advice at 1.30 pm after being injured when being transported to the course.

CHARRED (J Kamaruddin) - Began awkwardly losing ground.

TAUMALOLO (L Allpress) - Crowded shortly after the start losing ground.

LOCALLY SAUCED (E Nicholas) - Crowded and buffeted passing the 2100 metres when OUTRIVAL shifted ground inwards.

HEY HEY HEY (E Bragg) - Raced wide without cover for the majority of the race.

ATA RANGI (K Hannan) – Raced three wide without cover rounding the first bend before improving to sit outside the leader near the 1200 metres.

MISS ONAKI (O Bosson) – When questioned regarding performance rider was unable to offer any excuse. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

V Colgan (OUTRIVAL) - Issued with a warning after angling his mount inwards after the start making contact with LOCALLY SAUCED near the 2100 metres.

Race 5 | **SAVABEEL 1400**

ANGELICA (J Kamaruddin) -Declared a late scratching on veterinary advice at 1.44 pm after being injured when being transported to the course.

ROSE CRESCENT (L Allpress) – Slow to begin then had to be steadied away from heels shortly afterwards when runners to either side shifted ground.

DARCI'S QUEEN (K Asano) - Shifted outwards abruptly at the start crowding outside runners. Hampered near the 1200 metres.

HOARD THE BORUBON (C Barnes) - Crowded at the start losing ground.

CAKEBYTHEOCEAN (T Harris) - Crowded at the start. Got its head up when being steadied to avoid the heels of PULLYOURSOCKSUP near the 1200 metres and shifting inwards hampering DARCI'S QUEEN.

ENCIERRO (C Grylls) – Crowded at the start. When questioned regarding performance rider advised that the gelding had been a beaten runner prior to entering the final straight and had not felt comfortable in today's track conditions.

PULLYOURSOCKSUP (T Newman) – Raced three wide without cover for the majority of the race.

WINDSPEED (S Weatherley) - Was not persevered with over the final 150 metres dropping out to finish last. When questioned regarding performance rider was of the opinion that the mare may be feeling the effects of recent racing. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

T Newman (PULLYOURSOCKSUP) - Issued with a warning after permitting her mount to shift inwards near the 1200 metres when not fully clear of CAKEBYTHEOCEAN.

N Parmar (DEEBEE ZAPOWER) - Admitted a charge in that he struck his mount DEEBEE ZAPOWER six times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$250.

Race 6 | **WAIKATO STUD FOXBRIDGE PLATE (1200 metres) (Group 2)**

DEMONETIZATION (S Spratt) – Slow to begin. Lost the right front plate during the running.

GREEN LUCK (J Laking) - Slow to begin.

WINNING FOR ALL (C Grylls) - Raced three wide without cover for the majority of the race.

AERO DE PARIS (J Kamaruddin) – Over-raced when being restrained passing the 1000 metres. Returned to the enclosure with blood present in both nostrils. Underwent an endoscopic examination which confirmed the gelding to have bled. AERO DE PARIS shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian. The stable representative advised that the gelding was now likely to be retired.

TAVI MAC (R Elliot) - Made contact with IMPERATRIZ entering the final straight passing the 400 metres.

IMPERATRIZ (O Bosson) – Contacted entering the final straight passing the 400 metres.

ONE MORE TIME (J Fawcett) - When questioned regarding performance rider advised that the mare was making abnormal breathing noises. Underwent a post-race endoscopic examination which found trace amount of mucus in the trachea along with inflammation in the epiglottis and larynx.

Race 7 | **NOVERRE MILE (1600 metres)**

OUR BO JAKK (J Kamaruddin) - Began awkwardly contacting ARJAY'S FLIGHT losing ground as a result.

WHOSHE'S BOY (M Kareem) – Crowded shortly after the start losing ground.

KERMALINA (S Spratt) – Raced wide without cover throughout.

RISING RISK (T Harris) - Blundered near the 350 metres.

THE HIGH PRIESTESS (O Bosson) - When questioned regarding performance rider advised that the mare had failed to handle today's track conditions.

Race 8 | **SUPER SETH MILE (1600 metres)**

CHASE 'N' GOLD (K Asano) - Slow to begin.

LAVITA VISHVI (L Allpress) - Crowded at the start losing ground.

ELECTRIC TIME (R Beemud) - Began awkwardly shifting inwards crowding LAVITA VISHVI.

CAPTAIN OUMUAMUA (J Riddell) - Began awkwardly.

HIT THE SWITCH (V Colgan) - Raced wide throughout.

TICKLE ME ALMO (C Barnes) - Was inclined to lay in under pressure in the final straight.

AURORA DOLCE (N Parmar) – When questioned regarding performance rider advised that the mare had not felt entirely comfortable in today's track conditions.

EVA CHIARA (C Grylls) - Eased down over the final 250 metres when well beaten with rider C Grylls being of the opinion there may be something amiss with the mare. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality. Trainer S March indicated that the mare was now likely to be retired.

E Nicholas (MAHOMES) - Admitted a charge in that she struck her mount MAHOMES six times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$500.
