Race 8 NELSON PINE/IPL MARKETING/MARSHALL WATERPROOFING 1550

C Dell (IFFIE SHOWS) - Was charged with a breach of Rule 638(3)(g)(i) in that he struck his mount six times prior to the 100 metre mark. Due to C Dell having left the course, this matter was heard at today's Matamata race meeting with the Adjudicator imposing a fine of \$500.

RACE COMMENTS

Race 1 COLCHESTER ENGINEERING LTD MAIDEN 2000

GINGEE (M Kareem) - Underwent a pre-race veterinary examination due to the gelding having not raced since August 2020 and was cleared fit to race. Slow to begin.

SPHINX (L Satherley) - Slow to begin.

SOUND OF SILENCE (C Grylls) - Crowded leaving the barriers.

TURNAROUND (T Harris) - Began awkwardly.

MIDNIGHT (J Fawcett) – Jumped inwards leaving the barriers crowding the inside runner.

ABU DHABI (E Nicholas) – Raced three wide without cover in the early stages.

AMARILLO SLIM (K Hannan) – Raced wide without cover throughout.

FLIGHT PLAN (J Kamaruddin) - Performed below market expectations. When questioned, the rider could offer no explanation.

Race 2 A P GOLLAN REGISTERED PROPERTY VALUERS MAIDEN 1050

CAITLYNS WISH (A Lawson-Carroll) - Slow to begin. Raced wide in the early stages. Over-raced when three wide in the early stages. Briefly contacted passing the 200 metres.

STERNLAND (N Parmar) - Slow to begin.

BELIEVE IT OR NOT (C Barnes) - Slow to begin.

HERO WORSHIP (T Harris) - Had to be steadied off the heels of POUR THE WINE near the 900 metres.

KAI (J Kamaruddin) – Over-raced in the early and middle stages. Lay in under pressure near the 200 metres making brief contact with CAITLYNS WISH. J Kamaruddin was advised to exercise greater care.

PIER (S Weatherley) - Made the bend near the 800 metres awkwardly.

Race 3 WRIGHTWAY BUILDERS LTD MAIDEN 1200

FIREBUG (D Danis) - Slow to begin.

ROSIE BRAHMA (T Newman) – Crowded at the start. Held up for clear running entering the final straight. Rider T Newman reported that the mare had hung throughout.

KIVA HAN (R Beemud) - Shied and ducked out near the 1000 metres.

FASHION A BELLE (K Hannan) - Raced wide without cover throughout.

GENTIAN BLUE (J Fawcett) - Contacted passing the 275 metres.

T Newman (ROSIE BRAHMA) - Issued with a warning after directing her mount outwards near the 275 metres making contact with GENTIAL BLUE.

Race 4 NZB INSURANCE PEARL SERIES MAIDEN RACE 1400

PRINCESS KEIRA (A Lawson-Carroll) - Slow to begin.

MOONLIGHT SHADOW (K Hannan) – Raced wide in the early stages.

RIDGEVIEW MANDY (J Fawcett) - Over-raced in the early stages.

BLUSHING BEAUTY (N Parmar) – Held up for clear running rounding the final bend and early in the final straight.

KICHEKO SANA (C Dell) - When questioned regarding the performance rider C Dell reported that the mare would be better ridden with cover in future. Blundered near the 50 metres. Underwent a post-race veterinary examination which found the mare to be mildly lame in the right hind leg and a superficial abrasion to the right hock.

E Nicholas (ON THE PROWL) - Issued with a warning after permitting her mount to shift inwards when not sufficiently clear of SMOOTH PASS which was checked near the 350 metres. When considering this matter, the Stewards were mindful that the films were somewhat inconclusive also taking into account that KICHEKO SANA lay out rounding the final bend which may also have been a contributing factor.

T Newman (SHEJENGAR) - Admitted a charge of careless riding in that she permitted her mount to shift inwards when not sufficiently clear of MOONLIGHT SHADOW which was checked near the 150 metres. After considering submissions the Adjudicator imposed a suspension of T Newman's licence to ride in races from the conclusion of racing on Sunday 28 August up to and including racing on Wednesday 7 September, 5 national riding days.

Race 5 COMAG LIMITED 1600

THE MIGHTY SPAR (J Kamaruddin) - Began awkwardly.

MILLENNIUM DAWN (L Satherley) - Began awkwardly.

MRS BIG (C Dell) - Slow to begin.

TAVI WITH ME (R Beemud) - Slow to begin.

NASHA RIVA (A Lawson-Carroll) – Raced three wide without cover.

TEEN TITAN (T Mitchell) – Raced wide in the early stages.

INDEEM (E Nicholas) - Performed below market expectations. When questioned, rider E Nicholas reported that in her opinion the gelding was feeling the effects of recent racing.

Race 6 SUPER LIQUOR MATAMATA 1400

FERDINAND (M Kareem) - Slow to begin. Held up for clear running rounding the final bend.

GO YOU GOOD THING (C Grylls) – Raced wide without cover in the early stages.

SHIVERS (T Mitchell) - Slow to begin.

FIERCE FLIGHT (J Kamaruddin) – Over-raced approaching the 1100 metres.

OUR JASMINE (N Parmar) – Performed below market expectations. When questioned, rider N Parmar reported that in his opinion the mare would prefer looser track conditions.

ANNA GRACE (D Danis) - Lost the near hind plate during the running.

Race 7 K R BELL ELECTRICAL MAIDEN 1400

MR FANTASTIC (E Nicholas) – Began awkwardly inconveniencing THELASTINVINCIBLE. Briefly held up rounding the final bend.

THELASTINVINCIBLE (J Kamaruddin) – Crowded leaving the barriers losing ground.

SLY VOLTAGE (A Lawson-Carroll) - Began awkwardly.

DIAMOND JAK (N Parmar) - Began awkwardly.

BADGERINGDAWITNESS (T Mitchell) - Raced wide without cover.

OCEAN CRUIZER (K Hannan) - Raced wide without cover.

BEYOND SKIES (S Weatherley) – Performed below market expectations. When questioned, rider S Weatherley could offer no explanation. Underwent a post-race veterinary examination which revealed the colt to be mildly lame left hind and a small abrasion on the right coronet. Stewards will follow up with connections in the coming days.
