### RACE COMMENTS

Race 1 CAMBRIDGE EQUINE HOSPITAL 1550

**ALWAYS MORE** (J Kamaruddin) – Got its head up in the early stages when being restrained to obtain cover after jumping from the outside barrier.

**RUSAVY** (J Fawcett) - Over-raced when leading in the early stages.

**PAPENHUYZEN** (J Riddell) - Performed below market expectations. When questioned, rider could offer no explanation.

**UP 'N' GONE** (O Bosson) – Held up for clear running near the 400 metres.

**HARMONIA** (A Lawson-Carroll) – Finished last. When questioned, rider could offer no explanation.

**Race 2** | **GROUP ONE TURF BAR MAIDEN 1550**

**GLORIFIED** (V Colgan) – Crowded leaving the barriers.

**THE UPRISING** (N Parmar) – Restrained in the early stages to obtain cover after jumping from the outside barrier.

**SADLER'S CHICK** (S Weatherley) – Restrained in the early stages to obtain cover. Held up for the majority of the final straight, only obtaining clear running in the final 50 metres.

**FREEWHEELIN** (T Mitchell) - Raced ungenerously shortly after leaving the barriers proving a difficult ride in the early stages when shifting outwards. Raced three wide without cover throughout.

**GAME PATROL** (J Riddell) - Inconvenienced when FREEWHEELIN shifted outwards near the 1400 metres.

**SAVAGE LOVE** (C Barnes) - Over-raced in the early stages having to be firmly restrained off the heels of the leader. When questioned, rider advised that she was disappointed with the mare's effort. Underwent a post-race veterinary examination which did not reveal any abnormalities.

**Race 3** | **ASCOT FARM MAIDEN 1300**

**SHANLORD** (S Weatherley) – Began awkwardly shifting out, crowding the outside runner.

**GINGE 'N' WINGE** (N Parmar) – Crowded at the start losing ground. Steadied off heels for a distance passing the 850 metres. Made the final bend awkwardly, shifting wider on the track.

**KAAPTIVATING** (J Fawcett) – Began awkwardly losing ground.

**HUTSON** (B Rogerson) - Restrained in the early stages to obtain cover after jumping from the outside barrier.

**STRONG** (V Colgan) - Performed below market expectations. When questioned, rider advised that he was disappointed with the gelding's effort.

**Race 4** | **ENIGMA FARM MAIDEN 1300**

**CELEBRITY'S BEAU** – Late scratched at 7.35 am on veterinary advice. Trainer A Forbes was advised that a veterinary clearance would be required prior to the gelding racing next.

**WOODHALL ROAD** (S Weatherley) – Contacted at the start. Raced four wide from the 900 metres.

**WOLFGANG** (S McKay) - Began awkwardly making contact with WALTER MITTY.

**WALTER MITTY** (D Danis) – Crowded at the start losing ground. Raced three wide without cover throughout.

**LOUISIANA MAN** (O Bosson) - Shifted outwards at the start contacting WOODHALL ROAD. Restrained to take cover passing the 1000 metres.

**HIGH END** (E Nicholas) - Over-raced for a distance near the 800 metres.

**Race 5** | **MANNING INVESTMENTS LTD 1300**

**DUNEAGLE** (J Kamaruddin) - Slow to begin. Briefly held up entering the final straight. Shifted outwards approaching the 100 metres inconveniencing ROC CHA.

**FELIX FAURE** (E Bragg) – Crowded then restrained off heels shortly after the start. Raced wide without cover throughout.

**LA ROMANEE** (S Weatherley) – Over-raced and made the bend near the 1000 metres awkwardly. Rider reported that the gelding had proved a difficult ride and hung outwards throughout.

**ROCKBANK** (L Satherley) - Over-raced having to be steadied passing the 1000 metres.

**KEATS** (E Nicholas) - Over-raced in the early stages before improving to race outside the leader near the 900 metres. Received veterinary attention following the race which found the gelding to have a cut to the right nostril.

**ROC CHA** (B Rogerson) – Inconvenienced approaching the 100 metres when DUNEAGLE shifted outwards. J Kamaruddin was advised to exercise greater care in similar circumstances.

**S Spratt** (CORISTA) - Shown the replay and spoken to advisedly for using her whip on a runner that was out of contention.

**Race 6** | **GARRARD'S HORSE HOUND 970**

**TINY TERROR** (K Hannan) - Bounded at the start making contact with MINI MYSTIC and as a result shifted outwards crowding RIP VAN GOGH. Raced wide throughout.

**RIP VAN GOGH** (O Bosson) - Slow to begin then further hampered by TINY TERROR which after beginning awkwardly, shifted out. Performed below market expectations. When questioned, rider reported that the gelding would be better suited to racing over further distance.

**MINI MYSTIC** (A Goindasamy) - Crowded and checked losing ground near the 700 metres.

**LAKEMAN** (J Fawcett) - Crowded and dictated inwards near the 700 metres.

**GIACOMO** (S McKay) - Steadied off heels approaching the 700 metres.

**B Rogerson** (OTTAVIO) - Defended a charge of careless riding in that she permitted her mount OTTAVIO to shift in when not clear crowding and checking MINI MYSTIC in onto LAKEMAN who was crowded passing the 700 metres. After considering submissions the Adjudicator found the charge proven and imposed a suspension of B Rogerson's licence to ride in races from the conclusion of racing on Saturday 10 September up to and including racing on Saturday 17 September, 5 national riding days.

**Race 7** | **MANELINE CAMBRIDGE MAIDEN 970**

**WHATS THE ONE CODE** (E Nicholas) - Underwent a pre-race veterinary examination at the barrier and was cleared fit to start after completing a circuit of the track during its preliminary. Lay outwards near the 600 metres.

**WEY TOO COOL** (J Kamaruddin) – Became fractious in its barrier and was removed to undergo a veterinary examination before being cleared fit to start.

**CRACKERJACK** (S Weatherley) – Slow to begin. Raced wide throughout.

**SACRED SATONO** (A Lawson-Carroll) - Got its head up when racing keenly near the 700 metres.

**Race 8**

**SHAW'S WIRE ROPES 2000**

**AQUILO** (O Bosson) - Slow to begin. Raced below market expectations. When questioned, rider could offer no explanation. Underwent a post-race veterinary examination which did not reveal any abnormalities.

**NITRATE** (J Riddell) – Began awkwardly. Over-raced in the early and middle stages.

**CHAMINGAFFAIR** (D Danis) – Raced three wide without cover throughout.
