RACE COMMENTS

Race 1 | **STALLION TENDER OPEN NOW MAIDEN 1200m**

J Burrows (LUCYBELLE) - Issued with a warning after presenting LUCYBELLE with incorrect gear (blinkers instead of side winkers).

BOOT IT SCOOTER (K Chowdhoo) - Jumped away awkwardly losing ground.

LUCYBELLE (T Jonker) - Jumped away awkwardly and raced ungenerously in the early stages getting its head up and losing ground.

SEVEN ELEVEN (K Williams) - Crowded leaving the barriers losing ground. Held up for the majority of the run home with the filly only obtaining clear running over the concluding stages.

MUMBO JUMBO (T Moseley) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

PORTMAN STREET (M Taylor) - Raced keenly through the early and middle stages. Raced three wide without cover.

AORANGI ASSASSIN (G Jogoo) - Disappointed for a run having to be steadied to avoid the heels of MY TARNZ GIRL which lay in under pressure with AORANGI ASSASSIN having to shift out hampering MISS AMADI approaching the 100 metres.

MY TARNZ GIRL (B Murray) - Lay in under pressure having to be corrected by its rider approaching the 100 metres.

MISS AMADI (R Mudhoo) - Hampered near the 100 metres.

BODYGUARD (W Papier) - Held up over the concluding stages.

Race 2 | **NZB INSURANCE PEARL SERIES RACE 1200m**

SOOO DUSTY (S Wynne) - Jumped away awkwardly getting its head up.

OUR ROSETTE (K Chowdhoo) - Checked when crowded for room to the inside of SOOO DUSTY near the 800 metres. Co-trainer Michael Pitman advised he had been disappointed with the mare's run and would be looking to apply blinkers at the next start.

S Wynne (SOOO DUSTY) - Admitted a charge of careless riding in that she permitted her mount SOOO DUSTY to shift inwards when not sufficiently clear of OUR ROSETTE which was crowded and checked near the 800 metres. After considering submissions the Adjudicator imposed a suspension of S Wynne's licence to ride in races from the conclusion of racing on Saturday 3 September until the conclusion of racing on Sunday 11 September, 5 national riding days.

Race 3 | **SPEIGHT'S SUMMIT ULTA ON TAP MAIDEN 1600m**

THEUNNAMEDFEELING (T Jonker) - Slow to begin.

CEEDOUBLEJAY (G Jogoo) - Slow to begin.

COVARCHI (K Mudhoo) - Over raced in the early and middle stages. When the pace eased near the 1100 metres improved onto heels shifting out forcing PERIA'S LEGACY wider on the track. Lay in under pressure throughout the home straight having to be corrected by its rider.

PERIA'S LEGACY (S Muniandy) - Raced keenly in the early and middle stages. Forced wider passing the 1100 metres. Improved onto heels shifting out near the 900 metres and was then obliged to race three wide without cover for the remainder of the race.

J Kamaruddin (ILLCIT MISS) - Shown film footage of his ride in the presence of the riding mentor and advised he must not ease the pace in a manner that puts other riders in difficulty.

Race 4 | **CUP WEEK TICKETS ON SALE 1 SEPTEMBER 1600m**

KENKI (B May) - Slow away.

LADY MODENA (R Mudhoo) - Slow away. Over raced in the middle stages.

BELASARD (D Montes de Oca) - Slow away. When questioned regarding performance rider could offer no excuse. Underwent a post-race veterinary inspection which revealed a slow recovery rate. Stewards will follow up with trainer M Pitman in the coming days.

SOMBRA DEAMOR (M Taylor) - Jumped away awkwardly from the outside barrier then being restrained in the early stages to obtain cover.

LA COFRADIA (C Barnes) - Raced keenly in the middle stages.

ROAD TO REIGN (T Jonker) - Raced three wide without cover.

DOC MARTYN (J Laking) - Shifted in under pressure having to be corrected by its rider over the concluding stages.

HEY SOUL SISTER (G Jogoo) - Checked when briefly crowded to the inside of DOC MARTYN near the 40 metres.

Prior to the authorisation of dividends trainer R Holmes (HEY SOUL SISTER) viewed Stewards' film footage before electing not to proceed with a protest.

J Laking (DOC MARTYN) - Issued with a warning after permitting his mount DOC MARTYN to shift inwards when not sufficiently clear of HEY SOUL SISTER which was briefly crowded and checked near the 40 metres.

J Laking (DOC MARTYN) - Issued with a warning for using an action that raises the rider's arm above shoulder height.

M & M Pitman (TAIL LIGHTS) - Issued with a warning after presenting TAIL LIGHTS without the notified gear (side winkers).

BELLE OF THE BALL (J Kamaruddin) - Jumped away awkwardly losing ground.

BEAU ROUGE (J Laking) - Jumped away awkwardly then further hampered when crowded.

TAIL LIGHTS (K Chowdhoo) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

INDI NINDY (T Jonker) - Over raced in the middle stages being allowed to improve forward to sit three wide without cover outside the leader rounding the bend.

THE ARCTIC BLAST (K Williams) - Over raced when being restrained then making the bend near the 800 metres awkwardly.

MARCHING ON TAVI (D Montes de Oca) - When questioned regarding performance, rider could offer no excuse. Underwent a post-race veterinary inspection which revealed a foot abscess to the right front coronary band. Stewards will follow up with trainer J Blackadder in coming days.

T Jonker (INDI NINDY) - Admitted a charge in that she struck her mount INDI NINDY 6 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a fine of \$250.

STRIKE FORCE (C Carmine) - Jumped away awkwardly.

JACK KNOWS BEST (C Barnes) - Had to be firmly restrained for a distance when improving onto the heels of STRIKE FORCE passing the 1200 metres.

ZOULUMINOUS (J Kamaruddin) - Lay out under pressure over the concluding stages.

C Carmine (STRIKE FORCE) - Shown film footage of his ride and advised he must not ease the pace in a manner that puts other riders in difficulty.

KUDOS DE SOTHYS (S Wynne) - Jumped away awkwardly making contact with MR RAFIKI. Had to be firmly restrained when over racing passing the 1200 metres.

MR RAFIKI (R Mudhoo) - Contacted leaving the barriers. When questioned regarding performance, rider advised in his opinion the gelding would benefit from a step up in distance. Underwent a post-race veterinary inspection which revealed no abnormalities.

FAME SHINES (B May) - Restrained to obtain cover shortly after the start after jumping from the outside barrier. When questioned regarding performance, rider advised the gelding had been making abnormal breathing noises. Underwent a post-race veterinary inspection which revealed no abnormalities.

GEMSTONE JEWELS (G Jogoo) - Made the bend near the 900 metres awkwardly.
