### RACE COMMENTS

#### Race 1 | DAVE HOSKIN CARRIERS MAIDEN 2Y7O 800

**DANCING DREAM** (K Hannan) - Began awkwardly and was checked and lost ground on the point of the home turn. J Fawcett (SHOW ME THE MONEY) was charged with careless riding in that she permitted her mount to shift ground when not clear and after a defended hearing the Adjudicative Committee dismissed the charge.

**SHERICKA** (A Mudhoo) - Slow away.

**DAPPER** (D Turner) - Made the bend awkwardly and was inclined to shift wider on the track.

<p><b>SAILOR JACK</b> (J Riddell) - Slow away.</p> <p><b>BRUCIE</b> (M Singh) - Slow away. Raced wide throughout.</p> <p><b>HALLELUJAH BROTHER</b> (D Turner) - Over-raced in the early stages.</p> <p><b>DIVINE SPIRIT</b> (K Hercocock) - Over-raced in the early and middle stages.</p> <p><b>TRAMORE</b> (T Taiaroa) - Held up in the home straight over the final stages.</p>	
<b>Race 3</b>	<b>TAKE IT EASY TOURS 2040</b>
<p><b>KICK ON</b> (L Sutherland) - Slow away. Contacted the rail near the 1200 metres, becoming momentarily unbalanced. Rider advised the gelding was unsuited to today's track conditions and was never comfortable at any stage so was not persevered with over the final stages. Underwent a post-race veterinary examination including an endoscopy, which did not reveal any obvious abnormality. Trainer K Myers will monitor the gelding over coming days and report any anomalies to Stewards.</p> <p><b>MONDORANI</b> (K Hannan) - Slow away.</p> <p><b>TIMBERLAKE</b> (L Allpress) - Over-raced in the early stages.</p> <p><b>THIS LADY ROCKS</b> (A Mudhoo) - Raced wide through the middle stages.</p>	
<b>Race 4</b>	<b>THE O'LEARYS FILLIES STAKES 3YO 1200</b>
<p><b>ROCABABY</b> (A Mudhoo) - Began awkwardly bumping <b>DIAGON ALLEY</b>. Wide throughout.</p> <p><b>DIAGON ALLEY</b> (A Goindasamy) - Bumped at the start. Made the final bend awkwardly. Finished towards the rear. When questioned rider advised the filly had failed to handle today's track conditions.</p> <p><b>WESSEX</b> (D Turner) - Over-raced through the middle stages. Lay out over the concluding stages.</p>	
<b>Race 5</b>	<b>WANGANUI INSURANCE BROKERS 1340</b>
<p><b>DEERFIELD</b> (K Hannan) - Began awkwardly.</p> <p><b>SECRET AMOUR</b> (C Grylls) - Slow away.</p> <p><b>CONOR O'CEIRIN</b> (M Singh) - Over-raced in the early stages. Raced wide throughout.</p> <p><b>RACED EVENS</b> (D Turner) - Bumped with <b>PUKE PARK</b> near the 200 metres.</p> <p><b>PUKE PARK</b> (A Mudhoo) - Bumped with <b>RACED EVENS</b> near the 200 metres.</p> <p><b>M Singh</b> (CONOR O'CEIRIN) - Spoken to advisedly with regard to his whip use in the home straight.</p>	
<b>Race 6</b>	<b>HS DYKE WANGANUI GUINEAS 1340</b>
<p><b>CARIGNAN</b> (A Mudhoo) - Restrained to the rear at the start.</p> <p><b>BOASTING</b> (D Turner) - Over-raced, having to be steadied passing the 1100 metres.</p>	

**SOPHMAZE** (L Allpress) - Over-raced through the middle stages. Lay in under pressure over the concluding stages.

**M Singh** (SHEEZ DOMINANT) - Admitted a charge under Rule 638(2) in that he made a celebratory gesture prior to the winning post. After hearing submissions, the Adjudicative Committee imposed a fine of \$300.

**Race 7** | **HAPPY 40<sup>TH</sup> CRAIG MCKINNON MAIDEN 1600**

**CELTIC JAZZ** (F Lazet) - Slow away. Over-raced in the early stages.

**ELUSIVE JOULE** (K Hercocock) - Had to steady when racing in restricted room passing the 1400 metres.

**EL ATTITUDE** (E Nicholas) - Over-raced in the early stages.

**Race 8** | **ST JOHNS CLUB 1600**

**SIDEBAR** (K Hercocock) - Connections requested and were given permission for SIDEBAR to race without blinkers, due to weather conditions.

**SPLODGE** (C Dell) - Underwent and passed a veterinary examination prior to the start, after becoming fractious in the birdcage.

**WINNIE ROSE** (L Allpress) - Very slow away.

**KINGFISHER LAD** (H Schofer) - Over-raced passing the 1000 metres.

**VAN DIESEL** (A Lawson-Carroll) - Became awkwardly placed and steadied when racing to the outside of INVISIBLE SPIRIT (D Turner) passing the 500 metres when that runner shifted out when only marginally clear. Finished well back. A Lawson-Carroll advised VAN DIESEL was never comfortable in today's track conditions.

**D Turner** (INVISIBLE SPIRIT) - Issued with a warning after allowing his mount to shift out passing the 500 metres when only marginally clear of VAN DIESEL.
