Race 5 SAVABEEL 1400

ENCIERRO (C Grylls) – Stable Foreman R Mildon advised Stewards the stable was satisfied with the post-race condition of ENCIERRO and it is their intention to continue on with the gelding's current preparation.

WINDSPEED (S Weatherley) – Stable Foreman R Mildon reported to Stewards that on Monday 29 August, WINDSPEED underwent a veterinary examination which included blood tests with results showing WINDSPEED to have a slight virus in her blood. R Mildon further advised it is the stables intention to continue on with the mare's current preparation.

Race 6 WAIKATO STUD FOXBRIDGE PLATE (1200 metres) (Group 2)

ONE MORE TIME (J Fawcett) – Trainer S Ralph advised Stewards he was satisfied with the post-race condition of the mare, however, in his opinion the mare may have held her breath throughout the running. S Ralph further advised he may look to apply a nose band prior to ONE MORE TIMES'S next race day start.

Race 8 SUPER SETH MILE (1600 metres)

EVA CHIARA (C Grylls) – Stable Foreman R Mildon advised Stewards EVA CHIARA has now been retired from racing.

Race 7 K R BELL ELECTRICAL MAIDEN 1400

BEYOND SKIES (S Weatherley) – Stable Foreman R Mildon advised Stewards the stable was satisfied with the post-race condition of BEYOND SKIES, however, has now been sent for a spell.

RACE COMMENTS

Race 1 THE PAKURANGA HUNT LANDOWNERS MAIDEN HURDLE (2800 metres)

TOGA PARTY (N Downs) - Slow to begin. Retired from the race prior to the third last fence when well beaten.

SOIREE (G Walsh) - Slow to begin. Had to be firmly restrained to avoid the heels of TAHUROA HEIGHT which shifted inwards when not fully clear near the 2600 metres. Over-raced in the early stages. Jumped the fence near the 1100 metres awkwardly dislodging its rider who was uninjured.

QUAFF (E Farr) - Slow to begin (5L). Misjudged the first fence. prior to the third last fence when well beaten.

SOUND OF SILENCE (K Joyce) - Slow to begin.

LOCHWINNOCH (D Parker) – Landed awkwardly after jumping the first fence. Over-raced through the early and middle stages.

TWEEDLEDEE (P Matthews) – Raced wide in the early stages. Ran down its fences in the early stages. Hit the fence near the 150 metres on the first occasion.

TAHUROA HEIGHT (M Roustoby) – Put in a poor jump at the final fence.

K Joyce (SOUND OF SILENCE) – Spoken to and reminded of her obligation to retire her mount from the race once out of contention.

M Roustoby (TAHUROA HEIGHT) - Issued with a warning after allowing his mount to shift inwards near the 2600 metres when not fully clear of SOIREE.

S Phelan (SULIMAN) - Fined \$200 under the minor infringement schedule after failing to make the weight on SULIMAN. S Phelan was permitted to ride SULIMAN 1kg over with no suitable replacement rider available.

Race 2	MARAMARUA HUNT MAIDEN HURDLE (2800 metres)
<p>OBRIGADO (D Parker) – Crowded at the start. Landed awkwardly after jumping the fence near the 900 metres.</p> <p>MONBEAU (T Moki) - Slow to begin. Put in a poor jump at the first fence.</p> <p>ODYSSEUS (P Matthews) - Restrained in the early stages after jumping from the outside barrier. Hampered jumping the final fence.</p> <p>BROTHER MAX (R Leech) - Over-raced in the early stages.</p> <p>UPCLOSENOUGH (C Case) – Rider briefly lost the use of his right iron after jumping the second fence. Retired from the race prior to jumping the final two fences.</p> <p>SPEED CALL (S Karnicnik) - Ran down the fourth fence.</p> <p>FABULOUS NANCY (M Cropp) – Retired from the race prior to the third last fence when well beaten.</p> <p>VERRY FLASH (S Fannin) – Ran down the final fence hampering ODYSSEUS.</p> <p>PESO (S Phelan) - Retired from the race prior to jumping the final two fences. When questioned regarding performance rider advised that he had felt there may have been something amiss with the gelding. Underwent a post-race veterinary examination did not reveal any significant abnormality other than a small laceration to the left hind leg. Co-trainer P Nelson indicated that PESO would now be retired.</p> <p>H McNeill (SWIFT) - Spoken to and reminded of his obligation to retire his mount from the race once out of contention.</p> <p>T Moki (MONBEAU) - Fine \$100 under the minor infringement schedule after adding a pad to her gear which she had not weighed out with.</p>	
Race 3	THE PAKURANGA HUNT SESQUICENTENNIAL OPEN HURDLE (3200 metres)
<p>BANKS ROAD (E Farr) - Slow to begin. Contacted by RINGBOLT near the 1700 metres. Misjudged the final fence.</p> <p>AIGNE (M Roustoby) - Jumped indifferently throughout. Retired from the race near the 900 metres when well beaten. Trainer N O’Dowd advised that the gelding would now be retired from racing.</p> <p>NEDWIN (A Kuru) – Shifted outwards prior to jumping the final fence.</p> <p>DR HANK (S Phelan) – Jumped the final fence awkwardly.</p> <p>N Downs (KAJINO) - Admitted a charge in that he used his whip in three consecutive strides on his mount KAJINO over the concluding stages. After considering submissions the Adjudicator imposed a fine of \$500.</p>	
Race 4	FLAIR AMATEUR RIDERS 2200
<p>MAGNANIMOUS MAN (A Clapperton) - Began awkwardly. Raced three wide without cover through the middle stages.</p> <p>LEICA WARRIOR (S Van Lierde) – Raced wide in the early and middle stages.</p> <p>FORTUNE WINGS (S Mynott) - Over-raced near the 1000 metres.</p>	

BEAUDACEA (M Northcott) – Commenced to give ground from the 600 metres.

ENCHANTED ELLE (L Phelan) – Raced keenly in the early stages. Lay out under pressure in the final straight.

Race 5 | **WAIKATO HUNT MAIDEN STEEPLECHASE (3900 metres)**

ZION HILL (R Leech) – Slow to begin (3L). Jumped its fences high in the early stages losing ground. Retired from the race near the 1000 metres.

MR FAHRENHEIT (H McNeill) – Jumped the second fence awkwardly. Put in a poor jump at the fourth fence. Misjudged the first of the double landing awkwardly.

LOCALLY SAUCED (G Walsh) - The surcingle broke early in the race being discarded by the rider prior to the fourth fence. Following the race G Walsh weighed in 0.2 kgs underweight, well within the 0.5 kg tolerance permitted under the rules.

INTERLECTUS (S Fannin) – Blundered on landing after jumping the first fence in the centre. Landed awkwardly after jumping the final fence.

MAGIC CANNON (E Farr) – Ran down the final fence.

Race 6 | **CLC PAKURANGA HUNT CUP (4800 metres)**

NO TIP (S Phelan) – Slow to begin.

DES DE JEU (P Matthews) – Slow to begin. Made contact with ARGYLL jumping the first of the double on the first occasion. Came together with SUFFICE TO SAY jumping the first in the centre on the second occasion, becoming unbalanced. Hit the fence near the 1200 metres then again put in a poor jump at the fence near the 1000 metres dislodging its rider who was uninjured.

DONARDO (H McNeill) - Slow to begin. Became detached from the body of the field through the early stages.

SUFFICE TO SAY (R Leech) – Landed awkwardly after jumping the first of the double on the first occasion. Over-raced through the middle stages. Came together with DES DE JEU jumping the first in the centre on the second occasion, becoming unbalanced. Landed awkwardly after jumping the fence near the 1000 metres dislodging its rider who was uninjured.

MAGIC WONDER (A Kuru) – Ran down the first fence of the stand double with a round to go. Put in a poor jump at the fence near the 1200 metres on the first occasion. Misjudged the final fence.

ZAMORA (M Cropp) – Put in a poor jump at the fence near the 1500 metres losing ground. Retired from the race prior to the final fence when well beaten.

KEYBOARD WARRIOR (G Walsh) – Briefly hampered by the riderless horse near the 1000 metres.

ZEDMAN (N Downs) - Retired from the race prior to the fence near the 800 metres when well beaten.

ARGYLL (C Case) – Retired from the race prior to the fence near the 800 metres when well beaten.

S Fannin (KIDDO) - Admitted a charge in that he failed to make the contracted weight on KIDDO. After considering submissions the Adjudicator imposed a fine of \$200. S Fannin was permitted to ride KIDDO 1.5 kgs overweight due to no suitable replacement rider being available.

CALL ME EVIE (C Lindsay) – Jumped away awkwardly making firm contact with MR UNIVERSE.

MR UNIVERSE (S Spratt) – Contacted leaving the barriers.

BELLE EN ROUGE (J Kamaruddin) - Slow to begin then being further hampered by MISS ELLA which jumped outwards. When questioned regarding performance rider advised that the mare had got further back than intended, and in his opinion would be better suited over more ground.

ROC CHA (R Beemud) - Began awkwardly. Awkwardly placed near heels 850 metres.

MR UNIVERSE (S Spratt) - Raced wide in the early stages. Lay in under pressure in the straight.

MISS ELLA (C Barnes) - Raced wide without cover.

ILLUMINATION (A Goindasamy) – Made the bend near the 850 metres awkwardly with ROC CHA then becoming awkwardly placed inside that runner’s heels.

AMARELINHA (N Parmar) – When questioned regarding performance rider was of the opinion that the mare would be better suited over more ground.

ON THE BUBBLES (O Bosson) - When questioned regarding performance rider advised that the gelding had weakened appreciably over the concluding stages and had been disappointing. Trainer M Walker advised that the gelding would undergo a range of veterinary checks on return to the stable which Stewards will follow up with in the coming days.

Following the running of this race O Bosson advised that he was feeling unwell and after being examined by the course Doctor was stood down from his remaining rides, being replaced per the schedule above.

TINY (K Hannan) - Hampered leaving the barriers.

VADARA (C Barnes) - Slow to begin.

THE PROPHET SPEAKS (E Nicholas) - Hampered leaving the barriers.

SHEJENGAR (L Satherley) - Jumped inwards at the start hampering inside runners.

CRAVING (S Weatherley) – Restrained to obtain cover in the early stages after jumping from the outside barrier.

MYSTERY BAR (A Goindasamy) – Jumped away awkwardly. Over-raced in the early stages when being restrained off heels.

BUBALINA (T Taiaroa) - Raced wide without cover.

GHAZZAH (S McKay) – Hung outwards rounding the final turn hampering SHEEZE A BREEZE near the 450 metres and forcing REGAZZO over extra ground.

REGAZZO (J Riddell) – Raced three wide without cover. Hampered by GHAZZAH which made the final bend awkwardly.

SHEEZE A BREEZE (E Bragg) - Hampered near the 450 metres by GHAZZAH which made the final bend awkwardly.

MISCREANT (M McNab) - When questioned regarding performance rider was unable to offer any excuse. Underwent a post-race veterinary examination which found the gelding to have a slow recovery with further veterinary tests recommended. Stewards will follow up with the stable in the coming days.

Race 9 | **WADE EQUINE COACHES 1500**

LE SABLIER (M Sanson) - Slow away.

OSAKA (C Grylls) – Slow away.

CORK (T Taiaroa) - Jumped away awkwardly.

VERNANME (C Lindsay) – Jumped away awkwardly.

BULLYBROOK (E Bragg) - Raced wide without cover throughout. Lay in under pressure in the straight.

MARRONI (K Hannan) - Severely crowded and checked near the 250 metres.

LOWRY (S Spratt) - Raced three wide without cover. Severely crowded and checked near the 250 metres.

MASETTO (S Weatherley) - Severely crowded and checked near the 250 metres.

DAWN PARADE (M Hashizume) - When questioned regarding performance rider was unable to offer any tangible excuse, advising that the gelding felt to have switched off when placed under pressure in the straight.

C Grylls (OSAKA) - Issued with a warning after weighing in 0.6 kgs in excess of the weight at which he weighed out.

N Parmar (PERFECT SCENARIO) – Admitted a charge of careless riding in that he permitted his mount to shift outwards when not sufficiently clear crowding MARRONI, LOWRY and MASETTO which were all checked near the 250 metres. After considering submissions the Adjudicator suspended N Parmar’s licence to ride in races from the conclusion of racing on Saturday 10 September up to and including racing on Friday 23 September, 9 national riding days.

Due to the nature of today’s breach and N Parmar’s record of careless riding breaches, he was directed by the Stewards to meet with an NZTR appointed rider skills review panel under the provisions of Rule 343.

Race 10 | **BRIDGES INSURANCE SERVICES 1400**

EL COOLIO (D Prastiyou) - Slow to begin.

SHE’S APPLES (C Lindsay) - Jumped away awkwardly hampering OFFENDED. When questioned regarding performance rider was of the opinion that the mare had failed to handle today’s track conditions. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

OFFENDED (N Parmar) - Hampered leaving the barriers.

EAGLE TARZAN (K Hannan) - When questioned regarding performance rider advised that the gelding had travelled well but had failed to finish the race off and had been making abnormal breathing noises. Stewards will follow up with the stable in coming days.

POVERTY BAY (V Colgan) - When questioned regarding performance rider advised that the gelding had travelled well enough until placed under pressure early in the straight where it had been quickly beaten and had been disappointing. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.
