BELASARD (D Montes de Oca) – Co-trainer Mr Matthew Pitman advised Stewards, the stable was satisfied with the post-race condition of the gelding, however, BELASARD will now spend two weeks on the walker and will then continue on with his preparation.

Race 5 ELLIE STOKES TRUST CHARITY DINNER 22/09 MAIDEN 1400m

MARCHING ON TAVI (D Montes de Oca) – Trainer Mr J Blackadder advised Stewards he was satisfied with the postrace condition of MARCHING ON TAVI, however, has now been sent for a brief spell.

RACE COMMENTS

Race 1 GRAND CASINO MAIDEN 820m

MINI MOET (B May) - Slow away. Lay inwards under pressure in the straight.

PORTMAN STREET (S Toolooa) - Raced greenly in the early stages. Raced greenly passing the 500 metres when placed in restricted room having to be steadied.

ELSIE MAY (C Barnes) - Raced three wide without cover throughout.

MISS MIRANDA (G Jogoo) - Lay out rounding the final bend.

PEARL OF DELGATIE (C Campbell) - Held up early in the straight.

BELLA ROSE (K Chowdhoory) - Rider reported that in his opinion the filly would be better suited over more ground.

C Campbell (PEARL OF DELGATIE) - Issued with a warning after weighing in 0.5kg in excess of the weight at which he had weighed out.

Race 2 POSITIVE SIGNS MAIDEN 1200m

MOVIE STAR (T Comignaghi) - Slow away after being fractious in the barriers (4L). The connections advised that the mare was now likely to be retired.

MOOLOOLABA (K Williams) - Over raced in the middle stages.

ROWAN ROAD (C Campbell) - Raced greenly having to be corrected on a number of occasions throughout the run home.

Race 3 DUNEDIN CITY FORD 1600m

ANJAMEME (T Moseley) - Slow away.

ITS SO EASY (K Mudhoo) - Slow away. Angled outwards across heels to obtain clear running approaching the 200 metres.

THE GROWLER (K Chowdhoory) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

VEE TWELVE (W Papier) - Raced three wide without cover throughout. Rider W Papier was spoken to regarding his riding tactics in the presence of the riding mentor and in particular why he had opted to remain three wide when the gelding was travelling well in the run down the back straight. W Papier agreed with Stewards that he had erred on this occasion and was advised that he would be expected to show better judgement in future.

Race 4

PROPERTY BROKERS DUNEDIN MAIDEN 1600m

DIAMONDSAREFOREVER (L Callaway) – Bucked dislodging its rider during the preliminary who was uninjured. DIAMONDSAREFOREVER was quickly recaptured being passed fit to run after undergoing a veterinary inspection at the start. Trainer S Muniandy was advised that the mare is now required to trial to the satisfaction of a Stipendiary Steward prior to racing again with Mr Muniandy indicating that the mare would no longer be pursued with from his stable.

CHOICE MOMENT (K Williams) - Slow away.

REINEDELARIVIERE (S Khetoo) - Slow away. Had to be steadied to avoid the heels of WEE TADHG which shifted inwards shortly after the start when not fully clear.

LEA (S Toolooa) - Shifted inwards abruptly crossing the junction onto the course proper near the 1400 metres. When being corrected shifted outwards hampering WEE TADHG which in turn shifted outwards hampering REPO MAGIC. Briefly hampered passing the 50 metres.

WEE TADHG (K Kwo) - Hampered near the 1400 metres. Over raced through the middle stages. Raced greenly under pressure in the run home having to be corrected then hampering LEA passing the 50 metres.

REPO MAGIC (T Moseley) - Hampered near the 1400 metres.

K Kwo (WEE TADHG) - Issued with a warning after permitting his mount WEE TADHG to shift inwards after the start when not fully clear of REINEDELARIVIERE.

S Khetoo (REINEDELARIVIERE) – Admitted a charge in that he struck his mount REINEDELARIVIERE six times prior to the 100 metre mark with the Adjudicator imposing a suspension of his license to ride in races from the conclusion of racing today Friday 9 September until the conclusion of racing on Saturday 17 September 2022 (6 national riding days).

S Khetoo (REINEDELARIVIERE) - Admitted a charge in that he struck his mount with the whip forward of the shoulder on one occasion near the 350 metres with the Adjudicator imposing a fine of \$250.

S Khetoo (REINEDELARIVIERE) – Given his further breaches of the whip rules today S Khetoo was further directed to again meet with the Rider Skills Review Panel as per the provisions of Rule 343.

Race 5 THANKS TERRY & DEB FROM GREEN ISLAND GRIZZLIES 1600m

REGAL GIRL (T Moseley) - Jumped away awkwardly losing ground.

JESSIE'S ROCK (C Barnes) - Slow away.

KITTY POWER (S Khetoo) - Steadied when becoming awkwardly placed inside the heels of FAME SHINES near the 800 metres hampering BOB MARLIE.

BOB MARLIE (K Mudhoo) - Hampered near the 800 metres.

EAVESDROP (L Callaway) - Raced ungenerously through the middle stages getting its head up on a number of occasions.

VALYRIAN (R Mudhoo) - Had to be eased off heels passing the 800 metres when there was a slight easing of the pace.

FAME SHINES (B May) - Lay in throughout the run home.

S Muniandy (BACK HUT) - Issued with a warning after weighing in 0.5kg in excess of the weight at which he had weighed out.

Race 6 NELLIES BAR AND RESTAURANT 1200m

GALLERY GIRL (C Barnes) - Slow away. Was unable to obtain clear running in the final straight.

CHEERS (Y Atchamah) - Crowded shortly after leaving the barriers. Trainer J Gordon advised in her opinion the mare didn't seem to hit out freely and will be receiving chiropractic work. Stewards will follow up with Miss Gordon in the coming days.

DOUBLE PROSPERITY (B May) - Over raced in the middle stages. Briefly crowded passing the 800 metres.

KERANY (S Muniandy) - Over raced in the early to middle stages.

LA OPCION (D Montes de Oca) - Raced three wide without cover.

OUR TEDDY BOY (C Campbell) - Lay in throughout the run home.

KAPALKA (K Chowdhoory) - Was held up rounding the final bend and in the early stages of the run home.

Trainer J Gordon (CHEERS) - Issued with a warning after presenting CHEERS in blinkers rather than the notified visor blinkers.

Race 7 NZB INSURANCE PEARL SERIES RACE MAIDEN 1200m

KOTIRO TERE (J Laking) - Had to be steadied approaching the 800 metres when placed in restricted room to the inside of ANAHERA which was improving forward. T Moseley was advised to exercise greater care. Also hampered as a result was LUCYBELLE. Inconvenienced approaching the 100 metres.

LUCYBELLE (W Papier) - Hampered near the 800 metres.

LA FROX (R Mudhoo) - Shifted outwards across heels to obtain clear running approaching 100 metres inconveniencing KOTIRO TERE.

S Khetoo (GO LOTTE) - Taking into account his clear record under this section of the rule was issued with a warning after striking his mount in two consecutive strides near the 50 metres.

W Papier (LUCYBELLE) - Admitted a breach of Rule 638(1)(d) in that he permitted his mount to shift inwards when not sufficiently clear of HALLOWING COMMANDS which was hampered near the 600 metres. After hearing submissions the Adjudicator suspended W Papier's licence to ride in races from the conclusion of racing today until conclusion of racing on Friday 16 September, five national riding days.

J Laking (KOTIRO TERE) - Issued with a warning after weighing in 0.5kg in excess of the weight at which he had weighed out.
