Race 8 THE PATRON'S 1400
MISCREANT (M McNab) – Stable representative R Mildon reported to Stewards MISCREANT underwent a veterinary examination on Thursday 8 September which included a blood test, with no abnormalities being detected. R Mildon further advised the gelding has now been sent for a spell.
Race 10 BRIDGES INSURANCE SERVICES 1400
EAGLE TARZAN (K Hannan) - Trainer A Forsman advised Stewards he was satisfied with the post-race condition of EAGLE TARZAN, however, will look to drop the gelding back in distance.

RACE COMMENTS
Race 1 HARCOURTS JUST RENTALS 1400
SEVEN TWENTY (M Hashizume) – Began awkwardly making contact with AQUA MAN at the start.
KID ROC (A Goindasamy) - Raced wide in the early to middle stages.

REGAL DUCHESS (E Nicholas) – Brushed the running rail near the 1100 metres when racing keenly. Held up rounding the final bend.

YELLOW JERSEY (J Fawcett) - Had to be restrained off the heels of **OUR WONDERLAND** near the 1100 metres when racing keenly.

ELYSIAN FIELDS (K Hannan) - Steadied to avoid heels passing the 850 metres then raced ungenerously for a distance.

AQUA MAN (A Lawson-Carroll) - Steadied when placed in restricted room passing the 850 metres.

A Goindasamy (KID ROC) - Issued with a warning after permitting his mount to shift in when not sufficiently clear of **AQUA MAN** which was forced inwards resulting in **ELYSIAN FIELDS** having to be steadied to avoid heels passing the 850 metres.

Race 2 | **HARCOURTS TAI TOKERAU CUP 2200**

DREAM FORCE (M Hashizume) - Began awkwardly.

Race 3 | **LION 1100**

DOUBLE O' SEVEN (E Nicholas) - Crowded leaving the barriers having to be steadied by its rider, losing ground. Steadied approaching the 50 metres when placed in restricted room to the inside of **LA ROMANEE** (K Hannan) which shifted inwards when not fully clear. K Hannan was advised to exercise care in similar circumstances. Underwent a post-race veterinary examination which did not reveal any abnormality.

DIVINE SAVA (C Barnes) - Began awkwardly. Lay out rounding the final bend and early in the straight. Held up for clear running until near the 250 metres.

MAGIC TOUCH (A Goindasamy) – Began awkwardly shifting inwards making contact with **DOUBLE O' SEVEN**, becoming unbalanced.

TAZIMOTO (E Bragg) - Slow to begin. Raced four wide without cover throughout.

LA ROMANEE (K Hannan) – Raced three wide without cover throughout.

FIFITA (J Fawcett) - When questioned regarding the performance the rider advised that the gelding had made abnormal breathing noises throughout. Lost the near hind plate near the 900 metres. Underwent a post-race veterinary examination which did not reveal any abnormality.

E Nicholas (**DOUBLE O' SEVEN**) - Stewards questioned apprentice E Nicholas in the presence of riding mentor N Harris regarding her perceived lack of vigour in the early stages. E Nicholas explained that after receiving interference leaving the barriers the gelding had lost ground quickly. When she attempted to urge **DOUBLE O' SEVEN** passing the 850 metres the gelding had commenced to lay outwards rounding the bend. She further explained that she had been instructed to allow **DOUBLE O' SEVEN** to find its feet in the early stages. Stewards noted E Nicholas' explanation and advised that she would be expected to show better judgement in the future.

Race 4 | **HARCOURTS WAIPU MAIDEN 1200**

THE GOLDEN GOOSE (E Bragg) - Connections were advised that a warning would be placed against the filly's barrier manners after proving difficult to load. Slow to begin.

MISCHIEF MANAGED (K Hannan) - Began awkwardly.

PATRICIA (M Kareem) - Knuckled leaving the barriers. Held up rounding the final bend.

MATAI BAY (J Fawcett) – Restrained to obtain cover in the early stages after jumping from an outside barrier.

STUNGUN (C Barnes) - Raced wide in the early stages.

SULABELLA (L Satherley) - Raced keenly in the early stages then had to be firmly restrained after becoming awkwardly placed on heels approaching the 950 metres.

WHISKY MAC (A Goindasamy) - Raced keenly in the early and middle stages. Held up rounding the final bend. Rider reported that the saddle shifted shortly after the start placing him at a disadvantage.

MIGHTY BRIGHT (M Hashizume) - Had some difficulty obtaining clear running early in the final straight.

Race 5 | **MATHIAS & CURRIE INSURANCE 1400**

PROVENCE (A Goindasamy) – The left barrier gate opened slightly faster than the rest of the field. Stewards were satisfied that the filly had not gained an advantage from its barrier opening slightly faster. Restrained to obtain cover in the early stages after jumping from the outside barrier.

STONYBRECK (J Kamaruddin) - Restrained to obtain cover in the early stages after jumping from an outside barrier. Steadied after improving onto heels near the 800 metres.

Race 6 | **HARCOURTS FOR HOSPICE FILLIES & MARES 1600**

SILVERINA (L Satherley) - Trainer advised Stewards that the mare would be racing in season. Improved onto heels passing the 350 metres having to be steadied before shifting inwards to improve. When questioned regarding the performance the rider advised that the mare had been unsuited by the improved track conditions.

LA FLORA BELLE (J Kamaruddin) - Slow to begin.

DARCI'S QUEEN (N Parmar) – Began awkwardly.

MOIRAS TOWN (E Nicholas) - Raced three wide without cover throughout.

SPIRIT OF BAZ (K Hannan) - When questioned regarding the performance the rider could offer no excuse. Underwent a post-race veterinary examination which did not reveal any abnormality.

Race 7 | **HARCOURTS BREAM BAY 1600**

ALWAYS MORE (N Parmar) - Slow to begin.

C'EST UNE STAR (L Satherley) - Slow to begin. Hampered passing the 450 metres.

SHOCKATILLATAP (E Bragg) - Raced wide without cover throughout.

FINN MCCOOL (A Goindasamy) – Steadied when awkwardly placed on heels passing the 800 metres.

BOSCH (E Nicholas) - Forced wider passing the 450 metres.

FLY MY WEY (J Kamaruddin) - Forced wider passing the 450 metres.

SHE SPEEDS (J Fawcett) - When questioned regarding the performance the rider advised that the mare had never travelled comfortably throughout and had failed to respond when placed under pressure.

M Hashizume (MOLLYS GAME) – Issued with a warning after permitting his mount to shift outwards passing the 450 metres forcing BOSCH and FLY MY WEY outwards resulting in C’EST UNE STAR being hampered after becoming awkwardly placed on heels.

Race 8 | **DUNSTAN ACCUMULATOR 2200**

LORD POLONIUS (M Kareem) - Stood in the barriers when the gates opened losing ground (5L). Connections were advised that a warning would be placed against the gelding’s barrier manners.

I’M ALICE (J Fawcett) - Slow to begin.

RODOLFO (J Kamaruddin) - Slow to begin.

KHAN HUNTER (A Goindasamy) - Over-raced in the early stages when leading.

CURRENT SURGE (E Nicholas) - Raced wide in the early and middle stages.

CIAMBELLA (C Lindsay) - Held up for clear running throughout the final straight.

OUTRIVAL (D Prastiyou) – Had some difficulty obtaining clear running early in the final straight.

Race 9 | **RUAKAKA CHRISTMAS AT THE RACES DEC 14 1400**

GAGLIARDI (B Rogerson) - Began awkwardly.

TANNAHILL (E Nicholas) - Began awkwardly. Restrained in the early stages to obtain cover from an outside barrier.

EVER SO EASY (J Fawcett) - Crowded leaving the barriers.

CAKEBYTHEOCEAN (A Goindasamy) - Jumped outwards at the start crowding an outside runner. When questioned regarding the performance the rider advised that the gelding had been unsuited by the improved track conditions.

THE BUFFER (K Hannan) – Raced wide without cover throughout.

DIAMOND GIRL (L Satherley) - When questioned regarding the performance the rider advised that the mare had failed to handle today’s track conditions.
