RACE COMMENTS

Race 1 | **COLLIERS COMMERCIAL HAWKE'S BAY 2000**

SO GORGEOUS (T Tairaoa) - Began awkwardly then raced ungenerously in the early stages.

KHAFEEF (R Elliot) - Began awkwardly settling towards the rear. Over-raced in the early and middle stages. When questioned rider advised that after over-racing the gelding had little left at the finish and was unsuited to the heavy going.

CALL ME JACK (L Douglas) - Over-raced and had to be steadied passing the 1600 metres.

KAHU ROCK (J Riddell) – Became awkwardly placed passing the 1600 metres, shifting outwards bumping FAR SITE.

FAR SITE (M McNab) - Bumped passing the 1600 metres.

SHE'S SO RELIABLE (L Allpress) - Lay inwards becoming awkwardly placed on heels passing the 1200 metres.

TOBKAY (A Mudhoo) - Held up for a short distance rounding the home turn.

LATE TO THE PARTY (T Newman) - Held up for a short distance rounding the home turn.

ALJAY (L Sutherland) - Held up for a short distance rounding the home turn before gaining clear running near the 300 metres.

LITTLE JOE (O Bosson) - Performed below market expectations. Lay in under pressure over the concluding stages. Rider advised the gelding was making abnormal respiratory noises. A post-race veterinary examination did not reveal any obvious abnormality.

Race 2	SH CIVIL 1200

ELLE AYE LADY (S Spratt) - Began awkwardly hampering VESMART and PACE ATTACK. Raced wide without cover.

VESMART (L Allpress) - Hampered at the start.

PACE ATTACK (A Mudhoo) -Hampered at the start clipping a heel and blundering, losing ground and settling at the rear.

GOHUGO (K Hercock) - Over-raced and had to be steadied passing the 800 metres when racing in restricted room.

LASER'S FURY (C Grylls) - Began awkwardly. Finished towards the rear. When questioned rider advised the gelding had failed to handle today's track conditions.

MOVIN' ON (L Douglas) - Finished last. When questioned rider advised the mare was making abnormal respiratory noises. A post-race veterinary examination did not reveal any obvious abnormality.

K Hercock (GOHUGO) - Admitted a charge in that she struck her mount GOHUGO six times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.

Race 3	HASTINGS – HEART OF HAWKE'S BAY MILE 1600

MASTER BREWER (S Weatherley) - Slow away. When questioned rider advised the gelding had never travelled well. A post-race veterinary examination did not reveal any obvious abnormality.

TASCIONI (M McNab) - Lay inwards shortly after the start striking a heel of FATTORE OTTO and blundering, losing ground. Held up rounding the final turn.

PRINCE OF TALLIN (H Schofer) - Over-raced through the early stages.

Race 4	VET SERVICES EQUINE HAWKE'S BAY 1600
<p>CHASE (K Hercock) - Slow away.</p> <p>SEAJETZ (C Grylls) - When questioned regarding performance the rider was unable to offer any excuse advising that the gelding had failed to respond when placed under pressure and had been disappointing. A post-race veterinary examination did not reveal any obvious abnormality.</p> <p>C Dell (DEERFIELD) - Issued with a warning after using the whip in two consecutive strides on DEERFIELD approaching the 200 metres with Stewards taking into account his clear recent record.</p>	
Race 5	EL ROCA – SIR COLIN MEADS TROPHY 1200
<p>The start was delayed approximately 2 minutes after IROQUOIS FALLS (T Newman) broke through its barrier, cantering a short distance. Underwent a veterinary check and was cleared to start.</p> <p>FELLINI (C Grylls) - Jumped away awkwardly.</p> <p>WRITTEN UP (A Mudhoo) - Hampered leaving the barriers when TE AWA BAY jumped inwards. Further hampered shortly after the start.</p> <p>TE AWA BAY (S Spratt) - Jumped away awkwardly having to be steadied shortly after the start when IROQUOIS FALLS shifted inwards before being corrected by its rider. T Newman was advised to exercise greater care. WRITTEN UP was also hampered as a result.</p> <p>PIER (S Weatherley) - Began awkwardly hampering SOTIRIO.</p> <p>SOTIRIO (C Dell) - Hampered at the start, losing ground before losing contact with the body of the field through the middle stages. When questioned rider C Dell advised that the gelding had raced greenly and been inclined to hang but agreed with Stewards that he should have made a greater attempt to stay in touch. C Dell further reported that he had recommended a gear change to connections. Ducked outwards abruptly near the 300 metres, making contact with LORD COSMOS.</p> <p>DUNCAN CREEK (K Hercock) - Slow away. Over-raced through the early stages.</p> <p>DYNASTIC (O Bosson) - Raced three wide without cover throughout.</p> <p>LORD COSMOS (M McNab) - Bumped approaching the 300 metres. Finished towards the rear. When questioned regarding performance rider advised the gelding had never felt comfortable in today's testing track conditions. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.</p> <p>O Bosson (DYNASTIC) - Admitted a charge in that he struck his mount DYNASTIC seven times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$1,150.</p>	
Race 6	NZB READY TO RUN SALE TRAINERS SERIES 1300
<p>BALALAIKA (C Dell) - Restrained to the rear from its wide draw. Held up entering the final straight and did not obtain clear running until approaching the 200 metres, then being inclined to lay out under pressure.</p> <p>EREBUS (K Hercock) – Raced wide throughout.</p> <p>BEAN A PLEASURE (M McNab) - Disappointed for a run near the 250 metres when runners to either side shifted ground. Rider M McNab reported the gelding had not felt comfortable in today's track conditions.</p>	

HAKA BOOGIE (J Mudhoo) - Held up entering the final straight having to shift inwards across heels to obtain clear running near the 250 metres.

HOOTER (J Riddell) - Held up for clear racing room until near the 100 metres.

FARAGLIONI (V Colgan) - Held up until near the 100 metres.

Race 7

HB/PB THOROUGHBRED BREEDERS ASSN GOLD TRAIL STAKES (G3) 1200

HANALEI (V Colgan) - Underwent a pre-race veterinary examination and was cleared to start. Was eased down over the concluding stages when well beaten. When questioned rider advised that the filly had failed to handle today's testing track conditions. A post-race veterinary examination did not reveal any obvious abnormality.

SANGRITA (K Hercock) - Jumped away awkwardly. Over-raced in the middle stages having to be firmly restrained off heels going into the bend near the 850 metres. Had to be steadied when improving onto the heels of **PACIFIC DRAGON** near the 400 metres.

SANS DOUTE (O Bosson) - Jumped away awkwardly.

ARROWETTE (L Allpress) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

BEST SELLER (S Spratt) - Over-raced when being restrained in the early stages. Inclined to lay in under pressure in the straight.

PACIFIC DRAGON (M McNab) - Performed below market expectations. When questioned regarding performance rider advised that the filly had not felt entirely comfortable in today's track conditions but that nonetheless had been disappointing. A post-race veterinary examination did not reveal any obvious abnormality.

C Grylls (MAZZOLINO) - Admitted a charge in that he struck his mount MAZZOLINO 6 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$250.

Race 8

REMEMBER "JOOKY" 1200

VISHAKHA (A Mudhoo) - Began awkwardly losing ground at the start.

CROSS ROADS (T Taiaroa) - Restrained to rear from its wide draw to obtain cover.

ONE DREAM ONE SOUL (L Sutherland) - Began awkwardly.

BLISSFUL BELLE (S Spratt) - Raced wide without cover.

OLD TOWN ROAD (H Schofer) - Raced wide without cover throughout.

AMOSIA (K Hercock) - Had to be steadied when crowded for room by **PARADIGM SHIFT** (C Dell) going into the bend near the 850 metres.

M Sanson (DURHAM LAD) - Spoken to regarding her whip action inside the final 100 metres.

C Dell (PARADIGM SHIFT) - Issued with a warning after permitting his mount to shift inwards near the 850 metres when not fully clear crowding **AMOSIA**.

Race 9

TARZINO TROPHY (G1) 1400

IMPERATRIZ (O Bosson) - Began awkwardly hampering DARK DESTROYER and JODELIN GAL. Raced wide without cover throughout. Performed below market expectations. When questioned rider advised that the mare had failed to finish the race off over the concluding stages finding today's track conditions too testing. A post-race veterinary examination did not reveal any obvious abnormality.

DARK DESTROYER (L Allpress) - Hampered at the start losing ground.

JODELIN GAL (T Newman) - Hampered at the start losing ground.

LA CRIQUE (C Grylls) - Held up rounding the final turn before obtaining clear running passing the 350 metres.

D Danis (HELENA BABY) - Admitted a charge in that he struck his mount HELENA BABY seven times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.

L Allpress (DARK DESTROYER) - Admitted a charge in that she struck her mount DARK DESTROYER seven times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$4,250.

O Bosson (IMPERATRIZ) - An information was filed alleging a breach of Rule 638(3)(g)(i) in that he struck his mount IMPERATRIZ six times prior to the 100 metre mark. Due to O Bosson having left the course the matter was adjourned.

O Bosson (IMPERATRIZ) - An information was filed alleging a breach of Rule 606 in that he left the racecourse without gaining permission of the Stewards. Again, the matter was adjourned.

Race 10

CANCER SOCIETY – DONATE NOW 1400

MAKE TIME (L Sutherland) - Underwent a pre-race veterinary examination after contacting a rail in the parade ring and cleared to start. Hampered and unbalanced at the start when hindquarters contacted by DON'T ASK.

ESTEFANIA (A Mudhoo) - Very slow away.

DEEBEE ZAPOWER (V Colgan) - Over-raced in the early and middle stages, having to be steadied for a distance.

ENCIERRO (M McNab) - Began awkwardly bumping DON'T ASK. When questioned rider was unable to offer any excuse, advising that the gelding had travelled well but had been quickly beaten when placed under pressure near the 600 metres. A post-race veterinary examination did not reveal any abnormality.

DON'T ASK (L Allpress) - Unbalanced when contacted leaving the barriers and forced outwards onto the hind quarters of MAKE TIME.
