**SHEEZ DOMINANT** (M Singh) - M Singh admitted a charge under Rule 638(3)(g)(i) in that he used his whip excessively in the home straight and was fined the sum of \$900.

Race 1	<b>TONY WILSON / CHRIS GRACE MAIDEN 1650m</b>
<p><b>LOVE ME MOST</b> (L Douglas) - Began awkwardly settling towards the rear. Had to steady off heels into the first turn and continued to over race through the back straight.</p> <p><b>THE AUDACITY</b> (M Singh) -Checked going into the first bend when over-racing to the inside of BARZETTI and PERFECTIONIST. After questioning riders and viewing footage which proved inconclusive no further action was taken other than to advise all riders to exercise care. Continued to over race into the first turn and when being steadied went back onto LOVE ME MOST, which had to steady off that runners heels. Made the final bend awkwardly.</p> <p><b>BARZETTI</b> (H Schofer) – Held up rounding the final bend.</p> <p><b>PRINCESS BIDDY</b> (L Allpress) – Lay out over the concluding stages.</p> <p><b>RED ROAD</b> (A Mudhoo) – Restrained to the rear to gain cover shortly after the start.</p>	
Race 2	<b>TOTAL TRANSPORT / SUMMIT ELECTRICAL MAIDEN 1400m</b>
<p><b>EXTRAORDINAIRE</b> (M McNab) – Slow away.</p> <p><b>TITLED</b> (L Allpress) - Raced keenly early.</p> <p><b>WHAT A CHARMA</b> (K Hercock) - Had to be steadied abruptly passing the 800 metres when racing keenly.</p> <p><b>TWOOUTATHREE</b> (J Mudhoo) - Raced wide without cover throughout.</p> <p><b>SOVIET WONDER</b> (L Sutherland) – Blundered at the start. Had to be steadied when EXTRAORDINAIRE (M McNab) shifted ground shortly after entering the home straight. M McNab (EXTRAORDINAIRE) was advised to exercise greater care when shifting ground.</p>	
Race 3	<b>NZB INSURANCE PEARL SERIES MAIDEN 1400m</b>
<p><b>HERMES</b> (L Douglas) - Slow away.</p> <p><b>CEE ARE EL</b> (J Mudhoo) - Raced wide without cover throughout.</p> <p><b>TASER</b> (K Hercock) - Checked passing the 200 metres when BANARAHMA (L Allpress) shifted inwards when not sufficiently clear.</p> <p><b>MISS BELLE</b> (L Sutherland) - Over-raced having to be steadied passing the 900 metres.</p> <p><b>SOMEONE</b> (H Schofer) - Over-raced having to be steadied passing the 800 metres.</p> <p><b>L Allpress</b> (BANARAHMA) admitted a charge of careless riding in that she allowed her mount to shift in when not sufficiently clear of TASER passing the 200 metres which was checked. After hearing submissions the adjudicator suspended L Allpress's licence to ride from the conclusion of racing on 17 September up to and including 23 September - four national riding days.</p>	
Race 4	<b>WANGANUI MOTORS MAIDEN 1200m</b>
<p><b>FIZZY MOON</b> (M Hudson) - Began awkwardly.</p> <p><b>TENNESSEE ROSE</b> (V Jalalkuncha) - Hampered at the start when CAPITAL EXPENSE shifted inwards.</p>	

**CAPITAL EXPENSE** (E Nicholas) - Began awkwardly shifting inwards hampering runners to its inside.

**BLUE RATA QUEEN** (T Taiaroa) - Slow away.

**ARCADIAN IYNX** (H Schofer) - Over-raced through the early and middle stages.

**DIAL A PRINCE** (J Kamaruddin) - Lay in under pressure over the concluding stages.

**SEE THE LION** (L Douglas) – Lay outwards passing the 400 metres.

**CALL ME LOLLY** (C Dell) - Made the final bend awkwardly.

<b>Race 5</b>	<b>WANGANUI INSURANCE BROKERS 1200m</b>

There was a delay to the start of this race as rider K Hannan (TOWN BELT) was attended to by St John ambulance after receiving a knock behind the barriers. Ms. Hannan was cleared to ride.

**SHE'S A SHOWOFF** (J Kamaruddin) - Began awkwardly settling at the rear. Was held up near the early stages of the home straight having to angle across heels near the 150 metres to gain clear racing room.

**HYDROEXPRESS** (M McNabb) - Over-raced in the early stages. Lay inwards under pressure near the 100 metres bumping TOWN BELT.

**TOWN BELT** (K Hannan) – Bumped near the 100 metres.

**SCOTCH BONNET** (L Allpress) - Performed below market expectations. When questioned the rider was of the opinion that although unhappy in the going would improve with the run.

**THATZ DAISY** (A Mudhoo) - Made the final bend awkwardly.

<b>Race 6</b>	<b>WAVERLEY HARVESTING / BIG BLADE MAIDEN 2200m</b>

**JAN'S GIANT** (F Lazet) - Became fractious in the barrier, was removed, underwent a veterinary examination and was cleared to start. Slow away.

**SUSIE JANE** (Mahipal Singh) - Clipped a heel and blundered near the 800 metres when HERE'S JOHNNY shifted outwards when not clear. Rider dropped his whip near the 200 metres

**NUN SO BAD** (L Allpress) – performed below market expectations. When questioned rider could offer no tangible excuse.

**HERE'S JOHNNY** (K Hercock) – showed signs of lameness on pulling up. A post race veterinary examination confirmed an injury to the off-hind leg consistent with being galloped on.

**K Hercock** (HERE'S JOHNNY) – Admitted a charge of careless riding in that she allowed her mount to shift out when not sufficiently clear of SUSIE JANE (Mahipal Singh) which clipped a heel and blundered near the 800 metres. After hearing submissions the adjudicator suspended K Hercock's licence to ride from the conclusion of racing on 16<sup>th</sup> September up to and including 23<sup>rd</sup> September – five national riding days.

<b>Race 7</b>	<b>WANGANUI STEEL FORMERS WAVERLEY CUP 2200m</b>

**PASSWORD** (E Nicholas) - Restrained from heels from its wide draw to gain cover.

**VERRY FLASH** (F Lazet) - Over-raced during the middle stages then taken forward passing the 1,000 metres.

**PRINCE LEO** (C Dell) - Not persevered with over the final stages. When questioned rider advised he had felt something was amiss. A post-race veterinary examination revealed the gelding had jarred up. Stewards will follow up with connections in the coming days.

**BOTTI** (J Kamaruddin) – Held up rounding the final bend gaining clear racing room passing the 200 metres.

**L Sutherland** (MONDORANI) - Stewards inquired into the manner in which L Sutherland used her whip in the home straight and could not be conclusively satisfied that she had the rule had been contravened.

**Race 8**

**MARK NEIL / TOM ANDREWS 22**

**MADAM ZARA** (L Sutherland) was a late scratching on veterinary advice after dislodging her rider prior to the start and galloping a circuit of the track. At the conclusion of the race meeting Ms. Sutherland showed signs of dizziness and after consultation with Apprentice Jockey's mentor, Ms K Clapperton, who was present, Ms Sutherland's employer will be advised that a medical clearance will be required prior to any race, trial or track work.

**TELL ME MORE** (F Lazet) - Slow away.

**PHELAN FOXY** (L Douglas) - Began awkwardly settling towards the rear.

**BEAR GRYLS** – Commenced to weaken from the 700 metres, inconveniencing LOCHWINNOCH.

**LOCHWINNOCH** (H Schofer) - Inconvenienced and lost ground near the 700 metres.

**MAUNA LOA** (M McNab) – Lay out over the concluding stages.

**AQUILO** (J Kamaruddin) - Finished towards the rear. When questioned rider advised the gelding was not happy in today's track conditions, however he was of the opinion that AQUILO would derive benefit from today's race.
