Race 1 COLLIERS COMMERCIAL HAWKE'S BAY 2000

LITTLE JOE (O Bosson) – Trainer Ms. K Little reported to Stewards, LITTLE JOE underwent a Veterinary examination on Wednesday 14 September which included a dynamic endoscope examination which showed no abnormalities. K Little further advised the gelding has now been sent for a spell.

Race 2 SH CIVIL 1200

MOVIN' ON (L Douglas) – Trainer Ms. D Guy advised Stewards, that on return to the stable MOVIN' ON underwent a Veterinary examination which included and endoscopic examination which revealed the mare to have throat issues. D Guy further advised MOVIN' ON has now been retired from racing.

Race 7 HB/PB THOROUGHBRED BREEDERS ASSN GOLD TRAIL STAKES (G3) 1200

PACIFIC DRAGON (M McNab) – Trainer Mr. T Pike reported to Stewards, he was satisfied with the post-race condition of the filly, however, in his opinion PACIFIC DRAGON failed to handle the Heavy 10 track conditions with T Pike further advising the filly now being sent for a freshen up.

Race 10 CANCER SOCIETY - DONATE NOW 1400

ENCIERRO (M McNab) – Stable Foreman Mr. R Mildon advised Stewards, ENCIERRO underwent a Veterinary examination on Thursday 15 September which included blood test with no abnormalities being detected. R Mildon further advised it is the stables intention to carry on with the gelding's current preparation and will look to apply blinkers prior to ENCIRRO'S next race day start.

Race 1 LIQUORLAND COURTENAY STREET MDN 1400M

I'M RONALDO (C Grylls) – Slow to begin (3 lengths)

SOVIET WONDER (D Danis) – Raced wide in the early stages.

SCHUSKI (L Douglas) – Over raced in the early stages. Not persevered with in the final straight when out of contention.

COM SI COM SA (K Hannan) – Raced three wide without cover throughout.

SHARADA (M Hudson) – Became awkwardly placed on heels near the 500 metres having to be restrained.

HOMEGROWN (L Allpress) – Performed below market expectations. When questioned, rider stated despite over racing in the early stages she could offer no excuse. A post race veterinary examination revealed no abnormalities.

Race 2 TARANAKI PINE DASH 990 M

SERENA'S SPIRIT (T Mitchell) - Hampered at the start. Raced three wide without cover.

HUZZAH (S Spratt) – Began awkwardly. Shifted outwards abruptly at the start hampering several outside runners.

OUR GYPSY KING (M Hashizume) – Hampered at the start losing ground.

WILEWINK (L Douglas) – Jumped outwards at the start then severely checked shortly after, losing ground. Brought down by a fallen runner near the 450 metres dislodging its rider.

VIOLETSRBLUE (M Mudhoo) – Hampered at the start. Had to be steadied when awkwardly placed on heels near the 700 metres when CAPE KENNEDY shifted in when not fully clear. This incident was opened and adjourned due to the unavailability of C Lindsay.

ANDIT HURTS (D Danis) – Shifted inwards at the start.

GUNDAHAR (J Mudhoo) - Crowded passing the 800 metres when STAR TRAIL shifted inwards when not fully clear.

STEVIE NIX (L Allpress) – Restrained in the early stages to obtain cover from an outside barrier. Inconvenienced near the 700 metres by VIOLETSRBLUE which checked off the heels of CAPE KENNEDY. Badly hampered near the 450 metres when avoiding a fallen horse and rider. Was not persevered with in the final straight when out of contention.

STAN (C Butler) – Raced in restricted room having to be steadied off heels approaching 800 metres. Briefly held up in the early stages of the final straight.

JINGLE JANGLE (L Sutherland) – Raced greenly in the early stages.

CAPE KENNEDY (C Lindsay) – Clipped the heel of JINGLE JANGLE and fell near the 450 metres dislodging its rider which in turn resulted in WILEWINK (L Douglas) being brought down dislodging its rider. Both riders were immediately attended to by St John paramedics and sent to hospital for further observation.

The section of the track near the 450 metres was checked by the RIB, course staff and trainers' representatives and was considered suitable to continue racing after divots dislodged during the incident had been replaced. A meeting was convened between officials and riders, with all riders expressing confidence in the safety of track surface.

L Satherley (STAR TRAIL) – Issued with a warning for allowing her mount to shift in when not fully clear of STAN which was crowded having to be steadied near the 800 metres.

Race 3 NZB READY TO RUN TRAINERS SERIES DASH 990 M

A delay to the start after a track inspection being carried out following an incident in race 2, then there was a further delay when horses proved reluctant to load into the barriers.

FLEMING (L Allpress) – Reared as the start was made losing ground. Over raced for a distance near the 600 metres when held up for clear running.

PASHAMALA (L Sutherland) – Slow to begin (3 lengths)

NOBELLUM (K Hannan) – Raced three wide without cover throughout.

LEON ROUGE (A Goindasamy) – Over raced in the early stages getting its head up in the air and made the bend near the 800 metres awkwardly shifting outwards inconveniencing IMA ROCA BEE.

IMA ROCA BEE (A Lawson-Carroll) – Inconvenienced near the 800 metres.

VINO BIANCA (A Bohorun) – Refused to load into the barriers and was declared a late scratching. Connections were advised that the filly must trial to the satisfaction of Stewards prior to racing next.

Race 4 SEATON PARK 1300 METRES

SOLDIER BOY (T Mitchell) – Raced three wide without cover throughout.

CHILLAX (M Hashizume) – Contacted leaving the barriers.

KIRRACONI (S Spratt) – Shifted outwards leaving the barriers. Gave ground from the 400 metres. When questioned regarding performance rider could offer no excuse.

SECRET KEY (A Lawson-Carroll) – Contacted leaving the barriers.

CHERRY ROSE (A Bohorun) – Began awkwardly. Over raced in the early stages.

OSO SAVVY (L Sutherland) – Raced wide in the early and middle stages.

HALF OF NOTHING (A Goindasamy) – Held up for clear running near the 400 metres. Raced in restricted room near the 100 metres having to be steadied off heels.

LUXURIANT (L Allpress) – Performed below market expectation. When questioned, rider could offer no excuse. Underwent a post race veterinary examination which revealed no abnormality.

Race 5 GIB OPEN 1400 METRES

TAVIS COURT (F Lazet) – Over raced in the early and middle stages.

ZOLA EXPRESS (C Dell) – Slow to begin. Held up for clear running passing the 250 metres having to shift ground inwards.

MAGDALA (L Sutherland) – Began awkwardly.

AMUSEZ MOI (L Allpress) – Began awkwardly.

TAVI MAC (A Bohorun) – Over raced in the early stages and middle stages.

DAWN PARADE (M Hashizume) – Made the bend passing the 800 metres awkwardly shifting wider on the track.

DIOGENES (C Grylls)— Raced keenly in the early stages getting its head up in the air.

Following the running of this race the track was upgraded to a Slow 7.

Race 6 ZED @ GRANGEWILLAM STUD 1800 METRES

CAPTAIN OUMUAMUA (J Riddell) – Contacted leaving the barriers. Raced wide in the early stages.

TURNMEON (S Spratt) – Raced three wide in the early stages before being allowed to stride forward to race outside the leader near the 1000 metres. When questioned regarding the performance rider stated that the gelding may have held its breath and she further advised that the horse may be better suited to being ridden further back in the field.

RONIN POROTENE (M Hudson) – Gave ground passing the 500 metres and was not persevered with in the final straight when well out of contention. When questioned into performance rider advised that the gelding failed to

handle the slow track conditions. Underwent a post-race veterinary examination which revealed the gelding to have suffered cardiac arrhythmia. Trainer V Keegan was advised that **RONIN POROTENE** will not be permitted to start in any race or trial until a veterinary certificate declaring the horse free of any cardiac arrhythmia following a gallop of at least 1000 metres.

ZEEFA ZED (H Schofer) - Slow to begin (4 lengths)

BROZGOTTWINKLETOES (L Allpress) – Slow to begin.

FERDINAND (A Lawson-Carroll) – Shifted inwards leaving the barriers making contact with CAPTAIN OUMUAMUA. Over raced near the 800 metres having to be restrained off heels.

JAY BEE GEE (C Grylls) – Contacted leaving the barriers.

KING KHAN (A Mudhoo) – Restrained to obtain cover in the early stages after jumping from an outside barrier. Firmly restrained rounding the first bend when over racing.

GOBUYIT (L Sutherland) – Raced ungenerously entering the first bend having to be restrained losing ground. Raced three wide without cover through the middle stages.

MISS ONAKI (V Colgan) – Restrained off heels racing into the first bend.

FLIGHT PLAN (D Turner) – Made contact with the running rail near the 450 metres and went off stride for a short distance.

Race 7 ITM INTERPROVINCIAL CHAMPIONSHIP 1800 METRES

MRS BIG (C Dell) - Slow to begin (3 lengths)

JUSTASKME (J Mudhoo) – Slow to begin. Lay in under pressure over the final 100 metres.

ARICINA (A Bohorun) - Slow to begin.

INMYSHADOW (M Hudson) – Raced three wide without cover throughout.

MONT VENTOUX (L Sutherland) - Raced four wide from 1000 metres.

BLUEY'S CHANCE (S Spratt) – Over raced through the middle stages.

LEADERBOARD (L Allpress) – Finished last. When questioned into performance rider could offer no excuse.

BEAUDZ WELL (V Colgan) – Held up for clear running rounding the final bend having to be steadied off heels.

CETUS (T Bau) – Lay inwards near the 200 metres having to be corrected by its rider.

LE SABLIER (M Hashizume) – Held up for clear running passing the 400 metres

M Hashizume (LE SABLIER) – Admitted a charge in that he struck his mount LE SABLIER six times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$250.

Race 8 NZB AIRFREIGHT ROAD TO JERICHO 3210 METRES

BLACKWOOD STAR (F Lazet)— Slow to begin (3 lengths). Raced wide without cover down the back straight and rounding the turn.

ORLA (L Sutherland) – Slow to begin. Had to be firmly restrained off heels of NASSAK DIAMOND near the 1600 metres.

HALLELUJAH BROTHER (D Turner) – Over race shortly after the start having to be restrained. Continued to over race before being allowed to stride forward passing the 1800 metres.

QUOTA (S Spratt) – Shifted out under pressure passing the 200 metres prior to being straightened. S Spratt was advised that she is expected to straighten her mount sooner than she did on this occasion.

BRUCIE (J Riddell) – Slow to begin. Shifted out and away from QUOTA passings the 200 metres.

RAZORS EDGE (E Nicholas) – Raced clear in the lead in the early stages. Rider E Nicholas was questioned regarding the tactics she adopted after the pace noticeable eased near the winning post with a round to go, inconveniencing NASSAK DIAMOND, HUSK, MY MAEBELLINE GIRL and GREYSTONE which all had to steady and were placed at a disadvantage. E Nicholas was issued with a warning and advised she is expected to exercise better judgement in future regarding the degree in which she eased the pace.

WIND CHIMES (D Danis) – Raced clear in the trail behind **RAZORS EDGE** in the early stages. Rider D Danis was questioned regarding the tactics he adopted after the pace noticeable eased near the winning post with a round to go, inconveniencing NASSAK DIAMOND, HUSK, MY MAEBELLINE GIRL and GREYSTONE in behind which had to steady and were placed at a disadvantage. D Danis was advised to exercise better judgement in future.

MEANDEEL (A Mudhoo) – Raced three wide in the early stages.

Following of the race the connections of 2nd placed BRUCIE viewed video footage of the final straight but elected not to proceed with an objection against the first placed QUOTA.
