Race 6 - NELLIES BAR AND RESTAURANT 1200m

CHEERS (Y Atchamah) – Trainer Ms J Gordon advised Stewards that on return to the stable CHEERS was showing signs of jarring up, with the mare now also undergoing treatment by a chiropractor. J Gordon further advised she may look to nominate CHEERS for the Gore Racing Club meeting on Friday 23 September.

Hawke's Bay Racing - Saturday 10 September 2022

Race 9 - Tarzino Trophy (Group 1)

O Bosson (IMPERATRIZ) - Admitted a charge in that he struck his mount **IMPERATRIZ** six times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.

O Bosson - Admitted a charge in that he left the racecourse without gaining permission from the Stipendiary Stewards. After considering submissions the Adjudicative Committee imposed a fine of \$100.

Race 7 - NZB INSURANCE PEARL SERIES RACE 1600m

PAGE THREE (K Chowdhoory) – Co-trainer Mr M Pitman advised Stewards that PAGE THREE has now been retired from racing.

Race 3 – CELEBRATING THE 50TH NZ 2000 GUINEAS MAIDEN 1200m

C Carmine (VAUDEVIRE) - Fined \$100 under the Minor Infringement Schedule after being unable to make the contracted weight.

Race 6 - ELLIE STOKES TRUST CHARITY DINNER 22/09 MAIDEN 1600m

J Lowry (THE ARCTIC BLAST) – Fined \$200 under the Minor Infringement Schedule after being unable to make the contracted weight.

RACE COMMENTS

Race 1 CANTERBURY WESTLAND RACING OWNERS ASSOCIATION 2000m

BELLA DORA (J Kamaruddin) - Slow to begin.

YEAH RIGHT (T Moseley) - Slow to begin.

KENKI (T Newman) - Slow to begin.

EAVESDROP (C Campbel) - Restrained behind runners shortly after the start. Raced three wide without cover throughout.

IFITHAPPENSAGAIN (C Barnes) - Over raced getting its head up in the middle stages.

HEY MICKEY (M McNab) - Crowded near the 1800 metres. Held up rounding the final turn from the 600 metres. Crowded and checked near the 250 metres.

MR RAFIKI (R Mudhoo) - Crowded near the 1800 metres.

S Wynne (EULOGY SHOW) - Admitted a charge of careless riding in that she permitted her mount EULOGY SHOW to shift inwards when not sufficiently clear of HEY MICKEY and MR RAFIKI with both runners being crowded near the 1800 metres. After considering submissions the Adjudicative Committee imposed a suspension of S Wynne's licence to ride in races from the conclusion of racing today Saturday 17 September until the conclusion of racing on Wednesday 28 September, 7 national riding days.

D Montes de Oca (VITAL PERFECTON) - Admitted a charge of careless riding in that he angled his mount VITAL PERFECTION inwards when not sufficiently clear of HEY MICKEY which was crowded and checked near the 250 metres. After considering submissions the Adjudicative Committee imposed a suspension of D Montes de Oca's licence to ride in races from the conclusion of racing today Saturday 17 September until the conclusion of racing on Saturday 24 September, 5 national riding days.

The starter was reprimanded and advised to review his all clear procedure after releasing the barriers when a barrier attendant was just clearing the front of the barriers.

Race 2 PRYDE'S EASIFEED 2000m

WHALE SONG (K Chowdhoory) - Crowded shortly after the start losing ground when runners to either side shifted ground.

TANTALEE (R Mudhoo) - Restrained behind runners to obtain cover shortly after the start. Had a tendency to over race in the middle stages.

EKSTREMEMISS (G Jogoo) - Slow to begin.

CAMPING (D Monte de Oca) - Raced in restricted room near the 50 metres.

C Campbell (VERMONT) - Admitted a charge in that he used his whip with an action which raised the rider's arm above shoulder height. After considering submissions the Adjudicative Committee imposed a fine of \$250.

Race 3 ELMWOOD TRADING COMPANY 1600m

POWERFUL MOSS (J Laking) - Became fractious upon entering the barriers and reared, triggering the front gate of its barrrier stall with the gelding remaining in the barrier. The barrier was then reclosed with the start effected shortly after.

KUDOS DE SOTHYS (S Wynne) - Began awkwardly losing ground.

ITS SO EASY (M Taylor) - Slow to begin.

PROSERVE (K Chowdhoory) - Slow to begin.

LADY MODENA (R Mudhoo) - Raced wide without cover until near the 800 metres.

NOBLE KNIGHT (J Kamaruddin) - Held up early in the straight making contact with HEY SOUL SISTER when attempting to obtain clear running near the 350 metres.

HEY SOUL SISTER (G Jogoo) - Contacted near the 350 metres.

Race 4 NZB READY TO RUN SALE TRAINERS SERIES 1200m

HE'S THE MAN (C Carmine) - Began awkwardly.

NAVALHA (O Bosson) - Slow to begin then placed in restricted room having to steady shortly after the start.

VENTURESOME (S Wynne) - Began awkwardly shifting outwards making contact with CHANDLER shortly after the start.

CHANDLER (J Laking) - Contacted shortly after the start losing ground. Commenced to over race near the 800 metres and shifted outwards to avoid heels of the runners in front hampering HAGGLE.

O'JUDE (R Mudhoo) - Began awkwardly losing ground.

GLOBAL BEAUTY (B May) - Shifted inwards shortly after the start.

VICTOR ROUGE (T Moseley) - Over raced in the early to middle stages.

HAGGLE (C Campbell) - Crowded shortly after the start. Hampered near the 800 metres. Checked passing the 350 metres. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

WHERE'S WALLY (K Williams) - Crowded shortly after the start. Had to steady to avoid the heels of BENAUD (D Montes de Oca) which shifted outwards when not fully clear near the 500 metres. D Montes de Oca was advised to exercise greater care. Had to shift outwards abruptly to avoid the heels of HAGGLE passing the 350 metres.

B May (GLOBAL BEAUTY) - Admitted a charge of careless riding in that he permitted his mount GLOBAL BEAUTY to shift inwards shortly after leaving the barriers crowding WHERE'S WALLY. After considering submissions the Adjudicative Committee imposed a suspension of B May's licence to ride in races from the conclusion of racing on Friday 23 September until the conclusion of racing on Saturday 1 October, 6 national riding days.

D Montes de Oca (BENAUD) - Defended a charge of careless riding alleging that he angled his mount BENAUD outwards when not sufficiently clear of HAGGLE which was checked passing the 350 metres. WHERE'S WALLY was also hampered as a result. After viewing films and considering submissions the Adjudicative Committee found the charge to be proven and imposed a suspension of D Montes de Oca's licence to ride in races from the conclusion of racing on Saturday 24 September until the conclusion of racing on Friday 7 October, 9 national riding days.

Race 5 DOUBLE TREE BY HILTON KARAKA HANDICAP 1200m

LIVE DRAMA (M Taylor) - Slow to begin. Badly hampered by riderless horse passing the 1000 metres.

SWISSWATCH (B May) - Began awkwardly.

SERIOUSLY (S Wynne) - Slow to begin then crowded shortly after the start losing ground.

GOODANYA (K Chowdhoory) - Began awkwardly losing ground.

PHELAN THE POWER (T Moseley) - Rider was dislodged passing the 1000 metres when the right stirrup leather broke. Badly hampered as a result were LOUIE LOUIE and LIVE DRAMA with SUMMER MONSOON and KING COUGAR also being inconvenienced. T Moseley was attended to by ambulance personnel and found to be uninjured.

LOUIE LOUIE (C Johnson) - Badly hampered by riderless horse passing the 1000 metres.

EPTIMUM (T Comignaghi) - Hampered by the riderless horse for a distance passing the 700 metres when forced wider on the track.

HARBOURSIDE (K Williams) – Hampered by the riderless horse passing the 700 metres having to be steadied and shift inwards. Badly hampered by riderless horse for a distance passing the 350 metres.

BURGUNDY ROSE (O Bosson) - Hampered by the riderless horse passing the 700 metres having to be steadied and shift inwards Contacted and crowded to the inside of HARBOURSIDE passing the 350 metres.

OUR GIRL GILLY (L Callaway) – Steadied to avoid heels as a result of interference caused by the riderless horse passing the 700 metres.

Race 6 NEW ZEALAND BLOODSTOCK CANTERBURY BELLE STAKES 1200m

I CHOOSE YOU (J Kamaruddin) - Underwent a pre-race veterinary examination at the barriers and was cleared to race. Slow to begin. Held up from the 600 metres and did not obtain clear running until near the 200 metres.

DEFIANT (R Mudhoo) - Slow to begin.

KIKIMORA (K Chowdhoory) - Began awkwardly losing ground. Raced keenly in the early and middle stages.

PERFECTLY SUITED (S Wynne) - Restrained behind runners to obtain cover shortly after the start. Badly held up having to be firmly restrained off heels near the 450 metres then had difficulty obtaining clear running until near the 250 metres.

MADAME GISELLE (T Moseley) - Had to be steadied to avoid the heels of ONE KISS near the 1000 metres.

SHAZZA (K Williams) - Shifted outwards when being steadied making contact with ONE KISS near the 800 metres.

ONE KISS (O Bosson) - Contacted near the 800 metres. Rider dropped his whip near the 100 metres.

GARDEN CITY (D Montes de Oca) - Held up approaching the 400 metres.

O Bosson (ONE KISS) - Issued with a warning after permitting ONE KISS to shift inwards when being steadied to obtain cover when not fully clear of MADAME GISELLE which had to be steadied near the 1000 metres.

Race 7 MARTIN COLLINS NEW ZEALAND CUP TRIAL 1800m

FRANKIE THE FOX (R Mudhoo) - Began awkwardly losing ground. When questioned regarding performance rider was unable to offer any excuse advising that the gelding had felt lethargic today. A post-race veterinary examination revealed a slow rate of recovery with an elevated heart rate.

WILLIAM WALLACE (O Bosson) - Slow to begin.

ORIGINAL GANGSTER (K Williams) - Improved onto heels when the pace eased having to be steadied shifting out making contact with CAMPIONESSA which was forced outwards passing the 1400 metres. K Williams was advised to exercise greater care.

CAMPIONESSA (J Kamaruddin) – Contacted passing the 1400 metres.

BURNVUE (L Callaway) - Steadied when improving onto the heels of CAMPIONESSA passing the 1400 metres. Held up rounding the final turn and early in the straight.

Race 8 RACECOURSE HOTEL & MOTOR LODGE 1400m

ZOULUMINOUS (O Bosson) - Slow to begin losing considerable ground. Following the race a request for a ruling was filed with the Adjudicative Committee by rider O Bosson for a determination as to whether ZOULUMINOUS had been denied a fair start. After viewing films and hearing submissions the Adjudicative Committee were of the opinion that ZOULUMINOUS had been denied a fair start, therefore declaring that runner a non-starter with all bets to be refunded. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

EL BEE JACK (C Barnes) - Slow to begin.

ITS ALL OVER ROVER (T Moseley) - Slow to begin.

REDFORD (Y Atchamah) - Began awkwardly losing ground.

DORIS DIOR (C Campbell) - Began awkwardly shifting inwards hampering FETTERCAIRN.

FETTERCAIRN (S Wynne) - Hampered shortly after the start. Held up near the 200 metres continuing to have some difficulty obtaining clear running for the majority of the race.

ELIZABETH ROSE (K Chowdhoory) - Raced three wide without cover.

FINAL SAVINGS (D Montes de Oca) - Angled outwards abruptly inconveniencing JEWEL OF PATCH near the 75 metres. D Montes de Oca was advised to exercise greater care when shifting ground.

JEWEL OF PATCH (J Laking) - Inconvenienced near the 75 metres.
