FRANKIE THE FOX (R Mudhoo) – Trainer Mr. M McCann advised Stewards he was satisfied with the post-race condition of FRANKIE THE FOX and it is his intention to continue on with the gelding's current preparation.

GIVEALITTLE (K Chowdhury) - Slow to begin.

MRS LAWRENCE (C Campbell) - Crowded shortly after leaving the barriers, losing ground.

DOODLE DASHER (R Mudhoo) - Lay out early in the final straight making contact with MINI MOET near the 200 metres. R Mudhoo was advised to exercise care. Continued to lay out for the remainder of the home straight.

MINI MOET (B May) - Contacted near the 200 metres.

MY TARNZ GIRL (B Murray) - When asked to comment on the performance rider advised he was very disappointed with the effort and felt that there may have been something amiss with the mare. A post-race veterinary examination revealed no obvious abnormalities. Trainer P Harris indicated that the mare was likely to be retired from his stable.

Rider **B Murray** (MY TARNZ GIRL) - Admitted a charge under Rule 648(5) in that he weighed in 0.7kgs in excess of the weight at which he had weighed out. After considering submissions on penalty the Adjudicative Committee imposed a fine of \$300.

SILENT BATTLER (L Callaway) - Slow to begin. Had to be steadied passing the 1000 metres when placed in restricted room to the inside of BEESLASTSTING. R Mudhoo was advised to exercise care. Briefly hampered passing the 700 metres when GOODANYA shifted ground outwards.

LOVE SQUIRRELS (M Taylor) - Jumped away awkwardly from the outside barrier and was then steadied in the early stages to obtain cover. Briefly hampered passing the 700 metres when GOODANYA shifted ground outwards. A post-race veterinary examination revealed the mare to have a slow rate of recovery.

GOODANYA (B May) - Got back shortly after the start. Made contact with the running rail when placed in restricted room to the inside of BEESLASTSTING which lay in and away from MIDNIGHT RUNNER near the 700 metres. After contacting the rail GOODANYA reacted poorly and ducked outwards hampering outside runners and almost dislodging its rider, losing ground.

KING COUGAR (K Williams) - When asked to comment on the performance rider advised she was disappointed with the run and was of the opinion the gelding may not have backed up from its previous start at Riccarton on 17 September.

ZA BEAUTEOUS (R Mudhoo) - Slow to begin.

MOROCCO MISS (T Comignaghi) - Jumped away awkwardly before being hampered shortly after the start losing ground. Over-raced through the middle stages having to be restrained off heels.

JAMIESON'S TIPPLE (B Murray) - Jumped away awkwardly hampering THE BLAZING ONE. Over-raced when being restrained in the early stages.

THE BLAZING ONE (T Moseley) - Hampered at the start.

FARAH (W Papier) - Ducked outwards shortly after the start hampering NO PROBLEMO, MOROCCO MISS and CATS IN THE CRADLE. When questioned rider advised the gelding had hung throughout.

NO PROBLEMO (C Johnson) - Hampered shortly after the start.

CATS IN THE CRADLE (B May) - Hampered shortly after the start.

ELSIE MAY (C Barnes) - Charged the front gate of its barrier stall prior to the start being effected. The Starter was advised that in future with similar circumstances the horse should be removed from the barriers to undergo a veterinary examination.

MIDNIGHT JANE (K Williams) - Got back shortly after the start.

LEROY (C Campbell) - Restrained to obtain cover in the early stages after jumping from an outside barrier.

TAP 'N' GO (L Callaway) - Raced three-wide without cover. Hampered near the 150 metres. Following the race the rider reported that the gelding had felt indifferent in its action. A post-race veterinary examination revealed no obvious abnormalities.

LILY OF THE VALLEY (R Mudhoo) - Hampered near the 150 metres.

ZAC BLACK (S Khetoo) - S Khetoo was spoken to advisedly regarding his whip action passing the 100 metres.

Apprentice rider **M Taylor** (COPY ME IN), assisted by C Barnes - Admitted a charge under Rule 638(1)(d) Careless riding, in that she allowed her mount to shift outwards near the 150 metres when not sufficiently clear of LILY OF THE VALLEY and TAP 'N' GO which were both hampered. After viewing replays and considering submissions on penalty the Adjudicative Committee imposed a suspension of M Taylor's licence to ride in races from the conclusion of racing today, Friday 23 September until the conclusion of racing on 01 October, 6 national riding days.

KITTY POWER (K Williams) - Slow to begin. Briefly inconvenienced in the middle stages of run home.

THE GROWLER (K Chowdhury) - Slow to begin. Over-raced in the middle stages. Held up near the 300 metres.

PETE THE DRIVER (Y Atchamah) - Restrained to obtain cover in the early stages after jumping from the outside barrier. Raced wide from the 800 metres.

ANJAMEME (T Moseley) - Over-raced in the middle stages.

ZAMBEZI ZIPPER (S Khetoo) - Raced three-wide without cover. Lost the off-hind racing plate during the running.

NOMEN LUDI (K Mudhoo) - Over-raced through the middle stages.

| VEE TWELVE (C Johnson) - Commenced to give ground passing the 500 metres and was eased down over the concluding stages, finishing last. When questioned regarding the performance the rider could offer no tangible excuse. A post-race veterinary examination revealed no obvious abnormalities. |
| PINHEAD (B May) - Became awkwardly placed on heels passing the 450 metres. Held up rounding the final bend and early in the run home. |
| HONESTY (R Mudhoo) - Lay out in the middle stages of the run home briefly inconveniencing KITTY POWER. |
| Race 6 GRANT FARMING PARTNERSHIP (1335m) |
| RUBY'S LAD (C Campbell) - The tongue-tie became detached in the barriers with the gelding then racing without that item of gear. Jumped away awkwardly. The hind quarters were contacted by ZENDORA which was attempting to improve to its inside passing the 200 metres with RUBY'S LAD then being inclined to hang inwards over the concluding stages inconveniencing ZENDORA near the 50 metres. |
| TAKE A RISK (W Papier) - Contacted on jumping by the front right gate on its barrier stall which failed to catch correctly. The barriers were checked prior to the next race. Apprentice rider W Papier was questioned regarding his riding tactics after continually challenging the leader BELLE DE VAL from passing the 1000 metres and in particular why he did not attempt to take a sit when there had been the opportunity to do so. Trainer J Burrows, who is Mr Papiers' employer was also spoken to regarding her riding instructions along with her thoughts on the ride in general. Whilst on this occasion no charges were laid Stewards advised Mr Papier that they were concerned with the lack of judgement shown and he was directed to meet with the Rider Skills Review Panel under the provisions of Rule 343. |
| MIRADELLO (S Toolooa) - Very slow to begin (4L). Held up rounding the final bend and in the straight, not obtaining clear running until inside the final 100 metres. Required post-race veterinary treatment for a lesion on the left hind pastern. |
| ZENDORA (G Jogoo) - Restrained to obtain cover in the early stages after jumping from the outside barrier. Held up near the 300 metres having to be angled outwards across the heels of HEIDI HI to obtain clear running near the 200 metres. Inconvenienced near the 50 metres. |
| COSY NOOK (L Callaway) - Raced three-wide without cover throughout. |
| PANDDE (C Barnes) - Held up rounding the final bend and early in the straight. |
| Race 7 CROYDON CONTRACTING MAIDEN (1335m) |
| SAVEZ VOUS (L Callaway) - Underwent a pre-race veterinary examination after an incident in the saddling stalls and was passed fit to run. |
| LOCKDOWN LEGACY (C Barnes) - Jumped away awkwardly. |
| LAST TRY (T Moseley) - Jumped away awkwardly then lay in making contact with PEARL OF DELGATIE and raced ungenerously getting its head up for a distance, then continued to over-race into the middle stages. |
| GUNWHARF QUAYS (D Bothamley) - Jumped away awkwardly. Went off stride after making contact with the running rail when placed in restricted room to the inside of MADISON ROSE when that runner was being steadied off heels near the 450 metres. B May was advised to exercise care. |
| GABBY DIAZ (K Mudhoo) - Jumped away awkwardly. Held up near the 400 metres. |
| PEARL OF DELGATIE (C Campbell) - Contacted on jumping. |

DICELAND (B Murray) - Raced three-wide without cover.

MADISON ROSE (B May) - Held up from the 600 metres until near the 300 metres.

CASTLE ON THE HILL (K Williams) - Raced without the tongue-tie after it was unable to be applied when the horse became very fractious. Hampered at the start when OUR TEDDY BOY jumped outwards then made contact with FAME SHINES losing ground. Hampered again near the 1200 metres.

PLATINUM PETALS (M Taylor) - Reared at the start and initially refused to leave the barriers, losing considerable ground and effectively all chance. Connections were advised the mare was stood down to barrier trial to the satisfaction of Stewards prior to resuming racing.

REDGUM (C Johnson) - Jumped away awkwardly losing ground.

OUR TEDDY BOY (C Barnes) - Jumped away awkwardly. Hampered near the 1200 metres.

FAME SHINES (B May) - Jumped away awkwardly and shifted inwards making contact with CASTLE ON THE HILL.

OUR CLARRY (Y Atchamah) - Ducked outwards crossing the junction onto the course proper near the 1200 metres hampering GINTYS GIRL which was forced outwards into the line of SWEET MOLLY MALONE which clipped a heel and blundered badly, dislodging its rider. Badly hampered as a result was SYMPATHIQUE with OUR TEDDY BOY and CASTLE ON THE HILL also being hampered.

SWEET MOLLY MALONE (K Mudhoo) - Clipped a heel and blundered badly passing the 1200 metres dislodging its rider. K Mudhoo was uninjured in this incident.

SYMPATHIQUE (G Jogoo) - Badly hampered near the 1200 metres.

GINTYS GIRL (L Callaway) - Briefly hampered by the riderless horse near the 800 metres. A post-race veterinary examination revealed the mare to have injured the outside heel bulb on its left hind leg which was treated by the on-course veterinarian.
