Race 5 was amended to start at 3.16 pm, Race 6 was amended to start at 3.51 pm, Race 7 was amended to start at 4.26 pm, Race 8 was amended to start at 5.01 pm at the request of the TAB.

###### Race 2 RACE IMAGES 1800

**MADAME MOET** (O Bosson) – Trainer M Walker advised Stewards on return to the stable a post-race inspection of the mare revealed MADAME MOET to be showing signs of back soreness with M Walker further advising the mare has now been sent for a freshen up.

##### Waikato Racing Club - Sunday, 18 September 2022

###### Race 7 BEN FOOTE RACING GREAT NORTHERN STEEPLECHASE (6500 metres)

**NO TIP** (S Phelan) – Co-trainer P Nelson advised Stewards the stable was satisfied with the post-race condition of the gelding, however, has now been sent for a spell.

###### Race 9 WAIKATO STUD WINNERS CIRCLE MILE (1600 metres)

**AMARELINHA** (O Bosson) – Trainer M Walker reported to Stewards AMARELINHA underwent a Veterinary examination on Friday 23 September which included a dynamic endoscope examination, M Walker further advised abnormalities were detected with AMARELINHA now being retired from racing.

#### RACE COMMENTS

##### Race 1 **BEAR MORGAN @ HARCOURTS BREAM BAY (800 metres)**

**BELIEVE IN MAGIC** (S Weatherley) - Began slowly. Commenced to buck shortly after the start. Had difficulty obtaining clear running early in the final straight. Connections were advised that the filly would be required to barrier trial to the satisfaction of Stewards prior to racing next.

**WHISKEY LIES** (A Lawson-Carroll) – Raced wide without cover throughout. Connections were advised a warning would be placed on the colt's barrier manners.

**PIXIE DUST** (M McNab) – Raced wide without cover making the final bend awkwardly.

**DANCING DREAM** (K Hannan) - Had some difficulty obtaining clear running early in the final straight.

**PERENARA** (E Nicholas) - Shifted out slightly making contact with JINN WARRIOR approaching the 350 metres who simultaneously shifted inwards.

**JINN WARRIOR** (L Satherley) – Contacted approaching the 350 metres.

##### Race 2 **MATHIAS & CURRIE INSURANCE (2100 metres)**

**ON THE RIVET** (J Fawcett) - Contacted the front of its barrier stall just prior to the start being effected resulting in its barrier stall opening slightly faster. Stewards were satisfied that the gelding had gained no advantage.

**LEITRIM LAD** (S Spratt) - Slow to begin.

**LOWRY** (O Bosson) - Raced keenly in the early stages.

**QUIZ KID** (K Hannan) - Stewards opened and adjourned an inquiry into the riding tactics adopted in the early stages. When questioned apprentice K Hannan explained that after working forward in the early stages the gelding had failed

to settle when asked once crossing to the lead, further advising that QUIZ KID had a tendency to lay out when racing right-handed and had resented being restrained. Trainer S Phelan confirmed his instructions were to lead, further adding that the gelding is better suited to more rain affected footing and a left-handed way of going.

**Race 3** | **CLOTWORTHY RACING (2100 metres)**

**MOLLYS GAME** (M Hashizume) - Began awkwardly then crowded shortly after, losing ground.

**LOGAN'S LOGIC** (B Rogerson) - Slow to begin.

**KHAN HUNTER** (N Parmar) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

**PUSHKA** (D Danis) - Finished a distant last. Connections were advised that a warning would be placed on the gelding's racing performance. Underwent a post-race veterinary examination which did not reveal any abnormality.

**Race 4** | **TOTE N POKE SPORTS BAR (1400 metres)**

**NEW ARRANGEMENT** (J Fawcett) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

**VIGOR WINNER** (W Pinn) - Jumped outwards at the start crowding FOLLOW YOUR DREAMS. When questioned regarding performance the rider advised that the gelding had raced keenly throughout which had been detrimental to its chances today.

**FOLLOW YOUR DREAMS** (K Hannan) - Crowded shortly after the start losing ground. Raced in restricted room for a distance passing the 1000 metres. Raced wide without cover from near the 900 metres.

**GINO SEVERINI** (A Lawson-Carroll) - Began awkwardly. Raced in restricted room for a distance passing the 1000 metres. Had to be steadied passing the 100 metres after improving onto the heels of FOLLOW YOUR DREAMS which shifted in and away from BELLE EN ROUGE after making contact with that runner.

**APOSTROPHE** (V Colgan) – Raced in restricted room for a distance passing the 1000 metres when racing keenly.

**BELLE EN ROUGE** (J Kamaruddin) - Raced in restricted room for a distance passing the 1000 metres when racing keenly.

**TELLALL** (M McNab) - Shifted inwards slightly passing the 1000 metres placing FOLLOW YOUR DREAMS, BELLE EN ROUGE, GINO SEVERINI and APOSTROPHE in restricted room for a distance.

**NEW YORK JAZZ** (T Newman) - Shifted outwards when racing keenly to avoid heels passing the 850 metres forcing FOLLOW YOUR DREAMS wider with NEW YORK JAZZ then racing three wide without cover for the remainder of the race.

**Race 5** | **KENSINGTON REFRIGERATION (1200 metres)**

**IMAGE OF YOU** (J Kamaurddin) - Slow to begin.

**LANDRY** (T Newman) - Reared at the start, losing ground. Lay in when placed under pressure in the final straight.

**IS THAT SO** (S Spratt) - Jumped outwards at the start hampering MOHAWK BRAVE. Came together with MR JAY EIGHT passing the 50 metres and again just prior to the winning post.

**GOLDEN HUE** (R Beemud) - Jumped inwards at the start making contact with IS THAT SO.

**MOHAWK BRAVE** (N Parmar) - Hampered at the start.

**PARADIGM SHIFT** (K Asano) - Had to be steadied approaching the 1000 metres after becoming awkwardly placed on the heels of MAGNETO which shifted in when not fully clear. V Colgan was advised to exercise care in similar circumstances. Then commenced to race keenly through the middle stages. Had difficulty obtaining clear running until passing the 150 metres.

**SHEPHERD'S DELIGHT** (O Bosson) - Shifted outwards approaching the 350 metres making contact with MR JAY EIGHT. Held up over the concluding stages.

**MR JAY EIGHT** (M Hashizume) – Contacted approaching the 350 metres. Came together with IS THAT SO passing the 50 metres and again just prior to the winning post.

**ZEITAKU** (S Weatherley) - When questioned regarding performance the rider advised that in his opinion the gelding would benefit from a step up in distance. Underwent a post-race veterinary examination which found the gelding to have a slow recovery rate. Connections were advised that the gelding would require a veterinary clearance prior to racing next.

Following the running of the race the connections of the 4<sup>th</sup> placed horse MR JAY EIGHT lodged a protest against the 3<sup>rd</sup> placed horse IS THAT SO alleging interference in the final straight. After considering submissions the Adjudicator dismissed the protest with placings standing 1<sup>st</sup> MISS CARTIER, 2<sup>nd</sup> TIVAAN WARRIOR, 3<sup>rd</sup> IS THAT SO, 4<sup>th</sup> MR JAY EIGHT.

**Race 6** | **TREE WISE NORTHLAND (1300 metres)**

**DESERT LIGHTNING** (V Colgan) - Raced keenly when being restrained in the early stages.

**NANCHO GIRL** (W Pinn) – Lay out rounding the bend.

**MAGIC TOUCH** (S Spratt) – Raced keenly in the middle stages.

**THE GOLDEN GOOSE** (J Kamaruddin) - Connections were advised that the filly would be required to barrier trial to the satisfaction of Stewards prior to racing next after proving difficult to load. Raced three wide without cover throughout.

**SLIPPER ISLAND** (M McNab) - Over-raced in the early stages. When questioned regarding performance the rider advised that the colt proved to be a difficult ride.

**MISCHIEF MANAGED** (E Nicholas) - Raced in restricted room passing the 200 metres having to be steadied.

**HEART OF ALLADIN** (J Fawcett) - Improved onto heels passing the 200 metres having to be steadied.

**Race 7** | **MARSH RACING (1400 metres)**

**FLAT TRACK BULLY** (J Kamaruddin) - Began awkwardly losing ground. Over-raced through the middle stages having to be steadied off heels.

**THE HIGH PRIESTESS** (T Newman) - Slow to begin then hampered shortly after losing ground.

**QUALITY PREVAILS** (E Bragg) - Raced wide in the early stages.

**AQUA MAN** (A Lawson-Carroll) – Made contact with the running rail near the 250 metres.

**A Lawson-Carroll** (AQUA MAN) - Issued with a warning for failing to ride his mount out to the end of the race when circumstances permitted him to do so.

**Race 8** | **MICHELLE BRADLEY RACING (1600 metres)**

**SOPRANO SUPREME** (O Bosson) - Slow to begin. When questioned regarding performance the rider could offer no excuse. Underwent a post-race veterinary examination which did not reveal any abnormality.

**YELLOW JERSEY** (W Pinn) - Slow to begin. Improved forward from near the 800 metres. Shifted outwards when placed under pressure passing the 150 metres.

**EVERY SO EASY** (J Fawcett) - Jumped inwards at the start. Held up rounding the final bend.

**AQUACADE** (V Colgan) - Began awkwardly.

**THE BUFFER** (K Hannan) - Over-raced in the early stages. Lay out entering the final straight forcing ACUTUS wider.

**NASHA RIVA** (L Satherley) - Restrained in the early stages.

**BROOKBOURNE** (R Beemud) - Raced wide throughout.

**ACUTUS** (E Bragg) – Raced wide in the early stages. Forced wider entering the final straight.

**VAN DIESEL** (A Lawson-Carroll) - Had some difficulty obtaining clear running early in the final straight.
