GENERAL

T Harris – Did not attend the meeting after advising that he was unable to make the weight for ZEEFA ZED in Race 4 and JUSTASKME in Race 7. T Harris was charged under the Minor Infringement Schedule and was fined \$200.

RACE COMMENTS

Race 1 MANAWATU TOYOTA/JOHN TURKINGTON FORESTRY MAIDEN 1550

MISS BELLE (L Sutherland) – Underwent a pre-race veterinary examination after contacting a rail in the stabling area and was cleared to start.

CANBITEABIT (D Turner) - Hampered shortly after the start losing ground.

MAGGIESCLAN (L Allpress) - Began awkwardly.

BARZETTI (H Schofer) – Raced three wide without cover passing the 700 metres.

RIDE THE TIDE (D Bradley) – Hung inwards throughout the home straight and was unable to be ridden out fully to the finish.

Race 2 CARRFIELDS LIVESTOCK/WOOLS OF NEW ZEALAND 1200

REIGN IT IN (H Schofer) – Slow to begin. Raced ungenerously, getting its head up on a number of occasions making the bend awkwardly near the 800 metres and steadied on two occasions after improving on to the heels of the runner ahead.

SEA MONARCH (F Lazet) - Blundered shortly after the start, losing ground.

SAPPORO (D Turner) - Slow to begin.

EAGLE TARZAN (C Grylls) - Had to be steadied when the pace eased, getting its head up, having to shift outwards near the 900 metres.

DOUBTFUL SOUND (L Sutherland) - Rider dropped her whip near the 300 metres.

TARGHEE (L Allpress) – Finished last. When questioned rider could offer no excuse. A post-race veterinary examination did not reveal any obvious abnormality.

NOBELLUM (C Dell) – Disappointed. C Dell advised the mare did not back up from its previous run and was to be freshened.

C Dell (NOBELLUM) – Reminded of his obligations in that he must not ease the pace where it places other riders in difficulty.

Race 3 CR GRACE LTD/WATERFORCE 2100

CALL ME JACK (K Hercock) – Slow to begin, then restrained behind runners to obtain cover in the early stages.

YOLO (L Sutherland) - Raced three wide without cover throughout.

KAHU ROCK (J Riddell) – When questioned regarding performance rider had no excuse.

Race 4 AGRICOM/H&T AGRONOMICS 2100

TOBKAY (D Turner) – Began awkwardly shifting outwards making contact with a runner to its outside. Finished some distance last and was not persevered with in the home straight when well beaten. Rider was of the opinion the gelding was feeling the effects of recent racing.

ZEEFA ZED (J Riddell) – Contacted then hampered at the start, losing ground.

SAILOR JACK (H Schofer) – Slow to begin.

LOVETTORLEAVIT (F Lazet) - Raced three wide without cover in the early stages.

BROZGOTTWINKLETOES (S O'Malley) - Raced three wide without cover passing the 800 metres.

D Bradley (ROSIELICIOUS) - Spoken to regarding the use of his whip in the home straight.

H Schofer (SAILOR JACK) - Admitted a charge in that she struck her mount SAILOR JACK 6 times prior to the 100 metre mark. After hearing submissions the Adjudicative Committee imposed a fine of \$250.

Race 5 MARSH INSURANCE BROKERS/FARMERS TRANSPORT 1200

BELCLARE (L Sutherland) - Began awkwardly, making contact with BUTLER.

BUTLER (T Mitchell) - Contacted then hampered at the start losing ground.

LOVE STORM (T Taiaroa) -Restrained behind runners shortly after the start to obtain cover.

STAR TREASURE (C Grylls) – Restrained behind runners shortly after the start to obtain cover.

RACED EVENS (L Allpress) - When questioned regarding performance rider advised that despite travelling wide the mare lost concentration when BUTLER improved to its inside near the 400 metres and was of the opinion RACED EVENS may benefit with the addition of blinkers.

Race 6 PIONEER SEEDS/PILET CONTRACTING LTD 1550

THIS LADY ROCKS (T Taiaroa) – Slow to begin.

MY ZOI (L Allpress) – Had to be steadied, becoming awkwardly placed on heels shortly after the start.

DUCK ROAD (L Sutherland) – Blundered shortly after the start.

SEQUOIA DAWN (F Lazet) - Contacted at the start.

QUEEN SARABI (C Grylls) – Crowded and hampered 200 metres, having to be steadied.

L Sutherland (DUCK ROAD) – Admitted a charge of careless riding in that she permitted her mount DUCK ROAD to shift inwards when not sufficiently clear of QUEEN SARABI which was crowded and hampered near the 200 metres. After considering submissions the Adjudicative Committee imposed a suspension of L Sutherland's licence to ride in races from the conclusion of racing on Saturday, 1 October up to and including racing on Friday, 7 October, 4 national riding days.

Race 7 BOEHRINGER INGELHEIM METRIC MILE (G3) 1550

JUSTASKME (D Turner) – Slow to begin (4L).

MUSTANG VALLEY (C Barnes) – Slow to begin. Lay inwards under pressure throughout the final straight.

DEERFIELD (C Dell) - Lay outwards under pressure over the concluding stages.

Race 8 NUFARM/PROPERTY BROKERS 1400

MANOLO (T Taiaroa) – Slow to begin.

DARLINGTON COUNTY (S O'Malley) – Slow to begin.

LURID (C Barnes) - Slow to begin.

BENDERMERRY (C Butler) - Raced keenly in the early stages.

SEMPER MAGICO (C Dell) – When questioned regarding performance rider advised the gelding had not handled the Heavy track conditions, which he described as holding.
