RACE COMMENTS

Race 1 **GARTSHORE CONSTRUCTION MAIDEN 2100**

I'M ALICE (T Thornton) - Underwent a pre-race veterinary examination after being found to have a minor laceration to the lower jaw and was cleared fit to race. Shifted inwards making contact with **STANIMA MAN** shortly after the start when not clear. Raced wide in the early and middle stages. Lost the off hind plate during the running.

GATO MONTES (B Rogerson) - Began awkwardly.

STANIMA MAN (V Colgan) - Began awkwardly. Over-raced in the early stages.

REASONTORETIRE (E Bragg) – Made the first bend awkwardly laying outwards briefly hampering MAC MCGEE. Attempted to jump the crossing near the 1600 metres. Lay out rounding the final bend and continued to shift ground outwards in the final straight.

MAC MCGEE (T Newman) – Briefly hampered rounding the first bend when REASONTORETIRE lay outwards.

OWNER OPERATOR (S Spratt) – Weakened from the 600 metres. Finished a distant last. When questioned, rider advised that the mare failed to handle today's heavy track conditions.

T Thornton (I'M ALICE) - Issued with a warning after allowing her mount to shift inwards making contact with STANIMA MAN when not fully clear shortly after the start.

DENBY ROAD (S Weatherley) - Began awkwardly.

RIPPLE EFFECT (D Prastiyou) - Began awkwardly. Hampered passing the 1000 metres. Improved onto the heels of ENJOYABLE having to be steadied near the 850 metres.

LATISHA (M Hashizume) - Crowded leaving the barriers when runners either side shifted ground. Over-raced in the early stages.

THREE NINETY (A Lawson-Carroll) – Shifted out shortly after the start crowding LATISHA. Simultaneously WEY TOO COOL shifted ground inwards crowding LATISHA.

THE WINKLEPICKA (M Sanson) – Over-raced in the early stages. Made the bend awkwardly near the 1000 metres when laying out running wider hampering RIPPLE EFFECT and continued to lay out for some distance.

Race 3	ARMORY STANDING AT MAPPERLEY STUD 1200

BETTE DAVIS EYES (M Sanson) - Slow to begin (5L). Connections were advised that the mare must barrier trial to the satisfaction of Stewards prior to racing next. Trainer advised that it was his intention to retire the mare.

SHE'S A SHOWOFF (M McNab) - Began awkwardly.

OUR TRISTABELLE (A Goindasamy) – Knuckled on jumping away.

OUR JASMINE (N Parmar) – Had to be eased near the 1000 metres.

APERITIF (T Mitchell) – Over-raced in the early stages getting its head up when being restrained.

HERO WORSHIP (O Bosson) - Performed below market expectations. When questioned, rider advised that he was disappointed with the gelding's effort and could offer no explanation.

Race 4	BROWNIES SPIT SPECTACULAR 1600

MILLENNIUM DAWN (E Bragg) - Slow to begin.

LEICALOT (W Pinn) – Raced wide without cover in the early stages.

LOCK UP (T Thornton) - Over-raced in the middle stages.

GO YOU GOOD THING (J Kamaruddin) – Over-raced in the middle stages.

LOCK UP (T Thornton) – Made the bend near the 1000 metres awkwardly.

ROSBERG (A Lawson-Carroll) - Performed below market expectations. Crowded having to be steadied near the 1000 metres. When questioned, rider advised that the gelding would be better suited to race in a more forward position in future.

SHE SPEEDS (S Spratt) - Finished a distant last. Underwent a post-race veterinary examination which found the mare to have respiratory coughing most likely due to inhaling some dirt.

W Pinn (LEICALOT) - Issued with a warning after permitting his mount to shift in when not fully clear of ROSBERG which was crowded having to be steadied near the 1000 metres.

OPAEA JOE (N Parmar) - Rider dropped his whip near the 200 metres.

Following the running of the race G Lord trainer of the 3rd placed runner MILLENNIUM DAWN viewed Stewards footage of the final straight before electing not to proceed with a protest against the 2nd placed LEICALOT.

Race 5	NZB INSURANCE PEARL SERIES MAIDEN RACE 1600

DAADS EXPRESS (E Bragg) – Slow to begin then hampered shortly after, losing ground.

ENDEAN AFFAIR (N Parmar) - Began awkwardly losing ground. Raced greenly having to be steadied approaching the 1000 metres. Raced greenly when placed under pressure in the final straight. Lay in near the 75 metres.

NINE REALMS (B Rogerson) - Raced keenly when being restrained for a distance approaching the 1000 metres. Had to be steadied near the 75 metres when ENDEAN AFFAIR lay in under pressure.

SEARCHLIGHT (E Nicholas) – Raced wide without cover in the early and middle stages.

GO FIONA (S Spratt) – Raced three wide without cover throughout.

BUBALINA (M McNab) - Gave ground passing the 500 metres. Performed below market expectations. When questioned, rider could offer no explanation. Underwent a post-race veterinary examination which did not reveal any abnormalities.

FIREBUG (T Thornton) - Finished last. Returned to the enclosure with blood present in both nostrils. Following a veterinary examination FIREBUG was confirmed to have bled. FIREBUG shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of at least 100 metres in the presence of a Veterinarian. Connections advised that it was their intention to retire the mare.

Race 6	MILLS REEF MAIDEN 1600

WHAT A CHARMA (B Rogerson) – Slow to begin.

JUST A TIPPLE (N Parmar) - Stood in the barriers when the start was effected losing ground (6L). Connections were advised a warning would be placed against the gelding's barrier manners.

PUDDIN 'N PIE (M Sanson) - Over-raced in the early stages.

RED NYMPH (V Colgan) – Raced wide in the early stages before improving forward to lead near the 1100 metres.

THE LETTER (S Spratt) – Lay out under pressure near the 100 metres hampering JACK IN THE BOX. S Spratt was advised that she must exercise greater care in similar circumstances.

JACK IN THE BOX (L Satherley) - Briefly hampered having to be steadied near the 100 metres.

Race 7

WAIKATO BRANCH NZ FARRIERS ASSOCIATION MAIDEN 1400

POSTULATE (W Pinn) - Raced wide in the early and middle stages. Not persevered with in the final straight when well beaten.

LIGHT SHOW (S Weatherley) – Began awkwardly. Raced wide without cover through the middle stages.

BULLISH (D Danis) - Jumped inwards at the start crowding HUTSON.

DRACHMA (A Lawson-Carroll) - Began awkwardly. Gave ground from near the 500 metres. Shifted ground near the 250 metres when improving onto the heels of POSTULATE. Performed below market expectations. When questioned, rider advised that the gelding would prefer looser track conditions. Underwent a post-race veterinary examination which did not reveal any abnormalities.

HUTSON (B Rogerson) – Crowded leaving the barriers.
