**RACE COMMENTS** 

Race 1 DANNEVIRKE MEAT COMPANY MAIDEN HURDLE 3200

WIND CHIMES (R Leech) - Slow away. Jumped the fence near the 1100 metres awkwardly on the both occasions.

**HARRY HARRISON** (G Walsh) - Over-raced through the early stages due to the slow early pace. Jumped the fence near the 900 metres awkwardly on the first occasion.

BUSYBEINGFABULOUS (P Matthews) - Jumped indifferently over the final stages.

**PRINCE TURBO** (S Fannin) - Jumped the second to last fence awkwardly.

## Race 2 MERRYLEES HOTEL MAIDEN HURDLE 3200

**MYSTERY BAR** (S Karnicnik) - Began awkwardly. Over-raced in the early stages. Jumped indifferently throughout. Retired from the event prior to entering the home straight. Received veterinary attention for a superficial laceration of the near hind post-race.

**CHEEKY AZZ** (G Walsh) - Jumped the fence near the 900 metres awkwardly.

TAUMALOLO (H McNeill) - Retired from the event before entering the home straight.

KHAFEEF (S Fannin) - Jumped the second to last fence awkwardly, losing ground.

**S Karnicnik** (MYSTERY BAR) – Spoken to advisedly regarding the use of his whip on a runner out of contention.

**P Matthews** (ODYSSEUS) - Admitted a breach of Rule 638(2) in that she made a celebratory gesture prior to the winning post. After hearing submissions, the Adjudicator imposed a fine of \$150.

#### Race 3 MARTY DI CATERING HURDLE 3200

MIZZENA (D Parker) - Slow away (4L).

**RINGBOLT** (R Leech) - Jumped the last two fences awkwardly.

## Race 4 BUCKLEY CONTRACTING MAIDEN 2200

**SLY VOLTAGE** (M Northcott) - Began awkwardly, hampering KID WARRIOR and SOIREE. Over-raced when tightened near the 1800 metres. Over-raced having to be steadied passing the 1600 metres.

KID WARRIOR (K Wiles) – Hampered at the start.

**SOIREE** (A Scott) - Hampered at the start. Raced three wide throughout.

NIGHTFALL (L Kennedy) - Began awkwardly, hampering MYSALLY. Raced four wide throughout.

MYSALLY (M Davies) - Hampered at the start.

FABULOUS NANCY (L Zydenbos) - Placed in restricted room near the 1800 metres.

**K Wiles** (KID WARRIOR) - Issued with a warning for permitting his mount to shift inwards near the 1800 metres, tightening SLY VOLTAGE.

# Race 5 JONES BROTHERS PAINTING 2200

KHAN HUNTER (K Wiles) - Began awkwardly losing ground.

**ELECTRIC TIME** (L Zydenbos) -Began awkwardly hampering runners to its outside.

**RISING RANSOM** (S MacNab) - Began awkwardly hampering runners to its inside.

**MONKEY TOWN** (S Mynott) - Hampered start when runners either side shifted ground. Over-raced passing the 1700 metres having to be steadied.

**TRAMORE** (A Scott) - Hampered at the start when runners either side shifted ground. Held up rounding the final bend.

**HEY HEY HEY** (C Sharp) - Hampered at the start when runners either side shifted ground.

**SET IN STONE** (M Northcott) - Raced three wide throughout. Lay inwards throughout having to be straightened on several occasions.

WAIAGARA (L Kennedy) - Raced four wide for the majority of the event.

**HARDTIMES** (T Mercer) - Lay outwards rounding the final bend.

### Race 6 PROPERTY BROKERS STEEPLECHASE 4000

**DES DE JEU** (P Matthews) - Dislodged its rider behind the barriers and cantered a short distance. DES DE JEU was declared a late scratching at 4.14pm due to the rider being injured. Rider P Matthews was examined by St Johns paramedics and stood down from her remaining rides.

**KIDDO** (R Leech) - Jumped the second to last fence awkwardly. Following the event KIDDO suffered a suspected aortic rupture near the stabling area with the Horse Ambulance being deployed and KIDDO being humanely euthanised.

**RAUCOUS** (S Phelan) - Made the last jump awkwardly.

# Race 7 DAVID ELLEN OLIVER MAIDEN STEEPLECHASE 3200

**MONITOR** was a late scratching 4.25pm as there was no available jumps rider.

**MOKELE MBEMBE** (G Walsh) - Jumped the second fence awkwardly, unbalancing the rider. Retired from the event prior to jumping the last fence.

AONGATETE EXPRESS (H McNeill) - Jumped indifferently through the early stages.

**ECHO BAY** (D Parker) - Blundered on landing after jumping the fence near the 700 metres.

**LEICA WARRIOR** (R Leech) - Retired from the event prior to jumping the last fence.

**H NcNeill** (AONGATETE EXPRESS) - Admitted a breach of Rule 638(2) in that he made a celebratory gesture prior to the winning post. After hearing submissions, the Adjudicator imposed a fine of \$150.

#### Race 8 SHANE BROWN RACING 1600

PINKERTON (H McNeill) - Slow away.

GOBUYIT (S Karnicnik) - Slow away. Raced wide throughout.

WANNABE 'N' VEGAS (R Leech) - Ducked in having to be straightened near the 300 metres.

**S Phelan** (ROCKTILYOUDROP) - Admitted a charge in that he struck his mount ROCKTILYOUDROP 7 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a fine of \$500.
