#### Race 2 - ROAD TO JERICHO QUALIFIER 22 OCTOBER MAIDEN (1400m)

**KIZ** (R Mudhoo) – Trainer Mr M McCann advised Stewards that KIZ suffered a fractured sesamoid and has now been retired from racing and sent to stud.

### North Canterbury Jockey Club at Riccarton Park, Saturday, 1 October 2022

#### Race 2 - PRYDE'S EASIFEED MAIDEN (1400m)

**FOLKTALE** (R Mudhoo) – Trainer Mr M McCann reported to Stewards he was satisfied with the post-race condition of the mare and advised the swelling which the mare received to the left front leg subsided within a couple of days after the race. M McCann further advised it is his intention to continue on with FOLKTALE'S current preparation and he may look to nominate the mare for the Canterbury Jockey Club meeting on Saturday, 22 October.

#### Race 5 - INGLEWOOD STUD GUINEAS TRIAL (1400m)

**ARROWETTE** (C Barnes) – Stable Foreman Mr R Mildon reported to Stewards that on return to the stable, ARROWETTE underwent farrier attention which revealed a foot abscess to the left fore. R Mildon further advised it is the stable's intention to continue on with the filly's current preparation.

#### Race 10 - PLOUGH HOTEL (1600m)

**WHALE SONG** (J Chung) – Co-Trainer Mr M Pitman advised Stewards that after a disappointing performance WHALE SONG has been retired as a racing proposition from their stable.

## RACE COMMENTS

### Race 1 CSI OWNERS & TRAINERS ASSN 3YO MAIDEN (1200m)

The start of this race was delayed approximately five minutes when the ambulance became briefly stuck on the track, and further delayed when rider G Jogoo (TYAGONAL) required some minor attention from paramedics once the ambulance arrived at the start area after being struck in the head by his mount.

**KINDRED SPIRIT** (K Chowdhoo) - Became fractious in the barriers prior to the start and then began awkwardly. Got its head up when being restrained passing the 1000 metres then having to be further restrained to avoid the heels of **DAYZEE DIOR** (C Campbell) which shifted inwards when **AN MORRIGHAN** (S Toolooa) was improving quickly to its outside and shifting inwards going into the bend near the 950 metres. Both C Campbell and S Toolooa were advised to exercise greater care.

**MY DEGREE** (M Taylor) - Slow to begin.

**MINI MOET** (B May) - Slow to begin.

**AN MORRIGHAN** (S Toolooa) - Began awkwardly and shifted outwards making firm contact with **PORTMAN STREET**.

**PORTMAN STREET** (L Callaway) - Contacted at the start. Raced wide without cover for the majority of the race. Jumped a shadow on the track near the 800 metres.

**TYAGONAL** (G Jogoo) - Raced ungenerously through the early to middle stages and near the 1000 metres was taken in by **DAYZEE DIOR** resulting in **JAFFA** having to be steadied. Made the bend near the 950 metres awkwardly.

**JAFFA** (K Kwo) – Had to be steadied off the heels of **KINDRED SPIRIT** near the 950 metres. Lay out in the run home having to be corrected by its rider on a number of occasions.

**C Campbell** (**DAYZEE DIOR**) – Issued with a warning after permitting his mount **DAYZEE DIOR** to shift inwards when not sufficiently clear of **TYAGONAL** near the 1000 metres.

<b>Race 2</b>	<b>DAVE GRANT &amp; NEIL KINGSTON 3YO MAIDEN (1200m)</b>
<p>The start was delayed due to a combination of the rider of EXPRESS COUP (K Chowdhoo) having to be re-weighed, along with the delay to race 1.</p> <p><b>POW TONG</b> (C Carmine) - Became fractious in the barriers then beginning very awkwardly and blundering losing ground. The stable representative was advised that a warning would be placed against the gelding for its barrier manners. Over raced in the middle stages being inclined to get its head up.</p> <p><b>IT'S NOT UNUSUAL</b> (T Moseley) - Slow to begin. Had difficulty obtaining clear running in the final straight, with the rider reporting that the gelding had raced greenly in its race day debut.</p> <p><b>MISS MIRANDA</b> (G Jogoo) - Shifted outwards abruptly at the start.</p> <p><b>EXPRESS COUP</b> (K Chowdhoo) - Hung throughout the running.</p> <p><b>BOSS MAN</b> (R Mudhoo) - Steadied when briefly placed in restricted room near the 300 metres then angling outwards across the heels of EXPRESS COUP to obtain clear running approaching the 200 metres.</p> <p><b>LADY INCANTO</b> (S Wynne) - When questioned regarding performance rider was of the opinion the filly would be improved by the experience of its raceday debut. Underwent a post-race veterinary inspection which found the filly to have a high heart rate with a slow recovery.</p>	
<b>Race 3</b>	<b>MACKENZIE SUPPLY SERVICES 2012 SPRINT MAIDEN (1200m)</b>
<p><b>LEAR JET</b> (G Jogoo) - Dislodged its rider leaving the birdcage, being declared a late scratching at 1.29pm after galloping for some distance riderless, with the start being delayed as a consequence.</p> <p><b>TELLME YOU LOVEME</b> (M Taylor) - Slow to begin.</p> <p><b>COUNT NICO</b> (T Moseley) - Slow to begin. Hampered when forced wider near the 600 metres. Lay in under pressure in the straight.</p> <p><b>AORANGI ASSASSIN</b> (R Mudhoo) - Got its head up when being restrained to take cover in the early stages.</p> <p><b>NIPPY THE HIPPY</b> (L Callaway) - Raced wide without cover throughout.</p> <p><b>SMALL TOWN BELLE</b> (J Chung) – Lay out in the run home and had to be straightened near the 300 metres.</p> <p><b>YOU HAVE SEEN</b> (C Johnson) - Improved onto heels near the 600 metres having to be steadied and shift outwards forcing COUNT NICO over extra ground.</p>	
<b>Race 4</b>	<b>JON SNOW &amp; ECHOES OF HEAVEN &amp; CLEARVIEW PARK (1200m)</b>
<p><b>DORIS DIOR</b> (C Campbell) - Began awkwardly losing ground.</p> <p><b>REDFORD</b> (T Comignaghi) - Held up early in the straight continuing to have some difficulty obtaining clear running until inside the final 100 metres.</p>	
<b>Race 5</b>	<b>THE KELMANS ON TRACK AT PLR TODAY (1200m)</b>
<p><b>BOOT IT SCOOTER</b> (K Chowdhoo) - Fractious in the barriers then began very awkwardly and blundered losing ground.</p> <p><b>HAGGLE</b> (C Campbell) - Slow to begin.</p>	

**PLAY THE FIELD** (T Comignaghi) - Raced wide through the early stages.

**GLOBAL BEAUTY** (B May) - Slow to begin then restrained to obtain cover from a wide draw.

**KAPALKA** (J Chung) - Restrained from a wide draw shortly after the start to obtain cover.

**SILVER CANNON** (R Mudhoo) - Over raced in the early stages and had to be restrained passing the 1000 metres to obtain cover.

**ZOULANDER** (L Callaway) - Checked when crowded near the 1000 metres.

**VENTURESOME** (S Wynne) - When asked to comment on the performance of this favoured runner, rider advised that the mare had raced disappointingly but added that in her opinion a step up in distance would be of benefit at this point in its campaign.

**M Taylor** (ADANNAYA) - Admitted a charge of careless riding in that she permitted her mount ADANNAYA to shift inwards when not sufficiently clear of ZOULANDER which was checked near the 1000 metres. After considering submissions the Adjudicator imposed a suspension of M Taylor's licence to ride in races from the conclusion of racing on Saturday, 15 October until the conclusion of racing on Saturday, 22 October, 5 national riding days.

<b>Race 6</b>	<b>MICHAEL &amp; MATTHEW PITMAN MILE (1600m)</b>

**VALYRIAN** (M Taylor) - Slow to begin.

**PROSERVE** (K Chowdhoo) - Slow to begin.

**JUST A PROMISS** (A Balloo) - Slow to begin.

**KING OF THE DANCE** (R Beeharry) - Began awkwardly.

**DOUBLE PROSPERITY** (B May) - Raced wide in the early stages.

**HEY SOUL SISTER** (G Jogoo) - Raced wide through the early and middle stages until improving forward passing the 900 metres.

**SPINDLESHANKS** (R Mudhoo) - Steadied when placed in restricted room near the 950 metres.

**UGO** (J Laking) - Held up rounding the final turn and in the straight not obtaining clear running until passing the 150 metres.

**THISTLE** (T Comignaghi) - Held up early in the straight and did not obtain clear running until inside the final 100 metres.

**B May** (DOUBLE PROSPERITY) - Issued with a warning after permitting his mount DOUBLE PROSPERITY to shift inwards when improving to the outside of DIORADELLE resulting in SPINDLESHANKS being placed in restricted room near the 950 metres.

<b>Race 7</b>	<b>JOHNNY WALSH &amp; NIGHT 'N DAY PARK MAIDEN (1600m)</b>

Trainer **R Bevin** (THE DUDE) – Issued with a warning after presenting THE DUDE without the notified pre-race ear covers.

The start was delayed due to EARS BACK (L Callaway) proving very difficult to load, with the connections advised that EARS BACK was on a barrier manners warning.

**EARS BACK** (L Callaway) - Proved very difficult to load and then began awkwardly losing ground. Had to be firmly restrained when improving onto heels passing the 800 metres. Again had to be briefly steadied off heels approaching the 400 metres. Held up early in the straight then having to be checked when disappointed for a run passing the 250 metres. EARS BACK then had to be angled outwards across heels to obtain clear running.

**NELLIE GREY** (G Jogoo) - Slow to begin.

**INDI NINDY** (M Taylor) - Slow to begin. Raced three wide without cover for the majority of the race.

**THE ARCTIC BLAST** (K Chowdhoo) - Began awkwardly shifting outwards crowding CEEDOUBLEUJAY. Over raced badly in the early stages having to shift outwards to avoid heels near the 1100 metres. Held up rounding the final bend. When questioned regarding performance, rider advised that the gelding had proved a difficult ride, over racing and being inclined to hang and then failed to finish the race off. A post race veterinary inspection did not reveal any obvious abnormality.

**CEEDOUBLEUJAY** (K Mudhoo) - Crowded at the start losing ground. Held up passing the 250 metres.

<b>Race 8</b>	<b>RICHIE &amp; BRIDGET PRESTON MAIDEN 2200</b>

**ASTRADEEL** (B Murray) – Slow to begin. Steadied to avoid the heels of BAILADOR which shifted outwards near the 600 metres. Hampered near the 50 metres when CLARA MONCRIEFF ducked outwards abruptly.

**STEVE AUSTIN** (L Callaway) - Over raced in the early stages and near the 1900 metres had to be heavily restrained when attempting to obtain cover.

**BAILADOR** (R Mudhoo) – Got its head up shortly after the start when being restrained to obtain cover. Had to shift outwards when becoming awkwardly placed near the heels of VITAL PEFECTION near the 600 metres hampering ASTRADEEL. Following the race rider R Mudhoo weighed in 0.7 kg under the correct weight. A request for a ruling was filed under the provisions of Rule 648(3) with the Adjudicator determining that BAILADOR be disqualified from 9<sup>th</sup> placing.

**THEUNNAMEDFEELING** (S Wynne) - Began to over race near the winning post on the first occasion and got its head up when being restrained to avoid heels. Held up passing the 600 metres.

**VITAL PERFECTION** (K Mudhoo) - Had to be steadied off heels approaching the winning post on the first occasion.

**CLARA MONCRIEFF** (A Balloo) - Ducked out abruptly near the 50 metres.

**R Mudhoo** (BAILADOR) - Admitted a charge in that he weighed in 0.7 kg less than the correct weight on his mount BAILADOR where it was found that he had failed to place the lead with which he had weighed out into the lead bag which had been passed onto connections for saddling. After considering submissions the Adjudicator imposed a fine of \$250.

<b>Race 9</b>	<b>EQUINE VETERINARY SERVICES STAYERS (2200m)</b>

**CAMPING** (S Wynne) - Reluctant to proceed to the start area, with trainer A Frye being spoken to regarding the gelding's manners.

**JILDI JILDI** (A Balloo) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

**PINHEAD** (B May) - Held up behind the weakening ROAD TO REIGN approaching the 500 metres then striking a heel of that runner and blundering.

**ROAD TO REIGN** (T Moseley) - Finished a distant last. A post race veterinary inspection did not reveal any obvious abnormality.

**T Comignaghi** (DIAMOND RIVIERE) - Issued with a warning when weighing in 0.6 kg in excess of the weigh at which she had weighed out.
