Race 1 MITRE 10 MATAMATA MAIDEN 1400

**MA BAKER** (D Prastiyou) – Trainer V Prendergast reported to Stewards she was satisfied with the post-race condition of MA BAKER, however, has now been sent for a brief spell.

**Race 6 AHD HAWKE'S BAY GUINEAS 1400 (G2)**

**DYNASTIC** (O Bosson) – Te Akau Racing Manager R Trumper reported to Stewards trainer M Walker was satisfied with the post-race condition of the colt, and it is his intention to nominate DYNASTIC for the Waikato RC meeting on Saturday 22 October.

**Race 7 TEAM WEALLEANS MATAMATA CUP 1600 (Listed Race)**

**CHEVRON** (L Satherley) – Trainer C Gibbs advised Stewards he was satisfied with the post-race condition of the gelding, however, has now been sent for a spell.

**BELLE EN ROUGE** (C Grylls) – Te Akau Racing Manager R Trumper reported to Stewards trainer M Walker was satisfied with the post-race condition of BELLE EN ROUGE, and it is his intention to continue on with the mare's current preparation.

**Race 8 ANCROFT DEVELOPMENTS 1600**

**CAKEBYTHEOCEAN** (M McNab) – Trainer C Gibbs confirmed with Stewards CAKEBYTHEOCEAN has been sent for a spell.

**Race 9 ARROWFIELD STUD PLATE 1600 (G1)**

**IMPERATRIZ** (O Bosson) – Te Akau Racing Manager R Trumper advised Stewards trainer M Walker was satisfied with the post-race condition of the mare, however, has now been sent for a spell. R Trumper further advised IMPERATRIZ will undergo a bone density scan on Tuesday 18 October. Stewards will follow up on the results of the scan next week.

**RACE COMMENTS**

**Race 1 SADDLERY WAREHOUSE CAMBRIDGE MAIDEN 1550**

**THE SPRINKLER** (A Lawson-Carroll) – Slow to begin.

**KING MANDALO** (M McNab) - Slow to begin then restrained to obtain cover in the early stages.

**BLACKCOMB** (J Fawcett) - Restrained to obtain cover in the early stages.

**JUSTASCOOTA** (C Grylls) - Raced wide in the early stages.

**HIGHLY VINDICATED** (D Danis) – Had to be steadied off heels near the 1000 metres then continued to over-race for a distance.

**SEARCHLIGHT** (K Asano) – Raced three wide without cover from the 1000 metres.

**BUCCHERI** (O Bosson) – Performed below market expectations. When questioned, rider could offer no explanation.

**Race 2 COOKIES KITCHEN FOOD TRUCK MAIDEN 1300**

**EPARAIMA** (K Hercocock) - Slow to begin. Held up entering the final straight and was unable to obtain clear running until near the 200 metres.

**SWAZI** (J Riddell) – Crowded leaving the barriers. Raced wide in the early stages.

**LYCOMEDES** (R Elliot) - Jumped outwards at the start losing ground. Finished a distant last. Performed below market expectations. When questioned, rider advised that the gelding failed to hit out at any stage during the race. Underwent a post-race veterinary examination which did not reveal any abnormalities. Stewards will follow up the recovery of the gelding with connections in the coming days.

**SUPER WARRIOR** (J Fawcett) – Jumped inwards leaving the barriers contacting LYCOMEDES. When questioned regarding the improved performance trainer advised that the filly appreciated the step up in distance and being able to lead and dictate the pace.

**MASTERCHEF** (M McNab) – Began awkwardly.

**BELLANO** (D Prastiyou) – Slow to begin.

**VILLON** (S Spratt) - Over-raced passing the 1000 metres having to be restrained off heels. Had to be steadied off heels close to the finish line.

**GOOD TIME GARRY** (O Bosson) - Performed below expectations. When questioned, the rider could offer no explanation.

**Race 3** | **PIKE RACING 1300**

**AOIDE** (K Hannan) - Slow to begin. Faltered for a stride shortly after leaving the barriers. Had some difficulty obtaining clear running for the majority of the final straight.

**CAMAROSA** (O Bosson) - Began awkwardly. Shifted out shortly after the start contacting MAGIC SHOW. Performed below market expectations. When questioned, rider could offer no explanation.

**ROCABURY** (J Riddell) - Slow to begin. Over-raced when racing wide in the early stages.

**MAGIC SHOW** (M McNab) – Contacted shortly after the start. Over-raced in the early stages.

**FELIX FAURE** (E Bragg) – Raced three wide without cover throughout. Gave ground rounding the final bend and was not persevered with in the final straight.

**RUSAVY** (A Lawson-Carroll) – Performed below market expectations. When questioned, rider reported that the gelding would appreciate a step up in distance.

**Race 4** | **BETAVET 1300**

**ALPHA CHARLIE** (T Mitchell) - Reared as the start was effected losing ground. Crowded and checked near the 100 metres when TIVAAN WARRIOR shifted in and away from DUNEAGLE which had improved into a marginal run to its outside. When assessing this incident Stewards took into account slight inward movement from PENNY ROYAL (K Hercock).

**TANNAHILL** (A Lawson-Carroll) – Began awkwardly losing ground. Became awkwardly placed on heels having to be steadied near the 500 metres.

**ROCK MY HEART** (L Satherley) - Restrained to obtain cover in the early stages after jumping from the outside barrier. Raced wide without cover through the middle stages.

**DEAR OH DEAR** (T Thornton) – Raced three wide without cover throughout.

**PROVIDENCEPROVIDES** (M McNab) - Raced keenly through the middle stages. Lay inwards early in the final straight making brief contact with MONZA which in turn shifted outwards.

**DUNEAGLE** (A Goindasamy) - Held up for clear running rounding the final bend.

**TIVAAN WARRIOR** (S Spratt) - Crowded having to be steadied passing the 100 metres. Performed below market expectations. When questioned, rider reported that in her opinion the mare may be feeling the effects of recent racing.

**Race 5** | **PETE NEAL THANKS CLIENTS MAIDEN 970**

**MI DUBAI** (L Satherley) – Shifted inwards leaving the barriers contacting MISS BEE.

**MISS BEE** (B Rogerson) – Contacted leaving the barriers.

**SHIVOO** (M McNab) - Shifted outwards abruptly shortly after leaving the barriers hampering RISING RISK and MARUSYA. Was inclined to lay out rounding the final bend.

**RISING RISK** (K Hercock) – Hampered leaving the barriers.

**MARUSYA** (T Mitchell) - Hampered leaving the barriers. Raced ungenerously having to be restrained shortly after the start.

**FIZZY MOON** (K Asano) – Began awkwardly. When questioned regarding the improved performance, trainer reported that the mare derived benefit from having its fresh up run from the stable.

**GUNNAGETYABEANS** (C Grylls) - Slow to begin.

**ANNIE** (T Thornton) - Performed below market expectations. When questioned, rider reported that the mare would derive benefit from today's race. Underwent a post-race veterinary examination which did not reveal any abnormalities.

**FLIP 'N' EASY** (K Hannan) - Raced three wide without cover throughout.

**TAKING MY TIME** (S Spratt) - Improved onto the heels of FIZZY MOON over the concluding stages having to be steadied.

**Race 6** | **HARRISON FENCE PAINTERS 2000**

**OXYGEN** (L Satherley) - Began awkwardly.

**CHARMINGAFFAIR** (D Danis) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

**TE POROPITI** (S Spratt) – Raced three wide without cover from the 900 metres. Weakened rounding the final bend.
