J Riddell did not attend today's meeting due to illness. J Riddell is to provide a medical clearance to Stewards prior to riding next.

Saturday 17 September – TARANAKI RACING INC

Race 2 TARANAKI PINE DASH 990

C Lindsay (CAPE KENNEDY) - Admitted a breach of careless riding in that she permitted her mount to shift inwards when not sufficiently clear of VIOLETSRBLUE which was checked near the 700 metres. After considering submissions the Adjudicator suspended C Lindsay's licence to ride in races from the conclusion of racing on Sunday 16 October up to and including racing on Sunday 23 October, 5 national riding days.

Stewards directed C Lindsay to meet with an NZTR appointed Rider Skills Review Panel under the provisions of Rule 343 due to an incident passing the 450 metres where CAPE KENNEDY fell.

Saturday 8 October – MATAMATA RACING CLUB RACE 12 TAB EXPRESS PAYOUT NOW HERE 2000

L Satherley (LA PALMA) - Admitted a charge in that she struck her mount six times prior to the 100 metres. After considering submissions the Adjudicator suspended L Satherley's licence to ride in races form the conclusion of racing on Wednesday 19 October up to and including racing on Friday 21 October, 2 national riding days and in addition imposed a fine of \$500.

Admitted a charge in that she left the course without permission from the Stipendiary Stewards with the Adjudicator imposing a fine of \$75.

RACE COMMENTS

Race 1 CELLAR DOOR @ WESTBROOK MAIDEN 2100

SMOLDERING YACHT (K Asano) - Jumped outwards at the start unbalancing its rider, losing ground. Made the first bend awkwardly racing wide on the track when racing keenly. Raced wide without cover.

TYNESIDER (A Goindasamy) - Reared as the start was affected, losing ground (5L). Held up rounding the final bend.

MAC MCGEE (J Fawcett) - Began awkwardly.

STANIMA MAN (S Spratt) - Inconvenienced at the start when SMOLDERING YACHT jumped outwards.

PARADING (T Newman) – Raced ungenerously in the early stages. Held up until passing the 300 metres.

BODACIOUS (D Prastiyou) - Raced three wide without cover until near the 1000 metres.

DENZEL (D Danis) - Went off stride approaching the 800 metres. When questioned regarding the performance the rider advised that the gelding had raced greenly throughout and failed to quicken when placed under pressure in the final straight.

Race 2 AVONDALE SUNDAY MARKETS MAIDEN 1600

WHISKY MAC (S Spratt) – Began awkwardly. Over-raced in the early stages.

DAYDREAM BELIEVER (D Danis) – Raced three wide without cover throughout.

JACK IN THE BOX (L Satherley) – Restrained to obtain cover in the early stages. Checked passing the 100 metres.

THE HIGH PRIESTESS (O Bosson) - Held up for clear running early in the final straight.

SMUG (T Thornton) - Contacted and checked near the 300 metres.

O Bosson (THE HIGH PRIESTESS) - Admitted a charge of careless riding in that he permitted his mount to shift outwards when not sufficiently clear of SMUG which was checked near the 300 metres. After considering submissions the Adjudicator suspended O Bosson's licence to ride in races form the conclusion of racing on Saturday 22 October up to and including racing on Saturday 29 October, 5 national riding days.

W Pinn (VADARA) - Admitted a charge of careless riding in that he permitted his mount to shift inwards when not sufficiently clear of JACK IN THE BOX which was checked passing the 100 metres. After considering submissions the Adjudicator suspended W Pinn's licence to ride in races form the conclusion of racing on Saturday 22 October up to and including racing on Friday 28 October, 4 national riding days.

Race 3 AUCKLAND ALARMS MAIDEN 1600

COMPLICATE (A Lawson-Carroll) - Dislodged its rider during the preliminary and was subsequently late scratched. A Lawson-Carroll was attended to by St John Ambulance personnel and was found to be uninjured.

SON OF SASANOF (T Abel) - Late scratched at the barrier after refusing to load. Trainer M Rogers was advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.

QUALIA (D Danis) - Began awkwardly.

JUST A TIPPLE (L Satherley) - Slow to begin.

KIWI MAN (M Hashizume) - Slow to begin.

LIGHT SHOW (T Mitchell) – Over-raced through the middle stages.

BRICKIE'S MOJO (S Spratt) – Raced wide in the early stages.

FRANKS MY WAY (W Pinn) – Raced wide in the early stages.

LOQUITA (M McNab) - Raced keenly in the early stages. When questioned regarding the performance the rider advised that the mare had settled further back than intended adding that LOQUITA would benefit from a step up in distance.

Race 4 WESTBROOK WINERY WAIMAUKU HANDICAP 1600

C'EST UNE STAR (E Nicholas) - Slow to begin.

MUSE (T Mitchell) – Jumped inwards at the start crowding OPAEA JOE. Raced four wide without cover throughout.

OPAEA JOE (C Grylls) - Crowded at the start losing ground.

INSIGNIA (O Bosson) - Jumped outwards at the start crowding GINSBURG.

GINSBURG (W Pinn) – Crowded at the start. Had difficulty obtaining clear running early in the final straight.

BURGUNDY DANCER (L Satherley) - Shifted inwards leaving the barriers crowding VERSTAPPEN which in turn contacted NOTHINSWEETABOUTME. Raced three wide without cover. Lay in when placed under pressure being unable to be fully ridden out over the concluding stages. When questioned regarding the performance L Satherley advised that when placed under pressure in the final straight the gelding had felt indifferent in its action. Underwent a post-race veterinary examination which did not reveal any abnormality.

VERSTAPPEN (S Spratt) - Crowded at the start.

NOTHINSWEETABOUTME (A Lawson-Carroll) – Contacted at the start.

YES WE KHAN (K Asano) – Held up early in the final straight.

Race 5 OFF THE RAILS LUNCHBAR RAILSIDE AVE 1100

GOLDEN HUE (R Beemud) - Knuckled at the start, unbalancing its rider.

PISCO SOUR (M McNab) – Checked passing the 1000 metres then commenced to over-race in the early and middle stages.

STARS 'N' CREAM (M Hashizume) - Raced three wide without cover throughout.

PURE IMAGINATION (O Bosson) - Lay in onto heels passing the 300 metres then continued to lay in for the remainder of the race. When questioned regarding the performance the rider advised that the gelding had lay in when placed under pressure and he had been unable to ride his mount out fully due to these tendencies. Underwent a post-race veterinary examination which did not reveal any abnormality.

QUATTRO QUINTA (K Hannan) - Underwent a post-race veterinary examination which revealed a poor recovery requiring veterinary attention.

R Beemud (GOLDEN HUE) - Admitted a charge of careless riding in that he permitted his mount to shift inwards when not sufficiently clear of PISCO SOUR which was checked near the 1000 metres. After considering submissions the Adjudicator suspended R Beemud's licence to ride in races form the conclusion of racing on Saturday 15 October up to and including racing on Friday 21 October, 4 national riding days.

R Beemud (GOLDEN HUE) - Admitted a charge in that he struck his mount GOLDEN HUE nine times prior to the 100 metre mark. After considering submissions the Adjudicator suspended R Beemud's licence to ride in races from the conclusion of racing on Friday 21 October up to and including racing on Sunday 30 October, 7 national riding days.

Stewards directed R Beemud to meet with an NZTR appointed Rider Skills Review Panel under the provisions of Rule 343 given his record under the whip rule.

Race 6 NEXT AJC RACEDAY 2 NOVEMBER 2022 MAIDEN 1200

SEA THE LIGHT (A Goindasamy) – Restrained to obtain cover in the early stages after jumping from the outside barrier.

DAME LILIBIC (L Satherley) – Over-raced in the early stages. Shifted outwards approaching 350 metres making contact with RUSSIAN SATIRE with that runner then shifting inwards passing the 250 metres making contact with DAME LILIBIC.

RUSSIAN SATIRE (W Pinn) - Contacted passing the 350 metres then shifted inwards passing the 250 metres making contact with DAME LILIBIC.

POLYGON (S Spratt) - Over-raced in the early stages having to be restrained off heels near the 900 metres.

ASKHAM (M McNab) - Restrained off heels near the 800 metres.

THEE AULD MINX (C Grylls) - Raced wide without cover throughout.

Race 7 TRIALS @ AJC 25 OCTOBER 2022 MAIDEN 1200

JUST A KARIN (E Bragg) - Slow to begin (3L).

MADIRAN (S Spratt) – Jumped inwards at the start crowding FULL ON.

HEY GIRLFRIEND (M Kareem) - Began awkwardly losing ground. Improved onto heels inside the final 50 metres having to shift ground outwards to improve.

FASHION DELIGHT (A Goindasamy) – Began awkwardly. Over-raced in the early stages having to be restrained off heels near the 800 metres.

GRAN CABALLO (E Nicholas) – Raced wide in the early stages before improving to lead near the 900 metres.

LULO ROSE (T Mitchell) – Raced three wide without cover.

FULL ON (S Fisher) – Lay out when placed under pressure in the final straight forcing SULABELLA wider on the track passing the 200 metres.

SULABELLA (L Satherley) – Forced wider on the track passing the 200 metres.

Race 8 MARSHALL STAND FUNCTION CENTRE HANDICAP 1200

FINN MCCOOL (T Thornton) – Knuckled shortly after the start.

CAPEL PRINCE (M Hashizume) – Raced wide without cover. Raced greenly when placed under pressure in the final straight.

FLEURGUNDY (M Sanson) – Steadied off heels approaching the 600 metres hampering RIP VAN GOGH.

RIP VAN GOGH (O Bosson) - Hampered approaching the 600 metres. When questioned regarding the performance the rider could offer no excuse.

EDGE OF WONDER (S Spratt) – Improved onto heels passing the 100 metres having to be steadied.

Race 9 AVONDALE RACECOURSE FOR FILMSHOOTS MAIDEN 1200

BEEBEEP (T Mitchell) - Began awkwardly jumping outwards making contact with DONTTELLTIMMY.

DONTTELLTIMMY (K Asano) - Contacted at the start.

JESKO ABSOLUT (J Fawcett) - Knuckled leaving the barriers with the rider losing the use of her left iron for a short distance. Raced wide in the early stages before improving to lead passing the 800 metres.

I'MINTOWIN (A Goindasamy) – Over-raced through the early and middle stages having to be restrained off heels near the 750 metres. Raced keenly through the middle stages.

KIWI'S CRUISIN (C Grylls) – Began awkwardly losing ground.

HARDCORE HENRY (M Hashizume) - Improved onto heels when the pace steadied passing the 500 metres dropping back onto I CAN FLY which had to shift outwards to avoid heels. Underwent a post-race veterinary examination which revealed a minor laceration to the right hind leg.

I CAN FLY (W Pinn) - Had to shift outwards to avoid heels when the pace steadied passing the 500 metres.

LEXA (T Newman) - Steadied when placed in restricted room passing the 300 metres.

J Fawcett (JESKO ABSOLUT) – Issued with a warning for the manner in which she eased the pace passing the 500 metres placing runners behind in difficulty.

W Pinn (I CAN FLY) - Issued with a warning after permitting his mount to shift out when not sufficiently clear of LEXA which had to be steadied when placed in restricted room passing the 300 metres.

Race 10 AJC MEMBERS MAIDEN 1200

MASTER BRUTUS (M Hashizume) - Slow to begin.

SUPER DAISY (S Spratt) – Raced keenly in the early and middle stages.

AMPED (T Mitchell) - Raced three wide without cover throughout.

LOOSE CHOICE (K Asano) - Lay out rounding the final bend.

LIPPY (O Bosson) - Had some difficulty obtaining clear running early in the final straight.

W Pinn (AGHANIM) - Admitted a charge in that he struck his mount six times prior to the 100 metre mark with the Adjudicator imposing a fine of \$250.

Race 11 TOPWELL BAKERY MAIDEN 1400

ESTELLA KHAN (K Asano) – Underwent a pre-race veterinary examination after rearing up in the parade ring and was declared fit to start. Restrained to obtain cover in the early stages after jumping from an outside barrier.

GET LIT (M McNab) – Slow to begin. Held up for clear running until passing the 150 metres.

CARRINGTON (D Danis) – Jumped outwards at the start crowding MIGHTY BRIGHT.

TAVIVIKI (E Nicholas) - Jumped inwards at the start making contact with MIGHTY BRIGHT.

MIGHTY BRIGHT (M Hashizume) – Raced three wide without cover throughout.

NANCHO GIRL (W Pinn) – Raced four wide without cover throughout.

HUTSON (B Rogerson) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

DROP OF SOMETHING (T Newman) - Had some difficulty obtaining clear running early in the final straight.

MALFY ROSA (L Satherley) – Over-raced in the early stages. Had to shift outwards passing the 300 metres to obtain clear running.

D Danis (CARRINGTON) - Admitted a charge in that he struck his mount six times prior to the 100 metre mark with the Adjudicator imposing a fine of \$500.
