E Nicholas did not attend the meeting due to injury and is required to provide a medical clearance prior to riding next.

RACE COMMENTS

Race 1 STELLA ARTOIS PREMIER 2000

CORUBA JAK (S Spratt) - Began awkwardly.

YOLO (L Sutherland) - Began awkwardly hampering INDEEM. Lay inwards throughout the home straight.

INDEEM (T Newman) - Hampered at the start.

CAPTAIN OUMUAMUA (R Elliot) - Raced three wide without cover. Had to steady when placed in restricted room near the 150 metres.

SHE'S SO RELIABLE (L Allpress) - Lay inwards near the 150 metres.

L Sutherland (YOLO) - Issued with a warning after using the whip in two consecutive strides on YOLO passing the 200 metre mark with Stewards taking into account her clear recent record.

L Sutherland (YOLO) - Admitted a charge in that she struck her mount YOLO seven times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of her licence to ride in races from the conclusion of racing on Sunday, 23 October until the conclusion of racing on Tuesday, 1 November, 6 national riding days.

C Grylls (MARGARET JEAN) - Admitted a charge in that he struck his mount MARGARET JEAN seven times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing on Sunday, 23 October until the conclusion of racing on Sunday, 30 October, 5 national riding days, and in addition imposed a fine of \$400.

S Spratt (CORUBA JAK) - Admitted a charge in that she struck her mount CORUBA JAK eight times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a imposed a suspension of her licence to ride in races from the conclusion of racing on Saturday, 22 October until the conclusion of racing on Sunday, 30 October, 6 national riding days.

Race 2BAY FORD PUNTER OF THE YEAR PREMIER 2200

SAILOR JACK (R Elliot) - Slow away.

MISS ONAKI (W Pinn) - Began awkwardly hampering outside runners.

TRAMORE (C Grylls) - Hampered at the start. Raced wide without cover throughout.

WHATSUP (A Mudhoo) - Hampered at the start. Raced three wide without cover throughout.

ROSIELICIOUS (D Bradley) - Hampered at the start

ONEZEDBEE (L Satherley) - Hampered at the start. Rider reported that the gelding had hung and felt a little indifferent in its action. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

NOVAK (O Bosson) - Had to be steadied to obtain cover near the 1800 metres. When questioned regarding performance rider advised the gelding had failed to cope with today's testing track conditions. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

ESCALADE (L Sutherland) - Held up from the 400 metres and continued having difficulty obtaining clear running until inside the final 150 metres.

REGAZZO (J Riddell) - When questioned regarding performance rider advised the gelding had failed to see out the 2200 metre distance in today's very testing track conditions. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

R Beemud (BROOKBOURNE) - Stewards inquired into the manner in which R Beemud used his whip in the home straight and could not be conclusively satisfied that he had contravened the rules, with a sixth strike being very close to the 100 metre mark.

Race 3 MARDIGRAS EVENTS 3YO PREMIER 1300

DUNCAN CREEK (K Hercock) - Slow away. Raced three wide through the early stages. Raced greenly under pressure in the straight. Rider reported that the gelding had raced greenly throughout and that she had recommended to connections the addition of blinkers.

PENNYWEKA (S O'Malley) - Slow away.

THINK TWICE (W Pinn) - Steadied when improving onto the heels of MASCARINTO near the 850 metres. Held up rounding the final bend and early in the straight and did not obtain clear running until near the 250 metres.

MASCARINTO (R Elliot) - When questioned regarding performance rider advised the gelding had failed to handle today's testing track conditions.

FREDERICK (O Bosson) - When questioned regarding performance rider could offer no excuse for the gelding which was making it's race day debut.

K Hercock (DUNCAN CREEK) - Stewards inquired into the manner in which K Hercock used her whip in the home straight and could not be conclusively satisfied that she had contravened the rules, with a sixth strike being very close to the 100 metre mark.

RIKKI RICARDO (D Danis) - Slow away.

MATINEE (K Hercock) - Began awkwardly. Hampered near the 1100 metres.

MAROTIRI MARSTA (S O'Malley) - Began awkwardly. Commenced to over-race badly shortly after the start and near the 1100 metres shifted outwards to avoid heels hampering MATINEE.

GOHUGO (D Turner) - Over-raced in the middle stages.

MOONLIGHT HUSTLER (T Taiaroa) - Held up rounding the final turn and in the straight until passing the 200 metres.

T Newman (ROSIE BRAHMA) - Stewards inquired into the manner in which T Newman used her whip in the home straight and could not be conclusively satisfied that she had contravened the rules, with a sixth strike being very close to the 100 metre mark.

T Mitchell (SHE'S MISS GEVIOUS) - Admitted a charge in that she struck her mount SHE'S MISS GEVIOUS six times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a imposed a suspension of her licence to ride in races from the conclusion of racing on Wednesday, 19 October until the conclusion of racing on Friday, 28 October, 7 national riding days, and in addition imposed a fine of \$400.

Race 5 TUMU GROUP PREMIER 1400

FARAGLIONI (A Mudhoo) - Underwent a pre-race veterinary examination after contacting a rail in the parade ring and was cleared to start.

EREBUS (K Hercock) - Began awkwardly making contact with DIVINE SAVA. Over-raced in the early and middle stages

DIVINE SAVA (L Allpress) - Began awkwardly then being contacted by EREBUS.

HAKA BOOGIE (T Mitchell) - Raced three wide without cover throughout.

SAPPORO (M McNab) - Performed below market expectations. When questioned rider advised the gelding had been unsuited to today's heavy track. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

Race 6 RED BADGE SPRING SPRINT (G3) 1400

CROSS ROADS (D Danis) - Began awkwardly. Ducked outwards passing the winning post to avoid fallen runners, contacting OSELETA and dislodging rider D Danis, who was uninjured.

BELLISSIMO (T Taiaroa) - Began awkwardly.

TIME TICKING (O Bosson) - Lay inwards under pressure in the straight

OLD TOWN ROAD (L Allpress) - Crowded for room over the concluding stages, becoming unbalanced dislodging its rider shortly after the finish. Prior to the authorisation of dividends connections viewed Stewards films before electing not to proceed with a protest. L Allpress stood down from her remaining rides with a hip injury and is required to provide a medical clearance prior to riding next.

TAVIS COURT (F Lazet) - Crowded for room over the concluding stages, becoming unbalanced dislodging its rider shortly after the finish. F Lazet stood down from her remaining rides with possible concussion and is required to provide a medical clearance prior to riding next.

BARI (T Mitchell) - When questioned regarding performance rider advised the gelding had failed to handle today's testing track conditions.

SPRING TIDE (J Riddell) - When questioned regarding performance rider was of the opinion that the gelding was feeling the effects of recent racing.

OSELETE (W Pinn) - Contacted passing the winning post when CROSS ROADS ducked outwards.

PULL NO PUNCHES (M Hudson) - Rider was dislodged after suffering interference following the finish of the race. M Hudson was uninjured.

O Bosson (TIMES TICKING) - Admitted a charge of careless riding in that he permitted his mount TIMES TICKING to shift inwards when not sufficiently clear, crowding OLD TOWN ROAD (L Allpress) and TAVIS COURT (F Lazet) over the concluding stages with both L Allpress and F Lazet being dislodged from their mounts after the winning post as a consequence, along with D Danis (CROSS ROADS) and M Hudson (PULL NO PUNCHES) from resulting interference. After considering submissions the Adjudicative Committee imposed a suspension of O Bosson's licence to ride in races from the conclusion of racing on Saturday, 29 October up to and including racing on Friday, 9 December, 6 weeks, and in addition imposed a fine of \$1000.

Race 7DAN DESPOSITO MEMORIAL PREMIER 1600HONG KONG (S Spratt) - Raced wide in the early and middle stages.

PRIDE OF ASPEN (W Pinn) - Restrained to the rear from a wide barrier. Over-raced in the middle stages.

DICTATION (K Hercock) - Restrained to the rear from a wide barrier. Briefly steadied away from the heels of ONE DREAM ONE SOUL near 300 metres.

WEE DRAM (J Fawcett) - Held up rounding the final bend.

QUEEN OF SPADES (M McNab) - Made the final bend awkwardly then lay outwards under pressure throughout the final straight.

Race 8 LIVAMOL CLASSIC (G1) 2040

SOLDIER BOY (K Hercock) - Began awkwardly. Over-raced when placed in restricted room passing the winning post on the first occasion.

OSAKA (M Hashizume) - Began awkwardly.

HELENA BABY (D Danis) - Over-raced in the lead in the early and middle stages. When questioned regarding performance, rider advised that after over-racing the gelding had been unable to see out the distance of today's race.

JUSTASKME (R Elliot) - Raced wide without cover from the 1400 metres.

DEFRIBRILLATE (J Parkes) - Had to briefly steady away from the heels of VERNANME near the 250 metres.

PRISE DE FER (O Bosson) - When questioned regarding performance rider advised that the gelding had been unable to quicken once placed under pressure in today's testing track conditions but had battled on fairly.

MARRONI (W Pinn) - When questioned regarding performance rider advised that the gelding had found today's track conditions too testing.

Race 9

COLLIERS COMMERCIAL HAWKE'S BAY PREMIER 1200

The start of this race was approximately three minutes late due to ROCKET SCIENCE refusing to load.

ROCKET SCIENCE (H Schofer) – Declared a late scratching at 5.01pm after refusing to load. Connections were advised that ROCKET SCIENCE must barrier trial to the satisfaction of Stewards prior to racing next.

LINCOLN'S KRUZ (J Riddell) - Slow away.

KAPINOS (L Sutherland) - Over-raced in the early and middle stages.

REAL SLIM TRADIE (K Hercock) - Raced wide without cover throughout.

K Hercock (REAL SLIM TRADIE) - Admitted a charge in that she struck her mount REAL SLIM TRADIE six times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of her licence to ride in races from the conclusion of racing on Sunday, 23 October up to and including racing on Friday, 28 October, 3 national riding days, and in addition imposed a fine of \$500.

Race 10 FASTTRACK INSURANCE PREMIER 1400

TAMAHINE (S O'Malley) - Slow away.

BELARDO BOY (J Riddell) - Raced wide without cover.
