**KEVIN MYERS RACING/KEENAN CONCRETE SERVICES MAIDEN 2200** Race 1

OPAL SPIRIT (J Mudhoo) - Knuckled at the start with the rider becoming briefly unbalanced.

**SOMEONE** (C Butler) - Crowded at the start losing ground.

**SPANISH HARLEM** (C Grylls) - Slow to begin.

**WHOSHE'S BOY** (A Goindasamy) - Blundered at the start losing ground. On a slow tempo improved forward to sit behind the leader near the 1000 metres.

**CANBITEABIT** (D Turner) - When over racing had to be steadied after becoming awkwardly placed on the heels of JAY ZED (S O'Malley) which shifted in when not fully clear passing the winning post on the first occasion. S O'Malley was advised to exercise greater care. Held up passing the 400 metres having to shift outwards to obtain clear running early in the final straight.

**JAY ZED** (S O'Malley) - Returned to the enclosure with blood in its mouth. A post-race veterinary examination revealed a laceration to the inside of its mouth.

#### Race 2 NZB INSURANCE PEARL SERIES MAIDEN RACE 1650

The start of this race was delayed approximately 2½ minutes when several runners proved difficult to load.

**BUNYUP** (L Sutherland) - Restrained behind runners to obtain cover shortly after the start.

**LA CAPITA** (C Dell) - Hung outwards rounding the final bend having to be corrected by its rider. When questioned regarding performance rider advised the mare failed to back up from racing on Monday at Woodville. Returned to the enclosure with blood present in the mouth. Underwent a post-race veterinary examination which revealed LA CAPITA to have lost a tooth.

**LADY SUPERB** (S O'Malley) - Raced three wide without cover in the early stages. Commenced to give ground passing the 500 metres and was not persevered with throughout the final straight. When questioned regarding performance rider could offer no excuse. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

ANOTHER BELLA (C Grylls) - Lay inwards under pressure throughout the final straight.

### Race 3 PALAMOUNTAINS/ACTION MOTO 1650

**TWEEDLEDEE** (C Dell) - Underwent a pre-race veterinary examination and cleared to start after being kicked behind the barrier. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

**HARDTIMES** (A Goindasamy) - Became fractious in its barrier and was then slow to begin. Held up approaching the 100 metres and was unable to be ridden out fully to the finish with the gelding going to the line untested.

**IRONWOOD** (J Mudhoo) - Began awkwardly losing ground. When questioned regarding performance J Mudhoo was of the opinion the gelding would benefit from more rain affected going.

**GINO** (L Allpress) - Slow to begin. Placed in restricted room over the concluding stages. Underwent a post-race veterinary examination after returning to the enclosure with blood present in its mouth, which revealed a lesion in its mouth.

**WHEELITIN** (F Lazet) - Knuckled badly at the start with the rider becoming unbalanced. Improved on to heels having to be steadied near the 850 metres.

**SHOWBOURNE** (C Butler) - Raced keenly throughout the early and middle stages. Improved on to heels having to be firmly restrained approaching the 1000 metres, then shifted out across heels and was obliged to race wide without cover for the remainder. Underwent a post-race veterinary examination after returning to the enclosure with blood present in its mouth, which revealed a lesion in its mouth.

**BIKINDY** (M Hudson) - Raced greenly and slowed noticeably when making the lead near the 800 metres resulting in SOVIET WONDER having to be steadied abruptly off heels and lose ground rounding the home turn. M Hudson confirmed BIKINDY raced greenly and hung throughout.

**SOVIET WONDER** (L Sutherland) - Steadied abruptly off heels, losing ground rounding the home turn. Placed in restricted room over the concluding stages.

## Race 4 HAWKEN CONTRACTING/I.S.DAM LINING 1650

**SWING LOW** (M Hudson) - Slow to begin and was then ridden with urgency to recover. Raced three wide without cover throughout.

MASTER FIN (T Taiaroa) - Slow to begin.

**THOMAS AQUINAS** (S O'Malley) - Raced keenly through the early and middle stages.

**PEP TORQUE** (C Butler) - Raced keenly through the early and middle stages.

**BULLY BOY** (T Davies) - Briefly held up entering the final straight.

**SO CALL ME** (L Sutherland) - When questioned regarding performance L Sutherland advised the gelding was not suited to the Good 4 track conditions.

## Race 5 WAVERLEY GOLF CLUB "A HIDDEN GEM" MAIDEN 1650

J Bridge (LET LOOSE) - Issued with a warning for presenting his runner with unnotified gear (bandages).

**HUNGRY** (S O'Malley) - Crowded shortly after the start losing ground. Commenced to over-race through the early and middle stages.

**WAGON WHEE**L (L Allpress) - Slow to begin. Lay inwards under pressure throughout the final straight.

**EXTRAORDINAIRE** (M McNab) - Restrained behind runners to obtain cover shortly after the start.

**RECKENBACKER** (L Sutherland) - Raced wide without cover throughout.

**OPAWA JACK** (C Dell) - Had to be steadied when racing ungenerously near the 750 metres. Briefly held up entering the home straight.

**LET LOOSE** (A Mudhoo) - Raced three wide without cover throughout. Placed in restricted room having to be steadied when BLUE ARROW (F Lazet) lay outwards under pressure passing the 100 metres. F Lazet was advised to exercise greater care.

**BLUE ARROW** (F Lazet) - Lay outwards under pressure passing the 100 metres.

### Race 6 PASTURE FIRST LTD 1200

BRITISH ROYALTY (M McNab) - Slow to begin.

**WHOSHE'S GIRL** (A Goindasamy) - Restrained behind runners to obtain cover shortly after the start. Forced wider 750 metres.

**PLEASURE** (S O'Malley) - Raced three wide without cover throughout.

LEON ROUGE (F Lazet) - Raced ungenerously through the early and middle stages.

**NOTSOMODEST** (C Butler) - Raced keenly through the early and middle stages. Improved on to heels having to be steadied and when doing so shifted out forcing WHOSHE'S GIRL wider on the track near the 750 metres. C Butler was advised to exercise care.

**GLIDE QUEEN** (T Taiaroa) - Held up entering the final straight having to shift inwards to obtain clear running approaching the 250 metres.

# Race 7 KAWA FARMS MAIDEN 1200

**GUNBASHER** (S O'Malley) - Declared a late scratching on veterinary advice at 4.02pm after rearing over backwards in the tie-up stalls.

**J Miller** (TRAINWRECK) - Fined \$50 under the Minor Infringement Schedule for presenting her runner without notified gear (blinkers).

**TIZ LOUIE** (F Lazet) - Began awkwardly with the rider becoming briefly unbalanced and as a result lost considerable ground.

BANANARAHMA (A Goindasamy) - Began awkwardly losing ground.

**OUR SASSIE ANNE** (L Allpress) - Hampered at the start losing ground.

**DUPUG** (C Grylls) - Slow to begin.

**GUNDAHAR** (A Mudhoo) - Raced ungenerously throughout the early and middle stages. Raced three wide without cover throughout.

KNICKERLESS (L Sutherland) - Raced wide without cover throughout.

**BELLE'S ECHO** (M Hudson) - Got its head up when being steadied going into the first bend.

**STOLEN SPIRIT** (C Butler) - Improved up on to heels passing the 600 metres and when being steadied shifted out hampering NASSAU, which was improving to its outside. Also affected was TRAINWRECK, which had to be steadied abruptly. C Butler was shown footage of her ride in the presence of the Apprentice Mentor and was advised to exercise greater care when in a similar circumstance.

NASSAU (M McNab) - Hampered 600 metres.

TRAINWRECK (C Dell) - Steadied 600 metres.

#### Race 8 HERENGAWE ROAD MAIDEN 1400

J-L Lupton (BE FLEXI) - Issued with a warning for presenting BE FLEXI without the notified gear (pre-race ear covers).

TRIGGER HAPPY (D Turner) - Slow to begin.

**TAMBERI** (C Butler) - Began awkwardly losing ground.

ARCADIAN IYNX (M McNab) - Raced ungenerously, getting its head up on a number of occasions in the early stages.

**KRONE** (L Allpress) - Raced three wide without cover throughout. Rider reported the mare had hung outwards throughout the running and was not persevered with over the final stages as she thought there may be something amiss. A post-race veterinary examination did not reveal any obvious abnormalities. Connections undertook to monitor the mare over coming days and report any anomalies.

**DAWN ESTELLE** (M Hudson) - Raced wide without cover throughout.

**SILVER EAGLE** (S O'Malley) - Lay outwards under pressure throughout the final straight having to be corrected by its rider.
