RACE COMMENTS

Race 1 | **SKYCITY HAMILTON WAIKATO CUP DAY 10 DECEMBER 2YO (1000 metres)**

JINN WARRIOR (L Satherley) - Blundered badly at the start then further hampered when contacted losing ground. Raced greenly throughout.

CYCLONIC KING (O Bosson) - Began awkwardly shifting inwards abruptly.

BALANCE OF POWER (M McNab) - Slow to begin.

TOA TUAHINE (V Colgan) - Contacted leaving the barriers losing ground.

PERENARA (A Lawson-Carroll) – Restrained in the early stages to obtain cover after jumping from the outside barrier.

ALL A FLUTTER (M Hashizume) - Raced wide through the early and middle stages.

FARRAVALLO (D Prastiyou) – Raced keenly outside the leader through the middle stages.

Race 2

SVS STARTING GATES MAIDEN 1200

CARAVELLA (M McNab) – Rider M McNab was granted permission to ride 1 kg overweight at 55 kgs. Lay inwards under pressure in the straight.

TAKING MY TIME (W Pinn) - Began awkwardly losing ground.

TIDAL FORCE (O Bosson) – Slow to begin. Briefly held up near the 400 metres having to shift outwards across heels to obtain clear running.

NANA’S WISH (W Kennedy) – Began awkwardly then restrained in the early stages to obtain cover after jumping from the outside barrier. Ducked outwards abruptly near the 200 metres.

SHIRAZELLE (T Thornton) - Raced three wide without cover.

KENOBI (J Riddell) - Made the bend near the 850 metres awkwardly when racing keenly. Shifted away from CARAVELLA near the 250 metres making contact with the hindquarters of ELUSIVE NATION. Hampered when crowded near the 200 metres to the inside of CARAVELLA which lay in.

ELUSIVE NATION (S Spratt) - Hindquarters contacted near the 250 metres. Badly hampered when crowded for a distance passing the 200 metres.

SHOOTIN TO SAKS (L Satherley) - Badly hampered when contacted and crowded passing the 200 metres.

OVER THE MOON (K Hannan) - Badly held up passing the 200 metres and did not obtain clear running for the remainder of the race.

M McNab (CARAVELLA) - Admitted a charge of careless riding in that he permitted his mount to shift inwards when insufficiently clear crowding KENOBI, ELUSIVE NATION and SHOOTIN TO SAKS near the 200 metres. After considering submissions the Adjudicator imposed a suspension of M McNab’s licence to ride in races from the conclusion of racing on Sunday 23 October up to and including racing on Sunday 30 October, 5 national riding days.

Following the race, connections of the 3rd placed runner KENOBI viewed Stewards footage of the final straight before electing not to proceed with a protest.

Race 3

DISTINCTION HOTEL @ TE RAPA 2400

LEICA WARRIOR (B Rogerson) - Began awkwardly.

HERE’S JOHNNY (D Prastiyou) – Began awkwardly. Raced three wide without cover from the 1100 metres.

MS ROSE (A Goindasamy) – Over-raced in the early stages.

CHAMINGAFFAIR (L Satherley) – Raced wide in the early stages. Hampered when weakening near the 400 metres.

PEERLESS WARRIOR (S Spratt) – Improved three wide from the 1600 metres before settling outside the leader approaching the 1000 metres.

PLUSHENKO (A Lawson-Carroll) - Over-raced passing the 1400 metres having to be restrained off heels.

PRIMO STELLA (M Hashizume) – Held up for clear running passing the 600 metres until near the 350 metres.

M Hashizume (PRIMO STELLA) – Issued with a warning after angling his mount outwards to obtain clear running hampering CHAMINGAFFAIR near the 400 metres.

Track upgraded to Good 4 following this race.

Race 4	DUNSTAN HORSEFEEDS STAYERS (2400 metres)

STARRYBEEL (M McNab) - Began awkwardly.

LEADERBOARD (O Bosson) – Began awkwardly then crowded shortly after losing ground. When questioned regarding performance rider advised that after suffering interference at the start the gelding appeared to have switched off and had felt disinterested.

SHE'S A MANEATER (N Parmar) – Restrained to obtain cover in the early stages after jumping from the outside barrier. Was inclined to lay inwards under pressure over the final 200 metres. When questioned regarding his riding tactics and in particular why he had opted to shift outwards to improve forward wide from the 800 metres, apprentice N Parmar advised that after getting further back than intended and racing adjacent to the running rail he had felt that he needed to attempt to improve his position but in hindsight agreed with Stewards that he had erred in his judgement and should have shown more patience. Apprentice N Parmar was advised that he would be expected to show better judgement in future. N Parmar further advised that the mare is better suited to more rain affected footing.

ATA RANGI (K Hannan) - Raced wide in the early stages.

WORDSWORTH (S Spratt) – Raced three wide without cover throughout. When questioned regarding performance rider advised that the gelding was unsuited by today's improved track conditions.

BROOKBOURNE (B Rogerson) - Raced keenly through the early and middle stages.

CLEESE (W Kennedy) – Lay inwards under pressure in the straight.

QUIZ KID (M Cropp) – Rider reported that the gelding had hung throughout and may be better suited by slower footing.

P Lock (SHE'S A MANEATER) – Issued with a warning after presenting SHE'S A MANEATER without the notified blinkers.

Race 5	SUPER SETH SOLILOQUY STAKES (1400 metres) (G3)

NANCHO GIRL (D Turner) - Began awkwardly losing ground. Raced ungenerously for a distance passing the 1000 metres having to be steadied off heels.

LEGARTO (R Elliot) – Began awkwardly losing ground.

SHEZ CLASS (M Hashizume) – Contacted leaving the barriers.

RIONACH (W Kennedy) - Began awkwardly. Had to be firmly restrained when improving onto the heels of **PROWESS** near the 950 metres. Had to shift ground to avoid the heels of **FLAMEBIRD** near the 100 metres.

VAL DI ZOLDO (S Spratt) – Raced three wide without cover.

MANZORATTI (T Thornton) - Over-raced near the 1000 metres having to be steadied off heels.

PROWESS (V Colgan) - Had to be restrained when awkwardly placed near heels passing the 1000 metres. Held up passing the 200 metres having to angle outwards across the heels of **VAL DI ZOLDO** to obtain clear running.

ROMANCING THE MOON (M McNab) – Raced keenly in the middle stages. Contacted passing the 300 metres.

ROBABABY (A Mudhoo) - Ducked outwards rounding the final turn near the 450 metres. When questioned regarding performance rider advised that he lost the use of his left iron for a short distance shortly after the start and the filly had raced greenly throughout.

FLAMEBIRD (A Goindasamy) - Raced in restricted room to the inside of **MAZZOLINO** near the 300 metres when that runner had shifted inwards slightly with **FLAMEBIRD** making contact with **MAZZOLINO** which was bumped outwards onto **ROMANCING THE MOON**. Crowded between **MISS NICO BELLE** and **MAZZOLINO** when both runners shifted ground having to be steadied near the 100 metres.

MAZZOLINO (C Grylls) - Contacted passing the 300 metres.

Race 6	BILL LACY MEMORIAL MILE (1600 metres)

SAMINA BIBI (A Goindasamy) - Began awkwardly. Steadied off heels near the 700 metres.

DARCI'S QUEEN (N Parmar) - Began awkwardly.

SOPHIA'S MAGIC (V Colgan) – Raced keenly in the early stages.

ROCKET LAD (O Bosson) – Raced wide in the early stages.

TANNAHILL (K Hannan) - Raced three wide without cover from the 1000 metres.

Race 7	JAMES AND ANNIE SARTEN MEMORIAL STAKES (1400 metres) (G2)

DYNASTIC (O Bosson) - Began awkwardly.

WILD NIGHT (C Grylls) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

GOLDBURG (A Goindasamy) – Hampered near the 1000 metres having to steady to avoid the heels of **THE RACKETEER** losing ground.

THE RACKETEER (J Riddell) – Hampered when **MR MOJO RISIN'** shifted outwards near the 1000 metres with **THE RACKETEER** then racing three wide without cover for the remainder of the race.

ALFRISTON (S Lacy) – Over-raced in the early and middle stages having to be steadied off heels near the 800 metres. Held up rounding the final turn.

MR MOJO RISIN' (W Pinn) – When questioned regarding performance rider advised that the gelding had never felt to hit out freely today and had been disappointing. Underwent a post-race veterinary examination which found the gelding to have jarred up.

LEEDOX (R Elliot) – Underwent a post-race veterinary examination which found the gelding to be 2/5 lame in the right hind leg. Connections were advised a veterinary clearance would be required prior to racing next.

DESERT LIGHTNING (V Colgan) - Steadied to avoid the heels of the weakening MR MOJO RISIN' near the 400 metres.

W Pinn (MR MOJO RISIN') - Admitted a charge of careless riding in that he permitted his mount to shift outwards when not sufficiently clear of THE RACKETEER near the 1000 metres with GOLDBURG being hampered as a result. After considering submissions the Adjudicator imposed a suspension of W Pinn's licence to ride in races from the conclusion of racing on Tuesday 01 November up to and including racing on Friday 11 November, 7 national riding days.

Race 8	SISTEMA RAILWAY @ TE RAPA NEW YEARS DAY 1400

SELF OBSESSION (M McNab) - Rider M McNab was granted permission to ride 1 kg overweight at 55 kgs. Slow to begin.

DAWN JESSIE (E Bragg) - Contacted leaving the barriers. Rider dropped her whip near the 250 metres.

THUNDER (M Hashizume) – Began awkwardly making contact with DAWN JESSIE. Was inclined to lay inwards under pressure in the straight hampering MORE WONDER near the 100 metres. M Hashizume was advised to exercise greater care.

PALM SPRINGS (K Hannan) – Began awkwardly.

GERMANICUS (O Bosson) - Restrained to obtain cover in the early stages after jumping from an outside barrier. Raced three wide without cover from the 800 metres.

LILY THUNDER (S Spratt) – Began awkwardly. Got its head up when being restrained to avoid the heels of DAWN JESSIE near the 1100 metres then continued to over-race through the middle stages.

MORE WONDER (R Elliot) – Raced wide in the early stages. Hampered near the 100 metres.

E Bragg (DAWN JESSIE) - Issued with a warning after permitting her mount to shift inwards when not fully clear of LILY THUNDER near the 1100 metres.

Race 9	WAIKATO DRAUGHT 1300

FALL ON A STAR (M McNab) - Began awkwardly then contacted by LA BELLA BEALS. Had to be steadied off heels approaching the 1100 metres.

LA BELLA BEALS (O Bosson) – Began awkwardly making contact with FALL ON A STAR.

KARMAN LINE (C Grylls) - Slow to begin.

BAD 'N' BOUJ (S McKay) - Restrained to obtain cover in the early stages after jumping from an outside barrier.

DAZZLING MISS (A Goindasamy) - Restrained to obtain cover in the early stages after jumping from an outside barrier.

DEEBEE ZAPOWER (R Elliot) – Raced wide without cover throughout. Eased down in the final straight and returned to the enclosure with blood present in both nostrils. Following a veterinary examination DEEBEE ZAPOWER was confirmed to have bled. DEEBEE ZAPOWER shall not be ridden in exercise for a period of two months or start in any race to trial for a period of three months and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.

Race 10

NZB READY TO RUN TRAINERS SERIES 1400

NEST EGG (C Grylls) – Began awkwardly.

BRECKON POWER (W Pinn) - Began awkwardly then hampered shortly after the start. Over-raced when being restrained in the middle stages.

DOUBLE O' SEVEN (M McNab) - Began awkwardly making contact with BRECKON POWER. When questioned regarding performance rider advised that the gelding had been outpaced early, and in his opinion would now be suited over more ground.

ORLEANS BELLE (M Hashizume) – Began awkwardly hampering CLASSIC BEETHOVEN.

CLASSIC BEETHOVEN (O Bosson) – Hampered at the start. When questioned regarding performance rider advised that the gelding had been inclined to over-race and had been unable to finish the race off.

RANGER (L Satherley) - Began awkwardly. Over-raced in the early and middle stages and raced wide throughout.

BILLY BUNTER (J Riddell) - Restrained to obtain cover in the early stages after jumping from an outside barrier.

EDGE OF WONDER (R Elliot) - Slow to begin.

EL BANDOLERO (T Newman) – Hampered shortly after the start.

OUR TRISTABELLE (A Goindasamy) - Shifted outwards shortly after the start hampering outside runners. Raced wide without cover. Rider reported that the mare had hung throughout and had felt awkward rounding the bend advising that it was its first start left handed, further adding that in his opinion OUR TRISTABELLE may not have been suited by the improved track conditions. A post-race veterinary inspection including an endoscopic examination found the mare to be coughing with mucus in the windpipe.
