Stewards were advised that D Prastiyou had been injured at trackwork and would not be attending today's race meeting. D Prastiyou is to provide a medical certificate prior to riding next.

Race 4 – DUNSTAN HORSEFEEDS STAYERS (2400 metres)

WORDSWORTH (S Spratt) - Trainer M Falconer reported that blood tests taken on return to her stable had revealed a bacterial infection with the gelding having received the appropriate treatment. M Falconer further advised that she would be monitoring the recovery of WORDSWORTH and looking to carry on with its current preparation.

RACE COMMENTS

Race 1

REVITAL GROUP 2000

NOVAK (T Newman) - Jumped away awkwardly making contact with ARJAY'S FLIGHT. Was unable to obtain clear running throughout the final straight going to the line without being fully tested by its rider.

ARJAY'S FLIGHT (W Pinn) – Contacted leaving the barriers. Rider reported that the gelding had felt unsure of its footing going into the first turn near the 1600 metres. Raced three wide without cover for the majority of the race.

LAGERFELD (J Riddell) - Following the race the rider reported that his mount had lost its footing going into the first turn near the 1600 metres.

ESS VEE ARE (R Elliot) - Shifted outwards passing the 700 metres making contact with NOTHINSWEETABOUTME which was forced wider.

QUEEN SARABI (M Hashizume) – Unable to obtain clear running over the concluding stages.

NOTHINSWEETABOUTME (A Lawson-Carroll) - Contacted and forced wider passing the 700 metres. Was eased down in the final straight. Underwent a post-race veterinary examination which revealed the gelding to have suffered from a tendon injury to the right foreleg. Connections were advised that a veterinary clearance would be required prior to racing next. Trainer W Hillis indicated that NOTHINGSWEETABOUTME was now likely to be retired from racing.

Following reports from riders about their mounts shifting rounding the first bend, Stewards inquired into the state of the track. After reviewing footage, inspecting the track and taking into account the views of the riders involved, Stewards were satisfied for the meeting to continue.

Race 2

REMEMBERING TOBY AUTRIDGE MAIDEN 1050

MISS CAPRICORN (A Goindasamy) - Bolted during the preliminary galloping for some distance before being able to be brought under control and was declared a late scratching at 12.34 pm. As a result, this race started approximately 4

minutes late. Trainer L Te Keeti was advised that the mare would be required to barrier trial satisfactorily before racing next.

POKURU SHOW (R Elliot) - Jumped away awkwardly after being fractious in the barriers making contact with DIGNITOSA then shifting inwards further hampering BELLO MIO. Made the bend near the 800 metres awkwardly.

BELLO MIO (V Colgan) - Contacted leaving the barriers when AGHANIM jumped outwards before being further hampered when crowded. Improved onto the heels of ORDER TO CHARGE which was shifting outwards approaching the 50 metres with BELLO MIO then ducking outwards abruptly unbalancing its rider. Rider V Colgan reported that the gelding had raced greenly in its raceday debut.

DIGNITOSA (W Kennedy) – Contacted leaving the barriers.

AGHANIM (W Pinn) – Jumped away awkwardly making contact with BELLO MIO then being further hampered by ORDER TO CHARGE which lay out shortly after jumping away.

TRUECOLOURS (L Satherley) – Raced in restricted room to the inside of ORDER TO CHARGE which shifted inwards passing the 700 metres.

C Lammas (ORDER TO CHARGE) – Issued with a warning after permitting his mount to shift inwards when not sufficiently clear of TRUECOLOURS which had to be steadied passing the 700 metres.

Race 3

CW COLE RACING 1050

HERO WORSHIP (N Parmar) – Restrained to obtain cover in the early stages after jumping from a wide barrier.

FIZZY MOON (J Fawcett) - Restrained to obtain cover in the early stages after jumping from a wide barrier.

LA VERITE (R Elliot) - Over-raced when being restrained in the middle stages. When questioned regarding performance rider reported that the mare had held its breath throughout the running. Underwent a post-race veterinary examination which revealed the mare to have suffered cardiac arrhythmia. Trainer C Cole was advised that LA VERITE will not be permitted to start in any race or trial until a veterinary certificate is provided declaring the horse free of any cardiac arrhythmia following a gallop of at least 1000 metres along with satisfactory results from an ECG.

AOIDE (K Hannan) - Raced wide without cover before improving forward to lead passing the 600 metres.

AMORAMIO (C Lammas) – Raced wide throughout.

OH HERMANI (A Lawson-Carroll) - Lay out rounding the final turn running wide. When questioned regarding performance rider advised that the mare had not felt comfortable in today's track conditions.

DRAGON BISCUIT (M Hashizume) - Checked to avoid the heels of BERBIZIER which was taken out by LA VERITE rounding the final turn near the 350 metres.

BERBIZIER (J Riddell) - Forced outwards passing the 350 metres.

SAGAN (W Kennedy) - Improved onto heels passing the 200 metres having to shift outwards to improve.

PARADIGM SHIFT (T Mitchell) - Briefly steadied after improving into restricted room near the 150 metres.

R Elliot (LA VERITE) - Admitted a charge of careless riding in that he permitted his mount LA VERITE to shift outwards when not sufficiently clear dictating BERBIZIER outwards into the line of DRAGON BISCUIT which was checked near

the 350 metres. After considering submissions the Adjudicator imposed a suspension of R Elliot's licence to ride in races from the conclusion of racing on Saturday 5 November up to and including racing on Friday 11 November, 4 national riding days.

Race 4 | **WAIKATO EQUINE VETERINARY CENTRE MAIDEN 1200**

TRU PLANET (T Mitchell) - Made the bend awkwardly near the 800 metres then continued to lay out rounding the final bend.

SHANGHAI TANG (V Colgan) - When questioned regarding performance the rider was unable to offer any excuse.

Race 5 | **NZB INSURANCE PEARL SERIES RACE 1200**

MAGIC SHOW (T Mitchell) - Slow away. Raced three wide without cover.

POLYGON (W Kennedy) - Knuckled on jumping away.

SIDE HUSTLE (C Lammas) - Began awkwardly losing ground.

ACTING OUT (M Hashizume) - When questioned regarding performance the rider advised that the mare had not travelled comfortably throughout, and in his opinion had failed to handle today's track conditions.

Race 6 | **NZB READY TO RUN TRAINERS SERIES 1200**

SHOW COURAGE (L Satherley) - Slow away. Raced keenly in the early stages. When questioned regarding performance the rider reported that the gelding had hung throughout and felt indifferent in its action when placed under pressure in the final straight. Underwent a post-race veterinary examination which did not reveal any abnormality.

COOL CHANGE (M Hashizume) - Jumped away awkwardly. Raced in restricted room for a short distance passing the 50 metres after **FISCAL FUN** shifted out and away from **SASSY MERLOT**.

HASSTOBEYOU (A Goindasamy) - Over-raced for a distance passing the 1000 metres.

COTE DE BEAUNE (J Laking) - Restrained in the early stages to obtain cover after jumping from a wide barrier.

MOHAWK BRAVE (N Parmar) - Restrained in the early stages to obtain cover after jumping from a wide barrier. Held up rounding the final bend.

FARRENC (M Sanson) - Restrained in the early stages to obtain cover after jumping from a wide barrier.

FISCAL FUN (W Pinn) - Crowded leaving the barriers.

Race 7 | **FLY HIGH TAIKI MAIDEN 1300**

TIME TO WONDER (R Elliot) - Slow away.

DEVASTATE (W Pinn) - Hampered near the 700 metres.

THATSALLSHEWROTE (C Lammas) - Slow away. Improved into a marginal run approaching the 300 metres making contact with **ALBY PARK** with both runners becoming unbalanced for a short distance. Contributing was slight outward movement from **KEENASABEAN**.

ALBY PARK (T Thornton) - Contacted and unbalanced approaching the 300 metres.

PRINCESS CIRILLA (M Hashizume) - When questioned regarding performance the rider reported that the filly had never travelled comfortably throughout.

J Laking (IT'S BUSINESS TIME) - Issued with a warning after permitting his mount to shift inwards forcing SENSE OF STYLE inwards hampering DEVASTATE near the 700 metres.

Race 8 | **RICHARDS RACING LTD 1300**

LES CRAYERES (N Parmar) - Jumped away awkwardly. Lay in contacting the hindquarters of NEW YORK JAZZ which became unbalanced near the 1000 metres. As a result, LES CRAYERES had to be steadied.

MANRICO (E Bragg) - Slow away. Raced wide without cover throughout. Raced in restricted room when weakening passing the 350 metres.

NEW YORK JAZZ (T Newman) - Contacted and unbalanced near the 1000 metres. Checked passing the 125 metres. Underwent a post-race veterinary examination which did not reveal any abnormality.

FUNNY GIRL (T Mitchell) – Blundered just short of the finish.

C Lammas (DRAGON QUEEN) - Issued with a warning after using his whip in two consecutive strides on DRAGON QUEEN near the 100 metres with Stewards taking into account his clear recent record with regard to a breach of this whip rule.

N Parmar (LES CRAYERES) - Admitted a charge of careless riding in that he permitted his mount LES CRAYERES to shift inwards when not sufficiently clear of NEW YORK JAZZ which was checked near the 125 metres. After considering submissions the Adjudicator imposed a suspension of N Parmar's licence to ride in races from the conclusion of racing on Saturday 5 November up to and including racing on Wednesday 16 November, 8 national riding days.

Following the running of the race T Newman advised Stewards that she was unwell and would not be able to fulfil her remaining engagements.

Race 9 | **HARRY RICK LOWE MEMORIAL 1600**

ALPHA CHARLIE (A Goindasamy) - Slow away then further hampered by SUPREME KHAN which shifted inwards on jumping.

SUPREME KHAN (N Parmar) - Jumped away awkwardly making contact with ALPHA CHARLIE.

ON THE PROWL (T Mitchell) - Raced three wide without cover.

SUPERETTE (M Hashizume) - Lay out rounding the final turn making contact with the hindquarters of ROCK MY HEART passing the 350 metres. Contacted near the 300 metres when CALPURNIA shifted outwards with SUPERETTE then becoming awkwardly placed near the heels of ROCK MY HEART for a distance. Contributing was slight inward movement from ROCK MY HEART. B Rogerson was advised to exercise care in similar circumstances.

B Rogerson (CALPURNIA) - Issued with a warning for leaving the course without permission.

Race 10 | **PRIMA PARK DANIEL MILLER RACING MAIDEN 1600**

STRANGE LOVE (K Hannan) - Due to there being no senior rider available, Stewards granted permission for apprentice K Hannan to replace T Newman. After becoming fractious in the barriers was removed to undergo a veterinary examination before being a late scratching on veterinary advice at 5.34 pm. As a result, this race ran 4 minutes late.

BUBBAJOCK (W Kennedy) - Jumped away awkwardly losing ground. Checked passing the 200 metres when crowded between PROPOSAL and SHE'S OUTRAGEOUS.

SHE'S OUTRAGEOUS (N Parmar) - Blundered passing the 1400 metres. Held up early in the straight and could not obtain clear running until passing the 150 metres.

TIDAL RUSH (A Goindasamy) – Raced three wide without cover.

ROCKET WON'T GO (T Thornton) - Knuckled shortly after the start. Held up passing the 250 metres and did not obtain clear running for the remainder of the race being unable to be tested by its rider.

FAY KHAN IT (J Laking) - Lay in onto heels approaching the 250 metres having to be straightened by its rider.

JACK IN THE BOX (L Satherley) - Made contact with GOLDEN KIWI when attempting a tight run to the inside of PROPOSAL which lay in near the 200 metres.

PROPOSAL (M Hashizume) - Lay in approaching the 200 metres making contact with JACK IN THE BOX then shifted outwards hampering BUBBAJOCK which was checked passing the 200 metres.

GOLDEN KIWI (J Riddell) - Unbalanced for a distance when contacted near the 200 metres.
