<b>RACE COMMENTS</b>	
<b>Race 1</b>	<b>NZB INSURANCE PEARL SERIES MAIDEN RACE 1600m</b>
<p><b>PHEROZ FRIENDS</b> (S Wynne) – Declared a late scratching at 12.08pm after refusing to load. Co-trainer A Furlong was advised that PHEROZ FRIENDS must barrier trial to the satisfaction of a Stipendiary Steward prior to racing next.</p> <p><b>MADAME GISELLE</b> (K Chowdhoo) - Began awkwardly shifting out crowding outside runners. Crowded and checked passing the 1300 metres having to be restrained for a distance and continued to over race until passing the 1100 metres.</p> <p><b>LA SUPERBA</b> (K Mudhoo) - Crowded at the start.</p> <p><b>HASSITALL</b> (T Comignaghi) - Crowded at the start losing ground. When asked to comment on the performance of this favoured runner, rider reported that after losing ground at the start the gelding had found the line fairly and she was not overly disappointed with today's performance.</p> <p><b>EARS BACK</b> (L Callaway) - Checked and crowded shortly after leaving the barriers when inside runners shifted out and when being steadied over reacted getting its head up on a number of occasions. Lay in under pressure in the straight.</p> <p><b>CHAMONIX</b> (C Carmine) - Over raced in the early stages.</p> <p><b>TAIL LIGHTS</b> (D Montes de Oca) - Lay in throughout the run home having to be straightened on a number of occasions.</p> <p><b>K Mudhoo</b> (LA SUPERBA) - Admitted a charge of careless riding in that he allowed his mount LA SUPERBA to shift inwards when not sufficiently clear of MADAM GISELLE which was crowded and checked passing the 1300 metres. After considering submissions the Adjudicator imposed a suspension of K Mudhoo's licence to ride in races from the conclusion of racing on Saturday, 5 November until the conclusion of racing on Friday, 11 November, 4 national riding days.</p> <p><b>K Chowdhoo</b> (MADAME GISELLE) - Admitted a charge in that he struck his mount MADAME GISELLE 6 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a fine of \$250.</p>	
<b>Race 2</b>	<b>MCINTOSH CATERING 1600m</b>
<p><b>TAKE THE DEEL</b> (G Jogoo) - Jumped away awkwardly and was then inclined to over race in the early stages.</p> <p><b>WHISPER ROCK</b> (R Beeharry) - Slow away.</p> <p><b>FOLLOW YOUR DREAMS</b> (D Montes de Oca) - Lay outwards on the bend near the 600 metres and made contact with CAMINO ROCOSO on a number of occasions. Continued to lay outwards for the remainder of the race.</p> <p><b>CAMINO ROCOSO</b> (J Laking) - Contacted on a number of occasions passing the 600 metres.</p>	
<b>Race 3</b>	<b>RACE READY ON BETAVET MAIDEN 1200m</b>
<p><b>CATS IN THE CRADLE</b> - Declared a late scratching at 7.43am on veterinary advice.</p> <p><b>TELLME YOU LOVEME</b> (T Comignaghi) - Hampered leaving the barriers when BURGUNDY GOLD jumped outwards. Raced wide without cover throughout.</p> <p><b>MERITORIOUS</b> (C Barnes) - Steadied for a distance when placed in restricted room between LOVE FIFTEEN and MARCHING ON TAVI passing the 200 metres. Crowded and had to steady again passing the 100 metres when LOVE</p>	

FIFTEEN shifted inwards under pressure. When asked to comment on performance, rider advised that the mare had only battled when placed under pressure in the run home, adding she had not had all favours in the final 200 metres.

**D Montes de Oca** (MARCHING ON TAVI) - Admitted a charge in that he used his whip with an action which raised the rider's arm above shoulder height. After considering submissions the Adjudicator imposed a fine of \$500.

**Race 4** | **THANK YOU BARNESWOOD FARM MAIDEN 1200m**

**BETTY SPAGHETTI** (K Chowdhoo) - Jumped away awkwardly losing ground. Crowded and checked passing the 1100 metres. Held up in the run home and had to shift ground outwards passing the 200 metres to find clear racing room.

**MISTER GOLDIE** (R Mudhoo) - Slow away.

**TWITCHY SQUIRREL** (A Balloo) - Crowded and placed in restricted room having to be steadied off heels approaching the 1000 metres when AN MORRIGHAN (K Kwo) which was racing greenly shifted in before being straightened by its rider. K Kwo was advised to exercise greater care.

**AN MORRIGHAN** (K Kwo) - Raced greenly throughout and was inclined to shift ground in the run home and near the 200 metres made contact with NAKAMOTO becoming briefly unbalanced.

**SWAY UP** (M Taylor) - Dictated wider near the 750 metres when BOLSHOI STAR shifted out to avoid the heels of CLARK KENT.

**BOLSHOI STAR** (S Wynne) - Over raced into the bend near the 750 metres and had to shift out to avoid heels.

**NAKAMOTO** (D Montes de Oca) - Crowded and checked near the 375 metres. Contacted and unbalanced near the 200 metres.

**CLARK KENT** (T Moseley) - When asked to comment on the performance of this favoured runner rider could offer no tangible excuse.

**T Moseley** (CLARK KENT) - Issued with a warning after permitting his mount CLARK KENT to shift inwards when not sufficiently clear of BOLSHOI STAR passing the 750 metres. In assessing this Stewards took into account the racing manners of BOLSHOI STAR.

**J Laking** (THATS CHARMING) - Admitted a charge of careless riding in that he allowed his mount THATS CHARMING to shift inwards when not sufficiently clear of BETTY SPAGHETTI which was crowded and checked passing the 1100 metres. After considering submissions the Adjudicator imposed a suspension of J Laking's licence to ride in races from the conclusion of racing on Saturday, 5 November until the conclusion of racing on Friday, 11 November, 4 national riding days.

**K Kwo** (AN MORRIGHAN) - Admitted a charge of careless riding in that he allowed his mount AN MORRIGHAN to shift inwards when not sufficiently clear of NAKAMOTO which was crowded and checked passing the 375 metres. After considering submissions the Adjudicator imposed a suspension of K Kwo's licence to ride in races from the conclusion of racing on Wednesday, 9 November until the conclusion of racing on Tuesday, 15 November, 4 national riding days.

**D Montes de Oca** (NAKAMOTO) - Admitted a charge of careless riding alleging that he allowed his mount NAKAMOTO to shift outwards passing the 150 metres crowding and checking AN MORRIGHAN. After considering submissions the Adjudicator upheld the charge and imposed a suspension of K Kwo's licence to ride in races from the conclusion of racing on Tuesday, 1 November until the conclusion of racing on Sunday, 6 November, 4 national riding days.

**Race 5** | **NZB INSURANCE PEARL SERIES RACE 1200m**

**SOOO DUSTY** (K Asano) - Slow away.

**CASTLE ON THE HILL** (S Wynne) - Slow away.

**DUBAI LADY** (R Mudhoo) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

**JUST MAYBE** (T Comignaghi) - Raced three wide without cover.

**SILVER CANNON** (D Montes de Oca) - Shifted in passing the 125 metres to find clear racing room. Crowded and checked passing the 50 metres.

**CAITLYN JAY** (S Toolooa) - Crowded and had to steady and unbalanced when awkwardly placed on the heels of **SILVER CANNON** which was also awkwardly placed on the heels of **HELLO MARY LOU** which after initially shifting out and contacting **RUSSIAN FABLE** when being corrected by its rider shifted in placing those runners in restricted room. After interviewing riders and reviewing films which were inconclusive, the matter was taken no further other than advising J Laking to straighten his mount earlier than he had on this occasion.

**S Toolooa** (CAITLYN JAY) - Admitted a charge in that he used his whip with an action which raised the rider's arm above shoulder height. After considering submissions the Adjudicator imposed a fine of \$250.

**Race 6** | **HYGAIN MAIDEN STAYERS 2200m**

**LOMBARDI** (R Mudhoo) - Made the first turn near the 1700 metres awkwardly. Held up rounding the final bend and had to be steadied away from the heels of a tiring runner passing the 475 metres. Crowded and buffeted for several strides near the 300 metres.

**BAD FLAMINGO** (K Asano) - Raced three wide without cover before improving forward to sit outside the leader near the 1200 metres.

**CHOICE MOMENT** (C Johnson) - Crowded and buffeted near the 300 metres. When asked to comment on the performance, rider advised that he had to do some work mid race and when placed under pressure the mare failed to respond and had been disappointing.

**STEVE AUSTIN** (L Callaway) - Crowded when tiring near the 250 metres. When asked to comment on the performance, rider advised that the gelding had a soft lead throughout but when placed under pressure failed to respond and had been very disappointing. A post-race veterinary inspection did not reveal any obvious abnormality.

**A Balloo** (CLARA MONCRIEFF) - Admitted a charge of careless riding in that he permitted his mount **CLARA MONCRIEFF** to shift inwards crowding and buffeting **LOMBARDI** and **CHOICE MOMENT** passing the 300 metres. After considering submissions the Adjudicator imposed a suspension of A Balloo's licence to ride in races from the conclusion of racing on Wednesday, 9 November until the conclusion of racing on Wednesday, 16 November, 5 national riding days.

**Race 7** | **EQUINE PRODUCTS 2200m**

**IFITHAPPENSAGAIN** (B Murray) - Jumped away awkwardly. Over raced badly through the middle stages having to be firmly restrained off heels on a number of occasions.

**THEUNNAMEDFEELING** (S Wynne) - Hampered at the start when runners either side shifted ground.

**TELLING TALES** (R Mudhoo) - Had some difficulty finding clear running rounding the final bend and early in the run home.

<b>KING OF THE DANCE</b> (R Beeharry) - Held up for a distance passing the 200 metres having to shift ground outwards across heels to find clear racing room.	
<b>Race 8</b>	<b>MID CANTERBURY SPRAYING 1400m</b>
<b>SEVEN AAJES</b> (C Campbell) - Slow to begin. Held up through the middle stages of the run home only finding clear racing room inside the final 125 metres.	
<b>PERFECTLY SUITED</b> (S Wynne) - Crowded at the start losing ground.	
<b>NAMIBIA MISS</b> (C Barnes) - Shifted in at the start crowding inside runner. Raced three wide without cover throughout. Lay in under pressure over the concluding stages.	
<b>SHARPIE</b> (K Chowdhoo) - Over raced in the middle stages and lay out on the bend passing the 800 metres and continued to lay out for the majority of the race.	
<b>Race 9</b>	<b>AGRAFORUM GROWING INNOVATION 1400m</b>
<b>STAR BALLOT</b> (D Montes de Oca) - Shifted in abruptly at the start crowding inside runners.	
<b>HOW UNUSUAL</b> (S Wynne) - Crowded at the start losing ground. Placed in restricted room early in the run home when DRAKE BAY lay inwards. Crowded again passing the 250 metres when inside runners shifted outwards, with rider S Wynne reporting that the mare had raced greenly and had been reluctant to take a marginal run between two runners.	
<b>LA COFRADIA</b> (C Barnes) – Crowded and buffeted at the start.	
<b>GOODANYA</b> (J Laking) - Crowded at the start losing ground when LA COFRADIA was forced inwards.	
<b>DRAKE BAY</b> (A Balloo) - Made the bend at the 800 metres awkwardly getting its head up.	
<b>Race 10</b>	<b>AGRAFORUM COMCAT 1400m</b>
<b>LIGHT UP</b> (C Johnson) - Began awkwardly.	
<b>DORIS DIOR</b> (C Campbell) - Crowded at the start losing some ground.	
<b>JUST TICKETY BOO</b> (D Tait) - Crowded at the start losing ground.	
<b>FINAL SAVINGS</b> (D Montes de Oca) - Began awkwardly shifting in crowding JUST TICKETY BOO. Raced three wide without cover for the majority of the race.
