RACE COMMENTS
Race 1 SOUTH AUCKLAND RACING CLUB MAIDEN 1400

BELLANO (N Parmar) - Began awkwardly losing ground.

DROP OF SOMETHING (T Newman) – Restrained in the early stages to obtain cover after jumping from an outside barrier.

PURRFECT PUSS (S McKay) - Began awkwardly. Raced in restricted room passing the 250 metres. When questioned regarding performance rider advised that the filly had raced greenly throughout, and in his opinion would be better suited by improved track conditions.

FASHION DELIGHT (W Kennedy) - Began awkwardly.

CHANNEL SURFER (J Fawcett) - Began awkwardly losing ground. Made contact with TAWI when shifting outwards to obtain clear running near 450 metres.

MY EXPLOSIVE (K Hannan) – Raced three wide without cover throughout.

TAWI (C Grylls) – Raced wide without cover throughout. Hampered when contacted near the 450 metres when CHANNEL SURFER shifted outwards to obtain clear running.

DIAMOND DISCOVERY (A Goindasamy) – Made contact with TIDAL FORCE when shifting outwards to obtain clear running near the 450 metres.

TIDAL FORCE (M McNab) – Contacted near the 450 metres.

J Fawcett (CHANNEL SURFER) - Admitted a charge of careless riding in that she permitted her mount CHANNEL SURFER to shift outwards near the 450 metres when not sufficiently clear of TAWI which was hampered and checked. After considering submissions the Adjudicative Committee imposed a suspension of J Fawcett's licence to ride in races from the conclusion of racing on Wednesday 9 November up to and including racing on Saturday 19 November, 7 national riding days.

Race 2 | **BEATTIE CIVIL PROJECTS & APS MAIDEN 1400**

DRACHMA (C Grylls) - Restrained in the early stages to obtain cover after jumping from the outside barrier.

ANNA TAIT (L Satherley) – Began awkwardly losing ground. When questioned regarding performance rider advised that the mare had felt indifferent in its action. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

ANNIE (T Thornton) – Raced wide in the early stages before improving to race outside the leader near the 900 metres.

SILVERSTREAM (E Bragg) - Began awkwardly. Raced wide without cover throughout.

EL PASO (N Parmar) - Raced wide without cover throughout.

SEA THE LIGHT (W Kennedy) – Held up for clear running early in the final straight.

POZZI VIBE (R Elliot) - Lay out in the final straight and was unable to be fully ridden out as a result. Rider R Elliot reported that the gelding had hung throughout the race.

Race 3 | **BARFOOT & THOMPSON 2400**

RODOLFO (K Asano) - Crowded leaving the barriers.

LOT OF ZEES (S Spratt) - Began awkwardly losing ground.

PLUSHENKO (A Lawson-Carroll) - Slow to begin.

DAYTONA RED (T Mitchell) – Began awkwardly. Raced wide through the early and middle stages.

HIWA (M Hashizume) – Raced three wide in the early stages before improving to lead near the 1600 metres.

SUPER SID (T Thornton) – Over-raced through the early and middle stages. Raced wide throughout. Contacted by ZA'FARAN having to be steadied passing the 400 metres.

CHARRED (J Fawcett) - Raced wide through the early and middle stages.

ZA'FARAN (V Colgan) - Held up early in the straight and when shifting outwards to obtain clear running near the 400 metres, made contact with SUPER SID.

V Colgan (ZA'FARAN) – Issued with a warning after making contact with SUPER SID when shifting outwards to obtain clear running near the 400 metres.

Race 4 | **AGROWQUIP MAIDEN 1600**

PENTARA (A Lawson-Carroll) - Began awkwardly losing ground. Briefly held up near the 200 metres when PILLAR OF SOCIETY lay in.

JUST A TIPPLE (M Hashizume) – Slow to begin. Raced wide without cover.

BOSCH (A Goindasamy) – Began awkwardly. Over-raced in the middle stages.

BRICKIE'S MOJO (L Allpress) - Over-raced through the early and middle stages before being allowed to stride forward to race outside the leader near the 800 metres. Lay out rounding the final turn.

TURAROUND (K Asano) – Raced ungenerously when being restrained in the early stages having to be firmly restrained off heels near the 1100 metres continuing to over-race through the middle stages.

BEYOND VIOLET (C Grylls) – Raced wide throughout.

CON ARTIST (S Spratt) - When questioned regarding performance rider advised that the gelding had over-raced in the lead then failing to finish the race off, and in her opinion may be feeling the effects of recent racing.

Race 5 | **BARFOOT & THOMPSON 1600**

SIX CHOUSTA (M Kareem) - Had to be re-saddled at the barrier. As a result, this race ran approximately 2 ½ minutes late. Raced four wide without cover throughout.

TRUST IN YOU (J Kamaruddin) - Began awkwardly then crowded leaving the barriers. Held up when improving onto heels near the 300 metres before obtaining clear running approaching the 200 metres, then again being held up until near the 100 metres.

MRS BIG (C Dell) - Slow to begin.

INSIGNIA (R Elliot) - Began awkwardly making contact with TRUST IN YOU.

YOULEDO (L Allpress) – Raced three wide without cover throughout racing keenly in the middle stages.

RANGER (J Riddell) - Raced in restricted room going into the bend near the 900 metres when racing to the inside of SIX CHOUSTA. Apprentice M Kareem was shown footage in the presence of the riding mentor and advised to exercise greater care. Had some difficulty obtaining clear running early in the final straight.

THE LETTER (T Abel) - Was unable to obtain clear running throughout the final straight.

THE HIGH PRIESTESS (K Asano) – When questioned regarding performance rider advised that the mare had never travelled well and had not felt confident racing amongst other runners.

BADGERINGDAWITNESS (K Hannan) – Required post-race veterinary treatment suffering the effects from heat stress.

T Mitchell (TAVIDORA) - Admitted a charge in that she struck her mount TAVIDORA six times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of T Mitchell's licence to ride in races from the conclusion of racing on Wednesday 9 November up to and including racing on Wednesday 23 November, 8 national riding days. In addition, T Mitchell has been directed to meet with an NZTR appointed Rider Skills Review Panel under the provisions of Rule 343.

APOSTROPHE (C Grylls) - Slow to begin.

GOLDEN HUE (R Beemud) - Began awkwardly.

ONEROA (R Elliot) - Slow to begin.

ZAILA (T Mitchell) - Began awkwardly. Raced wide without cover.

RED INFERNO (N Parmar) - Slow to begin. Made the bend near the 900 metres awkwardly shifting outwards hampering REVERBERATIONS.

REVERBERATIONS (M Hashizume) – Hampered near the 900 metres.

BELLA LUCE (K Asano) - Raced wide throughout.

ROCHMIE RAY (T Thornton) - Over-raced in the early and middle stages having to be steadied off heels on a number of occasions. Was unable to obtain clear running throughout the final straight.

FLASH MARY (B Rogerson) – Over-raced through the early and middle stages.

STARS 'N' CREAM (V Colgan) – Raced three wide without cover throughout.

DUBAI DIVA (M McNab) – Held up early in the straight.

PATSYS LASS (J Fawcett) - Held up rounding the final turn then having to be steadied to avoid the heels of ROCHMIE RAY when again held up passing the 400 metres.

SHE'S A MANEATER (L Allpress) - Began awkwardly losing ground. When questioned regarding performance rider advised that the mare had hung throughout. Trainer P Lock was advised that a veterinary clearance would be required prior to racing next.

ROGER THAT (L Satherley) - Began awkwardly losing ground. When questioned regarding performance rider advised that the gelding had felt a little indifferent in its action. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

ZOLA EXPRESS (C Dell) – Restrained to obtain cover in the early stages after jumping from an outside barrier. Placed in restricted room near the 150 metres when runners to either side shifted ground with ZOLA EXPRESS being steadied and shifting outwards across the heels of QUIZ KID.

MASETTO (R Elliot) – Reared at the start losing ground. Steadied when placed in restricted room to the inside of VIKTOR VEGAS just short of the finish.

QUIZ KID (M Cropp) – Raced clear in the lead through the early and middle stages. Lay out rounding the final turn. When questioned regarding his riding tactics M Cropp advised that his instructions had been to let the gelding roll along in front before applying pressure from near the 1000 metres. These instructions were confirmed by trainer S Phelan.

K Asano (VIKTOR VEGAS) – Issued with a warning after permitting his mount to shift inwards over the concluding stages resulting in MASETTO having to be steadied.

M Cropp (QUIZ KID) - Admitted a charge in that he struck his mount QUIZ KID seven times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$550.

HELENA BABY (W Kennedy) - Jumped away awkwardly crowding JUSTAMAIZ.

JUSTAMAIZ (M McNab) - Crowded leaving the barriers due to movement from runners to either side then having to be steadied when further hampered shortly after the start.

BARI (J Fawcett) - Jumped away awkwardly crowding SELF OBSESSION onto JUSTAMAIZ. Raced keenly in the early stages. When questioned regarding the performance rider advised that the gelding had been making abnormal breathing noises, Stewards will follow up with the trainer in coming days.

SELF OBSESSION (V Colgan) - Crowded leaving the barriers then further placed in restricted room shortly after the start.

SOLDIER BOY (T Mitchell) - Raced three wide without cover throughout.

BELLE EN ROUGE (J Kamaruddin) - Restrained in the early stages to obtain cover after jumping from the outside barrier.

AQUAOIR (T Newman) – Held up for clear running until passing the 250 metres.

S Spratt (MACUSHLA) - Issued with a warning after permitting her mount to shift inwards shortly after the start when not fully clear of HELENA BABY which was dictated inwards placing JUSTAMAIZ and SELF OBSESSION in restricted

room with JUSTAMAIZ being steadied. In assessing this incident Stewards took into account the outward movement from BARI after jumping awkwardly.

Race 9 | **EDWARDS SOUND 1200**

PURE IMAGINATION (C Grylls) - Restrained in the early stages to obtain cover after jumping from an outside barrier. When questioned regarding performance rider advised that the gelding had never travelled well and had felt indifferent in its action and in his opinion was not suited by the improved track conditions. Underwent a post-race veterinary examination which found PURE IMAGINATION to have suffered from cardiac arrhythmia. The stable representative was advised that PURE IMAGINATION will not be permitted to start in any race or trial until a veterinary certificate declaring the horse free of any cardiac arrhythmia following a gallop of at least 1000 metres.

NOT GUILTY (V Colgan) – Raced three wide without cover throughout.

WILD WEST (W Pinn) - Shifted outwards under pressure passing the 100 metres inconveniencing LOOKSEASY near the 75 metres.

LOOKSEASY (E Bragg) – Inconvenienced near the 75 metres.

RUDYARD (M McNab) - When questioned regarding performance rider advised that the gelding had raced greenly throughout and had been disappointing.

Race 10 | **CHEVALIER PRODUCE 1400**

CHARLOTTE AMALIE (L Satherley) - Bounded as the start was effected.

STRINGLINE (M Hashizume) – Contacted and crowded leaving the barriers.

FLIGHT PLAN (J Fawcett) – Contacted leaving the barriers.

ANGE DE REVE (L Allpress) - Jumped away awkwardly making contact with FLIGHT PLAN.

ME LIBEREZ (J Kamaruddin) - Jumped away awkwardly making contact with STRINGLINE.

ANNELIESE (R Elliot) – Began awkwardly then restrained to obtain cover in the early stages.

LORD VALENTINE (T Thornton) - Restrained in the early stages to obtain cover after jumping from the outside barrier.

LIL RED'EYEDHOOD (E Bragg) - Raced four wide without cover throughout.

ELYSIAN FIELDS (S Spratt) – Raced three wide without cover throughout.

CULLINAN (C Grylls) - Held up over the final 200 metres.

K Hannan (IMPRESA) - Admitted a charge in that she struck her mount IMPRESA seven times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$300.
