**MALFURION** (H Schofer) - Underwent veterinary examination at the barrier and was cleared to start after dislodging rider H Schofer in the preliminary. H Schofer was examined by St John paramedics and cleared to ride.

**MANDIRANCAN** (M Singh) - Began awkwardly, bumping WAGON WHEEL.

**WAGON WHEEL** (L Allpress) - Bumped at the start, losing ground.

**TWOOUTATHREE** (J Mudhoo) - Raced greenly in the early stages, over-raced and when being restrained went off stride passing the winning post on the first circuit. J Mudhoo reported the gelding raced greenly and hung throughout.

**STAYINYALANE** (L Sutherland) - Over-raced into the first turn. Lay in under pressure over the concluding stages.

**LOWE FLYING** (L Allpress) - Over-raced in the early and middle stages.

The start of this race was delayed due to the headgear on MAKETAWA MISS having to be adjusted.

**THE BIG BAD WOLF** (L Kauri) - Began awkwardly.

**SPROCKET ROCKET** (T Taiaroa) - Began awkwardly bumping SECRET FALLS.

**SECRET FALLS** (L Sutherland) – Bumped at start.

**CACTUS ROSE** (C Grylls) - Slow away. Performed below market expectations. When questioned rider could offer no excuse. Trainer R Patterson advised he would be reconsidering the mare's future.

**MAKETAWA MISS** (L Allpress) - Raced greenly when being restrained passing the 800 metres. Displaced a back plate during the running. Raced greenly over the concluding stages.

**LINDT** (M McNab) - Steadied when in restricted room near the 500 metres.

**CHEAP SAV** (K Hannan) - Made the final bend awkwardly. Raced greenly throughout the home straight.

**BELLA DA PARTY** (K Hercocock) - Lay inwards passing the 200 metres.

**BELLE'S ECHO** (M Hudson) - Raced greenly passing the 150 metres.

**Race 4**

**GLADIATORS DARTS TEAM 1100**

**AMOSIA** (L Sutherland) - Underwent a veterinary examination at the barrier and was cleared to start after dislodging rider L Sutherland in the preliminary. L Sutherland was examined by St John paramedics and cleared to ride.

**GURTLYN** (T Taiaroa) - Underwent a pre-race veterinary examination after being kicked behind the barriers and cleared to start.

**POWER 'N' GLORY** (M Singh) - Slow away.

**EAGLE COUNTY** (L Kauri) - Over-raced in the early and middle stages.

**THATZ DAISY** (K Hercock) - Made the final bend awkwardly.

**DOUBTFUL SOUND** (C Dell) - Held up for some distance in the early part of the final straight prior to being angled inwards passing the 200 metres.

**Race 5**

**BERNIE WALSH ALUMINIUM & GLASS LTD MAIDEN 1200**

**ZEDDIANI** (L Sutherland) - Late scratching at 2.23pm after refusing to load. Trainer K Gray was advised the filly must trial to the satisfaction of Stewards prior to racing next.

**GUESSING GAME** (M McNab) - Slow away. Raced greenly near the 900 metres.

**LUVANUVA** (L Allpress) - Commenced to weaken from the 550 metres, finishing a distant last. Trainer J Bary advised he was disappointed with the run and undertook to notify Stewards should any anomaly come to light in coming days.

**SCELTA DI ELENA** (M Singh) - Raced greenly in the home straight.

**OTAPOURI** (L Douglas) - Connections were advised a warning has been placed against the colt with regard to its competitiveness.

**NEW ORLEANS JAZZ** (A Mudhoo) -Rider weighed in 0.7kg underweight resulting in NEW ORLEANS JAZZ being disqualified from 5<sup>th</sup> placing under Rule 648(3).

**D Howard** (NEW ORLEANS JAZZ) - Admitted a charge under Rule 614(2) in that he was neglectful in saddling NEW ORLEANS JAZZ resulting in A Mudhoo weighing in 0.7kg under the weight at which he weighed out, due to a towel being left off when being saddled in the tie-up stalls. After hearing submissions, the Adjudicator imposed a fine of \$300.

**D Turner** (LUVANUVA) - Admitted a charge under the Minor Infringement Schedule in that he was unable to make the carded weight for LUVANUVA and was fined \$200. D Turner was replaced by L Allpress.

**PROPERTY BROKERS 1400**

**CHICA BONITA** (L Allpress) - Slow away. Lay in over the concluding stages.

**BEAN A PLEASURE** (M Hudson) - Raced three wide without cover throughout.

**LUXEMBOURG** (C Grylls) - Performed below market expectations. When questioned rider could offer no excuse.

**CANUCIA** (M McNab) - Restrained to the rear from its wide draw.

**ROAD DIVA** (J Mudhoo) - Slow away.

**LORD SPENCER** (A Mudhoo) - Raced greenly near the winning post, having to be straightened.

**Race 7** | **MARION HICKEY MEMORIAL 1400**

**ONE DREAM ONE SOUL** (A Mudhoo) - Slow away, losing ground (4L).

**BELARDO BOY** (J Riddell) - Raced three wide without cover throughout.

**STREAK OF POWER** (Mahipal Singh) - Began awkwardly. Over-raced passing the 1100 metres and shifted out hampering **ROYAL FLOWER**, **SAVANAH BELLE** and **SCUTAR**. Mahipal Singh was shown footage of his ride in the presence of the Apprentice Mentor and advised that when steadying his mount, he is expected to show better judgement when allowing his mount to shift ground.

**ROYAL FLOWER** (T Taiaroa) - Hampered 1100 metres.

**SAVANAH BELLE** (L Allpress) - Hampered 1100 metres.

**SCUTAR** (D Turner) - Hampered 1100 metres.

**TANNAHILL** (K Hannan) - Held up rounding the final bend.

**HACKSAW RIDGE** (M McNab) - Held up for a short distance approaching the home turn.

**Race 8** | **KB FORD MAIDEN 1600**

**BE FLEXI** (J Mudhoo) - Slow away.

**LIVINONTHEEDGE** (L Douglas) - Slow away. Improved on to heels having to be steadied near the 600 metres.

**THE UNDERBELLY** (C Grylls) - Over-raced in the early and middle stages.

**JAMESON** (J Riddell) - Raced three wide without cover throughout.

**SCRIPT** (L Sutherland) - Lost its position going into the first turn. L Sutherland was shown footage of her ride in the presence of the Apprentice Mentor and advised that she is expected to show better judgement in future after beginning well but allowing her mount to drift in the early stages when the opportunity to maintain her position was available. Improved on to heels near the 1100 metres.

**OPAWA JACK** (C Dell) - Lay outwards under pressure over the concluding stages.

**BRIAR** (L Allpress) - Performed below market expectations. Rider advised she did not persevere with the mare in the home straight as she felt there was something amiss. A post-race veterinary examination did not reveal any obvious abnormality.

**Race 9** | **DOUG LOCKHEAD PAINTING 1600**

**IRRIGATE** (K Hannan) - Very slow away (5L).

**GINO** (L Allpress) - Raced wide into the first turn and remained three wide without cover throughout. L Allpress reported the gelding hung throughout, placing her at a disadvantage, and was of the opinion **GINO** would benefit with the addition of blinkers. Trainer JJ Rayner advised that blinkers would be added prior to its next start.

**TWEEDLEDEE** (C Dell) - Lay inwards under pressure over the concluding stages.
