RACE COMMENTS	
Race 1	LAMB PETERS PRINT 1600
HUNGRY (S O'Malley) - Raced keenly through the early stages.	

EXQUISITE PEARL (D Turner) - Began awkwardly, losing ground.

PRECIOUS NIAMH (L Sutherland) - Began awkwardly.

VENATO (H Schofer) - Slow to begin. Rider reported that in her opinion the gelding was looking for further ground.

Race 2 | **DR SEPTIC 2050**

RISING RANSOM (F Lazet) - Slow to begin.

THOMAS AQUINAS (S O'Malley) - Made the bend near the 1600 metres awkwardly and was inclined to race keenly through the early stages.

DALMATIA (L Allpress) - Lay outwards in the run home.

SUBTLE POINT (M Singh) - Raced in restricted room near the 150 metres and inclined to shift ground over the final 100 metres.

Race 3 | **ARB INNOVATIONS MAIDEN 2050**

OPAWA JACK (M Singh) - Fractious in its barrier prior to the start.

BOCAGE (J Mudhoo) - Slow to begin. Raced ungenerously entering the first bend, getting its head up. Continued to race greenly throughout the race.

BUNYUP (L Sutherland) - Restrained from a wide draw to obtain cover. Rider was of the opinion the mare would be better suited to tracks with more moisture.

BEERSHEBA (K Hercock) - Placed in restricted room and had to steady in the shadows of the post when ESME (L Allpress) shifted in under pressure. L Allpress was advised to exercise greater care.

ESME (L Allpress) - Shifted in under pressure over the concluding stages.

CANBITEABIT (D Turner) - Hung outwards rounding the final bend.

UNUSUAL BITE (M McNab) - When asked to comment on the performance of the favoured runner, rider advised the gelding had raced greenly throughout but would improve with race-day experience.

Race 4 | **JOHNSON BROTHERS MAIDEN 1600**

Trainer G Nicholson (YUNGBLUD) - Issued with a warning for the late notification of a gear change.

SHOWBIZ (M Singh) - Began awkwardly, shifting out abruptly and when being correctly shifted inwards, losing ground.

ORIGIN (H Schofer) - Slow to begin.

BEAUTIFUL NOISE (C Dell) - Slow to begin.

SHEZ SUPER (Mahipal Singh) - Raced three wide without cover throughout. Shifted in under pressure over the concluding stages.

RIDE THE TIDE (D Bradley) - Steadied outwards across heels passing the 1350 metres when racing keenly. Continued to race keenly for a distance thereafter. Rider reported the gelding had been obliged to improve four wide rounding the home bend and this had taken its toll on today's effort and was also of the opinion the gelding was better suited to tracks with more moisture and a shorter distance.

THE TRUE BELIEVER (S O'Malley) - Placed in restricted room and had to steady when bumped from the inside by **MOMENTS LIKE THESE** which, when tiring, shifted out and away from **FLICK THE SWITCH**, which improved to its inside passing the 150 metres.

MOMENTS LIKE THESE (L Allpress) - Raced greenly in the final straight when under pressure. Rider advised the filly would be better suited to tracks with more moisture in them.

Race 5 | **SELLAR & SELLAR MAIDEN 1000**

Co-Trainers J Benner & H Wynyard (**STRIDES**) - Issued with a warning for the late declaration of rider for **STRIDES**.

Trainer D Jensen (**MCCRAW**) - Issued with a warning for presenting **MCCRAW** in pacifier blinkers when only pacifiers had been declared.

There was a delay of approximately 2 minutes to the start of this event when **HAVARTI** proved difficult to load.

PAPA SURF (F Lazet) - Slow to begin. Raced greenly throughout and near the 600 metres became awkwardly placed inside the heels of **MCCRAW** and when being restrained, shifted in crowding **ZAMBUCCA ROSE** and **TIN PAN ALLEY**, which both had to steady, losing ground. After interviewing riders and reviewing Stewards' footage, which was inclusive, Stewards deemed that no one rider was culpable and took the matter no further. Dislodged rider on returning to the birdcage but was quickly recaptured. Rider F Lazet was uninjured.

ZAMCUBBA ROSE (K Hercock) - Crowded 600 metres having to be steadied.

STRIDES (L Allpress) - Taken back from a wide draw.

TIN PAN ALLEY (D Bradley) - Slow to begin. Crowded 600 metres having to be steadied.

MCCRAW (L Kauri) - Raced wide for the majority of the event.

HAVARTI (M McNab) - Rider dropped his whip near the 100 metres.

CHERTSY (L Sutherland) - The saddle slipped passing the winning post with the rider being dislodged after the finish. L Sutherland was examined by St John paramedics and cleared to ride.

Race 6 | **LIQUORLAND 1000**

PRIORESS (L Sutherland) - Stayed in the starting stalls and took no part in the race, with connections advised the mare must trial to the satisfaction of Stewards prior to racing next.

HAPPY HERO (L Kauri) - Slow to begin then raced keenly in the early stages and had to steady when becoming awkwardly placed inside the heels of **PLEASURE** which, when being steadied, shifted in passing the 650 metres.

MISS SWEET PEE (L Allpress) - Blundered leaving the barriers. Inconvenienced 150 metres.

LITTLEREDCORVETTE (A Mudhoo) - Taken back from a wide draw shortly after the start.

ACTING UP (C Dell) - Had some trouble obtaining clear running in the run home until shifting out to obtain clear running passing the 150 metres and in doing so inconvenienced MISS SWEET PEE.

PLEASURE (S O'Malley) - Awkwardly placed inside heels passing the 650 metres having to be steadied for a distance.

M McNab (MORE THAN WORDS) - Issued with a warning for allowing his mount to shift in when not fully clear of PLEASURE, which was placed in restricted room and steadied passing the 650 metres.

Race 7

PRINT CRAFT MAIDEN 1300

GRAEME JOHN (D Turner) - Began awkwardly, losing ground.

BIGGIE (S O'Malley) - Slow to begin.

LADY POSH (L Allpress) - Slow to begin.

VICTORTHEINFLICTOR (F Lazet) - Slow to begin, then ridden forward to gain a handier position.

BELLES BIG BOY (M Singh) - Crowded shortly after the start, losing ground.

RUBY SEEKER (A Mudhoo) - Raced wide without cover throughout.

MCKHAN (K Hercock) - Crowded and buffeted 1100 metres. Crowded and buffeted 1000 metres.

RITA BONITA (J Mudhoo) - Crowded and buffeted 1100 metres. Crowded and buffeted 1000 metres. Inclined to shift ground outwards in the run home.

SOUL OF FIRE (M McNab) - Crowded and buffeted 1100 metres. Crowded and buffeted 1000 metres.

FLERTA (D Bradley) - Crowded and checked 1100 metres. Crowded and checked 1000 metres.

UNSCRIPTED (C Dell) – Crowded and checked 1100 metres. Crowded and checked 1000 metres.

T Bau (MARTINA DIVA) - Admitted a charge of careless riding in that he permitted MARTINA DIVA to shift inwards near the 1100 metres when not sufficiently clear of FLERTA and UNSCRIPTED, which were both checked. Also hampered in this incident were SOUL OF FIRE, RITA BONITA and MCKHAN. After hearing submissions, the Adjudicator imposed a suspension of his licence to ride in races from the conclusion of racing today, 6 November up to and including racing on Tuesday, 15 November, 6 national riding days.

F Lazet (VICTORTHEINFLICTOR) - Admitted a charge of careless riding in that she permitted VICTORTHEINFLICTOR to shift inwards near the 1000 metres dictating inside runners inwards into the line of FLERTA and UNSCRIPTED which were both crowded and checked. After hearing submissions, the Adjudicator imposed a suspension of her licence to ride in races from the conclusion of racing on Friday, 11 November up to and including racing on Friday, 18 November, 5 national riding days.
