C Johnson was advised he is required to produce a medical certificate prior to racing next.

Race 9 - NELLIES BAR AND RESTAURANT 1400m

LOVINGYOURWORK (T Moseley) – Trainer Mr R Didham reported to Stewards that he was satisfied with the post-race condition of the mare, however has now been sent for a brief freshen up.

Race 5 - DONALDSON BROWN PEGASUS STAKES 1000m (Listed Race)

CHALLA (C Grylls) – Racing Manager Mr R Trumper advised Stewards, the stable was satisfied with the post-race condition of the gelding, and it is their intention to continue on with CHALLA'S current preparation.

RACE COMMENTS

Race 1 | BIDFOOD PROCESSING PREMIER MAIDEN 2000m

POMANDER (C Barnes) - Slow to begin.

HASSITALL (S O'Malley) - Began awkwardly losing ground. Held up for the majority of the run home only gaining clear racing room inside the final 100 metres.

NIGHTFALL (L Sutherland) - Crowded shortly after the start losing ground.

POWERLITE (M McNab) - Blundered shortly after the start. Lay in throughout the run home.

IT'S THE VIBE (C Grylls) - Shifted out shortly after the start crowding NIGHTFALL. Raced greenly when being steadied to take a trailing position through the early stages.

EISENHOWER (Y Atchamah) - From a wide barrier was restrained behind runners to obtain cover shortly after the start.

TAIL LIGHTS (D Montes de Oca) - Shifted out abruptly shortly after the start crowding CHOICE MOMENT and LOMBARDI.

CHOICE MOMENT (C Johnson) - Crowded shortly after the start losing ground.

LOMBARDI (R Mudhoo) - Contacted then crowded shortly after the start losing ground. Shifted away from heels approaching the 800 metres.

HEADS UP (L Callaway) - Got its head up when over racing through the middle stages. Improved quickly onto heels near the 400 metres having to be steadied and shift ground inwards.

JUSTA LAD (K Asano) - Raced in restricted room and had to steady and shift ground outwards passing the 300 metres when runners to either side shifted ground.

Race 2 | **HALLS REFRIGERATED TRANSPORT 3YO PREMIER 1400m**

GOLDIE'S CHANCE (K Kwo) - Blundered at the start. Got its head up when over racing through the early stages and passing the 1000 metres had to be restrained away from heels when continuing to race keenly for a distance.

GUITAR MAN (K Williams) - Lost its footing badly at the start briefly unbalancing its rider losing ground. A post-race veterinary examination did not reveal any obvious abnormality.

CORRECTION (T Moseley) - Blundered at the start briefly unbalancing its rider losing ground.

BOSS MAN (R Mudhoo) - Blundered badly at the start losing ground.

JAFFA (L Allpress) - Over raced in the early stages. Got its head up when being restrained near the 1000 metres and continued to race ungenerously for a distance. Rider reported the saddle had displaced early in the race.

MADAM GISELLE (S Wynne) - Raced three wide without cover for the majority of the race.

DEPLOY (M McNab) - Lost the left hind plate during the running. Rider could offer no tangible excuse for the disappointing performance. A post-race veterinary examination showed a slow recovery. Stewards will follow up in coming days.

Race 3 | **NZB READY TO RUN SALE TRAINERS SERIES MAIDEN 1400m**

SATELLITE (V Colgan) - Slow to begin and was then restrained behind runners to obtain cover.

ALLASERA (C Carmine) - Began awkwardly making contact with TAKE ON and as a result lost ground. Over raced in the middle stages and near the 700 metres had to be steadied away from heels.

TAKE ON (L Sutherland) - Contacted and crowded at the start losing ground. Held up rounding the final bend and early in the run home.

CAPITAL EXPENSE (T Moseley) - Began awkwardly making contact with TAKE ON.

MIA SORELLA (L Allpress) - Began awkwardly shifting in making contact with AMATERASU. Raced three wide without cover throughout.

AMATERASU (T Mitchell) - Contacted at the start.

MISS OTIS REGRETS (C Barnes) - Lost its footing badly at the start losing ground. A post-race veterinary examination did not reveal any obvious abnormality.

MADISON ROSE (T Newman) - Blundered shortly after the start losing ground.

BELLA ROSE (M McNab) - Held up passing the 75 metres and went to the line not fully tested by its rider.

D Stackhouse (BETTY SPAGHETTI) - Admitted a charge in that he struck his mount BETTY SPAGHETTI 7 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$350.

L Sutherland (TAKE ON) - Admitted a charge in that she struck her mount TAKE ON 7 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of L Sutherland's licence to ride in races from the conclusion of racing on Saturday, 19 November until the conclusion of racing on Friday, 2 December, 8 national riding days.

Race 4 | **LIVING TURF PREMIER 2000m**

ELIZABETH ROSE (K Chowdhury) - Blundered shortly after the start.

KILOWATT (T Moseley) - Slow to begin and was then crowded shortly after losing ground.

RAINMAN (G Jogoo) - Slow to begin.

AQUATTACK (S Wynne) - Slow to begin.

CAMINO ROCOSO (C Grylls) - Raced three wide without cover through the early stages before improving forward to sit behind the leader passing the 1200 metres.

IT'S ONLY MONEY (L Allpress) - Held up in the run home only gaining clear racing room inside the final 125 metres.

Race 5 | **RICCARTON PARK FUNCTION CENTRE WELCOME STAKES 1000m (Listed Race)**

NAVY LARK (S Wynne) - Began awkwardly making contact with SURF QUEEN and as a result lost ground. Hung outwards throughout the running and was not persevered with in the home straight. When questioned regarding performance, rider advised she thought the colt had broken down during the running when becoming awkward in its stride and therefore she did not persevere with her mount in the run home. A post-race veterinary inspection revealed the colt to be lame, with the connections advised that a veterinary clearance is required prior to racing next.

SURF QUEEN (T Moseley) - Began awkwardly making contact with NAVY LARK.

RHETORICAL (D Stackhouse) - Began awkwardly. Inclined to lay in in the home straight having to be straightened near the 300 metres.

GWYNVER (K Asano) - Began awkwardly making contact with ILLICIT DREAMS losing ground as a result.

ILLICIT DREAMS (M McNab) - Contacted at the start. Raced greenly in the early stages.

IN THE NAVY (R Mudhoo) - Began awkwardly making contact with RUBICON CROSSING.

RUBICON CROSSING (L Allpress) - Contacted at the start.

SEMPER SUPRA (C Grylls) - Hampered shortly after the start then became awkwardly placed on heels having to be steadied losing ground.

Race 6 | **AMICUS INSURANCE BROKERS PREMIER 1000m**

HELLO MARY LOU (D Stackhouse) - Blundered shortly after the start shifting out crowding POWER 'N' PASSION. Rider reported he was disappointed with the performance and in his opinion the mare may be better suited to a more turning track. A post-race veterinary examination revealed a slow recovery. Stewards to follow up with the connections in coming days.

POWER 'N' PASSION (T Moseley) - Crowded shortly after the start losing ground.

MAKE BELIEVE (C Barnes) - Hampered shortly after the start.

OH NO NO NO (A Mudhoo) - Slow to begin.

COPY THAT (M McNab) - Lost its footing badly at the start losing ground.

VINO BELLA (V Colgan) - Slow to begin.

PAPAGENA (S Toolooa) - Began awkwardly and was then crowded shortly after the start losing ground.

TWIN SHOT (K Asano) - Raced wide without cover throughout.

OUR CLARRY (Y Atchamah) - Had to be steadied away from heels when over racing near the 700 metres.

CASAQUINMAN (L Allpress) - Became awkward in its action when making the crossing near the 700 metres.

YARI (B Rogerson) - Shifted ground outwards in the run home.

Race 7 | **VALACHI DOWNS CANTERBURY BREEDERS STAKES (G3) 1400m (Listed Race)**

Co-trainers **K Rae** and **K Williams** (VEGAS STRIP) were fined \$50 under the Minor Infringement Schedule for presenting VEGAS STRIP without the notified blinkers.

AMAZON GODDESS (A Balloo) - After rearing up and dislodging the rider on leaving the birdcage was quickly recaptured and underwent a veterinary examination on arrival at the barriers being cleared to race.

PROVIDENCEPROVIDES (V Colgan) - Blundered badly at the start with the rider becoming unbalanced and losing considerable ground as a result. Over raced through the middle stages having to be restrained several times on a slow tempo. Held up rounding the final turn and early in the run home.

DORIS DIOR (C Campbell) - Blundered shortly after the start losing ground. Improved onto the heels of VEGAS STRIP which was being steadied having to shift out for a short distance hampering SANIBEL as a result passing the 900 metres

ZOULUMINOUS (C Grylls) - Blundered at the start losing ground. Raced wide without cover throughout.

SEIKRID (K Chowdhoo) - Slow to begin and from a wide barrier was then restrained behind runners to obtain cover shortly after the start. Held up in the run home only gaining clear racing room inside the final 200 metres.

LIVE DRAMA (L Allpress) - Crowded and checked losing ground passing the 1100 metres then over raced for a distance.

VEGAS STRIP (T Newman) - Over raced in the middle stages on a slow tempo.

IRISH GIRL (T Moseley) - Over raced through the middle stages on a moderate tempo.

MONZA CIRCUITO (R Mudhoo) - Crowded and severely restrained to avoid the heels of AMAZON GODDESS passing the 1050 metres

FASHION SHOOT (J Parr) - Raced three wide without cover for the majority of the race.

SANIBEL (K Williams) - Hampered near the 900 metres. Again had to be steadied away from heels passing the 600 metres.

BELCLARE (M McNab) - Rider dropped his whip passing the 50 metres.

K Chowdhoo (SEIKRID) - Admitted a charge of careless riding in that he allowed his mount SEIKRID to shift inwards near the 1100 metres crowding and checking LIVE DRAMA which lost ground. After considering submissions the Adjudicative Committee imposed a suspension of K Chowdhoo's licence to ride in races from the conclusion of racing on Saturday 12 November until the conclusion of racing on Thursday 24 November, 7 national riding days.

A Balloo (AMAZON GODDESS) - Admitted a charge of careless riding in that he allowed his mount AMAZON GODDESS to shift inwards when not sufficiently clear of MONZA CIRCUITO which was crowded and checked near the 1050 metres. After considering submissions the Adjudicative Committee imposed a suspension of A Balloo's licence to ride in races from the conclusion of racing on Wednesday, 16 November until the conclusion of racing on Friday, 25 November, 5 national riding days.

Race 8	CHAMPION FLOUR PREMIER 2500m

SPINDLESHANKS (M Taylor) - Bounded at the start losing ground. Held up early in the run home and near the 300 metres shifted in to find clear racing.

KING KHAN (A Mudhoo) - Restrained from a wide draw to obtain cover.

HEY MICKEY (G Saejorhor) - Restrained from a wide draw to obtain cover.

EULOGY SHOW (S Wynne) - Raced wide in the early stages before improving forward to lead.

PETE THE DRIVER (T Mitchell) - Over raced badly in the early to middle stages and hung outwards for the majority of the race proving a difficult ride. The connections were advised that PETE THE DRIVER is on a racing manners warning.

MANHATTEN AFFAIR (B Rogerson) - Hampered near the 300 metres when SPINDLESHANKS shifted in to find clear racing.

ESCALADE (L Sutherland) - When asked to comment on the performance of this favoured runner, rider was of the opinion the gelding was more suited to a track with more moisture in it.

M Taylor (SPINDLESHANKS) - Admitted a charge of careless riding in that she allowed her mount SPINDLESHANKS to shift inwards passing the 300 metres crowding MANHATTEN AFFAIR which had to be steadied and shifted off its rightful line of running. After considering submissions the Adjudicative Committee imposed a suspension of M Taylor's licence to ride in races from the conclusion of racing on Saturday, 12 November until the conclusion of racing on Wednesday, 23 November, 6 national riding days.

S Wynne (EULOGY SHOW) - Admitted a charge in that she struck her mount EULOGY SHOW 8 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of S Wynne's licence to ride in races from the conclusion of racing on Saturday 12 November until the conclusion of racing on Wednesday 23 November, 6 national riding days.

Race 9	18TH COUPLAND'S BAKERIES MILE (G3) 1600m (Listed Race)

REDFORD (S O'Malley) - Hampered then crowded shortly after the start losing ground.

BLUEY'S CHANCE (A Balloo) - Restrained behind runners from a wide barrier draw to obtain cover shortly after the start.

SERIOUSLY (K Chowdhoooy) - Restrained behind runners from a wide barrier draw to obtain cover shortly after the start then began to over race and near the 1200 metres had to be restrained when improving onto the heels of GERMANICUS.

NEW ARRANGEMENT (J Fawcett) - Crowded shortly after the start when runners to either side shifted ground and as a result lost ground.

FIRODEN (C Campbell) - Raced three wide without cover for the majority of the race. Briefly steadied when placed in restricted room near the 200 metres.

KHIMAR WAR (L Allpress) - Raced wide throughout.

HE'S A DOOZY (K Asano) - Shifted ground under pressure throughout the straight and near the 50 metres inconvenienced HUMBUCKER. K Asano was advised that he should straighten his mounts earlier than he had on this occasion.

KICK ON (T Moseley) - Rider was advised that he should straighten his mounts earlier than he had on this occasion.

HUMBUCKER (K Williams) - Inconvenienced 50 metres.

PHELAN THE POWER (T Mitchell) - Crowded in the shadows of the post when KICK ON shifted in under pressure.

MARKUS AURELIUS (M McNab) - Raced disappointingly finishing in last place. Rider could offer no tangible excuse. Stable connections advised that the gelding would be returned to the home stable and sent for a spell. A post-race veterinary examination did not reveal any obvious abnormality.

KENKI (D Montes de Oca) - Slow to begin.

RED RUFUS (C Campbell) - Blundered at the start losing ground. Crowded checked and unbalanced near the 150 metres.

THE GROWLER (K Chowdhoooy) - Taken back from a wide draw to obtain cover. Crowded checked and unbalanced near the 150 metres.

WAY ABOVE (S O'Malley) - Raced three wide without cover for the majority of the race.

YOLO (L Sutherland) - Held up rounding the final bend and early in the run home.

ZENDORA (S Wynne) - Held up early in the run home.

After taking initial evidence from riders, Stewards opened and adjourned an inquiry into the reasons that **RED RUFUS** (C Campbell) and **THE GROWLER** (K Chowdhoooy) were checked passing the 150 metres.

A Balloo (THISTLE) - Admitted a charge in that he struck his mount THISTLE 6 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$250.
